Covington man killed in Nelson Heights

A Covington man died from multiple gunshot wounds the night of Saturday March 28, following an incident in the Nelson Heights community.

According to the police report, there were gunshots fired on Puckett Street and Chaney Drive around 7:30 p.m. Officers found several spent rounds from two different caliber weapons around the street on scene.

After the incident, officers and EMS were flagged down by a bystander who was transporting a shooting victim to the hospital.

The victim was 33-year-old Michael Stanley. Stanley had been shot multiple times and would later die as a result of his injuries.

According to Capt. Ken Malcom, the Covington Police Department Investigative Division is still investigating the case and is working on leads. Anyone who witnessed the incident is asked to call Detective Travis Pierce at 678-625-5562.

"The motive is still under investigation. Detectives have gathered evidence from the scene, identified suspects and continue to follow up on credible leads to solve this case," Malcom said.

Newton County records first death from COVID-19

The state of Georgia now has 184 deaths from COVID-19 including one from Newton County.

The Georgia Department of Public Health reported Friday at noon that a 61-year-old man from Newton County with underlying health conditions had fallen victim to the novel coronavirus.

Out of the 184 deaths in Georgia, just four were confirmed to not have underlying health conditions, all of which were over the age of 50. It is still unknown if 58 of the deaths due to COVID-19 in Georgia had underlying

health conditions. One of those 58 includes the youngest person in the state to die from the virus: A 29-year old female from Peach County.

As of DPH's noon Friday update, Georgia has 5,831 confirmed cases of COVID-19. Out of those 5,831 cases, 1,158 are hospitalized. Newton County has 40 confirmed cases of COVID-19, an increase of 25 cases since last week.

Much of the increase can be contributed to an increase in testing. Gov. Brian Kemp announced Tuesday a large surge in the ability to test for COVID-19 in Georgia thanks to a partnership with two

state universities.

Kemp said there will be an increase in the availability of polymerase chain reaction testing, featuring pooled resources of the University System of Georgia, Georgia Public Health Laboratory and Emory University.

"Adequate testing for COVID-19 has continued to be a top priority for the Coronavirus Task Force as we fight this pandemic," Kemp said. "With this innovative partnership between state government agencies, our world-class research institutions and private-sector

Abuse cases on rise during shutdown

Hospitals aren't just dealing with a rise in cases related to the growing COVID-19 crisis. They're also seeing more people who are victims of abuse.

That's according to Gov. Brian Kemp, who said there are ripple effects to the coronavirus outbreak that has disrupted nearly every aspect of life across the state and world.

"As we continue to fight this virus, our office is receiving reports that are concerning and deserve the public's immediate attention," Kemp said Wednesday in a news conference outside the state Capitol.

"We have been told by one Atlanta-area hospital that they are seeing a 15% increase in domestic violence

cases in their facility. This is disturbing and cannot be tolerated."

Kemp urged people who are victims of domestic violence, or who know victims, to call the state's hotline at 800-334-2836.

However, with schools being closed since mid-March — and Kemp later announced campuses won't be reopening until the fall — the state actually has taken fewer reports of abuse.

"Teachers and administrators are often the first ones to see the signs of abuse, and with schools closed, we must remain vigilant about this problem and work to remedy it," he said.

Kemp issues statewide shelter-in-place order

Grocery stores, food pick-up, deliveries exempt

Amid the push to curb coronavirus, a statewide shelter-in-place order that will shutter in-person patronizing of bars, gyms, restaurants, theaters and many other activities began at 6 p.m. Friday and will last through April 13.

Gov. Brian Kemp issued an executive order Thursday evening that exempts a range of activities deemed "essential services" like food and medical supply pick-ups and deliveries, critical infrastructure and those that help maintain minimum business operations.

Many types of businesses deemed essential will remain open but under tightened rules to keep work areas clean and for people to keep six feet of distance at minimum between each other, as well as a maximum of 10 people per any given space.

Restaurants will have to close in-person dining areas, but food pick-ups and deliveries will be allowed. People in Georgia will also be able to travel to grocery stores, medical appointments and pharmacies, according to the governor's office.

"Preference should be given to online ordering, home delivery and curbside pick-up services wherever possible as opposed to in-store shopping," the order says.

Exercising is allowed out-

side so long as people keep their distance from each other, the order says.

Critical infrastructure, per federal guidelines, includes health-care sectors, law enforcement and first-responder agencies, food and agriculture industries, energy companies, water and sewer utilities, trucking, public transit, information technology and more.

The order also requires rules at businesses that remain open, including health screenings, hand washing, staggered shifts and teleworking where possible.

Gov. Brian Kemp announced Wednesday he would sign the order following changes to federal modeling and guidelines earlier this week that account for the fact that the respiratory virus can spread from infected persons who do not show symptoms.

As of noon Thursday, more than 5,400 Georgians had tested positive for COVID-19,

the disease caused by the novel strain of coronavirus that has sparked a global pandemic. It had killed 176 patients from Georgia.

Kemp also signed an executive order Wednesday to close in-person classes for all Georgia public schools for the rest of the current school year. Thousands of schools across the state are poised to lean on online instruction to finish the spring term.

Per the order, enforcing the shelter-in-place will be left to Georgia State Patrol officers and any state agency members deputized by the governor or the Georgia Emergency Management and Homeland Security Agency.

Those officials, along with state Department of Public Health officers, will have authority to close any business or organization not complying with the order. Individual violators will be charged with a misdemeanor.

Atlanta doctor braces for COVID-19's worst days

ATLANTA — Denial, fear, anxiety and worry have been the constant companions of Dr. Colleen Kraft and her colleagues at Emory University Hospital in recent weeks.

Coronavirus has pummeled the physical resources and mental toughness of hospital staff, and the patient "super surge," as Kraft describes it, has not even arrived yet.

"We have all collectively and individually gone through that grief cycle," said Kraft, an associate chief medical officer at the hospital who gave a video briefing for

reporters Friday.

As of noon Friday, more than 5,800 people in Georgia had tested positive for COVID-19, the disease caused by the novel strain of coronavirus that has sparked a global pandemic. It has killed 184 Georgians.

Hospitals are grinding across the state under the reality of dwindling amounts of protective gear and bed space for critically sick patients. State health officials say the peak period for hospital capacity is likely still three weeks away, on April 23.

At Emory, hospital workers who have been battling

US 278 repave coming for Newton County

Pittman Construction is set to begin working on the \$2.58 million resurfacing of State Route 12/US 278 from east of State Route 142 up to the Morgan County line on Monday.

It will be an 8.4-mile project that will take

part in 5.96 miles of Newton County and 2.43 miles in Walton County.

Contract crews will start on the SR 142 side Monday and will put in work daily until they reach completion. Single-lane closures are to be expected during construction hours until repaving is complete.

partners, we will be able to dramatically increase testing capacity.”

The partnership allows Georgia’s universities to transfer equipment needed for COVID-19 testing from their research labs to accredited clinical labs at Georgia State University, Augusta University, Em-

ory University and the Georgia Public Health Laboratory.

The state has now reported to have conducted 16,181 tests with the majority of those being done at commercial labs. The Georgia Department of Public Health’s lab has tested just 1921 cases with 326 returning positive while the other 3,791 positive tests have come from the 14,260

tests completed by commercial labs.

COVID-19 seems to be affecting males and females evenly in Georgia, with females accounting for 52% of cases in the state. The virus is also affecting those in the 18-59 age group the most at 59% of confirmed cases. Meanwhile 36% of confirmed cases involve those over the age of 60.

Nearly every county

in the state now has at least one confirmed case. Taliaferro, Hancock, Glascock, Crawford, Marion, Quitman, Treutlan, Montgomery, Telfair, Jeff Davis, Evans, Wayne, Brantley, Treutlen, Montgomery, Evans, Jeff Davis, Wayne, Brantley, Atkinson and Echols counties are the only counties out of 159 in the state to not register confirmed cases.

the highly infectious virus for two months now are “definitely gearing up” for an even tougher fight ahead, said Kraft.

In-house lab work is now turning around diagnostic test results in 24 hours. Local universities are making 3-D face shields to help reuse protective masks. The hospital has purchased 50 new ventilators. And Emory staff are figuring out flow plans for moving patients to free up the most space possible

in anticipation of the coming surge.

Still, the thought of what the rest of this month could bring is daunting.

“It’s been a difficult time of preparation to think about how we haven’t hit the peak yet,” Kraft said.

But Kraft, who was part the university hospital’s Ebola treatment team in 2014, said the statewide shelter-in-place order set to start Friday at 6 p.m. should lessen the stress for hospitals like Emory if it helps slow transmission rates of the virus.

Gov. Brian Kemp ordered the loose state-

wide shutdown a month after the first people in the state, a father and son from Fulton County, tested positive for the virus.

Restaurants, bars and other common social spots will shutter through April 13, per the order, while grocery stores and other businesses can largely remain open so long as patrons and workers can keep at least six feet apart from each other.

“As we take the fight to COVID-19, I’m asking Georgians to hunker down, follow the directives we’ve issued and help us flatten the curve,” Kemp said

Thursday.

Through the struggle, Kraft has also witnessed daily acts of strength and courage at Emory. Teamwork, she says, has kept up their spirits as staff clean their face masks with ultraviolet radiation and it remains a toss-up for how many new masks, gowns and gloves there will be whenever the latest supply shipment comes.

“What I’ve seen personally is on the days that I’m not feeling best, there’s someone there to lift me up,” Kraft said. “I think we’re focusing on trying to be a team and breaking down as many silos as possible.”

GHSA cancels spring sports, questions remain about fall

Following Wednesday's announcement from Gov. Brian Kemp that all schools would be closed for the remainder of the 2019-2020 school year, the Georgia High School Association officially announced Thursday that all spring sports were canceled for the remainder of the academic year.

"Given the announcement yesterday by Governor Kemp, it is with a heavy heart that I inform you that all GHSA activities and sports are cancelled for the 2019-2020 school year," GHSA Executive Director Robin Hines said in a statement. "I especially want to commend the graduating seniors who have not only missed most of the spring season but prom, senior nights, awards

ceremonies, possibly graduation, and spent the last few months away from their friends and classmates. Our

seniors have a great deal to be proud of and while this is not the way any of us wanted it to end, I want to thank them for a

job well done."

The GHSA's sanctioned spring sports include baseball, golf, gymnastics, lacrosse, riflery, soccer, slow-pitch softball, tennis and track and field.

At the time of cancellation, all three Newton County varsity baseball teams were sporting unblemished records in region play. The Alcovy Tigers finished the year at 5-6 overall and 1-0 in Region 3-AAAAA, the Eastside Eagles finished 6-7 overall and 2-0 against Region 4-AAAA competition and the Newton Rams closed out the season at 6-4 and 3-0 in Region 8-AAAAAAA.

The cancellation also brought a premature finish to Newton County athletics on the pitch. Eastside's boys' soccer team finished its 2020 campaign at 5-3-1 and 2-1 in the region. The Lady Eagles, meanwhile, were sitting at 5-3-0 and

ranked No. 10 in Class AAAA before their season came to an abrupt halt.

While the NCAA is granting an extra year of eligibility to college athletes in spring sports, that won't be the case for high school seniors.

"There have been quite a few requests for the GHSA to allow a fifth year of eligibility to students due to this crisis. There are no plans to grant an additional year," Hines said. "As sad and disappointing as this spring has been, there is a backward trickle effect and there are many unintended consequences associated with waiving this by-law. GHSA activities and sports are education-based and exist as an extension of the classroom."

The bigger issue now is if the effects of COVID-19 will affect the fall sports season. Unfortunately, that something that no one can predict at this moment. What is for sure, however, is that fall sports that train months in advance like football won't be able to have workouts for the foreseeable future.

"As I stated in the newsletter earlier this week, I am concerned about the summer as well as the fall," Hines said. "I am hoping for the best but there is no information available that would allow for any decision regarding when practices and workouts will be allowed. There are no GHSA activities or practices allowed until further notice."

Eastside's Elizabeth Ozburn signs with Middle Georgia State for soccer

Interest in Isakson's former US Senate seat

Despite the wishful thinking of some there will be plenty of choices for voters when it comes to the November special election to fill the remaining term of Johnny Isakson.

In the world of reality, that's how it should be. After Isakson, one of our state's most respected officials, resigned due to health reasons it allowed Governor Brian Kemp the opportunity to appoint someone to the position, bypassing Georgia voters in the process. A special election will still be held to fill the remainder of the term but Kelly Loeffler, Kemp's choice, has the power of "incumbency" even though she has yet to be elected to anything by the voters in Georgia.

Some inside GOP circles didn't want anyone else in the party challenging Loeffler in the special election, which will be Nov. 3. The "jungle election" will feature all candidates on the ballot at once with no party primaries leading up to the November vote.

Collins officially qualified for the race last week. It's ironic that some didn't want Republican infighting for fear it might allow a Democrat to take the coveted seat in the US Senate.

Doug Collins wasn't the only Republican to qualify though. Four other Republicans also signed up for the race including: network engineer, Derrick Grayson; businesswoman, Annette Davis Jackson; business executive, A. Wayne Johnson; and educator, Kandiss Taylor.

Eight Democrats are in the race as well including: attorney, Deborah Jackson; Air Force veteran and businesswoman, Jamesia James; advocate, Tamara Johnson-Shealey; Matt Lieberman (son of former US Senator Joseph Lieberman); physician, Joy Felicia Slade; attorney, Ed Tarver; pastor, Raphael Warnock; and University

of Georgia professor, Richard Dien Winfield.

Libertarian Brian Slowinski, who once ran for the Congress from the 10th district as a Republican, is running. In addition independents Al Bartell (a business consultant), Allen Buckley (a lawyer, accountant and former Libertarian candidate for US Senate), Michael Todd Greene (a former educator) and Valencia Stovall (a business owner) will also be on the ballot. Green Party candidate John Fortuin joined the race on the final qualifying day and will be on the ballot.

Georgia voters will have their choice from 20 total candidates for the seat. Choice is always a good thing, although some in political circles were hoping for less choice. Some Democrats wanted the race cleared so Warnock could benefit from more than one Republican being in the race, and some Republicans wanted Loeffler to be the lone GOP choice.

With this many candidates on the ballot at once a runoff is a certainty. Candidates will have eight months to make their case to the voters.

A poll conducted by the University of Georgia (prior to qualifying) showed Collins with a slim overall lead in the race followed by Loeffler and Lieberman.

And if those 20 candidates don't do it for you, there is always Rod Mack, a member of the Board of Appeals for the City of Hapeville, who qualified as an official write-in candidate. An official write-in candidate means votes for the candidate will officially count and be recorded.

This is going to be fun to watch.

When Dr. Fauci Speaks, We Should Listen

We're in the midst of a pandemic that could result in the deaths of hundreds of thousands of Americans, and the experts call that a "best-case scenario."

It will touch the lives of us all, for decades to come.

Many who live in the south will never forget April 25, 2011. In my neck of the woods, we lost 80 lives in a 60 mile radius, in the span of a few hours. The property damage was also devastating. Ever since that day, we get nervous if there's a strong breeze in the forecast. When the wind starts whistling and the trees begin to sway, we head for our safe space. Our survival instinct kicks in.

We don't know how long this pandemic will last, nor do we know how it will end. What will "normal" be like a year from now? Will you eagerly reach out and shake someone's hand? If a good friend rushes in for a hug, will you move forward, or back away? If the man next to you in church sneezes, will you move to a different pew? At what point will you feel comfortable in a crowded theater? It's much like our first steps. We're unsteadily moving forward.

This much I know. Just as firefighters, police officers and EMT's became heroes to us after 9/11, we are now adding doctors, nurses, and their assistants to that category. We have long thanked our military personnel for their service, as we should. Now, the brave men and women who staff our hospitals and medical offices are on the front lines, working long hours. They're fighting an unseen enemy, at great risk to themselves and their families. They are in the line of fire, trying to save our lives. In some cases, they are unable to do so, and they



will carry that burden forever. We will always salute our heroes in fatigues. Let's add those in scrubs to the list.

We must now honor our doctors' requests to isolate ourselves, to help them help us. Our strong nation must join hands, even when we cannot touch each other.

I get upset when I see cocky conspiracy theorists and selfish religious leaders not only ignore this directive, but actually encourage people to act as if they are invincible. Many say their personal liberties are being threatened. Freedom will be the last thing on their mind when they, their spouse, their parents or their children get sick. Georgia Power offers tips, resources for managing “stay-at-home” energy use amid COVID-19 crisis

Spring has arrived in Georgia, meaning the needle on the thermometer will be making a steady climb for the foreseeable future. As temperatures continue to rise across the state, and families find themselves in their homes more often due to the COVID-19 pandemic, electric bills are expected to escalate.

In response, Georgia Power sent out a press release this week offering tips and resources for customers to conserve energy throughout the coronavirus crisis. Here are six tips the company believes will help customers save money on their bill without making drastic changes to their lifestyle:

- Set it for the season: When the warm weather comes rolling in during the spring and summer, keep the thermostat set to 78 degrees. Georgia Power suggests that

each degree above 78 can result in a 3% to 4% decrease in energy use. Also remember that fans are your friends, and they can cool the air with less energy in spite of a higher thermostat setting.

- Phase out phantom energy loss: Unplug devices when they aren't in use to eliminate a phantom loss in energy. Smart power strips also work great to combat this issue if customers remember to turn off the strip when it's not in use.

- Chose wisely with appliances: Georgia Power urges customers to be mindful of the types of appliances they use throughout the day. Avoid using a device that gives off heat during warmer parts of the day, for example, as well as frequent opening of the refrigerator or freezer.

- Feel the flow; free your filters: It's essential to clean or replace air conditioning filters on a monthly basis. Georgia Powers notes that a dirty filter can

result in a higher bill due to the load it puts on other equipment to work harder. Customers should make sure vents and return air registers are not obstructed by furniture, rugs, curtains or other items.

- Follow on and off advice: Similar to the phantom energy loss tip, Georgia Power urges customers to keep elec-

tronic devices off when not in use. Additionally, many newer TVs, computers and other types of electronics have energy-saving settings to help keep your bill at a reasonable rate.

- Save with LEDs: Swapping our your standard light bulbs for LED light bulbs is one way to significantly cut down the amount of

energy you use. Tests show LEDs use 90% less energy than a standard bulb while also lasting up to 15 times longer. The Georgia Power Marketplace offers saving and direct deliver on LED options, such as an ENERGY STAR-qualified LED bulb.

Georgia Power announced last month it

would be temporarily suspending residential disconnections for 30 days beginning Saturday, March 14, 2020, in response to COVID-19. However, the company urges customers to follow these energy-saving tips and continue making payments if possible to avoid facing large balance due amounts when the suspension is over.

Customers also need to be wary of an influx of scammers during the ongoing pandemic.

Georgia Power stated it will never ask its customers for credit card or pre-paid debit card information over the phone. If someone receives a call from someone claiming to work for Georgia Power and demanding a payment to avoid disconnection, the customer should end the call and contact the company's customer service line at 888-660-5890.

Newton County makes amendments to shelter at home resolution

The Newton County Board of Commissioners held an emergency meeting via teleconference Wednesday evening to modify the shelter at home ordinance the county put in place March 25.

The original resolution went into effect Thursday, March 26, and was set to run through 11:59 p.m. on April 7. The amendments made Wednesday became effective at 11:59 p.m. on Wednesday night and will continue through 11:59 p.m. on April 8, unless altered by way of being extended, rescinded, superseded or amended in writing by the Chairman and Board.

The commissioners passed an amendment updating the dates and statistics listed in the original ordinance to better reflect the latest information regarding the impact of COVID-19. They also made three notable modifications to the ordinance, which are as follows:

- Religious assemblies are encouraged to voluntarily limit activities to no more than 10 people.
- Funeral homes and crematories are to limit

attendance at funeral services, visitations or other gatherings to the maximum number recommended by either the CDC or President Trump. As of Wednesday, April 1, that number is 10.

- Outdoor recreational businesses and businesses licensed to sell firearms and ammunition are considered essential and are permitted to stay open, so long as they follow the six-foot social distancing requirements.

These changes were largely influenced by the modifications the city of Covington made to its shelter at home ordinance Friday, March 27.

Following these amendments, the commissioners added language authorizing the Newton County Sheriff's Office to enforce the Shelter in Place Ordinance. Discretion is

advised for the Sheriff's Office when making arrests for criminal activity considered less serious while enforcing the ordinance.

The commissioners also approved additional temporary funding for the Sheriff's Office to help cover costs related to COVID-19. They agreed to set aside up to \$164,685 per month to go toward supporting nursing at the Newton County Jail and paying school resource officers, as well as auto repairs, fuel and overtime for patrol deputies.

Sheriff Ezell Brown noted an additional pod has been opened in the jail and is being used as a quarantine unit for inmates infected with COVID-19. Additionally, overtime has increased in recent weeks due to the necessity for more staffing to take temperatures and cleaning.

At a news conference Wednesday, Kemp called revised guidelines from the Centers for Disease Control and Prevention on asymptomatic spreading of coronavirus as “a game changer.”

“We are taking action to protect our hospitals, to help our medical providers and prepare for the patient surge that we know is coming,” Kemp said Wednesday. “Now is the time to fight and continue to be strong and courageous.”

The governor's shelter-in-place order follows mounting pressure from health experts and politicians from both parties who have called for a statewide approach. Up to this point, Kemp has largely deferred to city and county authorities to decide whether to issue stay-at-home orders for

their areas.

Kemp drew criticism Thursday from local officials and political opponents who blasted his reliance on this week's new federal guidelines, arguing the governor and state health officials should have known much sooner about the ability of the virus to spread without symptoms.

Officials with the governor's office stressed Kemp's decision was also based heavily on the worsening strain hospitals are facing with shortages in protective gear and life-saving equipment, as well as new projections for patient capacity at Georgia hospitals to peak later this month.

In a news release Thursday, the state Department of Public Health pointed to information from CDC Robert Redfield that as many as 25% of people infected with coro-

navirus do not show symptoms and can be infectious up to 48 hours before symptoms appear. Redfield provided that information on Monday, the state public health agency noted.

The best way to halt the spreading virus and ease the burden for hospitals is for everyone to keep their distance from each other and practice good sanitary habits, said Dr. Kathleen Toomey, the state public health commissioner.

“Until now, containing the spread of COVID-19 has been based on early detection and isolation of people with symptoms of the virus,” Toomey said in a statement Thursday. “Social distancing and keeping people apart from each other are now more than just recommendations; they are the best weapons we have to stop the spread of COVID-19.”
