Newton mourns death of coach

Rollerson passes away suddenly

COVINGTON - Newton High School track and field assistant coach Jay Rollerson died in his home last weekend from an apparent heart attack, Newton



Perry-Stokes announced. He was 66. Funeral arrangements were not

Jay Rollerson immediately made available

Perry-Stokes took to Facebook on Monday to make the announcement and share a heart-felt message about the loss she and the Newton Ram community suffered.

"My heart is sooo heavy right now, I am really in disbelief at this moment," she said in the social media post. "I lost a great friend, mentor, and legendary coach who stuck with me from the beginning to the end."

Rollerson, referred to by many as 'Coach Rollo,' was an assistant on Perry-Stokes' staff for the past seven years after retiring from teaching. He oversaw an extremely successful period of the Rams program, which included back-to-back region championships.

Perry-Stokes spoke with The Covington News about what Rollerson meant to the track program at NHS.

"Coach Rollo was a mentor to me. He was like a dad and he treated me like his daughter. You could talk to him about anything because he was so laid back," she said. "We worked together really, really well. The girls on the team loved him and he loved the girls. He'd give them the world if he

In addition to his charismatic personality, it was Rollerson's devotion to his job that helped earn the admiration of his peers. After spending years

Judicial emergency extended

Set to expire on June 12

ATLANTA — Georgia's coronavirus-prompted judicial emergency has been extended for another month.

Chief Justice Harold Melton signed an order last week extending the emergency from May 13, the current expiration date, until June

All criminal and civil jury trials will continue to be suspended, and courts will be barred from summoning and impaneling new trial and grand juries.

While Georgia businesses are gradually reopening following Gov. Brian Kemp's

lifting of his shelter-inplace order on May 1, Melton said the courts are different from most private establishments

and public places. "We compel people to attend court proceedings, and that requires us to be extra cautious," he said.

Since Melton issued the first judicial emergency order in mid-March, courts have remained open to handle critical and essential court ser-

Under the new extension order, courts will be urged to develop plans for restoring non-critical operations that can be conducted remotely by videoconferencing or by maintaining adherence

Newton County records eighth COVID-19 death

Georgia tops over 30,000 positive cases

COVINGTON — An eighth COVID-19-related death was confirmed in

Newton County this week

as testing continued to

become more accessible

across the state. According to the Geor-

gia Department of Public Health, the two latest deaths in the county were females ages 58 and 73. It remains undetermined if either of the females had underlying health conditions prior to contracting the coronavirus.

On April 3, the DPH confirmed a 61-year-old male with underlying

health conditions was the first person from Newton County to die from COVID-19. Shortly thereafter, males ages 84 and 77, both of whom were said to have had compromised immune systems, died from the novel virus.

During the week of April 24, three more deaths were reported. The

first was a 62-year-old

female with compromised

health, followed by males ages 66 and 52. The prior health conditions of the two males remains un-

On Thursday afternoon, Gov. Brian Kemp addressed the media at the Georgia State Capitol and announced that the criteria for testing has now been expanded beyond those showing symptoms, health care workers, the

elderly and those with chronic illnesses. Thanks to numerous partnerships with universities and corporations around the state, as well as the federal government, Georgia has seen a significant boost in the number of tests that have been administered in recent weeks. As of Thursday, Georgia

Decision coming on Covington's Stars and Stripes Fest

COVINGTON — The Covington City Council has agreed to make a decision regarding the city's annual Stars and Stripes Fest by May 18.

The fireworks display Covington holds on the Square each July is widely renowned as one of the top Independence Day events in Georgia. However, while the state continues to slowly reopen in the wake of the COVID-19 outbreak, this year's Stars and Stripes Fest is in jeopardy of being postponed or canceled.

Covington City Manager Scott Andrews addressed the issue during a City Council meeting on Monday, April 20.

Just hours before the meeting took place, Gov. Brian Kemp announced the state would begin scaling back its coronavirus orders prior to the expiration of the statewide shelter-in-place

order on April 30. Consequently, Andrews believed citizens would like to see similar progress made at the local level.

"This is a huge event for us," Andrews said of the fireworks display, "and I think as we've started to see some light here based off the governor's conversation earlier, we want to give people something to be excited for. But we want to take social distancing and safety into account."

Council member Anthony Henderson asked what the deadline would be for the council to come to a decision. Andrews said the city could wait "a couple council meetings" before putting it

In response, Henderson expressed his desire to hold off on deciding whether or not to host the event on July

"I think we should be patient and see how events play out as far as the governor's restrictions," he said.

Henderson added that he believed making a decision in mid-May or late May would be more efficient. Fellow council member Fleeta Baggett publicly agreed with him, and the rest of the council followed in voicing their agreement.

Mayor Steven Horton stated that Covington can push the event back without facing a penalty. However, he urged the council members to decide one way or another in a timely fashion.

"I will say for the record that we do have a letter in hand right now from the fireworks company that says we can reschedule to another date between now and the end of the year with no penalty," Horton said. "I think the further out you get, the harder it may be to get a date."

The council then unanimously approved a motion to table the decision until their meeting on May 18.

ranked No. 43 out of 54 states and territories in testing per capita to No. 29. Additionally, the state ranked No. 12 in per capita testing among the 23 states with a population greater than 5 million people.

"I'm proud to report that we are seeing record highs in testing," Kemp said, crediting the state's numerous partnerships for the ability to ramp up the number of tests. "While

I'm proud of what we've accomplished, there's more we can do to realize our full potential."

Dr. Kathleen Toomey, the state's public health commissioner, announced that an estimated 110,000 tests were administered in Georgia over the last two weeks. That's nearly half of the 225,937 total tests that were reported by the DPH early Friday morning.

She added that the state now has roughly 550 employees and student workers performing con-

tact-tracing tasks. That is over halfway to the goal of the 1,000 tracers which are needed.

"We want to be able to identify everyone in the community who may be infected, whether symptomatic or not, so that we can ensure we can stop that spread," Toomey said.

Tending to elderly patients in long-term care facilities continues to be a top priority for the state. Kemp stated that more than half of Georgia's coronavirus deaths — as well

as 20% of all confirmed cases as of Thursday were related to residents of those facilities.

"These are heartbreaking statistics," Kemp said, "and we are doing everything in our power to keep these Georgians safe."

The federal government is gearing up to send 210,000 test swabs to Georgia throughout May, according to Homer Bryson, the state's emergency management director. Furthermore, CVS and Walmart have aided the

cause by setting up testing sites around the state.

As of 8:25 a.m. on Friday, May 8, the DPH reported that there had been 31,624 total confirmed cases of COVID-19 across Georgia. Additionally, 5,875 patients had been hospitalized due the virus and 1,351 deaths had been reported.

In Newton County, 236 people have now contracted the coronavirus, leading to 39 hospitalizations and eight deaths.

Fulton County leads

the state in total confirmed cases at 3,260, as well as hospitalizations with 607 and deaths with 137. Dekalb now has the second-most confirmed cases of any county in the state with 2,397, followed by Gwinnett at 2,257 and Cobb at 2,024.

In neighboring Walton County, 147 people have contracted the coronavirus and five have died. Two of those deaths have been long-term care facility residents at Park Place Nursing and Rehab in Monroe.

COVID-19 Budget

Up to now, the focus on the pandemic has been on the Healthcare side of the equation. This week, the Joint Appropriations Committee of the General Assembly met (virtually) to discuss what it has cost us.

The economic fallout is even worse than the Recession of 2009.



Georgia's revenue for April was down 36 percent – a stunning \$1B loss from last year in one

month alone. The May numbers will be worse. Overall, we expect a 15 percent tax shortfall or \$3.8B for the year. Even more shocking, a third of all previously employed Georgians have filed for unem-

Yes, you read that right. A third of all Georgians are now out of

Thankfully, the state's previous conservative fiscal policy has built a rainy-day reserve balance of \$2.7B. But even if we drained that entire account, it would still not balance our budget. We would also lose our AAA Bond Rating which will make borrowing money to overcome short-term short falls vastly more expensive.

Thus, the Governor has instructed every state agency to reduce their budget by 14 percent for FY2021. That is on top of the 4 percent we already took for FY 2020. Since 90 percent of the state budget is tied up in 11 large budget areas, that is where 90 percent of the cuts will have to come from. Education will probably lose about \$1.5B, Community Health \$500M, our Universities \$361M, Transportation \$280M, Corrections \$170M, Student Finance \$141M, Human Services \$116M, Early Care and Learning \$61M, and our Technical Colleges \$52M. Another \$333M will have to come from the remaining 38 agencies. The Governor has said there will be no exceptions.

Obviously, this crisis is much different than the Recession of 2009, because the problem was not caused by a weak economy, but rather a foreign virus. Tens of millions of lives are being shattered, and a grim new study predicts that half of all small businesses will be shuttered in six months. We're hoping when we start up the economy again, the recovery will be robust. But that depends on consumer confidence, which doesn't look promising. 75 percent of Georgians fear to go to a mall, 60 percent won't go into a restaurant, 68 percent don't want to go on a vacation, and 53 percent of us don't want to go shopping. Until those number turn around, we will continue to face further hardships.

I believe it's time to get back to work. The majority of states have begun that process, and many states never shutdown in the first place. Following the science, the numbers in the states that were never closed are no worse off than the ones who did. And it must be noted that no governor is mandating that businesses must open; rather, they are giving their citizens the freedom to open...if they so choose.

Freedom is a word we haven't heard a lot these days. What we have heard is the need to flatten the curve to keep hospital beds open. Well, the curve has been lowered - way down from that fearful "2.2 million deaths" model the media hyped so much. And despite all their dire predictions, no one in this nation who needed a ventilator or a hospital bed didn't get one. In fact, hospitals across the nation are actually furloughing nurses and doctors - in the middle of a pandemic because no one will go there for fear of contracting this virus.

Poverty is deadlier than any virus. Poverty leads to hunger, want, homelessness, alcoholism, domestic abuse, suicides, and an array of heartbreaking circumstances that no government - no matter how much money they print – is able to fix.

The truth is that everyone accepts a certain level of risk every time we walk outside our door... and we always will. Shutting ourselves in indefinitely is a false

choice that cannot be maintained. Of course, we need to take protective measures to keep ourselves safe. Governor Kemp recently urged all Georgians to schedule a coronavirus screening, regardless of whether they have symptoms. Of course, the elderly and people with co-morbidities need to remain quarantined. Of course, no business should be forced to re-open. But I believe that healthy Americans should have the freedom to go back to work - safely - if they choose to. The consequences if we do not restart our economy will be misery and strife on a scale hitherto unimaginable.

In praise of our first responders both here and away

It seems to take a pandemic for us to get our priorities in order. With the death toll in the country having passed 60,000 and with over a thousand of those here in Georgia, suddenly we realize that those who entertain us — like actors and ballplayers — are nothing more than diversions. They are paid obscene amounts of money to make us forget the vicissitudes of our daily lives. In fact, they are as irrelevant as a bump on an elephant's rump.

The real heroes are the first responders. They are the doctors, emergency room personnel, nurses (including one in my family for whom I pray every day), police officers, firefighters, EMTs and others on the front lines in the battle with the deadly coronavirus battle. They don't get paid nearly what they are worth for the risks they are taking and the enormous pressures they are

Not only are they on the front lines, in many cases this is an added responsibility to an already dangerous job which often goes unappreciated until we need them. When we have a life-ordeath situation, who do we want to see — a first responder or Colick Kaperdoodle who, if we are lucky, has crawled into a rathole, never to be heard from again?

There is another set of first responders we sometimes overlook — the National Guard. It was my privilege some years ago to be embedded with Georgia's 48th Brigade Combat Team in a part of Iraq aptly known as the Triangle of Death. These unsung warriors are not only soldiers of the first rank, back home they are schoolteachers, electricians,



prison guards, truck drivers, plumbers and our neighbors. Today, members of Geor-

gia's National

Guard are fighting a different battle as fearlessly as they did in Iraq. Only this time it isn't bombs or bullets. As we speak, men and women of the Guard are disinfecting nursing homes, assisting hospital staff so they can focus on saving lives, packaging food and delivering it to needy Georgians across the state and a host of other responsibilities.

Many members of the National Guard still find themselves far away from home. A friend recently shared a Facebook post with me from April McDaniel, an E4 Specialist with the North Carolina National Guard, who is posted somewhere in the Middle East(For security reasons, she can't say where).

If you are feeling sorry for yourself these days because of having to shelter in place or fretting as to whether you have hoarded enough toilet paper to last you through this decade and beyond, consider yourself fortunate. You could find yourself in the sweltering heat of some godforsaken cesspool in the Middle East, worrying about the health of your family thousands of miles away and that the coronavirus might find you up-close-andpersonal, not to mention some nutcase trying to kill you. That is the case of April McDaniel.

McDaniel has been deployed in the Middle East since October 2019. More importantly, she is a wife and mother of eight children, the oldest a 14-year-old daughter.

On Facebook she says, "This coronavirus is affecting everybody. You hear some people complaining about being with their kids. I have to be able to get a good signal just to be able to call home and parent my children and to be a wife.

"It's a hard time for us. Pray for everybody, not just your situations and your family but for us overseas, too. PTSD (Post Traumatic Stress Syndrome) is real. Suicide is real. Depression is real. These are things that people wake up thinking about and feeling every day.

"Appreciate this time you get to spend at home with your kids, reading a book or something. I read a book in the USO, made a recording of myself reading to my child and sent it in the mail home. I don't even know if it made it yet.

"Embrace and enjoy the little things: Cooking dinner, tucking your kids in at night, making sure you are saying your prayers with them, watching TV on the couch on weekends, telling your parents you love them, going to see your mama."

May this pandemic one day be history, but may we never forget who the real heroes are in our society, be they first responders on the front lines here at home or in some godforsaken cesspool in the Middle East. Thank you one and all and please stay safe. Can I get an amen?

That cafe-gym-atorium was hot, and my fellow scholars were ready to disrobe. Don't get the wrong idea. We didn't have any sordid plans for that night. Well, come to think of it, there were a few wild ones in that class

to anyone under 18). As he launched into his speech, he promised to share his "Rules







Local healthcare professional answers COVID-19 questions

Dr. Arona speaks with Newton BOC

By MASON WITTNER

COVINGTON — During the Newton County Board of Commissioners meeting on Tuesday night, Dr. Audrey Arona, district health director and CEO of Gwinnett, Newton and Rockdale County Health Departments, joined the call and spent 30 minutes fielding questions from the commissioners.

Below you'll find a transcript of some the most pertinent answers she provided in an attempt to shed more light on COVID-19:

Q: We are excited to have you in the meeting with us

tonight. If you will, could you please give us an update on COVID-19?

A: "Thank you, chairman. Thank you so much. I am just so grateful to be able to be here with you guys tonight. I feel led to have taken this position for such a time as this. I'm just daily in prayer asking for guidance and wisdom every day. I'm just so grateful to work for counties, including yours, that are just so supportive and so wonderful in terms of keeping community's hearts as a priority. I'm just grateful to you, commissioners, and chairmen. Let me start

First of all, worldwide we have over 3.6 million cases now and we have over a quarter of a million deaths. The United States has over 1.2 million cases now, and

we toppled over 70,000 deaths. Georgia has 29,769 cases now - almost 30,000 with 292

deaths. In our district,

Gwinnett has 2,094 cases with 77 deaths, Newton County has 213 cases with eight deaths, and Rockdale has 203 cases with six deaths. Our median age for cases is 48. For the deaths, the median age is 79 years old. And, of the deaths, 86% of those were hospitalized. We do have a COVID-19 snapshot that's on our website now at gnrhealth.com.

If you click on 'More Information' under the COVID-19 bullet and scroll down, you'll see a document and right below the map, information will come up. This is basically information about male/ female, race, ethnicity. It's also got our case history confirmed and presump-

the back wits one other data as well. That is updated right now weekly every Monday night at midnight, so if you look at that [Tuesday] it's up-to-date information. I'm trying to update it more than once a week right now, but it's pretty labor-intensive, so we're going to try to do that. Of our testing, we have increased and ramped up our testing to where we've conducted over 6,150 tests now. We have about a 10% positivity rate overall. We tested at the Georgia International Horse Park last Friday and did 1,189 tests, and there was a 5% positivity rate for that. So, our largest spot has a lower positivity rate, but overall it's around a 10% positivity rate.

Since Melton issued the first judicial emergency order in mid-March, courts have remained open to handle critical and essential court services.

Under the new extension

order, courts will be urged to develop plans for restoring non-critical operations that can be conducted remotely by videoconferencing or by maintaining adherence to public health guidelines. Increasing the use of remote judicial proceedings where legally permitted is aimed at limiting the backlog once the emergency order is ended.

The state Supreme Court has set an example by starting to hold hearings via remote videoconferencing.

The task force will include judges from every category of courts, civil trial lawyers, court clerks and sheriffs.



week now, and our goal is to get to 4,000 tests per week. We're on track to do that.

We're just trying to build up our test kit supplies in order to be able to do that. So, we're looking also at a second location in Gwinnett County to fit more in the Norcross area because we believe that there's a lot of the population that doesn't have vehicle access to get to our other places, so we're looking for sites in that location as well. We also have ramped up our case investigation epidemiology team because all the positives in Georgia are reported for our district to the health department. We've also had to increase our contact-tracing staff because every time we have a positive, we now have to track their contacts, so we've been doing that as well. Our system is set up so that all the negatives are in portal access for patients, so we don't have to record all the negatives, just those who don't want to or can't use the

The National Guard has been testing and all of their results need to be called upon, so we're doing about 1,000 to 1,200 results for them every week as well. That's getting a little bit easier, but I still do request that if anyone is test by the National Guard, if they would please let me know so I can reach out because we are sometimes unaware that the National Guard has been there.

I really want people to get timely results so that we don't have any

You guys have probably all heard about this new drug called Remdesivir, which is an IV medication given to patients who are severely ill with COVID-19. It's shown to be about 31% of the patients that get this are better recovered quicker, so it's showing some promise. It's made by Gilead, and Gilead is donating over a million doses for this. This was a medication that was investigated at the time of our ebola days, so that looks very promising. Although in China, they have some reports that it wasn't working as well. But here we've had some luck. Oxford University is also looking at a vaccine, and it's very promising looking in monkeys. So they've accelerated to human studies now, so we're hoping that by the first of the year that might be available."

"I'll now open up for any followed-up questions you may have

Q: You turn on the news and you hear of a new possible vaccine every day. The vaccine that you mentioned, do you believe the fourth quarter of the year is quickest we'll see some type of vaccine on that scale?

A: "There are nine vaccines that I know of that are being developed and looked into. This is the one that showed the most promise that I'm aware of out of Oxford University. I can't imagine we'll an available vaccine before the fall. We're very close to the fall

anyway. Dr. Fauci thinks it might be available by January, and I did some research and they're really pushing to try to get this out sooner. That's the one I know has the most progress."

Q: Do you know any statistical data on if we're testing our first responders on a consistent basis?

A: "We have been testing symptomatic first responders. Now we're testing asymptomatic first responders and health care workers. We're still testing those who have developed symptoms, but we've been testing that group all along. That's why our positivity rate was higher to begin with. It was 16% initially because our health care workers and first responders were the ones we were testing, plus those that have highrisk factors."

Q: For those that have contracted the virus and already recovered, do we know if it's a possibility that they can get reinfected with COVID-19?

A: "We don't know the answer to that question. There have been cases that appear the same person has been infected twice, but the real question is, were they just lingered and then they had a second wave of it before they completely recovered? The antibody test hopefully, over time, will give us more of those types of answers. But until we have more data and research, we won't really be able to answer that question."

Salvation Army reopens **Covington Family Store**

Now operating three days per week thru May

COVINGTON — The Salvation Army is reopening its family store in Covington this week.

The Covington Family Store closed its doors at the end of March in response to the COVID-19 outbreak. While its food pantry and financial assistance program for utilities continued standard operations, the store itself was closed throughout the month of April.

"We took that time to close, really go through our cleaning process here in the center and make sure that all of our store operations would be functional for the new way that we opened our business," Director Steve Wallace said.

Beginning on Wednesday, May 6, the location will be open three days a week — Wednesday, Thursday, Friday — from 10 a.m. to 4 p.m. For the time being, however, donations will only be accepted on Mondays.

Wallace explained the reasoning behind limiting donations to one day a week, noting that donated items must be quarantined for 72 hours before employees can handle

"One day a week is probably all that we can handle for now as we rotate those donations out of the warehouse and into the store," he

The Covington Family Store will continue following CDC recommendations for keeping its facility safe for employees and customers. Hand-sanitizing equipment will be placed at several locations throughout the store, gloves and masks will be made available and social-distancing measures — such as limiting the number of customers permitted inside at one time — will be enforced.

The end goal is to return to operating six days a week, but the store's top priority at this time is ensuring customer and employee

"On behalf of The Salvation Army, and of all the people that have supported us for so many years, we're blessed and honored to be able to reopen back to the community in a very safe, very protected environment," Wallace said. "We certainly want to continue to provide resources to our community in every way we can. We're honored to have this sort of grand reopening week. We hope the public will come out and
