County cuts ribbon on \$1.7 million senior center addition

COVINGTON, Ga. — The grand opening of a major addition and renovation of its Senior Center near Turner Lake is the latest phase in the half-century evolution of the county's Senior Services department.

Current and former county officials helped cut the ribbon to ceremonially open a 5,300-square-foot addition to the Josephine E. Brown Senior Center on Turner Lake Road on Wednesday.

The \$1.7 million project increased the senior center's total space to almost 12,000 square feet, said officials with general contractor Sunbelt Builders. New space in the facility includes a

large fellowship hall and dining room with south side windows overlooking Turner Lake; new administrative offices; and an expanded kitchen facility. A renovation of the original

6,500-square-foot building included converting part of it into a media center and a quilting room, officials said. Proceeds from the county's 2017

Special Purpose Local Option Sales Tax (SPLOST) provided the funding. The center has been named for Jose-

phine Brown, who headed the depart-

ment for 46 years, prior to her retirement in 2016. She told attendees of a ribbon-cutting ceremony that she needed a job in 1970 when she applied to lead a pilot program

to provide meals for Covington seniors. It evolved over the years to include programs and activities for seniors and

went through several locations.

"We had to go through so many substandard buildings," Brown said.

In 2001, the original Senior Center was completed, which Brown said was a "dream accomplished for the moment." District 4 County Commissioner J.C.

Henderson, in whose district the center operates, recognized former County Chairman Keith Ellis for his efforts to include funding for the addition in the 2017 SPLOST.

Ellis said the expansion had been a topic of discussion for almost two decades before "seniors wearing their red shirts" to commission meetings helped convince the board to include the fund-Senior Services director Freda Reed

now leads the center that offers on-site and home-delivered meals to Newton County residents 55 and over. It also offers its 300 members classes

on ceramics, arts and crafts, quilting, sewing, exercise, drama, dancing and State, federal and local governments

Newton funds new position to help EMA distribute vaccine

County government also giving employees one-time pandemic incentive payment

COVINGTON, Ga. Newton County is giving its employees a one-time payment for working during the pandemic and has added a new emergency management agency position to help distribute a vaccine when it becomes available.

County commissioners voted to give a \$300 "pandemic incentive" payment to each of its employees hired before March 2020 after more sales tax than anticipated had come into county coffers recently.

The payment "is a pandemic incentive that was used to recognize the hard work and sacrifice for employees who worked to keep things going and our community safe during this time of public health emergency," said County Manager Lloyd Kerr.

It will be given to employees hired after March on a prorated basis, Kerr said.

County officials will use \$225,000 from its Local Option Sales Tax fund to pay for the incentive after revenues came in 19% higher than budgeted in recent months, said county finance director Brittany White.

"They've been coming in really strong," she said.

Collections of the sales tax — which counties use to allow them to decrease property taxes — had been budgeted at a lower amount because of economic uncertainty due to COVID-19, White said.

The county also recently received almost \$600,000 after an audit of an undisclosed corporation resulted in the state government sending money originally coded as state sales tax back to the county government, White said.

The incentive is in addition to a \$300 Christmas bonus each employee already has received this year, an area newspaper report-

Commissioners also voted to fund a new employee for the county's Emergency Management Agency after its director explained the agency would help the Georgia Department of Public Health distribute any COVID-19 vaccine the state receives

County commissioners had not anticipated the position in their 2021 budget. However, they voted to use \$9,495 in contingency funds for new employees and combine it with about \$19,500 the Emergency Management Agency had left over in its budget for a

total of \$28,969 to fund the position for six months, White said.

Newton County EMA Director Jody Nolan said his agency would assist the Gwinnett, Newton and Rockdale Health Departments in distributing a COVID-19 vaccine when it becomes available in Newton County.

The Capitol Beat News Bureau reported Tuesday Georgia could have "several hundred thousand doses" of the vaccines in the next week or so for distribution to health-care workers and elderly

care facilities. Dr. Kathleen Toomey, commissioner of the state Department of Public Health, said the doses will roll

Council purchases \$1.43 million ladder fire truck

Replacement for one in current fleet to arrive within 18 months

COVINGTON, Ga.

 Replacing one of the Covington Fire Department's current fleet of trucks with a 100-foot,

mid-mount ladder truck will cost nearly \$1.43 million dollars.

During its meeting Monday, Dec. 7, the Covington City Council unanimously approved a resolution to purchase a new ladder truck in the amount of \$1,429,800 from Pierce Manufacturing, Inc. and an associated budget amendment to cover up-front costs, contingent upon the city attorney's review of the agreement.

Up-front costs will equal approximately \$285,960 (20% of the purchase price). Covington Mayor Steve Horton said the amount would be transferred from the city's General Fund balance to the necessary fund accounts to meet the required payment. Covington Fire Chief Jeremy Holmes said the overall price tag was a bit lower than he originally anticipated

by more than \$100,000.

If the council waits to

issue a purchase order after Feb. 1, there would be an increase in

total cost of 3%.

Once the truck is delivered to the city, the total cost will be financed over 10 years through a Georgia Municipal Association (GMA) Master Lease program, equating to roughly \$157,000 per year of debt service, at that time \$285,960 will be used to replenish the General Fund balance, Covington City Manager Scott Andrews said. Councilman Don

Floyd was first to vocalize his support for the purchase by calling for the initial motion for approval. The former firefighter said ladders typically have 20-year lifespan,

Court for mentally ill crime suspects named 'model' program

COVINGTON, Ga. A Newton County court program designed for crime suspects

whose mental illness contributed to their alleged actions has been named one of eight "model

courts" in Georgia. The Georgia

Samuel Council **Ozburn** of Account-

ability Court Judges (CACJ) has recognized the Newton County Mental Health Court for the honor which carries with it a commitment to provide assistance to similar court programs in the state.

Model courts are programs reviewed and selected by the CACJ's Nominations Committee to provide assistance to other court programs across the state, according to the council's website.

A panel of accountability court judges from throughout Georgia evaluated the court and selected it for the award based on "its strong performance in this peer review process," said Robert Fox, coordinator for the program in Newton and Walton counties.

Superior Court Judge Layla Zon is the presiding judge for the Newton County program which works with individuals whose mental illnesses contributed to their criminal conduct, Fox said.

The Newton program was established in 2013 and serves an average of 16 participants, Fox said.

Superior Court Judge Samuel Ozburn established the Newton County program in 2013 and presided over it until his retirement earlier this year. Fox has served as coordinator since 2017.

Since the courts were established, the Newton County program has graduated 41 participants, according to Fox.

Ozburn said organizing and presiding over the court program "was one of the most rewarding experiences I had as a judge."

"It is rare for a court to not only save lives but save money as well, but that's what this court has been able to do," Ozburn said.

"Credit must be given to the court staff members who provided treatment, random drug testing, home visits, curfew checks and much care and kindness to the participants. I am confident that under the capable leadership of Judge Zon this will continue," he said.

Fox said Mental Health Courts help participants improve their independent functioning, reduce substance abuse, provide greater consistency in receiving mental health treatment, spend fewer days in jail, and reduce long-term government

The programs provide

a full range of support and supervision to the participants including individual therapy, evidence-based group treatment, psychiatric assessments, medication management, clinical case management, and more, the CACJ stated in a review of the program.

Participants are screened to determine eligibility. They regularly attend treatment, and the court regularly supervises their actions through random drug testing and in-home visits by sheriff's deputies, Fox said. However, he noted

state law prohibits participation by individuals who have committed such offenses as murder, armed robbery and sex-related crimes. CACJ Executive

Yet we have somehow reached the point that the Republican Secretary of State for Georgia, along with his family and elections staff, have received death threats.

From a political observer standpoint, it has been truly amazing to see how loyal some Trump supporters are.

t the beginning of each December, we celebrate the Immacu-Late Conception of the Virgin Mary. On this day we read in Luke the amazing response of a

Covington farmer named to national Christmas tree promotion board

COVINGTON, Ga. — The longtime owner of a Newton County Christmas tree farm will become the first Georgia grower to help guide a national promotional effort for

the product. Chuck Berry, owner of Berry's Tree Farm & Nursery west of Covington, has been appointed to serve a three-year term on the U.S. Christmas Tree

Promotion Board. U.S. Secretary of Agriculture Sonny Perdue appointed Berry and four other U.S. tree producers to the board, which oversees a

national research and promotion program for the trees.

The board's purpose is to promote, publicize and educate the public about the trees "while engaging in research to better serve our customers and growers," according to its web-

Berry said the program operates in a similar promotional fashion as the one that produced classic advertising series like "Got Milk?" for U.S. dairy

The lifelong farmer is the fifth generation of his family to operate a farm of some sort in 126 years on the site of Berry's Tree Farm. He and other mem-

bers of his family run the 206-acre operation on Mt. Tabor Road in the Almon community.

After operating as a dairy and row crop farm for 80 years, it

began converting its crops solely to Christmas trees in 1977 and sold its first trees in 1983, according to its website.

Berry said he has sold more than 2,000 trees this year, marking his best sales season in 20 years.

He attributed the increase to the pandemic prompting many area residents to seek to celebrate a more traditional kind of holiday.

"People are wanting to slow down," he said.

Berry said he was proud to be the first Georgian on the board because the state is not usually seen as a major producer of the trees compared to states like North Carolina.

He noted the Georgia Farm Bureau was among the individuals and organizations that sent letters of support for his appointment.

Berry joined Roger W. Beyer of Oregon, Michael Cocco of California, Jane M. Neubauer of Ohio, Renee' Beutell Campbell of North Carolina and Larry Downey of Quebec, Canada, as new appointees.

The 12-member

board includes 11 growers representing production in the eastern, central and western regions of the U.S., and one importer member. Each member can serve up to two consecutive three-year terms.

Then-U.S. Secretary of Agriculture Tom Vil sack appointed the first board in January 2015. The board is made up of Christmas tree producers representing production in the east, central and west regions of the U.S., along with an importer member.

the addition created space for 24 large dog runs, eight small dog cages, four puppy pens, and 45 cat cages.

It also allowed the animal services staff to provide better segregation of cats and dogs throughout the building; and create areas that allow potential adopters to have better access to the animals, Wiemann said.

She said the new construction will provide better ventilation for the building; make cleaning and maintenance faster and easier; create more quarantine space for sick animals; and allows the shelter to provide emergency space in situations when animals are discovered in illegal hoarding situations.

Covington veterinarian Dr. Kristian Shriver, who has assisted Animal Services since 1998, said the shelter is now overseeing the most adoptions of dogs

and cats in 20 years. He noted it also has been able to lower its animal euthanasia rate from around 90% to

around 30%.

"That's phenomenal," Shriver said.

Wiemann thanked her staff, and county commissioners and county voters for approving the SPLOST that funded the projet.

She said the shelter had been successful enough in finding

homes for kittens in recent weeks that it was able to offer space to other counties after they ran out of room for cats in their shelters.

The county department employs eight full-time workers.

Wiemann has led the department since February 2018 and is active in such organizations as the Georgia Animal Control Association and National Animal Care and Control Association.

saw the flames — or the smoke — from (the main road), and I honestly didn't think anything about it," Kenney recalled. "Once we turned the corner here to the driveway, I saw the kitchen and flames coming out the windows. I just went in panic mode. Didn't

really know what to think, what to do, how to react, because I've never been in a situation like this."

The 46-year-old said he was unsure when the fire started, but guessed it was between 2 and 2:30 p.m.

Kenney said he didn't know where his family would go or what would happen next, but he was thankful no one was around to get hurt.

"First and foremost, you got to thank God everybody is safe. That's the most important thing, no matter what else didn't make

it," he said. Kenney said his family's home was built in 1993 and the first of December marked its

27th anniversary. It took firefighters ap proximately one hour to extinguish the fire. The home was ruled a total loss. The incident remained under investigation, as of Friday.

Walden was arraigned on the charges in August 2019 in

Newton County Supe-

rior Court and has been held without bond in the Newton County jail for a year and a half.

She faces charges of malice murder, felony murder, aggravated assault and possession of a firearm during the commission of a felony.

so "it's not like we're buying a ladder truck every budget cycle." But one concern Floyd brought to light was about getting the truck on time.

Holmes said the truck would likely take up to 18 months to build and deliver to Covington. Floyd asked if there was a penalty clause for the manufacturer being late on the order. Holmes said there was not because their delivery dates had been as early as 12 months in the past.

"At least ask them to see if that's something that they would look at," Floyd said. "My experience with Pierce was very positive in that nature."

Holmes agreed with Floyd's stance and said the department would seek information about a penalty clause with the company.

Councilman Kenneth Morgan asked if the purchase would be a replacement or an addition to the fleet. Holmes said it would be a replacement, but he was not yet sure which truck it would replace. He said the department had recently been experiencing trouble with a few different trucks.

Ladder fire trucks are commonly used to reach high locations, but they can provide a high vantage point for spraying water and creating ventilation as well. They also double as an access/escape route for firefighters.

out immediately once approved by the U.S. Food and Drug Administration this month but will not be enough to cover all of Georgia's hospital workers and nursing-home staff and residents, the news bureau reported.

More rounds of the vaccine will arrive depending on how fast pharmaceutical companies Pfizer and Moderna produce it, as well as how the federal government's Operation Warp Speed distribution

program plans to divide up the doses, Toomey said at a news conference Tuesday.

Nolan said Newton County EMA has two full-time employees and one part-timer. It will typically use employees from other county departments temporarily to help it respond to natural disasters, he said.

He said he is in the early stages of filling the new position but wants it to continue to be funded in future EMA budgets.

Nolan also said he wants the new employee to be certified by the state's Peace Office Standards and Training Council (POST) to help provide security for the vaccines the Newton County agency will help distribute.

POST is the primary agency that provides law enforcement officers with certification that many agencies require in Georgia.

The public health depart-

ment reported a total of 4,206 Newton County COVID-19 cases had been reported by Tuesday, Dec. 8. Almost one in eight of those cases were reported in the last two weeks, according to the department.

It also reported 111 Newton County residents had died, with 357 hospitalized because of the disease.

Director Taylor Jones said the Newton program is part of the inaugural group of Mental Health Court programs to be named model courts, following other accountability


courts which received the same awards.

The agency rates individual court programs on such objective criteria as program age, length of time the judge and coordinator

have served, certification, and peer review results, according to the CACJ.

Once selected, the state agency notifies them of the award and requests that the model court assist other programs for three years. Model courts provide support ranging from simple calls and emails, to hosting visitors who want to observe their accountability court processes firsthand.

They also assist other judicial circuits with establishing new programs, Jones said.

Eagles' historic season comes to bitter end against Jones County

Eastside's season came to a close Friday night with a 28-7 loss to Jones County in the Class AAAAA State quarterfinals. Despite the deficit, the Eagles finished the year allowing just 12.3 points per game.

GRAY, Ga. — Eastside's quest for a state title came to an end in the Class AAAAA state quarterfinals on Friday night.

A fourth-quarter push from the No. 2 seed Eagles temporarily placed top-seeded Jones County on its heels. The Greyhounds found a way to defend their home turf, however, as they salted the game away late en route to a 28-7 victory.

Eastside finished its first season in Class AAAAA at 10-3. The team has now met the end of the road in the third round of the playoffs twice in the last three seasons.

Trailing 14-0 late in the third quarter, Eastside swung the momentum in its favor when senior defensive end Sambo Button made an acrobatic interception at the Greyhound 30-yard line. Six plays later, senior quarterback Jaylen Woods connected with junior tight end Cole Shannon for a 9-yard touchdown pass.

Jones County's advantage was slimmed down to 14-7 with 10:38 remaining in reg-

ulation.

Unfortunately for the Eagles, the Greyhounds had an answer — and quick.

On its ensuing drive, Jones County marched the length of the field before senior running back Andrew Carner rolled

into the end zone from two yards out. The score pushed the point differential back out to 14 at the 6:41 mark.

Desperate to stay in the game, the Eagles were forced to go for it on fourth down and 14 deep in their own

territory on the next drive. They failed to convert, giving Jones County the ball on the 33-yard line going in. Shortly thereafter, the Greyhounds put the game away on Carner's third and final rushing touchdown of the game.

Carner and company found a way to crack the code to the Eagle defense. Prior to giving up 28 points on Friday, Eastside had refused to allow an opponent to reach 10 points in six consecutive contests.

Just how dominant was head coach Troy Hoff's bunch on the defensive side of the ball this fall?

Eastside allowed 130 points through 13 games. That average of 12.31 points per game ranks fourth all-time in program history behind only the Eagle defenses in 2008 (11.15 PPG), 2009 (11.64 PPG) and 1997 (11.75).

Jones County put Eastside's defense to the test right away Friday night.

The Greyhounds started their opening drive on their own 33-yard line. After back-to-back incompletions

Newton's Green commits to Georgia

COVINGTON, Ga. — Nyland Green is going to be a Georgia Bulldog.

The Newton senior announced his commitment to play college football in Athens on Tuesday morning inside the Newton High School auditorium. Rated as a four-star cornerback by Rivals and 247Sports, the 6-foot-2, 183-pound Green was listed as the No. 2 corner in the nation and the No. 69 overall prospect in the Class of 2021.

Green was primarily recruited as a cornerback, but he proved to be a versatile phenomenon on the gridiron for the Rams. He left his fingerprints on games week after week, whether he was locking down receivers, making acrobatic interceptions, returning punts and kickoffs or hauling in touchdown passes.

During his senior season, Green reeled in 25 receptions as a wide receiver for 457 yards and four touchdowns. On the defensive side of the ball, he totaled 47 tackles,

five tackles for loss and five interceptions, one which was returned for a touchdown.

Green's top performance of the season came against county rival Alcovy on Sept. 11. On the Rams' second drive of the night, he showed off his wheels by catching an intermediate pass and taking off for a 72-yard touchdown. He put his athleticism on display once again at the start of the third quarter by returning the Tigers' kickoff 97 yards for a score.

"Every time he touches the ball, a simple play can be an

explosive [play,]" Newton head coach Camiel Grant Jr. said of Green that night. "You don't have to do something huge with him; just get it to him.'

Grant spoke Tuesday morning about Green closing his recruitment with the commitment.

"I'm just happy that he can finally get to the end of the process. I don't think a lot of people understand the pressure that's on these kids," Grant said. "At the end of the day, kids like him, they just want to play ball.

"Georgia is getting a good one in Nyland. He's an explosive player and a great kid, and he can help them out in a lot of different ways."

Green received offers from across the country, with Auburn, Clemson and Tennessee also listed among his finalists.

He's the 20th player to commit to Georgia for the Class of 2021.

Green is verbally committed to begin his collegiate career with the Bulldogs, but he's expected to make things official by signing his National Letter of Intent within the next few months. The early signing period for Division I football begins Dec. 16 and runs through Dec. 18. This small window will be followed by the regular signing period, which begins Feb. 3, 2021.



The game between No. 12 Georgia and Missouri that will take place Saturday at Faurot Field probably won't look a whole lot like the one the Bulldogs and Tigers would have played if they

met a few weeks ago.

Georgia was still trying to settle on a quarterback, listing four possibilities at the position, before the matchup set for Nov. 14 was postponed because of COVID-19 issues within the Tigers program. Missouri was still trying to get on track after a lopsided loss at Florida left coach Eli Drinkwitz's team 2-3 in his first season.

Nearly a month later, J.T. Daniels is entrenched under center for the Bulldogs, while the Tigers have ripped off three straight wins, capped by a dramatic comeback victory over Arkansas last weekend.

"Any time you have a new quarterback who's got game experience under him, there's going to be a challenge to figuring out how to stop him," Drinkwitz said. "One of the benefits of film is that you get to see other people try things and figure out, 'OK, that gives him problems. That doesn't give him problems. This fits into our scheme.' And there's just not a lot of tape on J.T. We know he's a tremendous talent at quarterback, so we'll have to hunt and peck and make adjustments.

Daniels put together some solid performances at Southern California before tearing his ACL and transferring to Georgia (6-2, all SEC), where he continued to rehab early this season. And when he was cleared to play against Mississippi State, he promptly threw for 401 yards and three touchdowns.

He won't be the only hot-handed quarterback on the field Saturday, though.

One of the biggest reasons Missouri (5-3) has been on a tear is Connor Bazelak, the redshirt freshman who has been playing beyond his years. He threw for 380 yards against the Razorbacks

and calmly led the Tigers downfield in the closing seconds to set up Harrison Mevis' winning field goal as time expired.

"I'm extremely impressed with the guy's composure, poise, and he's going to be there for a while," Georgia coach Kirby Smart said. "He knows coverages — as soon as he sees a coverage, he knows where to go with the ball. He throws a really good deep ball. When you play contested, pressed man all over the field, he makes the throws and they make 50-50 catches. When you play zone and you spot-drop all over, he knows where to go with the ball and he completes it."

Smart was equally impressed by Drinkwitz, the front-runner for SEC coach of the year.

"If you're not in the perfect call then they can get you here or they can get you there," he said. "He's going to be great for our league because when you look at what he does, there are going to be people copycatting what he does to add that to their offense because his history at App State was that, his story at NC State was that. He was really good at creating offense."

SPEAKING OF OFFENSE The Bulldogs also have had some time to adjust to new offensive coordinator Jeff Monken, and it has shown in the way their offense has hammered Mississippi State and South Caroli-

na the past couple of weeks. "He's really added some explosiveness to it," Drinkwitz said.

AWARD SEASON

Georgia punter Jake Camarda was announced as a finalist for the Ray Guy Award, kicker Jack Podlesny for the Lou Groza Award and linebacker Azeez Ojulari for the Bednarik Award. They

joined linebackers Monty Rice and Nakobe Dean, who had already been announced as semifinalists for the Butkus Award.

The Tigers' Nick Bolton is also a Bednarik semifinalist, and Mevis is on the short list for the Groza.

CHILLY RECEPTION

The forecast for Saturday calls for temperatures in the 30s and a mixture of rain and sleet.

"Playing in cold weather doesn't bother me at all. I feel like it's a mindset," said Dean, the Georgia linebacker. "My senior year of high school, we went to the playoffs, so we played in cold weather. Three of my last four games, we played in 36-degree weather with rain."

INJURY NEWS

Bulldogs center Trey Hill is out with a meniscus injury, leaving Warren Ericson and

Sedrick Van Pran competing for the starting job. Safety Richard LeCounte (concussion and ribs) is unlikely to play despite getting some reps in practice this week, though running back Kendall Milton (knee) and nose tackle Jordan Davis (elbow) should be available.

Atlanta travels to Chargers; all eyes on future

geles (3-9) assured of a losing season for the second straight year.

While Falcons owner Arthur Blank is preparing to evaluate general manager and coaching candidates, Chargers owner Dean Spanos would like to wait until the end of the season before making any final decisions. However, a repeat of last week's 45-0 loss to New England, the largest in franchise history, could move up that timeline.

This may also be a game when no lead is safe because both have a mystifying case of "can you top this?" when it comes to blowing games. Atlanta squandered leads of 16 points or more two straight weeks, including a 20-point advantage against Dallas on Sept. 20. Los Angeles went one step further, becoming the first team in NFL history to squander leads of 16 points or more in four straight games. The Chargers' nadir came on Nov. 1 when they were up by 21 in the third quarter only to see Denver rally for a win on the final play of the game.

"We talk about life situations all the time. We're in a valley right now, but we're down but we're not out. So, we're gonna finish the season out the right way," Lynn said. "You can only talk so much. You got to go out and execute."

VETERAN VERSUS ROOKIE

Chargers rookie Justin Herbert is fourth in the league in passing yards per game (278.5) while Atlanta's Matt Ryan is eighth at 270.6. Both can accomplish significant milestones Sunday.

Ryan, who has 54,622 career yards, needs 207 to surpass Peyton Manning for most by a player in his first 13 seasons. Herbert needs two touchdown passes to become the fourth rookie with at least 25.

Ryan said he had a chance to meet Herbert before the start of the season and has been impressed.

"We've seen them a couple of times on film playing like opponents

and he's played extremely well, not only for a rookie but for anybody," said Ryan of Herbert. "He's gone out there, been really competitive, very accurate, and battled. I think he's only going to get better. I think he's going to do a great job moving forward."

RUNNING WOES

The Falcons must improve their running game, a big reason for the team's red-zone woes.

Atlanta rushed for only 70 yards in last week's loss to the Saints. Todd Gurley was thrown for a 7-yard loss on a crucial third-down run from the Saints 12 with less than two minutes remaining, ruining a chance for the Falcons to pull off an upset.

Gurley has rushed for nine touchdowns this season and is still counted on for the tough yards in the red zone. But Gurley has been held under 3 yards per carry in five of the past six games, and a balky knee limited his availability against the Saints.

The Falcons have touchdowns in only 50% of their red-zone possessions this season, ranking 29th out of 32 teams.

Red and green have become the traditional colors of Christmas, just as blue and white symbolizes Chanukah. But how did this color palette come to evolve?

The custom of using red and green continued into the 14th century. Dr. Spike Bucklow, a research scientist at the University of Cambridge, says red and green also were used to paint medieval rood screens, which were partitions installed in churches to separate the congregation from the priest and altar. Dr. Bucklow notes that Victorians also extended the association of these colors as a physical boundary to another boundary: the marking of the end of the old year and the beginning of a new one at Christmastime. While red and green

had associations with Christmas in early times through holly and other sources, the connection was perhaps best solidified thanks to a man named Haddon Sundblom. Sundblom was an artist commissioned in 1931 by the Coca-Cola company to create an im-

age of Santa Claus for

the company's upcoming holiday ads. Until this point, versions of Santa were rarely consistent, with his clothing vacillating between green, blue and red. He also wasn't the plump, jolly fellow associated with Christmas as we know him today, but rather thin and elf-like Sundblom portrayed him as a chubby man wearing red robes, likely as a nod to Coca-Cola's own red logo, even though the company denies the connection. Santa was featured in front of a green background. The ads proved popular and Sundblom's Santa became the preferred depiction. Santa's red robes perfectly complemented the green background and other green components of
