The Newton County Board of Commissioners (Owner) is seeking qualified companies (Proposers) to respond to requests for the collection, disposal, processing and conversion services of the municipal solid waste (MSW) generated in the unincorporated areas of Newton and any other MSW received at its Lower River Road MSW Landfill. Processing and conversion technologies are to be from companies utilizing established and proven methods.

All proposals must be sealed and clearly marked for the work to be done as described below and submitted to the attention of Mary Ann Patterson, Purchasing Coordinator. No proposal may be withdrawn after the closing time for the receipt of proposals for a period of sixty (60) calendar days.

The Work to be done consists of the following:

Collection and Disposal

- Furnishing all materials and equipment and performing all labor necessary for coordination, staffing, operating and hauling waste and recyclables from the eleven (11) existing Newton County Convenience/Recycling Centers to the Newton County Lower River Road Municipal Solid Waste Landfill.
- 2. Furnishing all materials and equipment and performing all labor necessary for the operation of a mandatory/volunteer curbside collection program for the approximately 28,000 households in the unincorporated areas of Newton County and disposed at the Newton County Lower River Road MSW Landfill.
- 3. Furnishing all materials and equipment and performing all labor necessary for a creative, economical use of any other collection methods. This item is not required to be addressed unless the Proposer desires to offer collection method(s) other than those specified in this section.
- 4. Furnishing all materials and equipment and performing all labor necessary for operation and management of the Newton County Lower River Road MSW Landfill.

Processing and/or Conversion Technology

1. Furnishing all materials and equipment and performing all labor necessary for mining and reclamation of the pre-subtitle D areas as part of the Georgia Environmental Protection Division (EPD) approved groundwater corrective action plan and anticipated methane

- collection systems, using a creative waste processing and/or conversion technology options in conjunction with current operations at the Newton County Lower River Road MSW Landfill.
- 2. Furnishing all materials and equipment and performing all labor necessary for a creative disposal and waste processing and/or conversion technology options at a stand-alone location in Newton County other than the Newton County Lower River Road MSW Landfill.

All anticipated federal, state or local permits for these areas of work have not been obtained since the final selection and award by the Owner for the various options will determine the necessary permits.
