Foster wins Superior Court race

Voters elect school board member for Newton County

By TOM SPIGOLON

COVINGTON, Ga. - Acomparatively high number of voters for a Newton County runoff election chose a new Superior Court judge and county school board member Tuesday,

A total of 8,948 Newton County voters -11% of those registered — turned out for the runoff election.

Runoffs for local races typically draw fewer voters, as in 2016 when 8% voted.

More than half voted by mail-in absentee ballots, which continued a trend begun in the June 9 election in response to the COVID-19 pandemic.

The county Board of Elections is scheduled to certify the results Monday.

STANSFIELD STRONG IN NEWTON

In Tuesday's election, Jeffrey L. Foster of Walton County defeated Covington attorney Robert H. Stansfield by 787 votes out of more than 16,000 cast in unofficial totals in the two-county Superior Court judge race.

Foster received 8,637 votes and Stansfield 7,850 votes in the election for one of five Superior Court judge positions in the Alcovy Judicial Circuit, which includes Newton and Walton counties.

Stansfield won the Newton County side of the vote with almost 65%, and won in all 22

However, he could not overcome the combination of Foster's Walton County majority, which was 73%, and his 35%

Family members reported the two missing Tuesday night after both went under the water around 7 p.m., said Sheriff Ezell Brown.

"(Responding deputies) were told the teenage son had gone out swimming and the teenage son appeared to have gotten in a ... challenging mode with the waters," Brown said.

COVINGTON, Ga. — Newton County's school superintendent became the final decision-maker Friday, Aug. 7, on when and how students will be taught this year.

In a special called meeting, Superintendent Samantha Fuhrey said all students will be taught virtually and the school year will begin Sept. 8 after a majority of county

of the Newton vote. The Monroe attorney, who also serves as Social Circle Municipal Court judge, will replace retiring Superior Court Judge Eugene Benton on the Alcovy Judicial Circuit bench in January.

Foster said he was grateful for the opportunity and appreciative of the voters' confidence.

"I am humbled by the outpouring of support and the trust placed in me by the residents of the Alcovy Judicial Circuit," Foster said. "I love this place and will strive to leave it better than I found it, and will honor my promise."

His election also keeps the Benton judgeship in the hands of a Walton County resident, which has been the case since the judicial circuit's creation, Foster said. Traditionally, three judges have been Newton County residents and two Walton residents because Newton is the larger of the two counties.

BAILEY **ELECTED TO** SCHOOL BOARD Longtime Covington

city worker Anderson Bailey won the de facto election for Newton County School Board's District 4 seat Tuesday, Aug. 11, and will take a position left vacant since late 2019.

Bailey received 725 votes, or 59%, to defeat Jeffrey Johnson, who received 505 votes or 41%, to win the Democratic nomination for the seat, according to unofficial totals from the Newton County Elections and Registration office.

Johnson, however, won more precincts

than Bailey on Tuesday. He won handily in the Beaverdam precinct at **Gateway Community** Church, and eked out narrow majorities in the Cedar Shoals, Oxford and Crowell precincts.

Bailey won handily in the City Pond and Town (Washington Street Community Center) precincts and earned a slight majority at the Covington Mills location.

He will be unopposed in November after no Republicans qualified for the school board seat. District 4 covers north central Covington and much of the city of Oxford.

Bailey attributed his election to name recognition gained from decades as a youth basketball coach, GHSA basketball referee, active church member, Covington city employee and native Newton Countian.

He praised volunteers — including some friends dating to childhood — who joined with such prominent supporters as County Commissioner J.C. Henderson to back his candidacy.

Bailey, 59, has been employed by the city for 14 years as a meter reader. He is retired from 23 years in the Army and National Guard. He also has been a GHSA basketball referee for more than a quarter of a century.

Some school board members have indicated they wanted to try to appoint Bailey as a board member immediately rather than waiting until the official start of his term Jan. 1. The five-member board has been split evenly

between Democratic and Republican members since November 2019 when the District 4 seat became vacant following the death of Almond Turner.

ACTIVIST EARNS NOMINATION

Meanwhile, Democratic voters in northeastern and south central Newton County chose political activist Dorothy Piedrahita to be the party's nominee for the Newton County **Board of Commission**ers District 5 seat in November.

Piedrahita received 62% of the vote and Casey Duren 38% to earn the Democratic nomination. She will face incumbent Republican Ronnie Cowan in the Nov. 3 general election.

The nominee received 609 votes to Duren's 368, according to unofficial totals. She won or tied in all eight precincts in the district.

District 5 stretches from Social Circle in the north to Heard-Mixon Elementary School in the south.

MAJORITY VOTE BY ABSENTEE BALLOT

About 1,600 Newton County voters cast ballots early and in-person during the three-week advance voting period.

However, a total of 4,805 voted by absentee ballot — following a trend begun in the June 9 election.

In that election, a record total of 13,000 absentee ballots were sent to the Newton County election office after the Georgia Secretary of State's office mailed applications in response to the COVID-19 pandemic in the spring. It was more than four

times the average and led to election staff members being delayed for a day in completing the final count because of the more time-consuming way state law requires absentee ballots to be counted, officials said.

The problem was seen throughout Georgia and the State Election Board on Monday, Aug. 10, voted for some measures to help ease the vote-tally bottleneck amid the pandemic and the upcoming Nov. 3 general election that will include the presidential race.

The pandemic drove voters to cast ballots by mail in historic volumes in April and May and spurred hours-long lines at polling places

during the June 9 primary elections, according to the Capitol Beat

News Service. Angela Mantle, director of the Newton County Board of Elections, said she and her staff "believe the new (state Election Board) rule will assist with the processing of voted absentee by mail ballots."

The news service reported that, instead of two weeks before an election, local ballot-counting officials in Georgia would be able to start tallying mail-in votes three weeks prior, according to an emergency rule change the state board approved Aug. 10.

Road in Covington, was killed after a 2005 Ford truck struck his bicycle Aug. 6 at about 11 p.m. as both traveled north on Washington Street near Flat Shoals Road.

A Georgia State Patrol report stated the victim was riding on the right side of the

northbound lane of Washington Street approaching Flat Shoals when the front of the truck struck the bicycle's rear.

The driver of the truck, Timothy Grant Millwood, 49, of Eatonton, told investigators "there was an oncoming car with

headlights temporarily obscuring his view, and he did not see the bicyclist until it was too late and struck him with the front right side of his vehicle," the report stated.

The bicyclist was wearing all black clothing but a small red reflector was located in

the grass near the bike's final rest position, according to the report.

The impact caused the victim to be carried on the hood of the truck for about "three car lengths" before falling from the hood and on to the roadway before ending up on the right shoulder at a private

drive.

Johnson was taken for treatment at an area hospital but was later pronounced dead.

The truck stopped in an adjacent parking lot after the incident, the report stated.

factors, it stated. The Georgia State Patrol Specialized Collision Reconstruction Team assisted in the investigation.

community partners. Originally, Pastor Eric Suddith believed volunteers at Newton High School would be able to give away approximately 20,000 pounds of food to families impacted by COVID-19.

Shortly before the giveaway began, that number more than doubled.

"We were able to give away 50,000 pounds," he told The Covington News.

The Newton County Sheriff's Office assisted Suddith's church and other volunteers. The sheriff believed the giveaway may have been one of the largest in the county's history.

"We met the needs of a lot of people," Suddith said. "Some people stood in line

for three hours ... We closed down in four hours and 45 minutes, and afterward, we still had people calling to see if we had anymore food."

The food was purchased from the Atlanta Community Food Bank and transported

with the help of the Sherwin

Williams Corporation. Families received a box of food that includes canned fruits and vegetables, beans, rice, cereal, pasta, peanut butter and meats.

I'm worried about change

t appears that there is yet another .problem resulting from the coronavirus pandemic: a shortage of coins.

"What's happened

is that, with the partial closure of the economy, the flow of

coins through the economy has gotten all — it's kind of stopped,"

Federal Reserve Chairman Jerome Powell, speaking at the "Monetary Policy and the State of the Economy" virtual hearing for the House Committee of Financial Services.

Chairman Powell may be correct as to the cause of the coin shortage. Or, there may be something more afoot. So sez me.

I am a fan of coins as legal tender and I try to do my part to keep that form of currency... current.

I am the smallest of small businesses, so when I am on the road I am strategic about spending. The self-employed driver no longer has to keep gas receipts; that particular Schedule C business expense is calculated by mileage, not how much is spent at the pump. (My mileage is miraculously logged and mapped by an app in my Swiss Army phone.) Since some filling stations give a discount for cash money, that's my method of payment for what goes in my tank. Therefore, from my fill-ups, I have real coinage in the little cubby to the left of my steering wheel.

That change in the cubby is my rest-stop reward.

As you might imagine, after many repeated drives on the interstates of this great land of ours, I have a set pattern of places to gas up, eat, and (euphemistically and literally) rest. Therefore, I know the rest areas with recycling bins. I know the rest areas with functioning water fountains. I know the rest areas with shade. (I'm the guy asleep in his car, the one you don't want to park next to.) I know the rest areas with covered concrete picnic tables on which one can recline for a cool nap. (Again, that guy.)

Sometimes, if I have succeeded in a particularly beneficial nap, I will reward myself with some peanut M&Ms from the vending machine.

When I grab my fist full of change from the cubby in prepara-

tion for my visit to the vending area, I always give the coins a quick check. It's a childhood-born habit to be on the lookout for Mercury dimes, Buffalo nickels, wheat pennies, and the like.

The Mercury Dime

This isn't Mercury, really, rather Lady Liberty in a winged Phrygian cap. It's the wings on Liberty's head that cause the cross-dressing confusion. Regarding those wings, Mercury does have an advantage over Liberty, for he has wings on his feet as well as his head, putting him in much less danger of severe neck strain as he flies. But it is important to remember, the dime is indeed Lady Liberty, not Mercury. Mercury would be a poor choice to adorn a coin. Sure, he's the Roman god of financial success, but he's also the god of trickery and thieves.

In 1945, the then

recently deceased President Franklin Delano Roosevelt had been a fitting replacement for the dime, but I must say FDR's profile thereupon leaves a lot to be desired. Truly, if you hadn't been told that the generic white fellow on the dime was FDR, you wouldn't know it. If I were in charge of the Federal Mint, President Roosevelt would be depicted wearing his pincenez spectacles and his "lucky fedora" with the upturned brim, and he would be smiling with his cigarette holder between his teeth at that famous 2-o'clock angle. Of course on the reverse side of the coin, we would have to replace "e pluribus unum" with the Surgeon General's smoking warning.

Buffalo Nickels

In sorting my M&M change I rarely encounter Buffalo nickels, and for my task at hand, that's a good thing. When the nickel's design was introduced in 1912, there was opposition from vending machine manufacturers, specifically from the Clarence W. Hobbs Company, because Mr.

Hobbs held that his machines had a way to detect slugs, rendering the machine inoperable, and this new nickel was particularly... sluggy.

Of course, this nickel was also known for its obverse side: The Indian Head Nickel. Today, thinking and caring people squirm at that exonym. And indeed, it demonstrates a benighted ethnocentricity to have an indigenous man's head on the coin without regard to his tribe or nation or even who this fellow is. The nickel's sculptor James Earle Fraser named several men that he had used for models, including Two Moons, the Cheyenne Chief of Little Bighorn fame. Two Moons' career culminated on a Staten Island bluff overlooking New York Harbor when he and 32 other chiefs were tasked with giving out newly minted Buffalo Nickels at the groundbreaking of The National American Indian Memorial. Part of the festivities included the chiefs signing a "declaration of allegiance" to the United States. Some say that after

William Howard Taft - whom the press had dubbed, "The Great White Father" – turned the earth with his silver-tipped shovel, Two Moons could be heard quietly addressing each dignitary as he wove his way through the crowd, prophesying as he pressed the nickels into the palms of the honored guests, "This monument ain't gonna happen."

Mr. Fraser reported that his model for the reverse side was a buffalo named Black Diamond. Mr. Fraser went on to say that Black Diamond was an uncooperative model. "the contrariest animal in the Bronx Zoo." Black Diamond looked straight at Mr. Fraser, refusing to show him a profile view, even when Mr. Fraser said, "Mr. Diamond, quarter turn, PLEASE!" (Being on the nickel, Black Diamond refused to give him more

than 5%.)

For his efforts Black Diamond was slaughtered in 1915. His head was mounted and taken on a tour of coin shows, a deceased celebrity appearance,

as it were. One can only imagine the difficulty engraver Donna Weaver encountered when she was trying to wrangle two American bison for the 2006 North Dakota Commemorative Quarter. Needless to say, with such uncooperative beasts, the project went beyond its allotted budget and past deadline. Therefore, in 2007 common sense and austerity ruled the day which is why the Montana commemorative quarter only displays a bison skull.

Yes, in these uncertain times I know frugal people who collect change to add to their coffers.

But my coins are for travel snackage. And now with the pandemic, it is my civic duty to keep the coins in circulation.

But with all due respect to Federal Reserve Chairman Powell... (uh-oh, nobody ever gets a compliment with an opening of "with all due respect")... I have evidence that the pandemic just might not be the entire problem.

On March 15, I was driving home from Silver Spring, Maryland, to do my quarantine-part. I stopped at the welcome center of South Carolina. I made my way to the encaged candy machine. (This keeps the machines from wandering onto the freeway.) I was happily bopping along with my fist full of change. Then, I spied it. An evil message. Beside the plugged slot it read, "NO COINS OR CASH. CREDIT OR DEBIT CARDS ONLY."

This is not a good sign for change.

Chairman: Using staff attorney could reduce county's legal costs

Newton County's chairman says the government should consider hiring a staff attorney rather than using an outside law firm so it can reduce legal costs that are much higher than many comparable metro Atlanta counties. In his weekly "Chairman's Corner"

column, Chairman Marcello Banes of the Newton County Board of Commissioners said that creation of a county legal department with one salaried attorney and one support staff person "is an example of how we can drastically reduce our legal fees and legal expenses."

He said his research showed Newton County government pays more for legal services than its neighboring counties and some larger counties in metro Atlanta. "Based upon these findings, I believe

that Newton County should quickly transition to an in-house attorney," he said. "After the incorporation of our new Strategic Plan, I am confident that our County Manager Lloyd Kerr, with the assistance of an in-house counsel, has the proper staffing to address Department and Human Resource legal issues that may arise on a daily (basis).

"The creation of a county Legal Department with one salaried attorney and one support staff is an example of how we can drastically reduce our legal fees and legal expenses.

"As an alternative, if a contract attorney is chosen, the legal fees and legal expenses should be capped between \$350,000 and \$450,000, in line with the spending of multiple other comparable (jurisdictions)."

Banes said Newton County paid a total of \$944,562 to two different law firms representing the county government and sheriff's office in the 2020 fiscal year. That amount has fluctuated annually but has averaged about \$910,000 annually since 2010, according to figures Banes reported. By comparison, some larger counties

Henry County at \$589,000, Hall County at \$765,310, and Paulding County at Counties comparable in size to Newton also spent less, including Fayette

(which uses a staff attorney), \$150,167;

Lowndes, \$409,391; and Bartow,

spent much less in 2020, including

Some neighboring counties' comparable costs include Walton, \$217,152; and Rockdale, \$640,165, according to

spending numbers provided by Banes. "The above data was compiled from open records requests presented to the respective counties asking for legal fees and legal expenses paid by the county for legal services rendered to the county and sheriff's office for the last two fiscal years. While the start and end time of the fiscal year may differ among the counties, the period of time covered is 12 months, with the exception of Coweta County, which had only nine months available for FY2020."

The county government has used the Forsyth County-based firm of Jarrard and Davis since before he took office, Banes said.

The county contracted with the firm after effectively firing its former, longtime attorney, Tommy Craig, in 2015 amid questions about management of

funds for the Bear Creek Reservoir project which was later abandoned.

The county commission eventually hired Jarrard and Davis. The sheriff's office, however, still uses Craig for its "I greatly appreciate the hard work

that (Jarrard and Davis) has done during a difficult transition period. However, it is clear that the time has come to address our legal costs in a more aggressive manner," Banes said. He said legal fees are among the

Newton County government's highest expenses and "the issue of our legal fees and legal expenses has always caught my attention" since taking office in 2016.

"Throughout the last year I have discussed legal fees with many officials from our neighboring counties and our commissioners. In addition, I have researched the handling of legal needs. legal fees and legal expenses in several counties with similar populations and characteristics of Newton County. My research has shown a drastic difference between our legal fees and those of our

neighbors," he said. "It is important to note that these counties have liability insurance that provide legal defense for civil damage claims filed against the county or sheriff's office. There is a \$10,000 deductible that is paid by the county per claim. The fees associated with the deductible are not included in these figures," Banes wrote.

Many counties he researched either used a single local law firm or an inhouse attorney. he said.

Newton County, Covington approve property tax rollbacks By TOM SPIGOLON

COVINGTON, Ga. –

The Newton County Board of Commissioners approved a property tax rate Tuesday, Aug. 4, that was almost 4% lower than the previous year. The rate was 12.916 mills which is almost 4% below

the 2020 rate of 13.43 mills. It also represented a full rollback of the property tax

rate as defined by the state government, county officials said. The state defines the full

rollback rate as the one that will produce the same amount of revenue from

property taxes as the previ-

ous year if no reassessments had been done. However, County Man-

ager Lloyd Kerr has said some residents could see higher property tax bills if their home values increased by more than the 7.27% increase in the tax digest which is the total value of all taxable property within Newton County. The property tax rate will

help fund the county government's 2021 budget that was 5.8% larger than the 2020 budget. County commissioners voted July 21 to approve a \$104.6 million budget for

2021. The Covington City Council also recently adopted a resolution to roll back the 2020 millage rate to 7.186. According to documents

provided by the city, the millage rate for 2019 was 7.413, meaning the rollback rate of 7.186 is a decrease of 0.227, which results in a decrease of \$140,018 in tax collections (-2.6%). In other action Aug. 4, the **Board of Commissioners**

approved the sale of almost 7 acres of land, previously purchased for a reservoir, back to its former owners. The county purchased the

land and surrounding tracts southeast of Covington in

the early 2000s for construc-

tion of the Bear Creek Reservoir — which the county abandoned amid problems with gaining required permits among other issues. Jack and Miriam G.

Wheeler bought the land, including 6.7 acres and easement land totaling almost 9 acres, for \$119,000. Commissioners also

approved the sheriff's office's request to accept an \$842,000 federal COPS grant that will allow it to pay salaries and benefits for seven deputies over three years. The board had to match 25% of the amount — bringing the total amount to more than \$1.1 million.

Playing on its own diamond for the first time in 2020, the Newton High School softball team made itself at home Tuesday evening by plowing through visiting Upson-Lee, 8-1, to move to 3-0.

Junior right-hander Hayden Pearson pitched a gem in the circle for Newton.

After giving up a run

in the opening frame, Pearson settled in and began to mow down Upson-Lee's lineup. She went the distance and finished her outing having allowed one earned run on three hits while collecting seven strikeouts en route to the complete-game victory.

"Honestly, I don't ever worry about Hayden," head coach Virginia Tucker-Smith said with a grin. "I know it always seems to take her a few pitches to get her going, but I don't ever worry about Hayden. Eventually all her pitches are going to be where they're supposed to be, and they're going to move the way they're supposed to move.'

Pearson received ample support from her teammates at the plate as well. The Lady Rams totaled 11 hits and pushed across eight runs — four of which came in the sixth inning

COVINGTON, Ga. Former Peachtree Academy basketball standout Jared Gaines recently furthered his academic and athletic career by signing a National Letter of Intent to play basketball at Young Harris College.

Gaines' signing took place during a ceremony held in the Peachtree Academy gym with his family and close friends, as well as current and past coaches. He's the program's third basketball player in the last two years to sign a college letter of intent. Gaines joins Walker Payton and Chaz Gothard, who signed to play baseball at Berry College and Dort College, respectively.

Peachtree Academy stated in a press release that it is, "extremely proud of Jared, as fine

a young man that has ever walked the halls of Peachtree Academy. Jared is a fine student-athlete that adds to his impressive court skills."

A combo guard,

Gaines shot 40% from the field, including 30% from 3-point range during his senior year. He averaged 13 points per game and twice had games of 25 points or more. He collected 72

assists and 53 steals on the year, showing the willingness to defend the basket and proving his value as an allaround team player.

Gaines earned All-Region and AllState honors while at Peachtree Academy.

"He and his family will be missed greatly and we do look forward to watching Jared's success at the college level," athletic director

Ken VanNess said. "He is a young man that will be missed greatly in the hallways and classrooms of our school. We are proud of this young man."

to give their ace some breathing room to work with.

Despite the offensive potency she observed from her club in the late innings of the game, Tucker-Smith is concerned about how long it's taken for the bats to wake up in each of their three contests this season.

"It seems like we are always slow getting started on offense," she said. "Even in the games we played on Saturday it took us two or three innings. I know we've got to get timing down, but

sometimes you may not have two or three innings to get the offense rolling... We just need to be in there aggressive and ready for the first pitch."

Newton took an aggressive approach at the plate in the second inning when it ambushed Upson-Lee's Zaria Childs for back-to-back singles to open the frame. The hits would later pay off in the form of an RBI groundout to knot the game up at one run apiece.

With two outs recorded

in the third inning, senior Ty'Liyah Hardeman smacked an RBI double over second base to give the Lady Rams the lead. A pair of RBI singles from Auburn commit Kyla Stroud and Aulora Edwards pushed their advantage out to 4-1.

The Lady Rams used more two-out cooking to give themselves cushion in the sixth inning. Childs collected two quick outs for the Lady Knights, but Newton answered with four straight hits — a pair of singles from

Aaliyah Wilcox and Smith, followed by run-scoring doubles from Pearson and Hardeman.

Newton then opened Region 4-AAAAAA play in triumphant fashion Thursday night by rolling to a 9-5 victory over visiting Brookwood to improve to 4-0 on the year. Deadlocked at five runs apiece, the Lady Rams lit up the scoreboard for four runs in the sixth inning before closing the door in the seventh to secure the victory.

The win over Brookwood

marked the first time the Lady Rams have reeled off four straight wins to start a season. Its win over Upson-Lee marked the second straight season to start 3-0 after failing to do so in any other campaign over the last

Next up for the club will be a trip to region foe Grayson on Tuesday, Aug. 18. The Grayson Lady Rams posted a 30-8 record last fall before finishing as the Class AAAAAA state runner-up.

Newton superintendent urges community to follow guidelines, says virtual only temporary

Tuesday night, a crowd of protesters gathered outside to petition for in-person instruction. Friday, Aug. 7,

the board revised its reopening plan to remove the in-person instruction option and push the start date for students to Sept. 8 with only virtual instruction options.

During the meeting, Superintendent Samantha Fuhrey spoke of the change and reminded the community it is temporary.

"[In-person instruction] is the goal. It's never not been the goal," she said. "It's the best way to educate children. And so, that's what I'm doing. Lifting rocks. Moving mountains. Talking to folks. Waiting for our teachers to get back — our veteran teachers — to return to the buildings. I've heard from some of our teachers who are interested in working directly with students, and I want to try to help them make that happen. But I always have to put the health and

safety first.

"We're going to get there. We're going to open our schools. I don't have any doubt in my mind about that," Fuhrey continued. "But if we want for in-person instruction to take place ... we must bring the case numbers and the positivity rates, ER visits — all of those pieces — down."

The superintendent challenged the community to practice social distancing, wash hands and wear masks, saying it would be the only way to make in-person instruction happen sooner rather than later. But Fuhrey said she and other administrators have driven around the county and do not see many people adhering to health and safety guidelines.

As of Friday, Aug. 14, there were 384 confirmed cases of COVID-19 in Newton County within the last two weeks. Since the pandemic began, there have been 1,914 cases confirmed, 46 deaths confirmed and 199 hospitalizations confirmed across the county.

The state's cumulative COVID-19 case total was 228,668 on Aug. 12. There have been 4,538 deaths and

21,581 hospitalizations. If Newton County's positivity rate shows greater decline over the next few weeks, Fuhrey alluded that in-person instruction options would be put back on the table.

"As I said when we had the [instruction] options, that if the conditions warrant a pivot to another action, then I would take that action," Fuhrey said. "Same thing in this situation. If the conditions warrant a pivot, we will pivot and do what we need to do. And I just want to assure people in the community that this is, for me, temporary as we work to drive down the numbers of positive cases in our communi-

Before Fuhrey's

comments, board member Trey Bailey asked administrators how students with Individualized Education Programs (IEP) or special needs would continue being supported. He wanted to make sure they weren't going to be "left behind."

Chief Academic
Officer Benjamin
Roundtree said if administrators deemed a change to IEP services
was needed, the change would be made; however, changes haven't been needed.

He said that was why parents of students with an IEP were not being contacted, because no significant changes to the service have been made. The only change is where the services will take place, Roundtree said.

If parents feel changes are needed for their students' IEP or have any other concerns, Roundtree encouraged them to email Special Education Director Brooke Ramsey at ramsey.brooke@newton. k12.ga.us.

In other business, the board reviewed agenda items for the next regularly scheduled meeting on Tuesday, Aug. 18, and approved a handful of business items.

Approved business items included:

 The purchase of 5.818 acres of property for \$70,177, as recommended by the superintendent. According to documents provided, the property is "required for the replacement high school facility" for Eastside. The property includes the tract of parcel of land lying and being in Newton County and being a part of that property deeded to East Newton Baptist Church, Inc.

• The purchase of Zoom video, web conferencing software needed for the school system from CDW-G of Vernon Hills, Illinois, in the amount of \$35,572 to be paid for from the FY 2021 Gen-

eral Fund. The software architecture can be used to replace the school system's legacy hardware conference rooms at about 1/9th of the price, administrators said, while requiring no ongoing maintenance costs as do hardware defined conferences rooms. Administrators said the software requires less dedicated bandwidth than other video/web conferencing solutions.

• The purchase of Chromebooks needed for select schools from Dell Marketing L.P. of Round Rock, Texas, in the amount of \$360,525. Administrators said the purchase brings the system closer to the 1:1 Chromebook to student ratio.

• The purchase of hand sanitizer and dispensers needed for the school system from Buckeye Cleaning Centers of Norcross for approximately \$70,000. The purchase was made to ensure the school system has plenty of hand sanitizer on hand and avoid a potential shortage when students return to school.

• The superintendent's personnel recommendations previously discussed in an executive session.

to begin the school year on Aug. 24 with all-virtual learning.

They later tied 2-2 on a vote to approve Fuhrey's recommendation to begin the school year Sept. 8 with a mix of in-person and virtual learning options — but following a board meeting Aug. 31 that potentially could have changed the learning method based on latest COVID-19 numbers.

Chairwoman Shakila Henderson-Baker said the tie votes meant Fuhrey would make the final decisions on the learning method and start date.

"With a tie, you have a right to say what it is that you want to do without a vote needed," Henderson-Baker told Fuhrey.

Henderson-Baker said if the board ties on a vote concerning school operations the final decision is given to the superintendent in her role as the school district's executive operations officer because of a board policy on closing due to health concerns.

"Her initial recommendation was to close schools and have a virtual operation if conditions exist that may threaten the health and safety of students and personnel," Henderson-Baker said after the meeting.

"The school board attorney had already advised that this policy could be used — since she wanted to close the schools — if the board could not make a decision," she said.

Fuhrey said the school year should begin Sept. 8 rather than the previously agreed date of Aug. 24 because staff members needed the extra time to be trained in virtual learning methods.

Other administrators at the meeting told board member they were prepared to provide enough devices and had worked with internet providers to increase data to serve all students.

But board members Trey Bailey of District 1 and Abigail Coggin of District 5 said parts of their districts lacked dependable internet access and in-person learning was the best option for them.

option for them.

Administrators could not assure

them the school district would have the needed infrastructure by the start of the school year, she said.

Coggin said numbers she had seen showed a decrease in the daily rate.

She also noted that schools typically are where such social ills as child abuse are detected. Some students also have said they were worried their grades will suffer if forced to only learn virtually rather than in a school setting, she said.

Bailey said Newton County was unique because it bordered rural Georgia counties on the east that favor in-person learning, and metro Atlanta counties on the west that are primarily using virtual learning. Because of its geographical and cultural mix, Newton County should offer a blend of both types of learning, he said.

The Aug. 7 changes followed the school system's early July announcement students would be allowed to choose either in-person or virtual learning this year.

About 4,000 students requested in-person instruction, while between 6,000 and 7,000 students requested virtual instruction and about 1,800 students requested the self-paced virtual option, Fuhrey said in July.

On Aug. 7, she told board members her new recommendation was based on her desire to keep staff members and students safe during the pandemic.

"I recognize how politically charged this is," she said. "I have no political motivation — zero, zilch, zip."

Some teachers and Newton High School football players were diagnosed with the virus recently, Fuhrey noted.

She also said state health offi-

cials had not been as clear in their explanations about the spread of COVID-19 in recent months because they were unsure about the transmission rate.
