



Sam Ramsey

Businessman, former Covington mayor dies

COVINGTON, Ga. — Some area residents who knew Sam Ramsey praised his work as a community, civic, religious and business leader during his decades of service to Covington and Newton County.

Ramsey, 81, died Tuesday, Aug. 25, at Emory University Orthopaedics and Spine Hospital following surgery for a broken hip, according

to an obituary from Caldwell & Cowan Funeral Home.

A funeral service honoring his life is set for Monday, Aug. 31, at 11 a.m. at Salem Campground Tabernacle at 3940 Salem Road in Covington with internment following in Covington City Cemetery, the obituary stated.

Covington Mayor Steve Horton said Ramsey — who was one of his predecessors in the mayor's seat — also was "one of the most selfless people I ever met." "Nothing

was more important to him than people," Horton said. "He loved people."

Ramsey

was owner and president of Ramsey Furniture Co. for 56 years near the Covington

His 37-year tenure as a public servant included a decade as mayor from 1996-2007 after serving on the city council for nine years and the city planning commission for 18 years.

Covington attorney Frank Turner Jr., said he knew Ramsey all his life. His father, Frank Turner Sr., and Ramsey were boyhood friends and Turner served as city manager during Ramsey's time in city govern-

"He was a good Christian man," Turner Jr. said. "He was level-headed ... he always tried to bring people together."

He noted Ramsey was a lifelong supporter and a major organizer of the Salem Campmeeting — and recalled traveling as a boy to the Campmeeting in west-

Oxford woman guilty of daughter's 2018 murder

Sentenced to 15 years in prison after pleading 'guilty but mentally ill'

COVINGTON, Ga. — An Oxford woman is going to prison for 15 years after pleading guilty to shooting her 2-year-old daughter to death but being mentally ill at the time.

And the district attorney said prosecutors got a tougher sentence than one they potentially could have seen

under state law.

Jennifer Michelle Bellah, 33, pleaded "guilty but mentally ill" Wednesday, Aug. 26, to a charge of felony murder in the 2018 shooting death of her daughter, Natalya Bellah.

Superior Court Judge Ken Wynne Jr. sentenced her to 15 years in prison without the possibility of parole, followed by life on probation.

Deputy Chief Assistant District Attorney Amber Dally and Chief Public Defender Anthony Carter said her plea was the result of an agreement between Bellah and prosecutors. Bellah's family and the Newton County Sheriff's Office lead investigator on the case also were in agreement, they said.

Bellah entered her plea Wednesday after pleading not guilty to the charges in May 2019.

The case stems from the Aug. 28, 2018, shooting death of Bellah's daughter in the basement of a residence on Brown Thrasher Run

NCSS announces plan for 'gradual' return to in-person instruction

tspigolon@covnews.com COVINGTON, Ga. — Newton County schools will allow students to begin a "staggered, gradual return"

to buildings with all possibly back in by mid-October if the COVID-19 "numbers allow," the superintendent announced recently.

The system is preparing for the eventual return of students for in-person instruction but it will be based on such factors as grade level, student status and if they originally chose an in-person learning model, a news release stated.

Superintendent Samantha Fuhrey and staff announced the development of a School System Re-Entry Plan that delineates the timetable students could return to school, the release stated.

On Sept. 8, all self-contained special education students will report to in-person instruction at their school buildings while all other students in grades pre-kindergarten through 12 will begin virtual instruction, the

release stated

"It is important to provide face-to-face instruction for our self-contained students starting on day one," Fuhrey said. "As a result, they will be the first students to return to the buildings for in-person instruction.

"From there, we will implement our re-entry plan and, if the situation allows, begin a staggered, gradual return of students to in-person learning," she said.

Fuhrey said the re-entry to buildings will be for those who originally opted for the in-person learning model; those who opted for the secondary self-paced virtual model will continue that learning format through the first semester.

"In addition, those parents who feel it is in their child's best interest to remain in virtual learning may do so we are not going to require them to return to in-person if they do not feel comfortable sending their child to school at this time."

Fuhrey and district staff will review data regarding COVID-19 every Friday, using the 14-day case rate, rate of positivity, the seven-day moving average, hospitaliza-

with the girl's grandmother.

At the time, a Newton County sheriff's spokesman said Bellah called 911 to report she "shot her 2-year-old daughter using a firearm." The girl was pronounced dead once authorities arrived, the spokesman said.

Assistant District Attorney Amber Dally said Bellah was being treated for mental illness and had asked for an increase in the dosage of prescription anti-depressants in days leading up to the shooting.

On the day of the incident, Dally said Bellah left a voice mail on her brother's phone saying she was upset, that "he would never know what it's like to lose a child," and referred to Natalya in "the past tense."

However, when he went to check

on them Bellah refused to let him in the home but showed him through a window the girl was unharmed. Soon after, she retrieved a handgun, shot the girl three times and called 911, Dally said.

A pistol, a shell casing and bullets were recovered from the scene, a sheriff's office spokesman said in 2018.

Dally said Wednesday investigators found the prescription anti-depressants, medical records about her ongoing treatment and "eulogies" Bellah had written for her and her daughter.

She said Bellah told investigators she shot and killed the child because she feared the girl would be taken from her and later harmed.

"We do agree she did suffer some sort of mental illness" which justified her use of the plea of guilty but mentally ill, Dally said. Carter, who represented Bellah,

said he fought for her to plead Not Guilty by Reason of Insanity but called Wednesday's agreement "a good compromise." Acting District Attorney Randy

McGinley said, "The death of Natalya was a horrendous crime and this plea and sentence ends the case with the appropriate outcome."

McGinley said that, in addition to the more common guilty and not guilty pleas, state law allows a defendant to plead Guilty but Mentally Ill or Not Guilty by Reason of Insanity.

"Should this case have gone to trial, a jury would have been given

all four of those options," McGinley said.

"When a jury finds a defendant Not Guilty by Reason of Insanity, the defendant is committed to a state mental health facility. The defendant is then evaluated within 30 days and then on a regular basis, usually every 12 months.

"Should an evaluation find that a defendant no longer meets the requirements of inpatient commitment, that defendant would be released from commitment by the court," McGinley said.

"Therefore, under a finding of Not Guilty by Reason of Insanity, a defendant can be released from commitment in a very short time after such a verdict. This could happen as early as shortly after the first evaluation 30 days after the verdict."

He said when a defendant enters a plea of Guilty but Mentally Ill or such a verdict is returned by a jury, the Georgia Department of Corrections will be responsible for the defendant's mental health needs.

"Therefore, a defendant under this plea or verdict is sentenced to prison but will receive mental health treatment while in prison," McGinley said.

He said Bellah was evaluated by "multiple doctors" while the case was pending.

"Should the case had proceeded to trial, all these mental health experts would have testified that Bellah was suffering from a serious mental health illness," he said.

"While that was undisputed, some of the experts would have disagreed at trial as to whether Bellah met the legal requirements for a finding of Not Guilty by Reason of Insanity."

He said his office "thoroughly reviewed all of the facts surrounding this case including all of the mental health evaluations, the body camera footage, and the interviews of the defendant and her family members conducted just after the crime. Additionally, the DA's office consulted with an additional well-known and well-respected experts to review the mental health issues," he said.

"After this exhaustive review of the case" the state and the defense reached a negotiated plea to Guilty by Mentally III with the sentence that Wynne accepted, McGinley said.

Sam Ramsey

Sam Ramsey, former mayor of the city of Covington, Chairman of the Board of Directors at Salem Campground and President and CEO of Paragon Furniture

Ramsey Furniture Company, passed away Aug. 25, 2020, following surgery for a broken hip. He was 81 at the time of his death.

Mr. Ramsey, a 1957 graduate of Newton County High School, continued his post-secondary education at Oxford College of Emory University before graduating with his BBA from **Emory University Business School** in 1961. He was later presented the Distinguished Alumnus of Emory University Award. A true servant, he began his lifelong years of service by courageously serving in the United States Air Force which included the tense military standoff known as the Cuban Missile Crisis. His outstanding service was recognized when he was awarded the Distinguished Materiel Control Officer Award by the U.S. Air Force.

Although he considered entering the ministry, after returning to his native home of Newton County, Mr. Ramsey devoted more than four decades to public service and the ministries of both the Methodist church and the local Salem Campground. Confirmed at the age of 6, Mr. Ramsey was a lifetime member of Covington First United Methodist Church where he faithfully served in several capacities including Chairman of the Administrative Board and the Council on Ministries. A Certified Lay Speaker, he attended the annual Salem Campground meetings for more than eight decades and served as Trustee and Chairman of the Program Committee for 57 years, and most recently as Chairman of the Board of Directors. Furthering his commitment to the Gospel, Mr. Ramsey was an active member of Gideons International.

A true pillar of his community, Mr. Ramsey launched his public service after being appointed to the City of Covington Planning and Zoning Commission in 1970, and in 1975, was elected President of Newton County Chamber of Commerce. He was later awarded the honorable R.O. Arnold Award for Community Service by the chamber. Additionally, he served as President of the Kiwanis Club, from 1971 - 1973, and began a dedicated tenure as leader and advisor for the Boy Scouts of America – Troop 222. He served on the Atlanta Area Council and the Advisory Board. Mr. Ramsey was awarded the highest Adult Scouting Award – the Silver Beaver.

In 1988, he was elected to the City Council (nine years), and in 1996, he was elected Mayor of Covington to complete a one-year unexpired term. Mr. Ramsey continued serving the citizens of Covington as he was re-elected mayor for three additional terms. During his incumbency, all departments within the city became nationally accredited – the police department having received the highest award possible - the coveted Webber Seavey Award. Further, Mr. Ramsey was instrumental in the expansion of the Covington Municipal Airport. In addition to the economic benefits the local airport provided to the community, safety was his top priority as new hangers were built, the runway was extended and new lighting was implemented. In addition to the vast progression of the city during his administration, he sought the support of local pastors and churches to create Faithworks, a local non-profit assisting indigent families with rent and utility expenses. When the City Council was at a standstill, Mr. Ramsey was the tie-breaking vote in favor of the Garden of Gethsemane Homeless Shelter being relocated to Covington, from Porterdale, allowing better facilities to serve those in need. His devotion to the shelter continued as he served on the Board of Directors for the last eleven years.

Those left to carry on his legacy include his beloved wife of nearly 50 years, Becky Griffin Ramsey; his devoted cousin, Tony Ramsey, his wife, Kimberly, and their children, Taylor and Rachel; his faithful sisters-in-law, Alice Griffin Walker and her husband, Ken, Lavinia Griffin; nephews, John B. Griffin, III, and his wife, Laura, Richard S. Griffin and his wife, Beth; great-nieces, Victoria, Nicole, Kaitlin and Makenzie.

A funeral service honoring the life of Mr. Ramsey will be held Monday, Aug. 31, 2020, at 11 a.m., at Salem Campground Tabernacle, 3940 Salem Road, in Covington, with Rev. Dr. Douglas Gilreath and Rev. Dr. Jan McCoy officiating. He will lie in state beginning at 10 a.m. A private family interment will immediately follow the service. 

Ramsey's urging. The Campmeeting's cancellation this year because of COVID-19 was the only time other than during the years of the Civil War in which it was not held since 1828.

Ramsey was a member of the Covington Kiwanis Club for almost 50 years. He also was a major supporter and longtime lay leader of Covington First United Methodist Church, Turner said.

The church's pastor, the Rev. Doug Gilreath, recalled Ramsey as a "very devoted, very dedicated member."


"He had a way of making his passions your passions," said Gilreath, who has served as the church's pastor since 2008.

He noted the church's choir typically performed as part of one of Ramsey's "passions" the Campmeeting. Ramsey even ar-

ranged for the bishop of the North Georgia Methodist Conference the parent organization of 800 churches to speak during the event, Gilreath said.

The pastor also said Ramsey and his wife, Becky, helped bring the church sanctuary's centerpiece, an 1,100-pound chandelier, to Covington First United Methodist after it proved too heavy for the ceiling of Emory Oxford College's

chapel. He also noted Ram-

sey was instrumental in what became Garden of Gethsemane Homeless Shelter on Turner Lake

According to a 2007 story in The Covington News, funding the shelter was a hot topic at the time. Ramsey cast the tie-breaking vote for the city council to approve \$1.08 million to establish the badly-needed but controversial shelter in

During Ramsey's decade as mayor, he supported development of the city's airport and sale of Covington Cable to Charter Communications, the 2007 story noted.

a former daycare center.

Covington also saw construction of a number of county facilities, including the Newton County Library, the Judicial Center, the Turner Lake Recreation Complex, the Newton County Board of Education headquarters and the Newton County Detention Center.

Georgia Piedmont Technical College and Georgia State University's Perimeter College in Newton campus also located in Covington during Ramsey's time in office.

Horton served as city manager, police chief, public works director and other positions during 36 years with Covington government much of it during Ramsey's time as an appointed and elected city official.

Among Ramsey's goals was making life easier for the neediest in society, Horton said.

Ramsey also looked to a higher power for guidance, the mayor

"He'd talk politics, but he talked about wanting to be in the 'prayer house' rather than the White House," Horton said, laughing. Horton said Ramsey was among the people who helped guide him

along the way in his career. Ramsey was a "mentor" to Horton who helped convince him to seek election to the mayor's seat that he won in 2019, the mayor said.

"Sam always was an encourager," Horton said.

Covington Police Chief Stacy Cotton was named to head the police department the same year Ramsey was elected mayor. He said Ramsey was "a gentleman to everyone he ever met."

"His passing is yet another one of Covington and Newton County's great homegrown people who cared about everyone in this community to leave us recently," Cotton said.

"I was honored to serve as his police chief when he became mayor but more honored that he was my friend. Mr. Sam, you will be missed."

County Commis-

sioner Ronnie Cowan was human resources director during a 25year span with the city of Covington, some of which included Ramsey's years in office.

Cowan recalled Ramsey being "fair and reasonable" as he worked with him to develop policies for city workers.

He said Ramsey was always knowledgeable about city initiatives, such as the city government self-funding its insurance.

"Sam was just a good all-around person," he

He said Ramsey and one of his predecessors, Bill Dobbs, led the town as it developed into a modern city over three decades.

"He is what I would call an elder statesman," Cowan said.

County Coroner Tommy Davis described Ramsey as a "great man" he had the honor of calling a friend.

"Mr. Sam Ramsey was a fine man — an outstanding man," he said. "He was a pillar of the community and a public servant.

"He was ever-present within the community. He was always so giving of his self to others ... Sam was just a great man. Just always Sam Ramsey — always the same. "And to say he was a great man is a huge statement. The measure of a man is not only who is today, but who he was yesterday and who he is the next

"And Mr. Ramsey was always the same. He was always positive and always had the best intentions for this community and city. He was a great role model for the community."

The Newton County government on its Facebook page posted photos from a celebration of Ramsey Furniture Co. being in business for 100 years in 2019.

"Newton County mourns the loss of Sam Ramsey and shares its thoughts and prayers with his wife Becky and family.

"Sam Ramsey served Newton County throughout his life, on the Covington City Council, as mayor, as owner of Ramsey Furniture, a faithful member of his church and dedicated chairman and advocate of the Salem Camp Meeting.

- Talking about feeling hopeless or having no reason to live.
- Talking about being a burden to others.
- Giving away possessions or pets.
- Drastic changes in moods and behaviors, unexplained anger or irritability.
- Engaging in risky behaviors.
- Increasing drug or alcohol use.

in fear is no way to live. The Bible tells us that tomorrow is not guaranteed, as the Proverbs say, "Do not boast about tomorrow, for you do not know what any day may bring forth" (27:1). The most repeated advice in the Bible is also. "Do not be afraid," or "Have no fear." God so wanted us to know that we should not fear, that He told us this advice hundreds of times in

the Bible! We can exercise and eat all the right food and drive safely, and in the end we are often surprised by our humanity. By our frailty. By our lack of control. I am often brought to tears hearing of the losses that people experience. There is a helplessness when staring into the eyes of people who have experienced a loss that rocks their world and all you can do is tell them how much you care but how you can't change what happened.

We can try all we

want to protect ourselves from loss and pain, but in the end, we have been given freewill and sometimes that means we suffer. So yeah, maybe that means we should throw caution to the wind and just live without taking precautions. That approach would go perfectly if we lived on an island, and our lives didn't impact the lives of others, but as stated above, that is not the truth.

My choices impact other people. Realizing that, and making decisions that consider other people, is not living in fear, it is called consideration. These are not my own thoughts, they come from someone who came long before me, "Do to others whatever you would have them do to you" (Matthew 7:12).

It feels like lately, there has been a push that says that I have the freedom to live the life that I want to live, without regarding other people. To argue about certain rights that the Constitution allows me while ignoring the fact that people around me don't even have the basic human rights that we take for granted, or to harm an employee at a store because I don't like the policy that he or she is enforcing.

To be sure, there are

a lot of decisions that we are trying to make right now...to wear a mask or not, to shop in stores or by pickup, to mandate mask wearing in our places of business or worship, to send our kids back to school virtually or in-person, to socialize in enclosed places or to keep it outside... the list goes on and on. These decisions can only be made with guidance from the Holy Spirit, but to be chosen on the basis of not fearing is not necessarily a formula that shares our faith in the best light.

I am by no means perfect, and I wish I could claim that I always think of others before myself. I have to stop myself all the time and question my motives — why am I doing the things I am doing? Do I really care about the other person or I am just trying to make my own life more comfortable or easy?

As we think about the decisions that we are making, now, more than ever, checking our motives and our consideration of others is critically important especially if we call ourselves Christians. It is in times of crisis and turmoil that people are looking for hope. And we have the hope and love that the world

needs to face these current times. But they will only pay attention to our words if the way that we live our lives reveals that hope and joy that comes through living our lives for others.

John had this to say about Jesus, "The way we came to know love was that he laid down his life for us; so we ought to lay down our lives for our brothers" (1 John 3:16). As His followers, His "feet and hands" on the earth, we are also called to lay down our lives, even if it is uncomfortable or hard. That is true love and in living that way, we are not living in fear, we are living in consideration of those around us, and shining the most convincing light possible towards the One who has love for all people.

Local father meets daughter after 53 years

tspigolon@covnews.com COVINGTON, Ga. — Ed Sanders could not believe the news he received in

It had been more than half a century since the events leading up to it had occurred. The Michigan native and his wife had been married 55 years and he at first discounted it, he said.

But Sanders, 74, found out earlier this year that he had a 53-year-old biological daughter in Michigan he never knew existed.

Then, the retired Georgia Power employee, wife Nancy and son, Eddie, "drove up during this COVID thing and took a chance." They traveled 900 miles in July to meet his newfound child, Tina Sherbutt, and her family.

"Ed was a nervous wreck," Mrs. Sanders

Sherbutt was expecting them, but Sanders said he greeted her on her doorstep with a dozen pink roses and a hug — despite the pandemic that can make such actions hazardous.

"Wonderful week, wonderful family,' Sanders said. "They're coming down to Covington (in September) to bring their family here to see where we "For our account, it

went from absolutely shocked to just euphoria. It's wonderful to be 74 and have a daughter you didn't know you had," Sanders said.

Sherbutt, who lives in Fort Gratiot, Michigan, said she was to meet the Sanders' daughter,

JaNiece Sopha, this weekend after meeting the Sanders and their son in July.

"They're truly wonderful people — I hear from Ed every day," she said. "He's really incorporated himself into our family."

Sanders found out about Sherbutt from Sopha, who happened upon her using the AncestryDNA testing service.

A Maryland resident, Sopha, 47, first used the Ancestry service to submit DNA because of questions about her grandfather.

She learned about her grandfather but the DNA service also showed she was somehow related to Sherbutt

 who also had been curious about her family tree and had submitted DNA to Ancestry in 2018.

Sherbutt also lived near the town where Sopha's parents grew up. In March, Sopha used Facebook to contact Sherbutt and they hit it off.

Then Sopha, on the same day, contacted her father to tell him what she found, Ed Sanders said.

"I got a text ... that said, 'Daddy, you've been a great dad, you've been a wonderful father ... but Dad, you've got some 'splainin' to do,'" he said.

He later took the AncestryDNA test and confirmed they were father and daughter.

Nancy Sanders, who is retired from Lifeway Christian Bookstores, said she "really wasn't surprised" when she got the news. She contacted Sherbutt and told her she was happy they were related, even before her husband confirmed it with a DNA test.

Mrs. Sanders told the Port Huron Times Herald newspaper she initially was bothered by the revelation but believed their marriage should not be sacrificed for something her husband did when he was 19.

his 17th birthday. When he was 19 and recently returned to his hometown of Port Huron, Michigan, in 1966, he met Sherbutt's mother for what was a onetime "indiscretion."

The Sanders later moved to Atlanta around 1970 and Ed went on to a career with Georgia Power Co. and the Rockdale County Sheriff's Office before he retired.

"God turned around what the devil could have used to destroy our 55-year marriage into a wonderful blessing for all of us," Ed Sanders said.

Sherbutt, meanwhile, grew up in Port Huron a town northeast of Detroit that literally borders Canada at the southern tip of Lake Huron. She is an accountant for a natural gas company there and is married with three adult children.

She said she long felt the man who raised her — who died in 1991 was not her biological father but could not confirm it until an aunt told her after her mother's death in 2009.

After that, she discovered she was possibly related to Sopha and her sister, Alabama resident Shelley Walden, before Sopha contacted Sherbutt in March.

"I was thankful for JaNiece opening that door," Sherbutt said.

"Everyone's so amazed by it," she said. "It's wonderful news at a time when there's not a lot of good news."

When the two families met in July in Michigan, they had to be extra careful about

how they greeted each other in the midst of a pandemic. Sherbutt's husband is medically fragile and underwent a stem cell transplant in March.

But the two families had more than DNA in common. Both Eddie Sanders, a South Carolina resident, and Sherbutt's husband Ron are Navy veterans. Sopha's husband is from Michigan.

In September, the Sherbutts will bring two of their children to meet the Sanders and their three other children in Covington.

Sherbutt admitted her family had not been close growing up. But both Sanders

and Sherbutt are glad a new relationship has been discovered between grandparents and grandchildren. She said it means her children will have grandparents again after many years.

"This is nice," Sherbutt said. "It's different for them because ... it's been a long time since they had grandparents.

Ed Sanders said the turn of events "has been a blessing to our entire family."

"(Sherbutt's parents) and her husband's parents died over 11 years ago. The grandchildren now have living, loving grandparents," he said.

Sopha said on her Facebook page that she got more from the AncestryDNA test than she "could have ever dreamed."

"This is just the best story and we are all so blessed to find a piece of our lives that was missing!" Sopha said.

tions, and emergency room visits related to COVID-19, to make a determination about if and when it is safe to return groups of students to school, the release stated.

"Once we review the

data, if the numbers allow, we will begin the phase-in of students," Fuhrev said. "We will notify parents via email beginning Sept. 11 if the

> to return to in-person instruction. "They must complete the questionnaire by 5 p.m. that Monday in order for their student to be included in the first wave of students reporting back on Sept. 21. If the numbers continue to improve, we will follow the same process every Friday, inviting increased numbers of students to return."

Grade levels of each phase of re-entry are as follows:

- Phase 1: Pre-K, Kindergarten, first grade, eighth grade, and 12th grade
- Phase 2: Second grade, third grade, sixth grade and ninth grade
- Phase 3: fourth grade, fifth grade, seventh grade, 11th grade

• Phase 4: 10th grade

If the data allow, stu-

dents could be back in

school by Oct. 13; however, should numbers indicate an increased rate of transmission of COVID-19 in the community, the school system may delay one or more phases of re-entry,

the release stated. Those students already back for in-person instruction would continue to report to school; others would remain in virtual learning until conditions improve. In that event, the district would update the dates for re-entry and continue to review data on Fridays.

"Our model allows for week-to-week consideration of community transmission of COVID-19," Fuhrey said. "Because the turnaround time for our Friday announcements to Monday deadline to respond to the survey is so short, it is imperative that parents have current email addresses in their student's Infinite Campus profile.

"As such, we have opened up the Parent Portal so parents may update their contact information on their child's profile. We implore parents to create a Parent Portal account and verify their email and phone numbers are correct as soon as possible."

Parents may create an

account at campus.newton.k12.ga.us/campus/ portal/parents/newton. "Ultimately, our goal is to have all students

return to in-person instruction and stay in face-to-face instruction," said Fuhrey. "We know that is the best learning environment for children of all ages.

"In order to do this, we have verified with our medical partners that the wearing of masks is of utmost importance. As such, members of the board of education, in partnership with school system administration determined that students and staff will be mandated to wear masks while in our schools and on our school buses unless there is a documented, clinical concern preventing them from doing so.

"Students who refuse to wear a mask will not be permitted to ride the school bus or attend classes in person; instead, they will remain in the virtual environment."

karaoke and trivia.


The Social Goat Tavern

All four owners are committed to the restaurant's day-to-day operations. They encourage feedback and strive to make themselves readily available to all guests.


"We want to be owners who are approachable, so that when you see us in the restaurant you feel welcome to engage in conversation,"

Newton schools resume fall sports, extracurriculars

COVINGTON, Ga. — Following an indefinite suspension that spanned more than seven days, the Newton County School System announced Monday, Aug. 24, that it would resume all sports and extracurricular activities beginning Tuesday,

According to a statement put out by Newton County Superintendent Samantha Fuhrey, the school district made the decision to end the suspension following a "careful monitoring" of numbers from the Georgia Department of Public Health.

"I know how important

athletics is to the overall social-emotional wellbeing of our athletes, and we did not take the decision to shut down and now resume sports lightly. We have continually monitored this situation and the data show a current

downward trend in the numbers of COVID-19 in our community," Fuhrey stated in the press release. "That

combined with our enhanced safety protocols led us to the decision to resume athletics."

Fuhrey added that the safe-

ty of all student-athletes is the county's top priority, and "as such, we will continue to monitor the data and consult with our local health organizations."

"Should the numbers warrant a change in our status, we will make an adjustment," she said. "This is a fluid situation and could change at any time."

The GHSA football season is set to begin next week. Alcovy and Newton are currently scheduled to kick off their respective campaigns on Friday, Sept. 4, with Eastside set to join Friday, Sept. 11.

Despite being forced to take the week off due to the suspension enforced by the school district, it appears as though all three of Newton County's GHSA football programs remain on track to start their respective seasons

'Right now it looks like

we'll be able to start the season as outlined," a jubilant Jason Dukes, who's entering his second season as head football coach at Alcovy, said Monday evening. Dukes and his Tigers returned to practice Tuesday afternoon to continue their preparation for next week's season opener at North Forsyth.

The softball teams at Alcovy, Eastside and Newton each returned to the diamond this week as well.

As of Monday, Aug. 24, the Georgia Department of Public Health reported there had been a cumulative total of 2,168 cases of COVID-19 in Newton County. Furthermore, the DPH stated that Newton County had reported 273 new cases per 100,000 residents. That rate appears to show a decline from Wednesday, Aug. 19, when the county had reported 350 new cases per 100,000 residents.

Lady Rams' Pearson pitches no-hitter against Alcovy

Newton softball improves to 6-0 with win; Tigers fall to 0-2

COVINGTON, Ga. Hayden Pearson has proven herself to be a reliable ace in the circle for the Newton High School softball team.

Over the past two

seasons, the junior right-hander has made a strong case as the most consistent arm in Newton's rotation. On Thursday, Aug. 27, she showed just how unhittable she can be when she's locked in.

Pearson took the ball against rival Alcovy High School and pitched a no-hitter, racking up 12 strikeouts and walking a pair of batters in an 11-0, six-inning victory for the Lady Rams.

Newton head coach Virginia Tucker-Smith continued to give her dominant righty high praise Thursday night while also lauding the work of the fielders behind her.

"Everybody plays with a lot more confidence when she's out there pitching, when she's on," Tucker-Smith said. "I think our defense always reacts to her, and they always seem most confident and play the best defense behind her. I think it's a whole mental aspect, and that's a blessing in itself."

The Lady Rams gave

Pearson a lead to work with in the second inning. With one out and one on, junior Katelynn Anglin roped an RBI double to center field to drive in Newton's first run of the day.

In the home half of the third inning, the Lady Rams doubled their lead on a sacrifice fly from senior Aulora Edwards.

But despite Newton's dominant pitching and early run support, Alcovy managed to stick around. Anchored by a gutsy performance in the circle from junior Lexie McDonald, the Lady Tigers found themselves in a 2-0 game in the sixth inning.

One out away from taking the narrow deficit into the seventh, the Lady Tigers surrendered nine two-out runs to invoke the mercy rule. Despite the late implosion, Alcovy head coach Miranda Lamb was pleased with the way her young team held tough against a formidable Newton club.

"We were one pitch away from potentially tying up the game, and also one out away from going into that seventh inning at 2-0. It's just the little things that we've got to correct, and we will," Lamb said. "I think we played
