

Family plans to start foundation to honor his life, legacy

Horace J. Johnson Jr. during a ceremony honoring him Friday, July 10, in a building newly renamed for

Alcovy Superior Court Judges John Ott, Eugene Benton and Ken Wynne and Senior Judge Samuel Ozburn were among those offering tributes.

Benton said he served with Johnson for 16 years. He called Johnson a "true friend."

"A true friend is neither an anchor to hold you back or a sail to take you where you want to go. A true friend is a guiding light to show you the way there," Benton said, his voice cracking.

"Horace was a bright, shining light that showed the way to a better community, a better court system

and a better state," he said. "Because of who he was and how he lived his life, his guiding light will shine and be a beacon for all of us forever."

Johnson also was a "great listener," Benton said.

"He had a way of making me feel welcome, that I could talk to him at any

time. And when I talked to him, I always felt better after our conversations. I could come by with my deepest concerns, without judgment or censure."

Originally, Superintendent Samantha Fuhrey proposed students return to school Aug. 17, but after spending several hours discussing how the reopening plan would be implemented, board members Trey Bailey, Abigail Coggin and Shakila Henderson-Baker felt there wasn't enough time. "There are 24 working days

to implement something we've

Woman shot, killed in Covington

Sheriff's Office seeks public's assistance

Newton County sheriff's investigators were asking the public's help after a woman found at a Covington residence with numerous gunshot

wounds died Wednesday night, July 8. Deputies responded to a call Wednesday at 10:45 p.m. about some-

one needing help after

suffering "penetrating

trauma" at a residence

on White Birch Drive in

Covington. They found victim Cassandra Arnold, age 32, with the wounds and she was transported to an area hospital where she later died, said spokeswoman Caitlin Jett of the Newton County Sheriff's Office.

No other information was immediately available in the ongoing investigation, she said. The Newton County

Covington commits \$1 million to pave Cricket Frog Trail

City enters into contract with PATH Foundation to facilitate construction, design

COVINGTON, Ga.

— The city of Covington is putting \$1 million toward paving the Cricket Frog Trail.

During its meeting Monday, the Covington City Council voted unanimously to dishout the funds to pave the trail, which should take about six months, City Manager Scott Andrews said.

"If it takes longer

than six months, I'd be disappointed," he said during the Zoom meeting.

of the former Norfolk Southern Railroad right-of-way, including an approximate 3.6-mile portion (the Cricket Frog Trail) which runs through Covington. A standing agreement between the city and Newton Trails allows the city to develop, build and maintain a multi-use trail on the old rail bed.

"I identified the Cricket Frog Trail as a key component for community development the first time I visited Covington, and I actually spoke of its importance when I interviewed with the mayor and council

for the city manager position," Andrews said in a statement. "The trail acts not only as a source of exercise and transportation for some, but it is an economic driver for the city as well as the county. It is an extremely important piece of the puzzle we are assembling."

Paving will begin at

Emory Street, across from Covington City Hall, and proceed west to Spillers Drive near Washington Street. Once that portion is complete, the trail from Conyers Street to Eagle Drive will be paved. The city plans to pour concrete five inches

thick and 12 feet wide, per Newton Trails' standard specifications, Andrews said.

Monday, the city entered into an executive services contract with the Atlanta based PATH Foundation to help facilitate the construction, design and engineering of the trail. The PATH Foundation will also complete the structural engineering for the railroad trestle located behind city hall.

The city is currently soliciting bids to begin clearing brush on the portion of the trail set to be paved, Andrews said. The city's concrete contractor, Peachtree Construction, will pour the concrete and will be funded by the 2011 TSPLOST.

Newton Trails has funds from two grants, as well as donors, to contribute toward renovation and paving the trestle.

"Newton Trails is thrilled about this development," said Greg Richardson, Newton Trails' board chair. "Our organization has been working toward this end for many years. We are so appreciative

of the vision and action of the city council, Mayor Steve Horton and City Manager Scott Andrews."

Newton BOC dissolves recreation commission

Commission cancels youth football, cheer

COVINGTON, Ga. — Newton County's Recreation Commission is no more. The Newton County Board

of Commissioners met Tuesday, July 7, and adopted a resolution to dissolve the commission, effective immediately.

The action came after the commission approved bonuses totaling approximately \$28,000 to certain employees in December that were later deemed illegal by the county.

The BOC pushed for legislation that would give it power to dissolve the commission shortly after the bonuses were approved. It cleared the Georgia General Assembly on June 24 and was signed by the governor

The legislation, sponsored by Rep. Pam Dickerson, D-Conyers, stated, "The Newton County Board of Commissioners, by resolution or ordinance, may dissolve the Newton County **Recreation Commission** originally created by said board of commissioners. If the Newton County Recreation Commission is dissolved by the Newton County Board of Commissioners, said recreation commission shall cease to exist as of the effective date of the resolution or ordinance, and all assets, debts, rights, and obligations of said recreation commission shall devolve to

The act went into effect July 1 — "the first day of the month following the month in which it is approved by the governor."

As its final order of business, the recreation commission canceled youth football and cheer for 2020 and finalized a repayment schedule requiring certain employees to pay back bonuses over 18 months with 1% interest to be paid on the 19th of the month. The bonuses, totaling approximately \$28,000, were first approved in December but later deemed illegal by

the county in February.

After disbanding, the recreation department becomes an arm of the county and will report directly to the county manager.

Longtime County Commissioner J.C. Henderson, who was the lone vote opposing the resolution, said the commission was originally formed to "keep politics out of the recreation department."

The move effectively reversed any department efforts to depoliticize department decision-making, and such an organizational change should "be put in the hands of the people," he said.

Football, cheer canceled

Youth football teams and cheer squads won't take the field in Newton County this

The Newton County Recreation Commission met for the final time via teleconference Tuesday, July 7, to discuss the possibility of offering fall sports this season and came to the conclusion that football and cheer would

pose too great a risk for spreading COVID-19. "It's a wait and see ap-

proach," Newton County Recreation Executive Director Ternard Turner told the commission. "Everybody is kind of like at a standstill The COVID-19 numbers are going up tremendously. I know there are a number of colleges that have canceled their fall sports in general. I know there's a couple of agencies that have canceled their fall sports in general. My opinion is I think we definitely cancel football.

"It's a physical sport," he continued. "The physicality of the sport — I think other agencies are going to start to follow. Now, you may have some that take the risk, but I don't know if we should take the risk based on that particular sport. Baseball and softball are different. Football is just too much physical contact. Sort of like basketball, there's just too much physical contact. I definitely suggest we should cancel football."

Shortly after Turner's

comments, the board voted unanimously to cancel football and cheer activities for 2020.

The future of fall baseball and softball seasons was briefly examined. Turner suggested it was possible to incorporate social distancing while playing both sports if "creative" enough.

"I think it's a possibility that we could do it ... but I'm still not sure with just the COVID-19 numbers," Turner said. "They just continue to rise and that, personally, alarms me, and what I don't want to do is bring that into our park and something

happen." Turner said the commission could look at shortening the fall baseball and softball schedules as well as limiting the number of players allowed in the dugout and inside the park as ways to help slow the spread of illness.

Because baseball and softball signups wouldn't be held until the end of August, the commission voted to table the matter.

Newton commissioners consider full property tax rate rollback

COVINGTON, Ga. County commissioners will get the chance to fully roll back the 2020 property tax rate to its lowest level in six years and still see some increased revenue for its new budget.

County Manager Lloyd Kerr told Newton County commissioners Tuesday, July 6, the new 2021 budget he was proposing assumes a full rollback property tax rate that is almost 4% less than last year.

As a result, use of a proposed tax rate of 12.917 mills — the lowest rate since 2014 spares the county from holding three public nearings because it will not be a "tax increase" as defined by the state law known as the "Property Taxpayers Bill of Rights," said Finance Director Brittany White.

Officials expected the property tax rate, or millage rate, to generate more than \$3 million in additional revenue to help fund the 2021 county government budget if it remained at last year's level of 13.43 mills because of a 7% increase in assessed property values in the tax digest.

The tax digest is the total taxable value of

all real and personal property within Newton County.

State law requires that calculation of the digest also include a rollback property tax rate that will produce the same total revenue on the current year's new digest that last year's tax rate would have produced if no reassessments occurred, White said.

But if a local government or school district in Georgia approves the rollback tax rate, they are not required to hold public hearings if increases come from new and improved property, White said.

The original \$105.6 million budget for 2021 that commissioners considered in late June

was almost 7% higher than the 2020 budget.

It also used the same 13.43-mill property tax rate as last year to calculate expected revenue in part because county officials did not have final tax digest numbers, White said.

Because using last year's rate amounted to a tax increase, county commissioners said they had concerns about approving the budget at a time when the COVID-19 pandemic had negatively affected many households' finances.

The Newton County Board of Education has tentatively adopted an M&O millage rate which will require an increase in property taxes by 3.98%. When voting, more choice is a good thing

which will help determine one of two U.S. Senate seats for the state of Georgia is unique for multiple

First, a "jungle primary" will have all candidates, regardless of party, listed together at one time. There are no separate primaries similar to the one which saw Republican incumbent David Perdue unopposed and Democrat Jon Ossoff emerge the winner from a field of six challengers.

Perdue and Ossoff, along with Libertarian Shane Hazel, will meet November in the general election.

For the seat occupied

by Republican Kelly Loeffler, things are much different. Not only must Loeffler defeat her GOP challengers, she must also defeat numerous Democrats. For good measure Loeffler must also gain more votes than several independents, a Libertarian (who is also endorsed by the Constitution Party) and a Green Party challenger.

The number of candidates in this "jungle primary" takes all of one's fingers and toes to count, so a runoff is all but a certainty. Loeffler was appointed to the U.S. Senate by Gov. Brian Kemp and her gift of the position has been anything but

smooth.

Loeffler was not the choice of President Trump for the vacancy. Trump preferred congressman Doug Collins, who has been a long-time ally of the president. Ironically, Collins threw his hat into the race and is one of the candidates facing Loeffler this November.

Loeffler meanwhile really appears uncomfortable in the role of U.S. Senator. She brags about her "accomplishments" such as voting against impeachment and being a supporter of Trump. To be frank, if those are the best things Loeffler can put front and center, then she is likely in trouble

in November. Recent

poll numbers, in fact, The upcoming "jungle primary" show her in a tough fight not only with Collins but with Democrat Matt Lieberman (son of former U.S. Sen. Joe Lieberman) and others.

Republican Kandiss Taylor has also built a solid grassroots campaign and could be a surprise candidate in the race. Democrat Raphael Warnock has the support of many powerful members of his party.

If nothing else, this "jungle primary" contest offers voters the ultimate menu of choice in terms of candidates. Due to the setup, third party candidates as well as independent are on a level playing field in terms of being on the ballot.

Similar to their Democratic and Republican foes, these candidates only had to pay a qualifying fee to ensure themselves a position on the ballot.

It's not always that way. Third party candidates in Georgia face some of the strictest ballot access laws in the country. The reason is simple. Democrats and Republicans typically work together to guarantee they will not have third party opposition.

Both establishment Democrats and establishment Republicans spoke of not wanting their designated candidates having opposition from within their own party. Those requests fell on deaf ears, as they should have.

More choice is a good thing in all aspects of life. That is especially true when we vote. We have a multitude of choices in the "jungle primary" for U.S. Senate and it can only be viewed as a positive thing. Worst of COVID-19 will be behind us, someday

s I write this, it has been 113 Adays since the first COVID-19 case was identified in my home

county. Within an hour, the school system an-



nounced schools would be closed for two weeks in order to give classrooms a thorough scrubbing. Little did we know.

I remember my first reaction. Wow, two weeks. That's a long time. Like many of you, I had kept up with this coronavirus thing at arm's length. When my (much smarter) wife bought some extra toilet paper back in March, I asked why. "You read the news on TV, and you don't know why?" she asked. "Well, I know there's something about a cruise ship, and some illness in China, but 20 rolls of toilet paper?" I responded. "Just wait and see," she said. Why are women right so often?

Much has been said about how the CDC was wrong, the World **Health Organization** was wrong, and so on. Facebook skeptics love to find something Dr. Anthony Fauci said in February, and pounce. "See! Even he didn't know how bad it would be!" Could anyone have predicted what we

have seen during the past 113 days?

As is so often the case, there's a paper trail to prove my cluelessness. On March 13, in this very newspaper I wrote, "God forbid, if this was September, can you imagine an SEC football game played to an empty stadium? I can't either." I can now.

I was among those who chose to be optimistic, hoping that warm weather would land a knockout punch, right square in the face of COVID-19. Maybe, I thought, by Memorial Day at the very latest, the ballplayers would be back on the field. Those spring weddings that had been postponed would result in a flood of June brides. I could comfortably return to my fast-food favorite haunts, and eat at the table, as God intended. I had no idea.

2020 is half over, and if it were a boxing match, the referee would have invoked the mercy rule by now. A recent national survey says only 14% of Americans describe

themselves as "happy." Having witnessed a pandemic, tornadoes, and street violence, you'd think the fates would be like Nick Saban when Alabama is playing against a small school. "Fellas, we're gonna ease up in the second half. We're up 42-0. Got a buddy up in the stands who

wants to play? We shouldn't run up the score."

So, in recent days, we've put on a brave face. Major League Baseball is gearing up for a July 24 comeback, despite several star players who are opting out. Many public school districts are holding firm with their usual August start dates. Some churches have been gradually reopening, with limited seating. Movie theater chains announced a July restart.

Having already proven that I am frequently wrong, I am not optimistic about any of these plans. The movie theaters have already backed off, and wisely so. I would be reluctant to put school-age children under someone else's care until I could do so with full confidence. I don't see that happening in the next few weeks.

As far as sports is concerned, nobody misses baseball more than me. Heck, I was loyal to the Atlanta Braves in the late 1980s, when they played to an empty stadium every night. There was no illness, just an epidemic of bad pitching, strikeouts and errors.

But again, I would be amazed if the abbreviated 60-game season (plus playoffs) actually happens. Despite the precautionary measures being taken in

the clubhouse and on the field, do we really expect these strapping 25-year-old athletes to live in a bubble around the clock? All it takes is one positive case, and the team is pretty much shut down. Multiply that by 30 teams.

That's why there is so much concern from high school to the NFL about the ultimate contact sport. In baseball, the butt-slapping, high-fives and victory celebrations can be curbed. In football, a few dozen guys are in each other's grille for three hours each week. Again, all it takes is one case.

Would I miss my weekly dose of SEC football, which dominates my weekends for four months each year? Most definitely. I've already dreaded the prospect of empty stadiums. Frankly, half the fun is watching the fans, or being among that crowd. Take that away, and all you have is a scrimmage game. And let's face it. My petty complaints aside. health is still the number one concern.

Yes, some day, the worst of this will be in the rear-view mirror. Just don't count on that day being in 2020.

Women at risk of losing access to birth control

Contraceptives treat medical issues like ovarian cysts and reduce the risk of unplanned pregnancies. Certain types, like IUDs, can cost hundreds if not a thousand dollars to insert.

In 2011, the Obama Administration issued guidance requiring insurers to cover contraception, but the rules pushed by the Trump Administration would expand exemptions for employers who object on religious or moral grounds.

If Trump prevails in dismantling the Affordable Care Act via the Supreme Court, more

than 100,000 women could lose

access to their birth control. Controlling women's bodies

has long been a priority of Republicans like Senators Perdue and Loeffler.

Let's face it, a decision invalidating the ACA would be a shock to the U.S. health system. It would end coverage for millions of people who signed up for insurance this year as they lost their jobs due to Trump's slow reaction to the pandemic. Insurers would again be able to deny people health coverage or charge higher premiums to consumers with pre-existing conditions and COVID-19

could be viewed as a preexist-

ing condition.

We have to ask, can Americans really trust Republicans to come with a new, better health plan? They didn't when in control of both the Senate and the House for two years and have yet to propose anything. Their silence is telling as they stand by while Trump attempts to dismantle what women and those with chronic health conditions depend on. Look hard at who you consider voting for in November.

Break (Oct. 12), three days for Thanksgiving Break (Nov. 25-27), two weeks for Winter Break (Dec. 21-Jan. 1) and one week for Spring Break (April 5-9) among other federal holidays regularly observed. A complete calendar will be made available at newtoncountyschools.org.

Before finalizing the 2020-2021 school calendar, the board spent the first two hours discussing the school system's Recovery and Reopening Plan.

The Recovery and Reopening Plan is a direct response to prevent further transmission of the novel coronavirus while providing instructional continuity and supporting student and family wellness. The plan calls for a spe-

cific set of health and safety measures to be instituted based on the level of community spread. Some of the guidelines within the plan include increasing the distance between seating assignments, rearranging classrooms to have students facing the same direction and implementing staggered class changes.

Students, staff and visitors will be asked to self-screen at home for symptoms of COVID-19. If students and staff members experience symptoms of COVID-19 or another illness, they will be required to stay home. Anyone with a fever of 100.4 or greater must stay home. Anyone who develops a fever of 100.4 while on campus will be isolated and sent home.

spread is low or nonexistent, students and staff members will be "allowed" to wear face coverings. If the level of spread is minimal or moderate, students and staff members will then be "expected" to wear face coverings, "especially when physical distancing cannot be main-

Frequent hand-washing of students and staff will be required and administered through the use of "scheduled hand-washing breaks" integrated into their daily schedules. Students will be discouraged from sharing books, materials, supplies or equipment, including devices and equipment used for athletics and band. Hand sanitizing stations will be placed throughout each facility.

Schools will be cleaned daily and frequently-touched surfaces will be sanitized multiple times throughout the day. Cleaning and disinfecting protocols will be used in computer labs, media centers and athletic facilities.

The plan states that the health department will determine whether a closure is warranted, the length of the closure, the number of schools impacted based on the specific incident and risk level within the community. Based on the level of community spread of the virus, the health department and other state or federal health officials may prescribe additional mass closures. If a closure is ordered, students will transition to the virtual

level of community spread of COVID-19. If it becomes substantial, students will be required to attend school remotely. For online instruction,

delivery location. Transportation for students will continue to be provided, however, to prevent the spread of illness, particularly COVID-19. The number of students allowed on a bus at one time will be limited when the level of community spread is determined to be mild or moderate.

Three surveys were administered to gather input from students and their families for the plan. The first survey garnered

6,664 responses concerning reopening schools. The majority of participants felt enhanced learning, regular hand-washing, limiting classroom seating, and staggering recess and lunch were all "very important factors" when considering reopening. When it came to what

school should look like, survey participants' responses were mixed. The most favorable response was associated with a full-time regular start to the school year; however,

opposed that approach. After reviewing the data,

a significant number strongly

the school system elected to give parents and students the option to choose how students are instructed. The survey indicated 76% of parents and guardians that responded have access to childcare for students who may participate in some form of online learning.

Teachers were also polled during a listening session on July 2. According to survey results, 63.2% of teachers felt comfortable with returning to normal school setting; 67.6% had no restrictions that might impact ability to return to work; 56.7% would like the opportunity to continue remote teaching; 91.7% had reliable access to the internet.

A survey of district staff excluding teachers showed 60.5% of employees were comfortable with returning to normal school/work set ting and 67.6% of employees had no restrictions that might impact ability to return to work.

In other business, the board:

- Approved the purchase of Edginuity, an online and blended learning curriculum, in the amount of \$358,890 to be paid with budgeted fiscal year 2021 general funds.
- Approved the actions relative to superintendent's recommendations in an executive session at the beginning of the meeting. The executive session was held to discuss "appointment, employment and compensation of employees."


