Judge denies bond for motel murder suspect

COVINGTON, Ga. An accused murderer will remain behind bars after a judge denied a motion to set bond for him during a Tuesday, June 23, hearing in Newton County Superior Court.

Judge John Ott said he would not set bond for the suspect, Terry Yates, because Yates had intimidated witnesses into lying about a May 27 shooting during a party at a Covington motel.

The shooting left Nijee Anderson, 31, dead from a gunshot wound to the head, police said.

Yates, 30, is being held in the Newton

County Jail on charges of murder, aggravated assault and tampering with

evidence.

Ott's ruling came



Yates

over the objections of Yates' attorney, Mario Ninfo, who said his client had never been arrested before the incident at Super 8 motel at Alcovy Road and I-20.

Ninfo said Yates is a native of Covington, and needed to be granted bond because he had a wife and minor child at home.

He also suffered from bipolar disorder, among other mental illnesses, which led to him being placed on suicide watch while in jail, the attorney said.

"Everyone he knows is in Covington," Ninfo

He said he was told all those attending the motel room party

had guns and multiple people in the room handling the firearms without regard to safety

led to the shooting. "I don't believe there was intent to kill anybody," Ninfo told Ott.

Hard work rewarded

Covington council hopes one-time first responders hazard incentive boosts morale

By TAYLOR BECK

COVINGTON, Ga. — To boost morale and help avoid potential turnover during "a time of civil unrest," the Covington City Council approved a one-time monetary hazard incentive payment Wednesday night for public safety employees in the amount of \$625 per employee.

During the special-called meeting, City Manager Scott Andrews first suggested the city provide a \$500 incentive to its employees. "As COVID has continued

on and the demonstrations have continued ... and the risk for COVID continues to increase as some of us sit here in masks," Andrews said. "So basically, I've listened to my experts, and at this point I want to do something for them. When I say do something for them, that's for their continuous efforts and everything that they are going to continue to do for us. Because during all

of this, I'd be lying if I said it didn't take a toll on morale. I think this is a gesture that would go a long way." However, Councilman

Don Floyd had one issue with the incentive: taxes.

"I think it's well overdue," he said. "I really appreciate their efforts... I know federal tax will take a toll on anything, but is there any way that it can be made up somehow ... because I don't want them getting a bonus,

and then after federal taxes they get \$150."

After discussion, the council opted to increase the incentive to \$625 so it would equate to approximately \$500 after taxes.

Police Chief Stacey Cotton said the COVID-19 pandemic has taken a toll on his officers and believed the incentive was a good idea.


"When my guys started asking me the question if we could get a bonus like

everyone else, I [told] my guys, 'Our job is to be there ... no matter what the situation is," Cotton said. "But then I had an officer look at me and say, 'Well my family didn't sign on for that. And I have to go home and expose them to all of it.' That's what I think is the issue. It's not the duty that they swore to do on the front end ... this is the one where we — we might take the stress home, we might take the See Rewarded | Page A5

Prosecutors asked Ott to deny bond because Yates had allegedly intimidated witnesses into lying to protect him and was a risk for fleeing the area to avoid prosecution if granted bond.

Police investigators determined the suspect had been drinking and smoking marijuana with others in a room at the motel the night of May 27.

He allegedly went to his truck, retrieved a handgun, shot the victim in the temple, grabbed the gun and got in his truck, Ott was told.

Police reportedly found the weapon used in the incident in a field next to Rocky Plains Road south of Coving-

When officers interviewed witnesses, they first told them Anderson had shot himself in the head but later said they were scared of Yates who had told them to give that false information to police.



√rain your buys, train your supplies, train your trip size and avoid urban demise... Good

training is the prize. Most of us stalled in traffic,



or two per minute and glanced up at a train rattling past on its elevated track bed, filled with commuters reading their papers, gazing out at passing scenery, grabbing a quick nap, calling their spouse on the phone or — in this era of massively defunded transit — clinging to overhead straps in a standing-room-only crowa.

Variations on the locomotive-pulling-cars arrangement include, among others, trolleys, monorails, the Elon Musk hyperloop, the Swiss autotrain that transports people in their cars upon flatcars, and airport trams ferrying passengers to loading gates.

Using technology such as linear induction, in which a magnet on a train moves along an electrified rail, the force is produced by a linearly moving magnetic field acting on conductors in the field and levitating the vehicle, producing a frictionless, smooth ride. Trains can be made to go hundreds of miles per hour. Given their ability to move unimpeded into urban centers —unlike airplanes which must locate on remote fringes trains can deposit passengers much closer to their in-town destina-

High speed trains are thus very competitive with airlines on short hops of 500 miles or less.

And — this is an often overlooked asset of trains — their sturdy construction affords much better survival odds in a crash. To paraphrase a famous quote: "If you in a train wreck, there you is. If you in a plane crash, where is you?"

In this pandemic-afflicted era, trains are not perceived as good candidates for transporting masses of people. Indeed, areas with the highest infection rates are those like New York City, which moves millions around its boroughs crammed into subways cheek by jowl — a coronavirus

But a little known (not to mention used and funded) aspect of train commuting involves adding cars and running trains twice as frequently, which can thin crowds to a manageable level.

And the cost is significantly less, when considering inter-city travel, than adding more airplanes to a route. The latter must be fully crewed with pilots, co-pilots and attendants on each flight and must deal with inclement weather — a condition that rarely affects trains. Trains usually have only an engineer, brakeman, and conductor, with dining car and pullman staff only on long distance routes.

But the most salient feature of trains is the tourism potential they embody. Europe is packed with trains many of them highspeed — that connect its many tourist destinations. Rome, Paris, Amsterdam, Munich beer halls, the Swiss Alps, Barcelona, Scottish castles; during tourist season they are filled to overflowing with crowds spreading out from stations to drop their custom on local restaurants, hotels, guided tours, etc. in a major boost to those local economies with found money.

That's right. "Found Money.'

Found money flows into a local economy when its spenders live and work elsewhere, adding dollars to the tax base without unduly stressing the services. No schools, hospitals, welfare systems and municipal government

structures — excepting

police, fire, OK-maybe



Citizens are crying out for help, that's what we should be giving them

fter taking a three-month break to prevent the spread of the novel corona-

virus, the Georgia General Assembly reconvened



for legislative business on Monday, June 15. Due to these unprecedented times, the Senate conducted business in a different fashion. Instead of recognizing guests and welcoming students to the Capitol, the Senate is instead implementing policies that maintain social distancing, encouraging the use of face masks, frequently sanitizing office spaces and a variety of other practices. While this unprecedented time has put a halt to many of the traditional aspects of session, the change has not stagnated our progress as we passed a number of bills out of our Senate chamber last week.

As state legislators, we have a constitutional duty to pass a balanced budget. This means the government cannot spend more money than it collects

in revenues. While a final budget document had not been agreed early last week, we didn't hear official budget recommendations until later in the legislative session, the Senate Appropriations Committee met on Wednesday to pass the FY 2021 budget using an estimate developed with the Governor's Office of Planning and Budget to make spending cuts of 11% or approximately \$2.6 billion. The budget will have significantly deeper cuts than the budget we originally intended on before the coronavirus devastated our economy.

While some cuts may be needed, we must find innovative ways to make sure we are best protecting the interest of Georgians. These cuts will lead to thousands of employees being laid off, and thousands more being forced to take unpaid days. Additionally, we should not be making detrimental cuts to healthcare and education, which are already underfunded. Our citizens are crying out for help and that's what we should be giving them.

I would like to highlight a couple of bills. The first I'd like to discuss is House Bill 888, the Surprise Billing Consumer Protection Act. Surprise billing happens when an insured patient encounters an out-ofnetwork provider at an in-network facility during their medical appointment. A few weeks later, the patient then receives a surprise bill, or a bill for a number of charges not covered by the insurer. This bill would provide consumer protection against surprise billing by creating an arbitration process, as well as a maintained database of all-player claims and insurer payments. Many of us are in tough financial times, and an unexpected bill is one of the last things we need. I'm in strong support of this legislation because it protects patients from egregious The second bill I'd

like to highlight is House Bill 823, which would create a lifetime disqualification from operating a commercial motor vehicle for those convicted of human trafficking. Often times, these victims are trafficked using commercial motor vehicles. This bill serves as an

initiative to eliminate human trafficking. By enforcing a lifetime ban on any commercial motor vehicle driver convicted of human trafficking, we will deliver a strong deterrent to this behavior.

It's a pity American authorities haven't twigged to this fact.

Found money. Brought to our shores by tourists the world over who have been inundated with pop culture. (A few years ago I visited Norway, where I was amazed to learn they speak better English than we do, and was told they picked it up watching American TV programs.)

What if, in a positive effort to restore the economy from the current unpleasantness with infrastructure projects, we dedicated some of those billions to creating high-speed rail service to all points within say, 25 miles of proven tourist destina-

tions? High-speed rail requires sophisticated trackbeds, reworking crossings to go over or under the tracks, extending electrification to remote areas, building stations, buying and staffing rolling stock, PR and loss-leader type promotions to kickstart the moribund tourism scene into a flood of international visitors, upgrading hotel and bed and breakfast and youth hostel availability, developing a Department of Tourism whose budget incentive is tied to the number of repeat visitors achieved.

What if we set about constructing this system, this found money sump, with the same dedication given to our impressive Interstate Highway Network?

What if a found money tax went into a special fund used to

develop and maintain the system, including busways, trolleys and taxis, hotels and campgrounds, bike and hiking trails and parks — all of which could borrow from it as needed?

What if everything were phased in according to a master plan, with underserved and impoverished areas getting first crack at available funds, and an orderly growth pattern in a pay-as-you-go system was adopted?

Wouldn't that be something? Found money and setting up a system to harvest it continuously... Oh, and I just thought of something: Another type of train is the miniature ride such as the one on occasional Saturdays in Conyers Equestri-

an Park. The trains are scale models with 16-inch tracks, locomotives and cars large enough that people can ride on them at about the speed of an urban scooter.

What if such a system were installed on Peachtree Street, scaled up slightly to a 24-inch wide track operating in a bike lane right of way? It would connect downtown, midtown and Buckhead with slow moving cars, covered to keep out bad weather. A no-frills fun ride that tourists would love to take their kids on. Wouldn't that be a

COVID-19 cases continue rise in Newton

As testing around the state continues to increase daily, so, too, does the rate at which Georgians are contracting COVID-19.

On Thursday, June 25, the Georgia Department of Public Health reported a cumulative total of 71,095 confirmed cases of the novel virus. This marked an increase of 1,714 cases within 24 hours — the sixth time in seven days that Georgia saw a bump of at least 1,000 new cases.

The recent spike is being felt at the local level as well. On Thursday, June 18, the DPH reported a total of 452 cases in Newton County. Seven days later, that number had jumped up to 538. The previous seven-day span saw 45 new cases reported for the county, with 25 new cases coming in during the week prior.

These increases can be attributed in part to a continuous effort to ramp up testing in Georgia.

As of Thursday, the DPH noted that 904,154 tests had been conducted for the coronavirus. This total reflects 757,924 viral tests and 146,230 antibody tests. There were 17,570 new tests -14,690 of which were viral — reported within 24 hours between updates. In addition to the increase in cases, the DPH stated Thursday that Georgia had totaled 10,457 hospitalizations and 2,745 deaths as a direct result of COVID-19. Both of these numbers appear to indicate negative trends, with 144 new patients and 47 new deaths in a

Covington celebrates Juneteenth

Demonstrators join celebrators of observance to air race relations issues

COVINGTON,

Ga. — A demonstration in response to the Black community's treatment by police nationwide and other issues drew a few hundred participants to the Covington Square on June 19 and proved to be the third in a series of incident-free protests in recent weeks.

However, it was the first to feature participants walking along downtown streets and brought a heavy police presence to protect both marchers and speakers on the square, officials said.

Local activist Timothy Birt organized the two-and-a-half-hour event, which combined a protest and speeches with a celebration of the annual Juneteenth observance by African-Americans.

He was among about nearly 200 Black and white attendees who walked along Brown, Clark, Church and Ivy streets chanting slogans like "Black Lives Matter" before giving prepared speeches and talking about their experiences with other races and law enforcement at the Covington Square.

Birt, a Newton County resident, said he and other organizers paid for food, bottled water and snacks which were free to attendees. He called the event "amazing."

"I would have rather had more people come out and speak, but a lot of people aren't ready for that so it's understandable," Birt said. "We definitely want more people to come out so that elected officials, when they come out to these events, they hear the people."

In late May, after a Minneapolis police

officer was accused of murder in the death of George Floyd — an unarmed Black man — it led to demonstrations, violent confrontations and widespread

In Atlanta, a peaceful protest earlier this month preceded a night of vandalism and property damage throughout the city.

However, Covington Police spokesman Capt. Ken Malcom said the June 19 event in Covington "was how you hope demonstrations should be."

"They're emotional, but the ones we've been dealing with have been very positive," he said.

He noted a prayer vigil and two similar demonstrations in recent weeks also were peaceful.

Sheriff Ezell Brown, who spoke throughout the event with attendees, said he knew it would be a positive and incident-free event after talking to organizers

including a group which had created past Juneteenth celebrations.

"I didn't see any problems," Brown said. "Juneteenth has been a day of celebration, and I thought we had a peaceful march from the church to the square and there and back."

Speakers touched on a variety of issues tied to race relations, including requests for continued support from white residents for changes in policing in the Black community; and the need for Black people to become involved in their government to bring about needed change.

Birt said he wanted attendees to see the event "not as a protest

but a celebration."
Gregory Brown said events in 2020, such as the death of Ahmaud Arbery in southeast Georgia, brought members of different races together and "allowed us to hear each

other" on the need for changing how the Black community is treated by law enforcement.

"When we collectively talk, leaders listen to us," he said.

He also spoke of the need for people of different races to communicate to clear up misconceptions about those with whom they are unfamiliar and "attack a system that allows people to be racist."

"There's no way we can change the system without changing our hearts," he said.

Gregory Brown also encouraged young Black people to work to educate themselves, own businesses and buy land to increase their political clout

their political clout.

Tyler Still asked the crowd to contact members of the Newton County Board of Commissioners to ask them to remove a controversial Confederate statue from the northwest side of the Covington

Square.

State law now requires local officials to move any historical monuments, including those dedicated to Confederates in the Civil War, to "a site of similar prominence" rather than a museum.

Gwen Green, a
Newton County Historical Society member,
referred to signs at
the front of the crowd
explaining the history
of the Juneteenth celebration.

Juneteenth is celebrated on June 19 because Black slaves in Texas learned on June 19, 1865, they were the last slaves in the U.S. to be freed after President Abraham Lincoln's Emancipation Proclamation order became effective more

than two years earlier.
An annual Juneteenth celebration has been organized for many years in Newton County.

sadness home if something bad happens, but ... there could be [children or other family members with health issues] that that public safety official might expose [COVID-19] to. That's their fear."

Cotton said it could cost the police department, and likely other departments as well, a lot more money to hire and train new officers than it would to fund the incentives to help retain existing officers.

After a motion was made, the council approved the \$625 incentive by a vote of 4-1 (Councilwoman Fleeta Baggett abstained due to difficulty hearing the discussion via telephone; Councilwoman Hawnethia Williams

was absent)

was absent.)
The incentive will be paid to approximately 100 employees, including fire department employees of battalion chief rank and below; police department employees of lieutenant rank and below and the "crew" at Covington-Newton County 911, totaling roughly \$62,500.

After the meeting, Fire Chief Jeremy Holmes said he was thankful that the city saw the need to fund the incentives for its first responders.

"So I think from being one of the first departments to have to actually isolate its firefighters from exposure and seeing their concerns about the family and children — that was their concern. Their concern wasn't about their job and helping the patients. It was about bringing it back to their families, and that's real. And that's something that we've made a priority, and obviously from their vote, it shows that we have the council's support in that as well," Holmes said.

Mayor Steve Hor-

ton said there isn't a dollar value anyone could put on what the public safety employees go through each day, especially under todays conditions. But he hopes the incentive is a gesture that can be appreciated.

"Traditional public safety employees are our first line of defense," he said. "And they run against the problems that all of us

would rather not go up against — night or day. And given the nature of COVID-19 in particular ... they don't get to pick and choose the calls they go to.

"When you do that, personally, it starts to weigh on you," Horton continued. "It's an unseen enemy. You can face someone with a gun ... but you can't see COVID-19. And you couple that with

the civil unrest — and I'm not speaking against civil unrest because everyone has the right to protest and have their voices heard — but [officers] are working under stressful conditions already... We see law enforcement officers across the country handing in their notices daily. We've got good people that we want to keep."

Newton commission throws out 2021 budget

Hearings for updated spending plan set in July

Newton County commissioners discarded their 2021 budget plan Tuesday night and will consider another that is more than \$1 million smaller to allow a reduced property tax rate to fund it.

Public hearings are planned for the revised budget plan July 7 at 6 p.m. and July 14 at 5 p.m., after which commissioners will consider final approval at a special called meeting.

The new budget will not contain \$1.07 million that had been planned for a new \$135,000 computer server; as well as more than \$300,000 to pay for budget changes throughout the year and a \$500,000 transfer to the Capital Improvement Fund.

Instead, those items will be funded as needed throughout the year from excess tax collections rather than the budget's General Fund, said County Manager Lloyd Kerr.

"By doing so, we will reduce the budget by that million-dollars-plus mark and we can reduce the (property tax) rate by three-tenths of a mill," Kerr said. "Then that would give some relief to the taxpayers."

After the meeting, Chairman Marcello Banes said he believed the revised plan was the best way to approve a 2021 budget.

"The taxpayers are getting what they want and the services that they needed, and this is an opportunity to take some off the (property tax) rate," he said.

"I believe it's a win-win for the taxpayers, especially citizens whose (fire safety) rating is so high they can't pay their homeowners' insurance," he said. "They need this and they've been asking for this.

"Others in the community who've been asking for more deputies on the road, they get an opportunity to get that," Banes said.

The \$105.6 million original budget was almost 7% higher than the 2020 budget. It included 76 new employees, including 14 new sheriff's deputies and 18 new firefighters, according to county

officials and documents on the county website.

The new firefighters will help man

new fire stations under construction on Gum Creek Road in Oxford, and planned for Dixie Road in eastern Newton.

The property tax rate — also known

as the millage rate — was expected to bring in more than \$3 million for the 2021 budget by remaining at its current level of 13.43 mills because of an expected 8% increase in assessed property values in the tax digest.

The tax digest is the total taxable

The tax digest is the total taxable value of all real and personal property within Newton County. The county finance department had not received final tax digest totals from the tax commissioner's office because the appeal process was not yet completed last week, Finance Director Brittany White said.

Banes asked Kerr to explain the new budget plan to commissioners after hearing some say they had concerns the original budget plan was funded with a property tax rate that would effectively be a tax increase if kept at its current level.

Commissioner Nancy Schulz said rising property values in the past year would lead to increases in property owners' tax bills at a time when many are reeling from job losses related to the coronavirus pandemic.

"Tax collections quite likely will be sluggish, which means that we need to be very careful in adopting a budget for 2021," she said.

Commissioner Stan Edwards said he also had concerns about the level of spending in the proposed budget because of the unknown economic effects of the pandemic.

Commissioner Ronnie Cowan said he did not want to see the need for employee furloughs to help reduce 2021 spending.

He also said employee raises in the budget were "deserved" but he did not see the need to use increased tax revenues created by rising property values for budget needs.

"The digest is moving pretty fast," Cowan said. "I think it's time to start slowing it down."

Speakers during a public hearing

Speakers during a public hearing before the meeting told commissioners they wanted them to address in the budget the removal of a Confederate statue on the Covington Square.

The total budget is a combination of four funds, with the General Fund used for most county operations comprising 71% of the total.

The General Fund totals \$75.4 million, which is up 5% from the General Fund in the 2020 budget.

Almost 75% — or \$3 of every \$4 — of the 2021 General Fund will go to salaries and benefits for regular employees, and purchased or contracted services.

Supplies, capital outlays, debt service and other uses make up the remainder, according to the county's budget document on its website.

Salaries and benefits are planned to increase 8.8%, from \$42.6 million in 2020 to \$46.4 million in 2021.

Increases are due in part to all em-

ployees moving up a step in a pay plan the board approved in 2019, according to the document.

Purchased and contracted services are proposed to rise 8.1%, from \$10.2 million to more than \$11 million, according to the document.

The proposed budget also plans for a 7% increase in health insurance costs; funding new positions for two new fire stations; providing \$505,000 for new sheriff's office vehicles and computer upgrades; and providing matching funds for almost \$1.3 million in federal, state and local grants, according to the budget document.

The county government's property tax rate is levied in addition to the tax rate used to help fund the county school system.

Newton County Arms Race

Preview QB battles at Alcovy, Eastside, Newton

 There's no position in sports quite like the quarterback of a football team.

Right or wrong, quarterbacks are ofttimes given more credit than any other individual for a team's success. On the flip side of the coin, they're also usually under the most scrutiny.

While it's universally understood that it takes a full team to win a game — let alone compete for a championship the question first asked of most football programs when entering a new campaign is, 'Who will lead the offense under center?'

In Newton County, all three Georgia High School Association programs will have fresh faces leading the way during the 2020 season. Newton and Eastside will be looking to replace graduated veterans, while Alcovy finds itself in the midst of a transitional period. All three head coach-

es spoke with The Covington News this week to discuss how their quarterback rooms are shaping up heading into the final week of June.

Alcovy High School

Jason Dukes' first season as head coach at Alcovy saw the Tigers experiment at quarterback late in the year.

Sophomore M.J. Stroud was tabbed as the starter going into the 2019 campaign. Touted as one of the best receivers in the area as a freshman, he underwent the growing pains of transitioning into a new position, but shone brightly under the spotlight.

By season's end, however, Dukes realized that Stroud's athleticism could be better utilized by plugging him in at different spots on the field. So prior to the Tigers' season finale against Greenbrier, he handed the starting quarterback job to freshman Ashton

As he now prepares for his sophomore year, Evans is slated to begin the season as Alcovy's starting quarterback. Despite his lack of experience he took limited snaps

throughout the season when Stroud dealt with injuries prior to making his lone varsity start — Dukes believes the young gunslinger is up for the task.

"It's one thing to throw a green freshman in at the beginning of the year and expect him to successful. There's another thing to have him kind of be a backup for the majority of the year and then feel comfortable putting him in at the end of the year," Dukes said. "He is a good player."

While Evans appears to be in the driver's seat, Dukes noted that the evaluation period is still ongoing. Evans showcases a stronger arm than Stroud, but Stroud's ability to extend plays with his legs while also making some quality throws leaves him in the mix.

"M.J., I believe, is a kid that can help us in several different positions," Dukes said. "You can expect to see

him moved all around the field, including taking snaps at quarterback.'

The Tigers operated their offense out of the spread formation in Dukes' first season at the helm. Their plan is to run a similar scheme, but with a heavier emphasis on offensive linemen winning battles in the trenches.

Breaking in a new quarterback isn't always an easy task. It's made even more difficult when a pandemic causes an unorthodox schedule, resulting in no 7-on-7 drills or pass-

ing camps before July — and no timetable for their return.

Fortunately, Alcovy is in the same boat as every other team in the GHSA. And while the search continues for answers about when football teams can resume standard operating procedures, Dukes is ensuring his kids — including his quarterbacks — remain mentally prepared.

"We haven't even been given a schedule to return to school next year. If you constantly think about that, it can paralyze you from preparing for the things that you need to do right now and today," Dukes said. "Our focus as a team is on taking every day for that day and doing our absolutely best job in getting better."

Eastside High School

The Eagles are tasked with replacing a threeyear starter at quarterback this season.

Noah Cook graduated from Eastside and will be taking the field for Garden City Community College this fall. Stepping in to fill Cook's shoes will be senior Jaylen Woods, who spent last season as one of Cook's primary targets at wide receiver.

Eastside head coach Troy Hoff believes the experience Woods garnered from starting at receiver on Friday nights — in addition to serving as Cook's backup — will pay dividends when the bright lights hit this year.

"I think it's helped

GHSA to add shot clock for high school hoops

A shot clock is coming soon to high school basketball in the Peach State.

The Georgia High School Association passed a proposal Tuesday to mandate the use of a 30-second shot clock for all varsity basketball games. It will be phased in through a three-year implementation period, beginning with the 2020-2021 season.

Georgia is now the ninth state in the nation to implement a shot clock for varsity basketball games, joining California, Maryland, Massachusetts, New York, North Dakota, Rhode Island, South Dakota and Washington.

Beginning this winter, the shot clock will be used by the GHSA only in approved holiday tournaments and showcase games. It will not be permitted for use in region games or playoff contests. Schools will have permission, however, to mount shot clocks on the top of backboards or set up portable clocks in the corners of

During the 2021-22 season, the shot clock will be approved for use in tournaments, showcase games and region play, so long as

the region permits it. The 2022-23 season

will see shot clocks used in all varsity basketball games throughout the regular season and state playoffs.

While the approval of shot clocks was the most notable takeaway from Tuesday's meeting, the GHSA's Executive Committee also approved proposals for considerable changes in cross country and track and field.

In cross country, teams will no longer compete in area meets throughout the season. Instead, they'll hold

Safety concerns lead to Fourth of July cancellations, postponements countywide

Most traditional Fourth of July events in Newton County have been postponed or canceled this year in response to safety concerns around the coronavirus pandemic.

Officials in Covington, Oxford and Porterdale decided to postpone or cancel popular holiday events because of their concerns about transmission of the disease among expected crowds.

Officials in the city of Oxford canceled an annual tradition because of concerns about the safety of attendees attending a live event during the ongoing pandemic.

The city of Oxford and the Oxford Lions Club in past years hosted a morning parade on July 4 followed by an event featuring food vendors and live entertainment at the historic Old Church on Wesley Street.

However, the city council "out of an abundance of caution" opted to cancel the annual event, said City Manager Matthew Pepper.

The Porterdale city government chose not to plan a fireworks show for this year because of safety concerns related to the disease, city officials said.

In a statement, Mayor Arline Chapman and Interim City Manager Robert Witcher said, "Due to the public health and safety recommendations issued by the CDC concerning COVID-19, the city of Porterdale will not be hosting an Independence fireworks display in 2020.

"Since March 26, when the city issued a Shelter in Place Ordinance and Resolution, and following all special orders issued from the governor's office, the safety and health of residents and visitors has been of utmost concern for the city.

"With the recent up rise in cases, it is important to insure that every opportunity is taken to prevent the transmission of COVID-19.

"We wish our citizens

safe and happy Fourth of July and to celebrate freedom and peace this Independence Day."

Covington City Council voted in May to reschedule

the annual Stars and Stripes Fest and its popular fireworks show to Labor Day weekend.

due to the COVID-19 pandemic.

The council voted to postpone the event to Sept. 6 amid concerns about the safety of the event during the pandemic because of the large crowds that typically gather to watch it.

The Stars and Stripes Fest typically includes food vendors, live music and a large-scale fireworks show that attracts crowds estimated at up to 50,000 to the area around the Covington Square on July 4.

Council members reportedly decided to reschedule the event to Sept. 6 because it would lessen the impact on some businesses that close on Sundays.

Officials in the city of Social Circle decided to go ahead and host a fireworks display this weekend on Saturday, June 27.

The northeast Newton County city was set to host a fireworks display this weekend and allow the public to attend at Stephens Park Field.

But the Boys & Girls Clubs of North Central Georgia's annual Duck Derby was to be done without an audience lining the banks of the Yellow River in Porterdale and only accessible via Facebook.

It featured 6,000 rubber ducks "adopted" by donors which are released on the Yellow River.

him see the big picture from playing receiver and now being in both spots," Hoff said. "As far as moving forward in our offense, he's got a real solid grasp of what we do because he's been doing it. It's a new role for him, obviously, but at the same time he's done an excellent job of transitioning into it."

Last year, Eastside sliced up opponents with an up-tempo spread offense. Woods and Cook are their own players, and tweaks will be needed to tailor the team to the new quarterback, but Hoff plans to continue taking a similar schematic approach to the offense.

"As coaches, I think the part of our job—the main part of our job—is to make changes work with our personnel," Hoff said. "I think we're flexible enough in our schemes that we can mold it to the players we have and see what Jaylen likes to throw, what he's comfortable with."

Woods' transition into the spotlight will be interesting to watch. While his varsity experience at wideout gives him a leg up over many first-year starters, Eastside's staff understands the approach they must make to afford the new guy time to adjust to his role.

"I know the first night under center will be different, but our approach with him is to play football. It doesn't have to all be on him," Hoff said. "That's part of our job as coaches is to have a diverse enough attack where it can spread the ball out to run or pass, so it's not all on the quarterback to have to win it every night."

Newton High School

After the departure of senior quarterback Neal Howard, rising junior Jevarra Martin has emerged as the favorite to lead the Rams offense in 2020.

The left-hander has piled muscle onto his six-foot, four-inch frame this summer and is set to enter July at roughly 210 pounds. Martin is still working to correct his footwork and nail down his timing, but his

build, experience and leadership qualities have made him a frontrunner for Newton.

"I don't expect anything less than Jevarra coming out and really moving us forward. It's his job to lose," Newton head coach Camiel Grant Jr. said.

Martin was the ace of Newton's baseball staff this spring and has started for the club since his freshman year. Grant Jr. stated that despite it being another sport, he believes Martin's experience of starting at the varsity level — notably being in a position that isolates him on the mound and calls for the team to lean on him — will transition well into playing quarterback.

Martin had a close relationship with Howard during his time with the Rams. The two have continued working out and throwing together this summer as Howard has taken it upon himself to help groom his replacement.

Grant Jr. believes that Martin has shown enough growth — both at the mental and physical level — to prove that he's ready to control Newton's spread attack.

"Jevarra understands what we're doing on offense," he said. "He has a different skill set than Neal; he's more of a pocket passer. He can push the ball downfield a little bit more with his arm strength. Some things we may feature a little bit different than last year. We're excited and we think he's ready."

Waiting in the wings for the Rams this season will be rising freshman Riley Scruggs. After showing tremendous potential during his eighth grade season, there's a lot of hype surrounding the young gunslinger. He'll need time to adjust to the speed of varsity competition, but could make a splash for the Rams in a year or two if he continues to develop.

"We're excited that he's going to be able to push Jevarra a little bit and create some competition in the room," Grant Jr. said. "I'm also excited about what he can do for on the JV team as he learns."


Report: Egg production down 5% in May

United States egg production totaled 9.10 billion during May 2020, down 5% from last year. Production included 7.86 billion table eggs, and 1.24 billion hatching eggs, of which 1.15 billion were broiler-type and 85.6 million were egg-type. The average number of layers during May 2020 totaled 386 million, down 4% from last year. May egg production per 100 layers was 2,357 eggs, down 2% from May 2019.

Total layers in the United States on June 1, 2020 totaled 384 million, down 3% from last year. The 384 million layers consisted of 320 million layers producing table or market type eggs, 60.9 million layers producing broiler-type hatching eggs, and 3.16 million layers producing egg-type hatching eggs. Rate of lay per day on June 1, 2020, averaged 75.6 eggs per 100 layers, down 3% from June 1, 2019.

Hatcheries in the United States weekly program set 235 million eggs in incubators during the week ending

June 20, 2020, up 1% from a year ago. Average hatchability for chicks hatched during the week in the Unit-

ed States was 82.1%. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

Hatcheries in Alabama set 33.0 million eggs during the week ending June 20, 2020, up 4% from a year ago. Hatcheries in Georgia set

34.6 million eggs during the same week, down 3% from a year ago.

Broiler growers in the United States weekly program placed 189 million chicks for meat production during the week ending June 20, 2020, down 1% from a year ago. Cumulative

placements from the week ending Jan. 4, 2020, through June 20, 2020 for the United States were 4.64 billion. Cumulative placements were down 1% from the same period a year earlier.

Broiler growers in Alabama placed 24.6 million chicks for meat production

during the week ending June 20, 2020, up 10% from a year ago. Placements in Georgia totaled 27.7 million chicks, down 4 percent from a year ago.

USDA provides flexibilities to ensure kids receive meals this fall

WASHINGTON. D.C. -U.S. Secretary of Agriculture Sonny Perdue recently announced a range of nationwide flexibilities to ensure America's children receive the nutritious food they need throughout the upcoming school year. These waivers give states, schools, and childcare providers time to plan for how they will serve children in the fall, including allowing for new and innovative feeding options as the

nation recovers from

the coronavirus. "As the country re-opens and schools prepare for the fall, a one-size-fits-all approach to meal service simply won't cut it," Perdue said. "The flexibilities announced today give states, schools, and child care providers the certainty they need to operate the USDA child nutrition programs in ways that make sense given their local, on-the-ground situations and ensure America's children can count on meal service throughout the school

As fall nears, schools are considering many different learning models. This announcement empowers them to operate the School Breakfast Program (SBP) and National School Lunch Program (NSLP) to best serve their students throughout the 2020-2021 school year. It also allows providers in the Child and Adult Care Food

Program (CACFP) to tailor operations to serve the children in their care. USDA is providing flexibilities around meal patterns, group-setting requirements, meal service times, and parent/guardian pick-up of meals for kids across all three programs to address anticipated changes for the coming school year.

USDA is also announcing a new flexibility that waives the requirement for high schools to provide students the option to select some of the foods offered in a meal. While this practice, known as "offer versus serve" is encouraged, social distancing or meals-in-the-classroom models would make this regulatory requirement difficult. Collectively, these waivers reduce barriers to meal service options that support a transition back to normal operations while simultaneously responding to evolving local conditions.

The following nationwide waivers will remain in effect through June 30, 2021 for the SBP, NSLP, and CACFP. These flexibili-

ties allow for:

• Meals that do not meet normal meal pattern requirements when necessary to keep kids fed;

 Meals to be served outside of group settings and outside of standard times to facilitate grab-and-go and other alternate service options; and

• Parent/guardian pick-up of meals for students participating in distance learning

distance learning.

The new waiver applies to the NSLP's "offer versus serve" requirement for high schools, which would be difficult to execute while maintaining social distancing, particularly if meals are prepackaged for in-classroom or graband-go service.

Food and Nutrition Service (FNS) previously extended numerous waivers through the summer months to give summer program operators the continued flexibility they need to leverage innovative solutions in support of social distancing - such as delivery and grab n' go - without interruption. These waivers ensure all children can access free meals throughout the summer. Families can use FNS's Meals for Kids interactive site finder to locate free meals for children ages 18 and under this summer at 67,000 sites across the nation.

Today's actions are part of USDA's focus on service during the COVID-19 outbreak. To learn more about




