Covington man accused of illegal voting

State Election Board alleges resident cast ballot as non-citizen

ATLANTA — A Covington resident was listed among organizations and individuals that a state agency on Wednesday, Feb. 10, referred for criminal prosecution for alleged violations of state election

The State Election Board bound over Sean Watson of Covington for prosecution for allegedly being a non-citizen and voting, according to a Georgia Secretary of State news release.

The Election Board listed Watson among 34 cases it recommended that local district attorneys or the state attorney general prosecute for violating state election laws.

Watson registered originally in November 2008 and said he was a U.S. citizen because he believed he automatically became one when his mother obtained her citizenship, the Newton County Board of Elections reported.

He voted in the November 2008 General Election, a November 2012 Special Election and the November 2018 General

However, he did not meet the criteria to become a citizen under derivation,

Commissioners approve plan for skatepark at Denny Dobbs Park

COVINGTON, Ga. — Newton skateboarders may only have to travel to the county's west side for a skatepark by the end of the summer this year.

The Newton County Board of Commissioners recently approved the use of Special Purpose Local Option Sales Tax (SPLOST) funds for construction of a skateboard park in Denny Dobbs Park on Georgia Hwy. 212.

The board approved a contract with low bidder Grindline Skateparks Inc. of Seattle, Washington, for \$189,875.

Funding is coming from the recreation part of the SPLOST voters approved in 2017, county records show.

State coroner council to consider removing Bailey-Butts' certification

Hearings would precede judge's decision on job, council's decision on pay

 Newton County's coroner is facing both losing her salary or her elected position after the county manager recently began the process of removing her

from office.

The Georgia Coroners Training Council is scheduled to meet later this month and could consider removing Dorothea Bailey-Butts' certification that state law requires she have before she can receive

her salary, said Chairman Richard Stanley of Dub-

a coroner is required to hold to receive her \$35,000 annual salary from the county.

The Georgia Administrative Code that governs the Coroners Training Council states, "No coroner shall charge or collect any fee, charge, or cost of any kind for his services unless such coroner is properly

certified."

The five-member Training Council can remove a coroner's certification if the holder of the office, "Is unable to perform the duties of the office with 'reasonable skill and safety to citizens' because of illness, use of substances, or the result of a physical or mental condition."

Other instances in which the Council can remove certification are for conviction of a crime involving "moral turpitude," or crimes classified as felonies or involving marijuana or a controlled substance.

However, the law is not clear how long she must be in office to

Newton legislator says proposed circuit split unlikely

COVINGTON, Ga.

— One local legislator says chances of Newton County's request to break away from the Alcovy Judicial Circuit and create its own was unlikely to happen.

District 112 State Rep. Dave Belton, R-Buckhead, who represents portions of Newton and Morgan counties, said he found the Newton County Board of Commissioners' decision to request a circuit split "very surprising" and unnecssary.

"I don't see any reason for it," Belton said.
"It's a surprise move that I can't see a reason for making because, to my knowledge, the caseload is manageable."

Belton said it was also surprising due to the fact that a proper study needed to be completed and the governor needed to make room in the state's budget for such a move — of which neither had been done.

Newton commissioners voted 3-2 during its

meeting Tuesday, Feb. 2, to formally request legislators to consider breaking up the Alcovy Judicial Circuit that includes Walton and Newton counties and allow Newton to create its own single-county circuit.

Belton and other representatives had planned to meet Wednesday night or Thursday to further discuss the proposal, but due to the manner of the vote, he said the chances of state legislators moving the issue forward was "very"

unlikely."

Because the potential bill would involve multiple counties, Belton said it's not just up to Newton County legislators to consider.

"Generally, on a local bill, we don't like to have more than one opposing vote. We prefer it to be approved unanimously or only one opposing vote for us to push it further," Belton said. "Since it's not local, it's very unlikely that the [state] leadership will take this any

'Sweet Magnolias' to begin season 2 filming in late March

COVINGTON, Ga. Production of one of Netflix's most popular series is expected to get back underway soon in Newton County.

Spokespersons for "Sweet Magnolias" recently notified residents and businesses of Covington that the production crew would return toward the end of March to begin filming its highly anticipated second season.

"Sweet Magnolias" is based on a book series by Sherryl Woods and centers on the lives of three women, including a restaurant owner, attorney and a recently-divorced woman, in the fictional town of Serenity, South Caro-

Covington doubles as "Serenity" and such locations as the Craig law firm, the Lee-Porter House, Mystic Grill restaurant, Southview

Cemetery and The Depot Sports Bar & Grill have been used in the show.

In a statement to *The* Covington News, Location Manager J. Brad Smith and Key Assistant Location Manager Matthew David Sparks said the production team was excited to be back in Newton County. Specific filming dates and locations were not disclosed but

are expected to be released soon, according to the statement.

The production crew is also taking a strong approach to filming during a global public health crisis, making

itself available for any feedback or concerns about the filming pro-"We understand that

COVID-19 is of great concern to the community and it is one we are taking steps to address when filming on location," part of the statement reads. "Our top priorities are to ensure safety and alleviate and concerns while we are guests in your neighborhood."

Daniel Paulson, the show's producer, told The Covington News in a July interview that his company opted to shoot in Covington after scouting locations in Savannah as well as Baton Rouge, Louisiana, and Charleston, South Carolina, Paul-

son said. Paulson said he chose the city as the primary outdoor location for the show — it also uses locations in McDonough and Decatur — for a

variety of reasons.

Despite the ease of shooting in a smaller city, unlike Atlanta, Paulson said the biggest reason for choosing Covington was largely due to the warm wel-

"I got a nice feeling about the town — the way we were welcomed," Paulson said.

"The police force, the various store owners, they welcomed us," he said. "Some places may not be as welcoming and friendly — that happens."

The Netflix series initially announced it would return for a second season July 23 after its first season just a few months after it went live May 19. Based on ratings numbers reported by various industry publications, it quickly became one of the hottest shows on the streaming

Porterdale

Council orders church to close warming center for homeless

Porterdale does not allow them in zoning laws, officials say

PORTERDALE, Ga. -Porterdale council members bowed to residents' wishes Tuesday and voted to order a church to stop operating a temporary warming center for the area's homeless in a

city neighborhood. Council members voted unanimously for the action Tuesday, Feb. 9 — which led Mayor Arline Chapman to tell Rainbow Covenant Ministries officials to stop using their Hemlock Street building to provide shelter and meals to area homeless residents after they closed

Wednesday, Feb. 10, at 9

Neither warming centers nor homeless shelters are permitted uses under the city's zoning ordinance, said City Manager Frank Ether-

Rainbow officials, led by Senior Pastor Clara Lett, told city council members at a special called meeting Tuesday, Feb. 9, they opened the warming center in their church building at 9 Hemlock St. on Feb. 3.

Lett said they offered the center to homeless people who live outdoors in makeshift camps or wooded areas of Covington and Porterdale.

"That's our main goal just to serve the community, Rainbow board member Catherine Warner said.

Lett said she found suitable locations were cost prohibitive in other areas of the county and board members

then decided to open the warming center in Porterdale, she said. The church planned to operate the warming center seven days a week from 5 p.m. to 9 a.m. through April 1, Lett said.

She said it was sanitizing the interior and taking daily temperature checks on the five or so individuals staying there to protect against the spread of COVID-19.

It also offered them shower facilities and beds, and a Covington restaurant pledged it would donate meals, Lett said.

In addition, church members were traveling to locations on Washington Street and the former Kmart shop ping center on Turner Lake Road in Covington to offer homeless residents transportation to the Porterdale

church, Lett said. City officials said they had little knowledge of the facility before the meeting.

Porterdale residents, meanwhile, essentially lined up to say they opposed the church using its building as a temporary warming center.

Complaints included its location in a residential neighborhood and the possibility that homeless people would remain at the building beyond the planned 9 a.m. ending time for its use.

Steven Daniel said his parents were forced to have 24-hour surveillance of their property near the church when a homeless shelter operated there in prior years.

Another resident, Ross Adams, said church officials should have received city permission to open the warming center just as homeowners must receive city approval for design changes in some parts of town.

Rainbow is not allowed to

operate a permanent homeless shelter in Porterdale under a prior legal agreement.

service.

Porterdale filed a lawsuit against Lett on the grounds that a homeless shelter she formerly operated in the city was not in compliance with its zoning regulations.

The suit was postponed at the end of 2006 when a new location for the shelter was found on Turner Lake Circle in Covington, according to a

past news report. Other Porterdale residents warned about the possibility that homeless residents' usage of the center would increase once word spread it

was available. After council members unanimously voted to order its closure, a defiant Lett said she planned to find a different way to offer the same

service at the church. "We'll have a revival there every night," she said.

Alcovy Judicial Circuit DA warns of scammer trying to collect money for missing jury duty

COVINGTON, Ga. The district attorney is warning that anyone trying to collect a fine in-person for missing jury duty is a fraud because of requirements

for notification spelled

out in state law.

Covington Police were on the lookout this week for a man who reportedly scammed a restaurant worker after telling her she owed money for missing jury

An officer reported responding to a call Tuesday, Feb. 9, from a worker at Your Pie on the Covington Square.

The worker said a man identified himself by name and said he was a judge and she had missed a call for

jury duty. He then said she owed \$189 and she told police she sent the money using the Cash App mobile digital platform to the account CCCGOV.

The victim said she later found she never got a notice in the mail for jury duty, a report stated.

District Attorney Randy McGinley said state law requires "notice and hearing" before an individual can be punished for failing to

appear for jury duty. The law says, "If any person is drawn as a juror and duly summoned to appear as such at court, or summoned as a tales juror, and neglects or refuses to appear, or if any juror absents himself or herself without leave of the court, said neglect, refusal, or absence may, after notice and hearing, be punished as contempt of court."

"Therefore, anyone demanding money over the phone or in person, is a scammer," McGinley said.

He said contempt powers do allow a judge to impose a fine

or a sentence to jail. "However, a hearing would be held in court and allow the person who missed jury duty to provide an explanation to the court," McGinley said. "The notice for such a hearing is done by personal service by the Sheriff's Office.

"A judge would not contact an individual directly. Any fine that would be imposed after notice and hearing would not be payable to a Cash App account. That is not how the Clerk's Office receives payments."

Anyone who believes they may have missed

jury duty should contact the Newton County Clerk of Courts office at 770-784-2035, he said.

Another friend told me, "My brother and I were always close and I thought he hung the moon. But I have lost some respect for him. It's painful to constantly be at odds over politics. Senator gives GRACE Commission full support

uring the third week of the legislative session (Jan. 26-29), the Senate took an

important first step in fulfilling our constitutional obligation of passing a balanced budget.



The House, after holding a series of Appropriations Committee meetings, passed out their version of the Amended Fiscal Year 2021 Budget. Now, the

budget has been sent over to the Senate for review.

The budget process is lengthy and provides lawmakers with numerous opportunities to examine the budgetary needs of our state departments and programs and evaluate which areas need more funding and where some funds can be reallocated. Thankfully, Georgia's economy has remained resilient through the COVID-19 pandemic and we are now in a position where we can begin restoring funds to areas that experienced

cuts during our last budget cycle. Our Appropriations Subcommittees convened for a long day on Friday to begin fine-tuning the bill that passed the House on Thursday. These hearings will continue on next week and, when the Appropriations Committee is satisfied with the final product, the budget will be heard in

the Senate for a vote. While discussions around the budget continued, I also had the opportunity to chair my first meeting of the Senate Judiciary Committee. Some of the most important bills of the session will likely come before our committee to be vetted and receive feedback from our members. This is an important task, but our committee contains combined decades of legal expertise, along with other subject matter experts in their fields. I am thoroughly looking forward to working with my committee members to ensure every bill that passes out of

our committee. Last Wednesday, Gov. Brian Kemp held a press conference to provide an update on the work of the GRACE Commission. The work of the commission is critically important, as they are tasked with combatting the vile practice of human trafficking in our state. While the GRACE

Commission is tasked with

bringing to justice those

who exploit others for servitude, it is also compelled to bring much needed aid and assistance to the victims who have suffered under this heinous crime. For this year's priorities, the Commission laid out three priorities: legislation allowing victims of human trafficking to legally change their names, creating a mechanism which would allow victims to sue anyone who knowingly benefitted from their trafficking, as well as requiring renewal applicants for Commercial Driver's Licenses to participate in an anti-human trafficking course in order to receive their license. As a legislator honored to have carried legislation emanating from the GRACE commission last year, I fully support their goals for the session and look forward to using my position on the Judiciary Committee to advance these bills.

Next week we will continue to hold Appropriations Subcommittee meetings in order to ensure this budget strikes the correct balance of fiscal responsibility, while still ensuring vital state services and agencies receive the funding they need to operate efficiently.

news release stated.

Students interested in attending must participate in a series of interviews and should be able to speak eloquently and in great detail about their field of study.

They are students who desire to work with their subject outside of school and go above and beyond, the release stated.

Students may be nominated in Communicative Arts (ELA), all Foreign Languages, Math, Science, Social Studies, Dance, Music, Theater, Visual Arts, Engineering, and Agriscience.

Nikkita Warfield, director

of secondary schools for NCSS, said, "Congratulations to our students who have been named semi-finalists in the 2021 Governor's Honors Program."

"These students persevered and worked tirelessly to complete many rounds of revisions to get their applications and essays prepared for the semifinalist round," Warfield said. "They did not allow the restrictions of COVID to stop them from reaching their goals.

"It is nice to see so many students so passionate about a subject area, that they wish to participate in a program to learn more in-depth information about the topic," she said. "I commend them and wish each of them well in the next phase of the Governor's Honors Program." Warfield said each school

has an Honors Program coordinator. "The coordinator informs

teachers about the program and asks teachers to nominate students who are highly talented and qualified to meet the criteria of the program," Warfield said. "After the teachers provide

the coordinators with student names, the coordinator meets with students to provide

them with an overview of (Governor's Honors) and how the nomination process


"Additionally, the school-level (Governor's Honors) coordinator checks to ensure students meet the criteria. If the student meets the criteria, the coordinator informs the teacher and has the teacher complete the (Governor's Honors) nomination form.

"The teacher completes his or her portion as well as assists the student with filling in his/her nomination information (essays)."

Warfield added that "due to COVID-19 restrictions, this year's interview process was virtual and centered around the students' application and essay."

"If selected as district winners, the students' names are submitted to the Governor's Office of Student Achievement (GOSA). The students are next contacted by GOSA to complete a state application in efforts to be selected for state interviews.

"If selected, students become semifinalists and then compete in state interviews. Students selected as finalists from state interviews will have the opportunity to participate in the (Governor's Honors) summer program."

A total of \$160,000 will be used for construction of the project's approximately 4,000-squarefoot first phase, with the remainder used for pre-construction work and an overall master plan for the facility, said county capital projects manager Jeff Prine.

He said recreation officials met with Grindline to begin work on the project Feb. 8.

Mask, a 30-year veteran of the department, said he had never worked on a similar recreation project.

"I'm kind of excited to see it done," he said. "I've gotten quite a few calls about it.'

He said he expected

county residents will have "good usage" of the facility.

"We've got quite a few skateboarders here," he said.

Nearest skateboard parks are in Gwinnett County and in Clayton County, according to an online search.

Prine said the overall plan Grindline will complete will include a facility covering an estimated 1.5 acres in the southwest Newton County park at a total

cost of about \$750,000,

County officials have not identified funding for its construction but sources could include future SPLOST referendums, Prine said.

Grindline has built skateboard parks worldwide, including one in Denmark and in 22 U.S. states including Hawaii and Alaska, ac-

cording to its website. In Georgia, it recently completed a park in Hapeville and built the 6,000-square-foot Arthur Langford Jr. Park Skatepark in Atlanta in 2015.

which refers to a law that allows children of non-citizens to meet certain criteria to automatically become citizens if their parents become citizens before the child reaches 18 years of age, said Phil Johnson, chairman of the Newton County Board of Elections.

The Newton County Board of Elections discovered the discrepancy in 2019 when checking driver license renewal applications against existing registrations, Johnson said.

He said the Newton elections office notified Watson that he had to

prove citizenship by letter on April 12, 2019; July 12, 2019, and July 17, 2019.

When Watson did not respond, the elections office referred the matter to the Secretary of State's office, Johnson said.

District Attorney Randy McGinley said he was unsure Thursday, Feb. 11, if his office or the State Attorney General will receive the case for prosecution.

McGinley said the state law defining the duties of the State Election Board says the board will report violations "either to the Attorney General or the appropriate district attorney who shall be responsible for further investigation and prosecution."

"The law does not provide any distinction as to which agency the report should be made to, so it appears that decision is solely up to the Board," he said.

"If my office does receive any report from the Board, we will completely review the facts and circumstances of the incident reported before making a decision as to what action my office will take," McGinley said.

An effort to reach Watson for comment proved unsuccessful. The Secretary of State's Office investigation division has

23 sworn officers with arrest power and experience as detectives in law enforcement, a news release stated.

They investigate allegations of voting

allegations of voting irregularities and present their findings to the State Election Board, which can levy fines, issue a letter of instruction or refer the case for prosecution, the release stated.

Secretary of State

Brad Raffensperger, chairman of the five-member Election Board, said, "Election fraud is not tolerated in Georgia. When there is evidence of it, the people responsible face prosecution."

"Georgia has multiple safeguards in place that allow our team of investigators to discover fraudulent voting," he said. "They worked to catch the wrongdoing in these cases, and they maintain the security of Georgia elections."

Among other cases the Election Board bound over for prosecution Wednesday were four incidents of felons voting or registering to vote, four cases of non-citizens voting or registering to vote and one case of misplaced ballots during the 2020 general election, which didn't change the outcome but did affect the total, the release stated.

The Board also sent for prosecution charges against canvassers for two organizations trying to register people to vote, including one who allegedly submitted registration applications they knew were false, the release stated.

satisfy the basic training requirements for certification. Bailey-Butts took office Jan. 1 and only recently attended her first training course after an initial training session was postponed because of COVID-19.

If the Council votes to remove her certification, the coroner can request a hearing to contest the action.

Meanwhile, the process of removing a coroner from office begins with someone informing the governor about the need for an investigation into the coroner's actions.

The governor then determines if the investigation is

needed because of pending criminal charges, alleged misconduct in office, or alleged incapacity of the coroner to perform the functions of the job, according to state law.

If the governor agrees, he then forms a committee made up of members or either the Georgia Coroners Association or the Training Council—the law does not specify which group—to launch an investigation and report its findings within 30 days.

Depending on the committee's recommendation, the governor may suspend

the coroner for up to 60 days and recommend the District Attorney file a removal petition.

A Superior Court judge then would make the ultimate decision to remove the coroner from office for reasons "including incapacity or misbehavior in office" following a hearing before a

The law states the process for removing a coroner mirrors the process for removing a Superior Court clerk.

A spokesperson for the Georgia Attorney General's office declined comment about the parts of state law

surrounding a removal from office.

County Manager Lloyd Kerr filed a petition Jan. 29 with the Coroners Training Council to seek an emergency injunction to prevent her from continuing in the elected position "effective immediately."

The allegations against her include refusing to transport a body from a fatal wreck on Georgia Hwy. 212 last month despite its requirement in state law.

She also possibly destroyed evidence and mishandled the body of a suicide victim; and left a deceased

hotel patron in plain view of other guests and employees, according to the petition.

Kerr's petition also includes other allegations against Bailey-Butts for actions she took between taking office Jan. 1 and Jan. 29 that he said show that "she is wholly unable to competently serve as the county's coroner."

The additional allegations range from possibly being mentally unstable; to saying she had damaging information in an effort to force the county commission to approve more money for her office.

further, or the governor for that matter."

If the county's request were to be approved, Belton said there was "a long road ahead." Specifically, he said splitting the judicial circuit could take up to five years, if legislation were passed.

And if the circuit were to be split, Belton said doing so could get expensive.

"To my understanding, the governor would have to budget this in," Belton said, "and now is not a great time fo add to the budget. There are a lot of other issues including [several education and health care issues]."

In a recent statement to The Covington News, District Attorney Randy McGinley said the commissioners' move to break away and create its own circuit was a political ploy.

"This resolution was added to the agenda during the afternoon of the meeting date, mere hours before the scheduled meeting," he stated. "It appears that such last minute additions to the agenda are allowed when the

matter is urgent or time sensitive. However, not a single reason why this matter was urgent was discussed. Instead, a copy of the proposed bill was already attached to the proposal which clearly indicates that this proposal was already in the works well before the day of the meeting. The late addition to the agenda precluded anyone with knowledge of the court system, the DA's office, and the potential financial impact to appear at the meeting ready to discuss the matter.

"I personally found out about the resolution just hours before the meeting time. I was unable, with such extremely short notice to have someone pick up and care for my 4- and 1-year-old daughters.

"The county commission has the power and right to vote on whatever resolutions they choose. But it is disappointing that a vote on a complicated, important subject would be held with so little information on the subject. The last minute addition of this resolution and

the vote were based on one thing, and one thing only: partisan politics."

McGinley echoed Belton's thoughts on the potential cost of breaking up the circuit.

"Splitting the circuit would not be without a cost to the people of the counties," McGinley said. "The DA's budget from each county split numerous costs. For example, the cost of expensive and necessary software is shared by both counties. The state creating a new DA costs taxpayers everywhere. Judges' caseloads would grow. This means that it would take longer for cases to be resolved. This means that individuals awaiting trial while in jail would have to wait longer for their day in court. If the speed of cases coming to court was truly a reason, then propose the

addition of a state court.

their jobs, people that work day in and day out to help our communities. With them would go priceless knowledge of open cases. A new DA would have no knowledge about these open cases that would include murders, rapes, child molestations, armed robberies, etc. I do not know how to put a number on the cost to victims of serious crimes."

Newton County Chairman Marcello Banes has centered his reasoning for requesting a split on the increased caseload and, simply, at the request of others within the county. He told The Covington News there was no ulterior motive. However, during the meeting, District 4 Commissioner J.C. Henderson said he knew of Newton residents who had wanted to run for offices within the Alcovy Circuit but likely could not have won because they also had to campaign in Walton.

Candidates for Superior Court judge and DA must win a majority of the total votes cast in both counties to earn election.

A copy of the commissioners' formal request can be viewed in its entirety online at CovNews.com. Within the request, commissioners called for legislation to be amended so the governor could appoint a district attorney for the proposed Newton Judicial Circuit for a term beginning July 1, 2021, through Dec. 31, 2022. A successor would be decided by voters.

The request also calls for three Superior Court judges to be plucked from the Alcovy Judicial Circuit, including Cheveda McCamy, Ken Wynne Jr. and Layla Zon all Newton County residents to serve on the proposed Newton Judicial Circuit. The circuit's chief judge would be determined based on who had served as Superior Court judge the longest. Expenses for the Newton Judicial Circuit not funded by the state would be funded by Newton County. Walton County would then be responsible for all expenses incurred by the Alcovy Judicial Circuit.

Eastside Athletic Director Phil David-

son told The Covington News Friday that offensive coordinator Jay Cawthon will serve as interim head coach for the Eagles while the school conducts a coaching search.

Prior to being tabbed head coach in 2015, Hoff served as an assistant coach in various roles for the Eagles for 10 seasons. During that span, he filled in as a special teams coordinator, running backs coach, JV head coach and offensive coordinator, varsity offensive line coach and assistant head coach.

Shortly after Woodstock shared the news on its social media, Hoff took to his personal Twitter account to express his gratitude for Eagle Nation.

There are no words

to describe what Eastside High School means to me & my family," Hoff stated in a note posted to a Tweet. "When you put your heart & soul into something for 16 years, it's more than just a job. For me & my family #WeBleedGREEN is and always will represent something special in our life.'

Woodstock went 3-7 in 2020 as members of Region 5-AAAAAAA. Former Wolverines head coach Brent Budde stepped down in December after 11 seasons. They've missed the state playoffs each of the last three years.

COVINGTON, Ga. Eastside is venturing into uncharted territory in 2021.


After residing in Region 4-AAAA for the past six seasons, the Eagles will now call Region 8-AAAAA home. Their last region was top-heavy, often leading to a two-man race for a title while the rest of the teams were left fighting for scraps. This year, however, the league will be overflowing with talent.

Eastside will be joined by perennial state powers Loganville and Greenbrier, as well as burgeoning talent pools at Walnut Grove, Apalachee and Clarke Central. It will be perhaps one of the most complete regions from top to bottom in the entire state.

And the Eagles are eager to face the challenge head-on.

"When you get a chance to play in a region like this, you can't sleep. You've gotta go to work every day and come to the ball field ready to play," Eastside head coach Brandon Crumbley said. "It's going to be exciting to strap it up against Walnut Grove and Loganville. [We] get to go up against coach [Jeff] Segars — a legend who's built a program from the ground up.

play some really good baseball every day that we get in region play. It's going to be a test, but it's going to be really fun at the same time."

As the program has done in recent years, Eastside will delve into a lethal non-region gauntlet with the hopes of emerging as a stronger club.

The Eagles will open the year with road games against Ola, Northside Columbus and Tift County during their first week. They'll

then head to former league rival Woodward Academy — the threetime defending Region 4-AAAA champion on Tuesday, Feb. 23.

"The first week of the season is going to be a test, but I didn't schedule any harder or softer than I would've if it had been a weird year, normal year, whatever," Crumbley said. "We're playing some tough teams early to get us ready for region play. And then region play is going to get us ready, hopefully, for the state

playoffs."

When the pandemic prematurely ended Eastside's 2020 season, the club was forced to bid farewell to one of its most talented senior classes in recent memory. The departure of five players — including a pair of four-year starters — left holes in the pitching staff and lineup.

"It's tough to replace a class like that, but those guys set a standard of excellence that we want to have here," Crumbley said. "The

guys that are taking over and filled those roles, they know what's expected. They know what they have to do to be successful."

Senior left-hander Cade Mitchell will return as the workhorse of Crumbley's staff. The Eagles will also use seniors Ethan Booth, Sambo Button and Dayton Green and junior Cole Shannon on the mound.

As for newcomers to keep an eye on, sophomore Hunter Denney has emerged as a promising outfielder Crumbley's crew will

lean on. "We're a good mix of experienced and inexperienced," Crumbley said, "which can be good because experienced guys can teach and tell the inexperienced guys what to expect."

The Eagles are currently scheduled to open the season Tuesday, Feb. 16, at Ola. First pitch is slated for 5:55 p.m.
