Biden's Inauguration

'Democracy has prevailed'

- Biden sworn in as 46th President
- Local leaders react to historic day

COVINGTON, Ga. — After Joe Biden was sworn in as the 46th president of the United States on Wednesday, Jan. 20, many local leaders both rejoiced in the peaceful transition of power and wished the best for Biden's administration.

In a roughly 21 minute speech on Inauguration Day, Biden opened his first remarks as president by briefly alluding to his race against former President Donald J. Trump and Trump's attempt to overturn the election results because of claimed voter fraud. Biden touted that democracy had triumphed.

"This is America's day," he said. "This is democracy's day. A day of history and hope. Of renewal and resolve. Through a crucible for the ages America has been tested anew and America has risen to the challenge. Today, we celebrate the triumph not of a candidate, but of a cause, the cause of democracy. The

will of the people has been heard and the will of the people has been heeded. We have learned again that democracy is precious. Democracy is fragile. And at this hour, my friends, democracy has prevailed."

Biden went on to plead Americans to join him in striving for unity.

"In another January in Washington, on New Year's Day 1863, Abraham Lincoln signed the Emancipation Proclamation. When he put pen to paper, the president said, 'If my name ever goes down into history it will be for this act and my whole soul is in it.'

"My whole soul is in it," Biden echoed.

"Today, on this January day, my whole soul is in this: Bringing America together. Uniting our people. And uniting our nation. I ask every American to join me in this cause. Uniting to fight the common foes we

Commissioner: Board holding east Newton fire station funding 'hostage'

COVINGTON, Ga. — The county's new Public Facilities Authority indicated it may not allow a fi-

nancing plan for a new east Newton fire station to move forward until projects Democratic members favored also were funded.

Authority members on Tuesday, Jan. 19, voted 3-2 to delay action for 30 days on recommending the only funding source available for the planned Station No. 4 for Newton County Fire Services.

The Authority, comprised of the five members of the board of commissioners, voted along political party lines for tabling the request for almost \$5 million in revenue bonds to finance the construction and equipment for the station planned for Big Woods Road in the Starrsville community.

District 1 Commissioner Stan Edwards was obviously angry after the vote.

"We're going to hold District 1 hostage," he said.

The board of commissioners must vote to guarantee the bond issue financially before it can be issued. It was scheduled to consider approval of the bonds at its regular meeting that followed the Authority meeting



Newton's newly-elected coroner says she inherited inoperable, inadequate equipment

Board votes \$50K for her to set up office, pay immediate needs

COVINGTON.

Ga. — Inoperable or damaged equipment and lack of adequate facilities and supplies to do the job were among the issues the county's new coroner said she inherited after taking office Jan. 1.

The Newton County Board of Commissioners responded by voting 4-1 on Tuesday, Jan. 19, to approve a onetime, \$50,000 transfer from the 2021 budget to Coroner Dorothea Bailey-Butts.

District 5 Commissioner Ronnie Cowan said the coroner's office needed that amount of money to pay for immediate needs like

a statewide coroners training session, purchase of office machinery and supplies and replacement equipment simply to operate through the end of the

budget year.

"I don't want somebody in my family to die and I call the coroner and the coroner's not able to provide an adequate service," Cowan said.

The county manager and finance director now will meet with Bailey-Butts to find her specific needs. Commissioners then must approve transfer of the funds from other areas of the budget at a future meeting to create the one-time payment to the coroner, officials

Bailey-Butts first went before the commissioners Tuesday to tell them she needed about \$9,000 for training and new supplies to replace non-working and obsolete equip-

ment. She then described for commissioners additional issues she encountered since beginning the job which requires her to investigate many types of

deaths in the county. Among them was an inadequate morgue in downtown Covington that she said needed immediate attention because it contained mold

Piedmont Newton Hospital officials share update on local pandemic response

COVINGTON, Ga. -Piedmont Newton Hospital's chief medical officer says patients that local ambulance services bring to the hospital will receive care even if those from other counties are turned away.

Dr. Norris Little told members of the Newton County Board of Commissioners Tuesday, Jan. 19, that he wanted to clarify the term "patient diversion" because many believed it had a different meaning as Newton and other area hospitals deal with the heavy demand for their services amid the COVID-19 pandemic.

Little said it meant that "out of county ambulances should not bring their patients to our

"That doesn't stop them necessarily but if they have another option and another choice at another facility...,'

"All of our patients in our community that need care with our own ambulance service are certainly ... brought to Piedmont Newton if appropriate," Little said.

Little spoke as part of an update Chairman Marcello Banes asked him to give to the board.

The chief medical officer said the hospital system was rolling out available COVID-19 vaccine and giving doses to its front-line workers and eligible residents.

He said news reports may have highlighted some adverse effects from the drug but it was "quite rare and we've not seen them."

Piedmont is making doses available to the eligible groups who are now patients of physicians in the hospital system's clinics, he said. However, doses are avail-

able at health departments and supermarket pharmacies such as Kroger and Publix, he said. Little added that the hospi-

tal's primary patient population in Newton County has generally done a better job of taking precautions not to spread the disease compared to some neighboring counties.

As a result, he said the hospital staff has been able to avoid contracting the disease.

The prevalence of the disease in Newton County also has generally been lower than neighboring counties, he said.

Newton County recorded a two-week positivity rate of 20.9% on Wednesday, Jan. 20, down from 23.2% on Jan. 6, according to the Georgia Department of Public Health.

5 NCSO detention officers test COVID-19 positive

COVINGTON, Ga. — Five detention officers have tested positive for COVID-19 as of Jan. 15, **Newton County Sheriff** Ezell Brown said, which is what likely sparked a recent outbreak of virus among more than 20 inmates.

Brown confirmed Friday, Jan. 8, that 22 inmates within the Newton County Jail had tested positive for the novel coronavirus, though all but one were demonstrating little to no symptoms.

After investigating and using contact tracing, Brown said there was reason to believe the inmates had contracted the virus from staff members.

"The time-lapse, beginning from when residents were incarcerated to the COVID-19 outbreak last week, helped us determine that the 21 inmates, who have tested positive for COVID-19 but show little to no symptoms. contracted the virus from staff," Brown said in a statement to The Covington News. "As of Jan. 15, there has been a total of five detention officers who have tested positive for COVID-19."

The lone inmate who was showing significant symptoms was transported in to the Newton County Jail from another jail that had already witnessed an outbreak. He is currently being quarantined and "receiving special attention as a result of his symptoms," Brown

Brown said the sheriff's office had developed a testing procedure for staff to help minimize the spread of COVID-19 in the jail but did not elaborate on the procedure.

"We have strictly fol-

lowed all CDC guidelines since the pandemic began last March, and again, we are blessed to have gone so long without a single positive case in the detention center up until last week," he said. "We will continue doing everything we can to ensure the safety of all staff and residents."

A spokesperson with the sheriff's office said the five officers who tested positive for COVID-19 has not caused the jail to become understaffed, as there are 63 total detention officers currently employed by the sheriff's office.

"We have cross-trained officers so that the Detention Center is fully staffed to the point where all duties are fulfilled," the spokesperson said.

In April 2020, the sheriff's office worked to reduce the jail population by more than 100 inmates to try and avoid an outbreak.

but removed it from its agenda.

Bond attorney Brian Huskey said he believed delaying issuance of the fire station bonds for 30 days would not affect the interest rate the county would pay.

County Fire Chief Mike Conner said officials had proposed using revenues from the county's fire district tax to repay the bond financing.

Edwards asked Authority Chairman Demond Mason of District 2 to move a vote on the bond issue to the top of the agenda.

The chairman refused and said projects he and members J.C. Henderson of District 4 and Alana Sanders of District 3 proposed for their commission districts would be considered

Mason said he supported construction of an aquatic center for about \$35 million that could include an Olympic-sized pool, fitness center and other facilities.

Sanders advocated for a \$13 million project that included a new community center and park on county-owned land adjacent to the Fairview Estates subdivision off Fairview

Henderson supported a list of projects totaling more than \$16 million.

Among them were

a \$9 million renovation of the former R.L. Cousins school building off Geiger Street; expansion of Nelson Heights Community Center and new construction of athletic fields and an indoor swimming pool at the same location; and a \$2 million addition to Por-

ter Memorial Library. Each list was approved with the three

Democrats favoring them and Republicans Edwards and Ronnie Cowan of District 5 voting against them.

County Manager Lloyd Kerr estimated the cost of debt service on bonds for the three commissioners' projects to be about \$2.6 million annually for 20 years.

Mason said he wanted Kerr to research the various funding options available — such as grants or corporate sponsorships — other than bonds for recreation projects. The authority then could decide how to fund them at a later date, he said.

"I'm hearing there are a lot of dollars out there," he said.

Kerr said if he could not find any grants or other funding sources then the only other options would be a tax increase for repayment of bond financing or a new Special Purpose Local Option Sales Tax for the projects.

Edwards said the fire station was needed to give east Newton, including parts of Districts 1 and 5, fire protection facilities equal to other authority members' districts.

'You are adequately covered, we're not," Edwards said.

He said other authority members were confusing a "want with a need."

"Fire stations are a matter of public safety," he said. "People's lives are at stake.'

Sanders, who was attending her second meeting after taking office Jan. 1, responded that she did not want the public "to have a negative connotation" of the project she favored.

"It's not a want," she said. "They need parks for children.

Henderson said the Cousins project is one "we promised the citizens on this side of town." He has proposed construction of a Black history museum, among other projects, in the county-owned building in recent years.

He recalled that one of his neighbors drowned in the Alcovy River last summer. Providing recreational facilities for some residents may give them skills, such as learning to swim, that could serve the same purpose as a fire station in saving lives, Henderson

The vote to approve the projects was for them to receive further consideration and not for bond financing.

Delay of the fire station bond issue which already had documents prepared — also included delay

of further action on the projects until Kerr can locate alternative funding sources.

After the meeting, Mason said he believed funding eventually would be approved for the fire station.

Longtime county government observer Larry McSwain said he was disappointed the action did not align with County Chairman Marcello Banes "OneNewton" effort to deal with issues in ways agreeable to all the county's political factions.

"This certainly was a backward step toward OneNewton," McSwain said.

Another longtime observer, Barbara Morgan, said she believed the board's action was only a temporary set-

back for the fire station. "It would be a dereliction of duty if the board of commissioners did not act to provide critically needed fire protection for places in the county that are now paying premium insurance rates due to the lack of protection,"



Georgia had a good year despite horrific pandemic

or the past few years, ◀ I've had the luxury of starting the new year with a happy pronounce-

ment about how great things are Obviously, I won't be doing that this



To be fair, Georgia has had an incredible decade-long run of historic successes. Per capita state taxes in Georgia are next to the lowest in the nation. We have the second-best Bond Rating. Our public schools have never had better SAT, ACT, and K12 scores... or a better graduation rate. Our university system is one of the best in the nation; as UGA and Georgia Tech are ranked among the top-20 in public, and Emory is among the best private universities. Before COVID, we had the lowest unemployment rates in history. Even during the pandemic, the Georgia economy has fared much better than most, including the fifth best in the nation in fewest jobs lost, and fifth best in most jobs regained. We've recently added 16,000 jobs in the past few

months, and over \$6 billion

in new investments, half of

which is outside Atlanta.

And for the eighth year in

a row we've been named

the Best State in the Nation

to Do Business in. Georgia

is poised much better than

most to rebound out of this tragic pandemic. Georgia has grown a whopping 25% over the last decade, adding 2.7 million people. Atlanta has hosted the Super Bowl and the College National Championship, and we're scheduled to host the Final Four, All-Star games in baseball and basketball, another College Championship, and probably the World Cup. Atlanta is still the busiest airport in the world, bringing in \$82 billion a year; and Savannah is now the fourth busiest port in the U.S., bringing in an astonishing \$106 billion a year. Atlanta is now being called the "Technology Capitol of the East," and

with the partnership of

Fort Gordon and Augusta

University, Augusta is now the "Cyber Capitol of the Nation".

On the other hand, COVID has halved our tourism industry, especially our hotels and hospitality. Ag, our No. 1 business, has suffered at least \$50 billion in losses, especially in cattle and crop farmers. Farm bankruptcies are up 25%, as the typical farmer has taken a \$50,000 hit. And restaurants and small businesses are struggling everywhere.

COVID has been horrible, costing so many lives. I grieve for the more than 11,300 Georgians that have died due to this virus, and fervently applaud our brave healthcare workers who have been on the front lines of this pandemic.

Georgia has conducted 5.7 million COVID tests, a total that surpasses half of our state population. We were first in the nation to activate the National Guard to help Stop the Spread, where they served 2,400 facilities and gave out 948,000 meals to children. And we've supplied tens of millions of pieces of PPE, and now have an 80 days stockpile.

Even better, America has produced two different vaccines in record time, and we are now working hard to get these shots into people's arms. And while Georgia has not had a great record in the early phase of the vaccine rollout, we're quickly addressing these problems.

A balanced budget is always the General Assembly's top priority. Election reform, COVID relief, mental health and broadband will also be high on the list. In order to help the COVID situation, the governor has promised an added \$405 million for Medicaid and healthcare access. He's also calling for an additional \$1.2 billion to fully fund K-12 education (including \$10 million for special-needs children), and a one-time \$1,000 bonus to every teacher. The federal government is also giving Georgia schools an additional \$1.7 billion in funding due to CARES 2.

The governor also talked about \$20 million for rural broadband grants and \$40

million for rural innovation. He emphasized there would be no budget cuts, no furloughs, and no new

I am working on two teacher bills, one which incentivizes teachers who retire to keep teaching, and another that encourages teachers to teach in very-rural communities. I am also working on four military bills.

I cannot end this article without commenting on the recent catastrophe. Not since the invasion of the British during the War of 1812 has our U.S. Capitol been so violated. There are now more soldiers stationed in Washington than Iraq and Afghanistan put together, a grim reminder of the ills of mob violence.

face: Anger, resentment, hatred. Extremism, lawlessness, violence. Disease, joblessness, hopelessness. With unity we can do great things. Important things."

The president ended his speech with a promise to "always level" with the American people and "defend the Constitution" as his administration works to "write an American

story of hope." "My fellow Americans, I close today where I began, with a sacred oath," he said. "Before God and all of you I give you my word. I will always level with you. I will defend the Constitution. I will defend our democracy. I will defend America. I will give

my all in your service thinking not of power, but of possibilities. Not of personal interest, but of the public good. And together, we shall write an American story of hope, not fear. Of unity,

not division. Of light, not darkness. An American story of decency and dignity. Of love and of healing. Of greatness and of goodness. May this be the story that guides us. The story that inspires us. The story that tells ages yet to come that we answered the call of history. We met the moment. That democracy and hope, truth and justice, did not die on our watch but thrived. That our America secured liberty at home and stood once again as a beacon to the world. That is what we owe our forebearers, one another, and generations to follow. So, with purpose and resolve we turn to the tasks of our time. Sustained by faith. Driven by conviction. And, devoted to one another and to this country we love with all our hearts. May God bless America and may God protect

Kamala Harris was also sworn into office, becoming the first female vice president and the first Black and South Asian vice president in U.S. history.

Newton County U.S. Rep. Hank Johnson, D-Lithonia, was in attendance for the inauguration of Biden and Harris. He sent out a series of tweets via Twitter, commenting on the day.

"Beautiful day in the nation's capital -- it's a new day in America," he wrote. "The clouds have

overtaken the sun, and snow has begun to fall. Winter is upon the nation, but winter always yields to spring!" "Just like that the

snow receded, as did the clouds, and now we have a beautiful blue sky as the historic VP @KamalaHarris is sworn in. #InagurationDay"

"@JoeBiden President Biden sworn in! A day of history where democracy lives on in America! It's springtime in America!"

Newton County U.S. Rep. Jody Hice, R-Greensboro, commented on the Biden-Harris inauguration via Facebook. He first recapped the accomplishments of Trump's administration and ended by saying he hoped Biden would "keep his word."

"May God bless America and all who love and serve her! Despite all that divides us, we are still the UNIT-ED States of America,"

Hice wrote. "As President, Donald Trump did more for Americans than any elected official in our lifetimes: enacting historic tax reform, securing the Southern border, negotiating better and fairer trade deals, protecting the right to life, improving healthcare for veterans, producing a COVID vaccine

through Operation Warp Speed — just to name a few! His accomplishments should be honored and preserved.

"Looking forward, I pray to God that President Joe Biden will keep his word to protect the rights of ALL Americans, no matter their political ideologies. If President Biden is truly committed to promoting unity, he should call for an end to Congressional Democrats' impeachment attempt of Donald Trump."

Chairs of Newton County's Democrat and Republican parties also commented on the historic day. "May our thoughts

be with the new leaders of our nation and their administration," wrote Ryan Barrett, chairman of the Newton County Democrat Party, on Facebook. "May we find determination in our convictions, perseverance in a greater tomorrow, and a undivided interest in the common good.

Bailey-Butts defeated longtime coroner Tommy Davis in the Nov. 3 election for the position.

Common sustainable agriculture practices

The concept of sustainability varies by industry. Within the agricultural industry, sustainability is a multifaceted concept that has become increasingly popular in recent

According to the National Institute of Food and Agriculture, sustainable agriculture seeks to increase profitable farm income, promote environmental stewardship, enhance quality of life for farm families and communities, and increase production for human food and fiber needs. In an attempt to reach those goals, farmers who embrace sustainable agriculture may look to various practices.

- Cover crops: The Union of Concerned Scientists, a nonprofit organization that aims to employ independent science to address the planet's most pressing problems, notes that cover crops are planted during the offseason when soils have traditionally been left bare. Cover crops can help prevent soil erosion and replenish the nutrients in the soil. Cover crops also can limit weed growth, reducing the need for herbicides that can prove harmful to the environment.
- Reduce or eliminate tillage: According to the UCS, traditional plowing, or tillage, can cause a significant amount of soil loss, even as it prepares fields for planting and

• Integrated pest management: Integrated pest management techniques aim to minimize the use of chemical pesticides that can prove harmful to the environment and local wildlife. According to the University of California Statewide Integrated Pest Management Pro-

gram, IPM strategies like habitat manipulation and the planting of disease-resistant plants are designed to promote long-term prevention of pests and the damage such pests can cause.

• Agroforestry: The Association for Temperate Agroforestry defines agroforestry as an intensive land management system that incorporates trees and/or shrubs to optimize the benefits they provide when deliberately combined with crops and/ or livestock. The shade and shelter provided

by trees and shrubs can protect plants, animals and water resources.

 Crop/livestock integration: The UCS notes that there is growing evidence to suggest that the careful integration of crop and animal production can help farmers make their farms more efficient and profitable.

any transitions have tak-en place in the agricultural industry over the last several decades. The widespread adoption of various technologies over the last 20-plus years has helped farmers streamline their operations, making their farms more efficient and less wasteful as a result. In addition, many farmers have embraced sustainable farming, which is a relatively recent approach to agriculture.

According to the Union of Concerned Scientists, sustainable agriculture is a complex, multi-faceted concept. Sustainable agriculture intends to contribute to a robust economy by making farms profitable. Farmers who embrace sustainable agriculture also aim to have a positive effect on the environment and their surrounding ecosystems. That's accomplished by embracing strategies that focus on building and maintaining healthy soil, managing water wisely, minimizing pollution, and promoting biodiversity.

Houseplants carry benefits

The lines between the outdoors and indoors are being blurred. Homeowners build extensive outdoor living spaces so they can relax on weather-resistant furniture and even cook in lavish kitchens in their backyards. In addition, indoor three-season rooms full of bright, open windows that showcase outdoor vistas challenge the boundaries between outside and inside.

For those working with limited budgets, there are some easy, inexpensive ways to enjoy the majesty of natural landscapes indoors. Houseplants can be used to improve indoor spaces, and they also provide various health benefits.

Help with allergies According to Web-MD, rooms with houseplants tend to have less dust and mold in them than those without any foliage. Leaves and other parts of the plants serve as natural filters, catching airborne particles and

allergens. Plants with textured leaves might be especially effective at trapping particles.

> Put more oxygen into the air

The human respiratory system works by bringing in oxygen and releasing carbon dioxide. Plants do the opposite during photosynthesis. They absorb carbon dioxide and then release oxygen. Plants can put much more oxygen into the air, improving indoor conditions.

> Increase indoor humidity, reduce

illness Studies from the Agricultural University of Norway found that indoor plants can increase humidity in indoor spaces, which decreases the incidences of sore throats, dry coughs, dry skin, and the common cold. Higher absolute humidity can decrease the chances of survival and transmission of the flu virus.

Filter the air Researchers who presented their work at the 252nd National Meeting & Exposition of the American Chemical Society found certain houseplants can combat the potentially harmful effects of volatile organic compounds. Plants may help filter out VOCs like benzene, acetone and formaldehyde, which can enter indoor air via cleaning supplies, dry-cleaned clothes, furniture, printers, and paints.

Can improve mood Growing and caring for plants can alleviate everyday stress. A nationwide study from UK Magazine Gardeners World found 80 percent of gardeners declared themselves satisfied with life compared to 67 percent among non-gardeners. Gardeners were more positive mentally. Greenery can help people feel more at home and improve mental health. A rehab center in Norway found patients reported a greater increase in well-being four weeks after having greenery added to their surroundings.



Honoring Newton County's elite from the 2020 season

COVINGTON, Ga. — With the 2020 prep football season firmly in our rearview mirror, it's time for *The Covington News* staff to take a look back at the most impactful players from our area.

In the context of a pandemic, simply completing a season should be viewed as a success. Even still, there are always individuals who find ways to rise above and beyond the call of duty in the face of adversity. Last season was no exception.

Those listed below showed up each Friday night and earned the right to be placed among the Newton County's elite.

It's an honor to present to you the 2020 All-Covington News Football Team.

MVP: Nyland Green (Newton)

Was there anything Green couldn't do on a football field in 2020?

As a senior, he racked up 457 receiving yards on 25 catches and found the end zone four times as a receiver. He was also productive on the other side of the field, recording 47 tackles, five tackles for loss and five interceptions — including a pick-six — while garnering national attention as a cornerback.

Green was also a lethal weapon for the Rams on special teams. His seemingly effortless stride and elusiveness made him a nightmare for opposing punt and kickoff teams. He picked up big chunks of yards on returns time and time again, including his electric 97-yard kickoff return for a touchdown against rival Alcovy.

No other player in the area had a bigger impact on his team's success than Green last season. He truly earned the title of Most Valuable Player in our area each and every Friday night.

Offensive POTY: Dayton Green (Eastside)

Five days before the 2020 season began, Eastside senior quarterback Jaylen Woods suffered a leg injury in practice that threatened to sideline him for nearly two months.

In stepped Green.

After emerging as one of the Eagles' top wideouts in 2019, Green transitioned to a new role under center as the team's emergency quarterback. There were some growing pains at first, but it didn't take very long for him to adjust to the life of a gunslinger.

Green started the first seven games of the season, throwing for 787 yards and nine touchdowns while tossing just one interception. He was also a threat on his legs, picking up 137 yards on the ground from the quarterback position.

Woods returned from injury for Eastside's eighth game of the season, but Green's contributions didn't stop. He shifted back out to receiver and reeled in 21 receptions—second-most on the team

— for 258 yards and two touchdowns in six games.

When adversity struck, Green didn't hesitate to do anything he could to bring his team success. As a result, the Eagles won 10 games and returned to the state quarterfinals for the second time in three years.

Defensive POTY: Justin Benton (Newton)

The freshman phenom lived up to the hype during his sophomore campaign last fall.

Coming off a season in which he was named the

All-Covington News Freshman of the Year, Benton added more muscle in the winter and summer. He also took on more of a vocal leadership role in practice, reaching outside his comfort zone to lead his teammates with words and instruction in addition to his actions.

These steps of maturation translated to continued on-field success.

Benton closed out the year with 93 total tackles. The defensive lineman led the team in sacks (12.5), tackles for loss (24.5) and QB hurries

(22), tied First Team All-Area defensive back Darius Green for solo tackles (55) and added an interception for good measure.

With offers from the likes of Georgia, Florida, Arkansas and Arizona State on the table, Benton has already begun to light up recruiting boards. As he continues to pile on muscle and hammer down his technique, he could prove to be one of the top college football recruits in the state — if not the country.

Newcomer of the Year: Ashton Evans (Alcovy)

Evans was tabbed the starting quarterback for the Tigers in their final game of 2019. Coming into his sophomore season poised to earn the full-time starting role, he didn't disappoint.

With Evans under center, the Tigers averaged 20.6 points per game — a significant uptick from 14.5 PPG in 2019 and 7.75 PPG in 2018. He proved to be a versatile threat, keeping defenders on edge with his shiftiness in the backfield as well as his powerful arm.

Alcovy was struck with adversity and scheduling issues due to the pandemic, but Evans' leadership as a sophomore quarterback helped guide the team to their first postseason appearance since 2013.

Coach of the Year: Troy Hoff (Eastside)

The departure of a fouryear starter at quarterback. A significant injury to the novel quarterback brought in to take the reins of the offense. A higher classification and tougher region to navigate than in years past.

It's a combination that would spell a setback for many programs. But not for Eastside.

Instead, in his sixth season calling the shots, head coach Troy Hoff led the Eagles to a 10-win season and a trip back to the state quarterfinals for the second time in three years.

It could be argued that the 2020 season was Hoff's most impressive from a coaching standpoint — even more so than the 2018 campaign that saw the Eagles coast into the quarterfinals at 12-0.

Hoff proved that he and his staff excel at utilizing the talent they have and moving puzzle pieces around to find the right fit.
