hirty minutes to an hour. It could be the time one waits for a table, or the amount of time before their food is served. Maybe a little less, or maybe a little longer. Nonetheless, it's a time no one really wants to hear when they're hungry.

But that timeframe has become a temporary normal as the food service industry, like several other industries across the nation, are still reeling from the pandemic and struggling to maintain a full

TRUE **HERO**

Local waitress lauded after removing badly injured wreck victim from burning car

MANSFIELD, Ga. — Keelyn Harper says she does not know why she chose County Hwy. 213 rather than her usual route home from her job in Mansfield last week.

When she saw a fire off the side of the road that turned out to be a woman trapped in a burning vehicle, she knew she had to help when other passing motorists chose not to.

"That's when I was kind of like, 'It's just me. I have to do something," Harper said.

Friends and the victim's family were praising the waitress at Rooster's Drive Inn after she was able to pull the badly injured driver from her car after it struck a tree and caught fire on the side of Hwy. 213 near Mansfield June 10.

Rooster's owner Kenny Anderson called Harper "a true hero."

"She would have surely burned to death if it had not been for Keelyn," he said.

Harper, 22, said she decided to help the victim because she would want someone else to do the same if it had been her daughter in the car.

"I have a 1-year-old daughter ... I guess my 'fight or flight' took over," she said.

Harper had just finished her shift at

Juneteenth not new to Newton County

Local residents have worked for years to bring attention to slavery's end in U.S.

COVINGTON, Ga. — The newest national holiday, Juneteenth, was to be celebrated in Covington this weekend for the 10th time since 2011 with pageants, music, vendors and a traditional parade.

Longtime organizer Terri James said this year's event on Saturday, June 19, moved to Legion Field on Mill Street after years at other locations because of the number and size of events

scheduled.

James said she has been willing to put in the volunteer hours over the course of a decade to organize the event because of the importance of what the holiday represents.

"This is something all people need to know about," she said.

James said she first learned of the then-little-known observance from a cousin in Louisiana when James was still employed in the telecommunications industry.

After retiring, she worked to spread the word about the observance of the event that marked the de facto ending of slavery of Black people in

"I found out people had never heard about it," James

Juneteenth's origins date to 1865 in Texas.

President Abraham Lincoln's Emancipation Proclamation in 1863 ordered an end to slavery but the order

County breaks ground on tower construction for E-911 radio system

OXFORD, Ga. — Next summer, public safety radio dead spots across Newton County will be no more.

County officials and first responders gathered outside Newton County Fire Station No. 9, located at 176 Mt. Zion Road in Oxford, on Thursday to break ground on the construction of the first of three towers that will help take the county's public safety communications system to new heights.

In June 2020, the

Newton County Board of Commissioners approved a contract with Motorola for a new emergency radio system. Despite an initial estimate of \$3.6 million, the radio system costs upwards of \$14 million to install, according to County Manager Lloyd Kerr, but is being paid for, in part, by SPLOST funding.

"Every time you and everybody else spends a dollar here in the county, a penny goes to help support projects just like this, which will help our community be a safer and better place to be, so we thank everyone for that," he said.

Kerr said the new radio system would boost the county's radio coverage up to 98%, "and give us the ability to talk in places that we never had the ability to communicate before."

"This is a great moment for us," Kerr said during the ceremony.

However, after the ceremony concluded, Sheriff Ezell Brown told *The Covington* News he remembered a time when the radio system was first-class with an expanded coverage area. He was excited to see the county's communications return to that level.

"What I see today is coverage like we once had," Brown said. "I can speak of that from, I guess, the dinosaur era – back about 48 years ago when we could talk from one end of the county to the other end of the county. We could talk from one county to the next county. And we have talked from the base station to a car station, from Newton County all the way to Perry, Georgia. So I feel that Motorola is going to put us back where we

should have been all along.

"My position is: we got to where we are today by agreeing and disagreeing," he continued. "That is what put us where we are today, and I'm proud of it. I'm proud to know that the equipment and the tools that the dispatchers are going to have is going to be state of the art. That said, they're no better than the equipment they're having to use. So, I'm excited about it."

Brown said he believed the current coverage was below 50% for the entire county.

To open the ceremony, Chairman Marcello Banes recalled a conversation he had about five years ago, shortly after he was elected, concerning the need for an improved radio system.

"I remember one call that I got from the police chief in Porterdale, and he said, 'Mr. Chairman, we got a few dead spots in Porterdale, and we really need to get that addressed," Banes said. "I want to say, today, we are taking the first steps in making that happen."

Covington Mayor

Steve Horton, who is a former police officer, gave his thoughts on the importance of a sound communications system.

"I have a little bit of a public safety background, so I understand how important and vital 911 is to all of us — not just those in public safety, but all of us,' Horton said. "Much like a bridge connects an island to the main land, E-911 operation connects our citizens and our businesses within this community to the people and agencies — generally public safety agencies — who can help them in times of need and crisis. Therefore, E-911 personnel who answer the phones and man the radios are often the first and sometimes the last call that's made when people need help the worst. During those times, competent, well-

"You work in a very stressful environment, and sometimes a very thankless environment, but I want you to know that what you do is vital to all of us in our community," he said. "You know, everybody can't do the jobs you do."

911 Director Trudy Henry, who was publicly lauded for helping lead the charge on the new radio system, spoke briefly during the ceremony. She implored how grateful she was to the county's leaders and all who had a role in the project thus far. "The public safety

radio system is an important part of my daily job, and it's important that these guys standing around in uniforms are safe and know that when they make a call, they can get it out and let us know what they need," she said. "This is exciting. It's been a lot of hard work, and there's a lot more work to come."

District 3 Commissioner Alana Sanders was also on hand for the groundbreaking. She talked about spending time with

Henry recently as part of a "county tour" she had taken to learn about the roles of each department. She also displayed her gratitude to county's leaders for coming together and seeing the project through.

"I've had the opportunity to sit with [Henry] and her staff for an hour to watch what they do," she said. "I've had a county tour and visited every department in the county and sat wit them for an hour or more to find out what they do. As [Henry] knows I love technology, and so I'm excited about this opportunity to be able to advance with Newton County, advance in District 3 and advance with your department, Trudy. So whatever it is with technology I am here for it. So thank you Motorola for bringing us up to the next level, and thank you Newton County and my fellow board of commissioners and the chairman for allowing

this to happen." Project consultants said the new radio system was expected to be up and running by "this time next year."

GSP investigates fatal wreck in Newton

COVINGTON, Ga. — Georgia State Patrol is investigating after a Newton County woman was killed when a truck struck her vehicle on U.S. Highway 278 recently.

The state patrol reported that June 11, at about 9:35 a.m., troopers investigated the wreck on Hwy. 278 near Deerfield Road east of Covington.

A preliminary investigation showed the victim was driving a silver Toyota Sequoia east on Hwy. 278 approaching Deerfield

At the same time, a small commercial panel truck bearing markings of the company that produces Red Bull energy drink, was traveling west in the same area on 278, a GSP spokesman

When traffic in front of the commercial truck slowed, the truck apparently was following too closely and it entered the eastbound lane to avoid a rearend wreck, a GSP spokesman

While in the eastbound lane, the truck sideswiped the Toyota Sequoia and the wreck occurred.

The driver of the Toyota Sequoia, Regina Clark, 52, of Newton County, died at the scene. Her husband, Jeffery Clark, was transported to Piedmont Newton Hospital with minor injuries, the spokesman

The driver of the commercial truck, Jalloh Habbibu, 38, was not injured.

The incident is still under investigation. Charges are pending, the spokesman said.

Setback rules squabbling leads to delay on store, eateries near Social Circle

COVINGTON, Ga. — A plan for a convenience store and fast-food restaurants at I-20 and Georgia Hwy. 11 will be delayed for at least two months after developers said they had problems with conditions and area zoning requirements.

Questions about an ongoing appeal of a previously rejected rezoning of the same site for a travel center also apparently led to the Newton County Board of Commissioners delaying action on the request for the site near Social Circle on Tuesday.

Commissioners voted to delay action until Aug. 17 on their consideration of Jackson-based JPC Design & Construction's request for a conditional use permit allowing construction of a convenience store with underground fuel tanks in the Little River watershed.

The request was for use of 10 acres of a total 46-acre site at the southeast corner of I-20's Exit 98 interchange with Georgia

JPC attorney Richard Milam said the company would face a major delay in starting construction if not given relief from a 100-foot setback requirement for commercial construction in the Brick Store Overlay District.

He asked commissioners for a 50-foot setback because con struction of the 8,000-squarefoot building at least 100 feet from Hwy. 11 would force developers to encroach on a creek

on the property. Encroaching on the creek would require approvals from the U.S. Army Corps of Engi-

neers that could take months to obtain, he said. He also said JPC wanted 16

fuel pumps rather than 12 as staff recommended, and 20 spaces for employees rather than

The Brick Store Overlay includes areas surrounding Hwy. 11's intersections with I-20 and U.S. Hwy. 278 in eastern Newton between Social Circle and Mansfield.

An overlay district places development requirements on new construction that are in addition to those already required by zoning regulations in place within a specific geographic area.

Area resident Wayne Pugh said he believed the developer needed to follow the overlay district regulations "to the letter."

JPC's plan will be the first major commercial project to build within the overlay zone since it was established in 2006 and commissioners "need to stand firm," he said.

"They knew that creek was there from the beginning," he

Commissioner Stan Edwards, who represents the area, said a Dollar General store on Hwy. 11 near Hwy. 278 exceeded the requirement with a 150-foot setback.

Milam said the project would be a \$6 million investment and employ a total of about 20 to staff the store and restaurants.

The developer has agreements with Burger King and Dunkin' Donuts to operate the fast-food restaurants — which he said will each include drive-through windows.

He said the new design includes gas pumps to serve personal vehicles only and no fuel

facilities for tractor-trailers. The Board of Commissioners rejected the same developer's plan for a travel center, fast-food restaurants and future big-box supermarket on most of the 46acre site in February after area homeowners groups united to oppose the plan.

County Attorney Megan Martin asked Milam about commissioners' belief that JPC agreed to drop an existing lawsuit against the Board if it approved the conditional use permit. Milam said he did not know of any such

He noted that a lawsuit it recently filed in Newton County Superior Court was the only method JPC had to appeal the Board's February decision to deny a rezoning request for the previous travel center plan.

However, he said the two issues were not related.

In other zoning action Tuesday, the Board of Commissioners approved a rezoning of a 35acre site on Georgia Hwy. 142 for construction of 226 rental

The request was for a rezoning from M2 (Heavy Industrial) to RMF (Multi-Family Residential) for the site at the highway's intersection with City Pond Road.

Jim Chapman of applicant Jim Chapman Communities told commissioners the "attached rental cottages" he planned near Three Ring Studios would target upscale residents who did not want to own their homes or be responsible for their mainte nance.

He said a similar community with such amenities as a clubhouse and swimming pool he developed in Athens that rent from \$1,595 per month for two bedrooms to \$2,275 for three

Also Tuesday, commissioners agreed to delay action until July 20 on a request to rezone 6.6 acres on Salem Road at Smith Store Road for construction of a multi-use project that will include a fast-food restaurant.

Developers said they wanted to work to address concerns from nearby homeowners about to request to rezone the site from Single-Family Residential to Highway Commercial.

Only 29% of Newton population fully vaccinated

COVINGTON, Ga. Newton County has some work to do before it can reach "herd immunity" against COVID-19.

As of Friday morning, only 31,360 residents had been fully vaccinated, according to the Georgia Department of Public Health, which equates to just 29% of Newton County's population. Nearly 36,000 had received at least one dose (33%).

Reportedly 70% of the population needs to be vaccinated in order to achieve "herd immunity." "Herd immunity" happens when a large part of the population — the herd — is immune to a virus.

Newton County's numbers are below the state's totals. Per the health department, more than 3.76 million (36%) Georgians have been fully vaccinated, while 4.35 million (42%) had received at least one dose.

The vaccine has been available to Georgians since December.

Chad Wasdin, who is communications director and public information officer for the Gwinnett, Newton & Rockdale County Health Departments, said the health departments were still working to get more residents vaccinated.

"We are first and foremost working to make the vaccine as widely available as possible, whether through our health centers, mass vaccination sites, or mobile teams set up around the community," Wasdin said. "We are also partnering with the school systems to provide vaccine opportunities to families over the summer.

Our health director, Dr. Arona speaks at as many events as she can to encourage vaccines."

Wasdin said the health departments were also advertising and pushing the message that "vaccine services are available as a walk-in service, no appointment needed," at any of the vaccine

"Our campaign is called 'Better Together," he said. "From birthdays and holidays to business meetings and game days, our life is better when we get to live it together. We're hoping that aspirational message encourages as many individuals as possible to get vaccinated so we can safely get back to doing the things we love."

Active COVID-19 case count dwindling

There were 34 new cases of COVID-19 confirmed in Newton County within the last two weeks, as of Friday. The county's cumulative total had climbed to 7,684 cases since the pandemic began more than one year ago with 235

The state eclipsed 900,000 cumulative cases this week. The death toll stood at 18,368 with 64,525 hospitalizations. In the last two weeks, there had been 4,078 cases confirmed, equating to 38 per 100,000.

Two books for your summer reading list

ummer is made for reading. Bookstores and online booksellers devote

sections and special marketing to summer beach



him to read several books and choose one to talk about on the first day of school. Even though many of us don't shift our work schedules in the summer, we still seem motivated to slow down and enjoy a good book. But how do we get

started on knowing what to choose? How do we find out about good books that are worth our time? There are a lot of lists

out there. One appeared in my inbox recently from the New York Times. "73 books for your summer reading list..." It's divided into sections – thriller, true crime, audio, cookbooks, fiction, music, and more. I recommend that as a good starting

I want to recommend two books for your summer reading. The first is "The Black Church: This Is Our Story, This Is Our Song" by Henry Louis Gates, Jr. Gates is

clear in this book that the Black church is not a single story, just as there is not one Black religion. The Black church, in Gates' view, is central in understanding the African American story in the United States. I appreciate many

parts of this book – the history, connections to social justice and community engagement, and how he confronts the issues for the church today. I was especially moved, though, with his treatment of the importance of music. Music has been a liberating force in and out of the church from slavery through Civil Rights on up to President Obama's moving rendition of "Amazing Grace" during his eulogy for the Rev. Clementa Pinckney in Charleston, South Carolina, in June 2015. This book is an important read given the state of race in the United States today.

Just in time for Father's Day gifts is "Pops: Learning to be a Son and a Father" written by my college friend and "Today Show" host, Craig Melvin. Pops is Craig's story about fatherhood - his own, his dad's, and fathers along the way who have made a difference to him in his life. In his personable and authentic way, Craig is honest about how difficult our human relationships can be, especially with family. His story is touching and beautiful and often quite funny. I am grateful how vulnerable he (and his own father) are willing to be in the book, something needed in our society today.

Digging into a good book gives me life. Earlier this year, I discovered what many people had been telling me for years. Book clubs can also be life-giving. Along with a co-worker, we started a Harry Potter book club and even though we have been meeting on Zoom due to the pandemic, we have formed a community. Either of the two books mentioned here would be ideal for your next book club. Don't have a book club? Be courageous and start one.

Now that vaccinations are up and COVID cases down, I am hearing about book clubs returning to meet in person. We need these communal gatherings after such a long stretch of isolation and computer screens. We also need books like the two recommended here for deeper understanding and to increase our capacity for vulnerability.

his trucking company. Broun has been elected before but has also come up short in various races. He was the first official candidate to declare for the 2022 seat in the 10th

One potential candidate to watch is state representative Houston Gaines. If he decides to enter the fray, Gaines will certainly be a contender to be dealt with in the 10th district race.

There will likely be more Republican candidates in the race. At least five more are considering throwing their hats into the ring. The 10th District cov-

ers a large area and will

take financial backing

to make a successful

run. Look for most, if not all, of the Republicans to associate themselves with former President Trump. Despite Georgia turning blue for the last presidential election, former President Trump remains extremely popular to a large portion of voters here in the

Peach State. Saying Trump's name is similar to throwing red meat to the lions and there will be plenty of it during the 2022 race. Trump's name won't appear on any Georgia ballot in 2022 but it will seem like he will be as often as his name will be mentioned at various campaign events for the open District seat.

Two Democrats have also announced they are seeking the seat but it will be an uphill battle. The district makeup is one that favors any Republican nominee.

Tabitha Johnson-Green, who was the Democratic nominee in the last two elections, is running again. Green is a retired nurse. In addition, Kimberly Reuter, a licensed professional counselor, is campaigning in the 10th District as a Democrat.

In reality, it would be a win for Democrats if their candidate was able to draw 40% of the vote in this district for the general election. It's doubtful any Democrat, regardless of who it is, could win this seat in November 2022

It should be a fascinating race to watch, especially the Republican primary. Open congressional seats don't happen often and it will be a grueling battle to emerge victorious.

"I'm back to working seven days a week," she said in an exclusive interview with The Covington News. "But, you just do what you got to

The iconic restaurant known for being featured on the hit TV series "Vampire Diaries" was operating with just more than half of its regular serving staff, Bezborn said Wednesday, leaving about 1/3 of server positions unfilled. She said the shortage has made things difficult over the last few months, but the staff has worked diligently to see customers feel little impact.

"Of course it makes the wait time to be seated longer, and that sometimes makes the wait time for the food longer," Bezborn said. "It's been trying, but it's just one more thing left over from COVID, I guess. We learned to do a lot of things differently during that time — rethink and restructure a lot of things. So, this is just one more bump in the road, but you just do what you've got to do. If you need to wash dishes, you wash dishes. If you need to cook, you cook. If you need to wait tables, you wait tables. Because the last thing you want to do is have your guests suffer for it."

Bezborn was proud of her employees who've continued to show up everyday and put in many hours to help keep the restaurant's doors open. She said there had been some days when only three servers were present to run the entire restaurant.

The shortage has also led to the restaurant's popular rooftop seating to remain closed. However, she's excited to see the turbulent time coming to an end.

"It's been tough, and the workers I do have are tired — we're all tired — but there's light at the end of the tunnel," Bezborn said. "We're starting to get applicants, so it's starting to break loose and there's some new

people coming in.

hold on for a while, but I just wasn't sure what 'a while' was going to be," she added. "It's been tiring, trying and difficult, but it's all part of the business. You can't be happy and have it great all the time. You can't be perfect — it will never be perfect... We coasted there for a while, you know. Everything was going good, but then COVID came and just — but you know, that's when your faith steps in. You can't see it, it looks like everything's just going the wrong way, and you just have to put your faith to practice.'

Bezborn believes the biggest reason for the staff shortages felt nationwide was due to not only the novel virus, but the increased, "I knew that we just had to extended unemployment

benefits available and stimulus money as well.

"I don't blame anybody," she said. "I get it and everything. But my question to some of these folks that were working for me but then decided to do that was, 'What are you going to do when that runs out?""

The restaurant owner said she encouraged all of her employees to secure their positions rather than taking the benefits, because they might regret it later.

"What I told them [was], I would secure a position in a good establishment where you're being paid well and you're being treated well, because some restaurants didn't open back up, and all the cream is going to rise to the top," she said. "At

some point, these places are going to be able to pick and choose, and they're going to pick and choose the people who are showing up, showing up on time, giving it their all, following the rules – those kinds of things. There's not going be room for everyone if you're not going to be fully committed to your job. What are you going to do then?"

Since the pandemic began, jobless Americans were eligible to receive \$600 boost to their unemployment benefits, which was later reduced to a \$300 boost. Gov. Brian Kemp announced in May that the boost would be no longer available to Georgians beginning June 26.

Putting an end to the increased unemployment benefits could be the solution, but Bezborn said there was really no way to be sure.

"I really don't know," she said. "I've never seen anything like this; I don't think anybody has."

In addition to staffing issues, Bezborn said minor changes were made to the menu to compensate for a different kind of shortage.

"We haven't been running any features lately because we're so heavily impacted by the tourists, so we make sure we stay as stocked up as possible," Bezborn said. "And that's another thing. Some of the purveyors are not able to get the product, so we have to all kind of come together and go, 'OK, they don't have this, this or this, this week, so what are we going to have in place of it?' Or, 'what are we going to do?' ... It's a lot going on."

But despite all the adversity, the restaurant's workers have placed a renewed focus on quality customer service in light of the pandemic, Bezborn said.

"[Someone once said], 'People might not remember what you said to them, but they'll always remember how you made them feel,"" Bezborn said. "So, we just really try to push customer service, Southern hospitality

[and] talk to people. Sometimes with tourists and outof-town people, this might be their one time to eat at the Mystic Grill ... but when they get here, we treat them like they're the VIPs that they are, because if it weren't for anybody — whether it's a tourist or a local — I always tell my staff, the person who walks in that door, that's who pays us.

"I also understand that people coming in are trying to get away from the outside world sometimes," she added. "Maybe they're experiencing some of this on a different level as well. So, it's our job to win them over, just be friendly and go the extra mile."

Bezborn said, unfortunately, some people don't understand the impact staff shortages are having on local businesses. For that reason, she decided to place a sign outside the restaurant's front door, at the corner of Clark

Street and Hays Street, that

states, "Sorry we are short

with the staff that did show

staffed. Please be patient

up to work. Thank you." "Some people do understand and some people don't. And I get it," she said. "They came in here to get away from the world for a minute. I guess they were thinking things should be the same,

but we all know nothing is

the same.

"People just need to remember that everybody is going through this, Bezborn continued. "What ever happened to — you know, when we all got in this mess, it was like, 'We're all in this together!' If they could just remember, we are all in this together. Everybody's got something that's not normal anymore. So if we could just all try to remember that, I just wanted to put a nice

reminder out front. "I think it would be just a much better world if everybody could remember just to always be kind, no matter what kind of day they're having. And that's what I always tell my staff."

County to repair, pave 34 roads with annual GDOT grant

COVINGTON, Ga. Newton County is repairing and resurfacing pavement on parts of 34 roads this summer and fall with money from local and state sources.

The county government received \$1.25 million from GDOT's annual Local Maintenance and Improvement Grant (LMIG) program after providing a 30% match — about \$375,000 -to receive the funds, according to information from GDOT.

The total of about \$1.6 million is being used to patch and resurface about 16 miles on a list of 34 roads in the unincorporated part of Newton County.

County spokesman Bryan Fazio said work is underway to complete all the projects on the list — which range in length from 1.7 miles to 0.11 of a mile — by late November.

"The list is being worked on now and is scheduled to be completed this paving season," Fazio said. "The season ends around Thanksgiving, depending on the weather."

Paving work was

recently completed on Johnson Road between Duncan and Hightower roads; Northwood Oak Court; and in three cul-de-sacs in Dove Landing subdivision, County Manager Lloyd Kerr said.

According to the county government, its 2021 paving list also includes:

The annual LMIG allocation from GDOT is based on a formula comparing the total centerline road miles for each local road system and the total population of each county or city with the total statewide centerline road miles and total statewide population.

Newton County has 768 miles of roads and a population of about 92,000 in the unincorporated area.

The county also uses money from the county budget's General Fund and collections of the Special Purpose Local Option Sales Tax (SPLOST) for paving, Fazio said.

Newton County Board of Commissioners members Tuesday to approve a property tax rate lower than the current rate in an effort to offset higher property assessments residents received this year.

As a result, commissioners will have less revenue to fund the budget that also included the pay increases. Kerr asked if board

members on Tuesday could postpone the budget's final approval until he could propose ways to cut enough in other areas to produce the \$1.1 million to \$1.4 million needed to maintain increases between 3.5% and 4.5%.

He said a pay increase for all positions was needed in such departments as Public Works where some jobs have a starting pay as low as \$11 an hour. An equivalent private sector position is paying about \$13 an hour, Kerr Kerr said he began

working in 2018 on plans to increase pay for county workers after finding Newton County government was paying an average

of 20% less than other area public and private

sector employers. Commissioner Stan Edwards asked Kerr why the proposed Newton County increase exceeded increases planned by other entities such as the federal government, for which a planned 2.7% increase had reportedly

been considered. Kerr said he believed the federal government was able to offer less than the county because it typically still offers such incentives as a pension plan.

Most local governments stopped offering pension plans after they found they could not afford their rapidly escalating costs.

Newton County offers a 401K plan to its employees after abandoning its own pension plan in the 1990s, Kerr Kerr said he was not

ready to recommend specific areas to cut and would "really need to dive into the budget" to see "where we are on some things and to see how many dollars we could generate." "It may take one or

two things, it may take half a dozen things," he said. The Board of Com-

missioners also voted Tuesday to approve a resolution to continue using 2021 budget funds in the 2022 budget year because it will not have approved a new budget by the start of the fiscal year July 1.

Rooster's and was traveling on Hwy. 213 on June 10 at around 9:30 p.m. when the incident

The Eastside High School graduate said she usually took a more direct route than Hwy. 213 to the home she shares with her daughter west of Covington.

"I don't know why I went that way," she said.

What she thought was a brush fire on the side of the road caught her attention, Harper said. She stopped her

vehicle and noticed the fire was on a car that was not moving after traveling down an embankment on the side of the rural road.

Harper said she called 911 and told another

motorist who also had stopped about making the call. The other motorist drove off rather than also stopping to help, she said.

"That's when I was kind of like, 'It's just me. I have to do something," Harper said.

She said she walked to the car, saw the driver's side window was open, but initially did not believe anyone was in the vehicle because the fully inflated air bag filled the interior.

Harper then was able to pull back the air bag and see the driver, Ashley Strawn of Mansfield, was trapped inside and bleeding heavily.

The car was pointed at a downward angle and Harper said she

was unable to open the driver's side door.

"The whole car was like it had run off the side of a cliff," Harper said. "It was completely embedded into the woods."

She then quickly worked her way through some bushes and branches on the other side and was able to pry open the badly damaged passenger side door.

The victim's leg was caught in the gas pedal area on the floor, she said. Harper said the heat from the fire was getting more intense and she told the victim — who was barely conscious — she would remove her from the vehicle.

"I told her it was

going to hurt and I'm sorry," she said. "But I grabbed her and I pulled her out."

Others had stopped to see what was happening but apparently did not want to help out of fear of what the growing fire might do, Harper said.

She said she was unable to muster the strength to carry Strawn by herself up the embankment. They then sat between the car and branches as it continued to burn — hoping help would arrive soon, Harper said.

"We just sat there and I just prayed and prayed that it would not blow up on us," she said.

"I don't think she was really comprehending the situation, which

is understandable," Harper said. "I held her and rubbed her hair and told her it was going to be OK."

Help arrived in the form of a Newton County sheriff's deputy and other first-responders who put out the fire and transported the victim in serious condition to Atlanta Medical Center, a Newton County Sheriff's Office report stated. The sheriff's office confirmed Harper's story.

The victim's boyfriend, Troy Anderson, told The Covington News that Strawn had driven to a nearby store and was "35 seconds" from the home they shared on Hwy. 213 when she apparently swerved to miss a deer

and ran off the road in the rural area.

He said she was "recovering" at the Atlanta hospital following surgeries to repair a broken neck and back. She also had a punctured lung and numerous cuts on her face he said may have been the result of striking the windshield.

Strawn's sister, Shannan, said on Facebook that her whole family thanked Harper and "appreciates her saving my sister."

Troy Anderson said he and Strawn's family had been in close contact with Harper through the ordeal and hoped he could somehow pay her back for her efforts.

"I think that that girl was amazing," he said.

could not be implemented in parts of the U.S. still under Confederate control.

Texas was the most western Confederate state during the war. It remained in Rebel hands until June 19, 1865, when about 2,000 Union troops arrived at Galveston Bay, Texas, and announced that Lincoln's executive decree had freed the more than 250,000 enslaved Black people in the

The newly freed people then began calling the day "Juneteenth," according to information from the National Museum of African-American History and Culture.

Texas officially made June 19 a state holiday in 1980 and total of 48 states and Washington, D.C., came to recognize Juneteenth as either a state holiday or ceremonial holiday.

This year, after a bill to establish it as the 12th federal holiday had stalled in 2020, the U.S. Senate and U.S. House overwhelmingly approved the legislation earlier this week and President Joe Biden signed it into law Thursday.

Newton County branch of the NAACP hosted its inaugural Juneteenth celebration in 2011 with keynote speaker Tyrone Brooks, a longtime Georgia state legislator and civil rights advocate, at Bethlehem Baptist Church on Usher Street. James and Gwen

Green first organized the annual celebration in its current form in 2012 with a daytime festival at Nelson Heights Community Center on Lassiter Street and a Black History Gala at an event

facility in Oxford.

Her nonprofit organization, the Newton County Historical Committee on Black Heritage Preservation, was formed in 2013 and now organizes Juneteenth and other events. It also gives a scholarship from its signature fundraiser, the Black History Scholar-

ship Gala, in February. James said she worked to organize a number of programs, such as Easter egg

Organizers have focused on local African-American history including putting a spotlight on historic African-American communities such as Frog Town and Petty's Hill in 2013; and making longtime Cousins Middle School band director T.K. Adams its parade grand marshal this year.

In 2020, the pandemic prompted James and other organizers to cancel any Juneteenth plans — though she said she marched with local activists before a program protesting the deaths of Black people at the hands of white police officers in other part of the U.S.

A short presentation about the origins of Juneteenth was part of the June 19, 2020, protest rally on the Covington Square.

James said she at times over the years became frustrated that older African-Americans seemed less enthusiastic about celebrating Juneteenth's importance than younger people. 'Older people don't

even want to think about the past," she said. She credited County

Commissioner Alana Sanders with helping expand the event by organizing a pageant and encouraging more volunteers to partici-

Sanders, in a state-

ment, said, "As a public servant to the people, it is my job to assist and to be involved in various events around the county, no matter how big or small.

'Supporting my neighbors in the community with their endeavors while also being involved with history allows me to not forget the struggles and to celebrate freedom; so that I could have a better life in this country we call America.

"It is an honor and a privilege to volunteer my service to the Juneteenth festivities. I have assisted with organizing many major events throughout my career and it is my duty to dedicate my God-given gifts and talents to

others. "I would also like to thank my neighbors in District 3 and throughout the county that have provided their time to make this event a success. This can only get bigger and better from here on out and I am excited to see what Mrs. (Terri) James and her team, Newton County Historical Committee, has in store for years to come.

"The organization has been putting on this event for years in the county and I am grateful for what they have done to preserve history.

"I am also thankful to Commissioner J.C. Henderson for his continuous support of this organization throughout the years and making sure that Juneteenth is recognized in Newton County."

COVINGTON, Ga. Eastside's coaching search is over.

This week, the Eagles announced the hiring of Brandon Davis as the school's next head baseball coach. Davis will take the reins from former head coach Brandon Crumbley, who stepped down to accept a head coaching job at Whitewater High following three seasons running the ship.

Davis comes over from Locust Grove, where he most recently helped coach baseball and softball. He has 14 years of experience as an assistant baseball coach, aiding dominant programs at Jones County and Heritage before his stint with the Wildcats.

Now, he's ready to take ownership and blaze his own trail.

"As a 14-year veteran assistant coach, I saw an opportunity to finally do something on my own," Davis said. "I've been around great coaches. I was under Barry Veal for eight years down at Jones County. I was with Shane Ramsey for a year at Heritage. I coached with coach [Stephen] Phillips for a year at Locust Grove.

"I think, at this time in my life, I'm at a place where I know where I want to be. And I can put 100% effort into it and do it the right way."

Davis is a baseball lifer. His childhood was spend around diamonds, whether he was swinging a bat, watching his brother, Chris, do the same or attending a game his dad was umpiring.

He played out his prep baseball career at nearby Salem High in Rockdale County before spending two seasons on the team at Truett-McConnell in Cleveland, Georgia. Through decades of playing and coaching, Davis says, his passion for and understanding

of the game continues to develop.

"It's been like that beard you keep growing — it's always there," Davis said of baseball. "The love of the game, the learning, the constant analyzation of every single thing that happens. Whether it be a Braves game, whether it be a rec ball game, whether it be a

high school game. Just being around the game itself."

Davis says the first step in integrating himself into the Eastside program will be showing his face. He wants his players and staff to understand that he's there and ready to join them in the trenches. He added that the preparation for the

2022 season will begin in the fall, not in the winter.

"Baseball season doesn't start until January, but I'm going to be starting from the very beginning of school," he said. "We're going to have kids in the weight room. We're going to go ahead and start getting our juniors and seniors some video portfolios that we can send out to college coaches so that they can see we've got these kids at Eastside, and they're going to be able to play. I want to get those names out to those coaches and I want them to come and see how good we can be."

As for the expectations he intends to set for the 2022 season, they'll be the same as the ones he hopes to set every season going forward.

"We're not going to out there to say, 'Oh, it was a great year because we made the state playoffs," Davis said. "No. Our expectations are, each and every year, to win a region championship and then compete for a state championship. Anything less than that, we've got to figure out why."
