Three suspects die in fiery wreck

Crashes during attempt to flee deputies

COVINGTON, Ga. — Three people were killed when their vehicle crashed and caught fire as they attempted to flee from pursuing

Newton County sheriff's deputies early Monday.

The incident occurred Monday, Sept. 7, at about 2:24 a.m. at the intersection of Jack Neely and Fairview roads, said spokeswoman Caitlin Jett of the Newton County Sheriff's Office.

It began when sheriff's deputies responded to a call about two people attempting to enter automobiles in a neighborhood off Fairview Road, Jett said.

"Upon arrival, the individuals took off and a vehicle pursuit ensued,"

Jett said.

The suspects' vehicle crashed at the intersection of Jack Neely and Fairview, which is west of Coving-

The victims' identities, as well as other information, were not immediately available. Georgia State Patrol is in charge of the investigation.

Third time's a charm

Covington Down syndrome advocate, girlfriend to be featured in Times Square video

COVINGTON, Ga. -A

Newton County resident is about to make his return to Broadway.

This time, he's bringing someone with him.

And though his image has been on display there twice before as part of the national observance of Down Syndrome Awareness Month, this third time also will be a total surprise to him, his mother said.

A photo of Bradley Carlisle of Covington with his girlfriend, Grace Key of Cartersville, was set to appear as part of the National Down Syndrome Society's annual Times Square video presentation Saturday, Sept. 12, said Carlisle's mother, Debbie Shadrix.

She and Key's mother, Carrie, were planning to surprise Bradley and Grace with the fact their photo is part of the video being livestreamed from New York City.

It will be among 500 photos in the video, which will be streamed from Times Square in New York City on the Society's social media platforms, a news release stated.

Bradley and Grace both are active with the Down Syndrome Association of Atlanta — so much so it awarded him its Adult Advocate of the Year award and her the Young Adult Advocate of the Year award in 2018.

"They're both very strong advocates," Shadrix said. Grace, 21, lives in Cartersville

and operates a business selling T-shirts, Shadrix said.

Bradley's photo already has been featured twice in the annual national video presentation, his mother said.

The 30-year-old is an Alcovy High School graduate and lives independently in a Covington group home with two other men with special needs, said Shadrix, who lives in Conyers.

He also is a busy advocate for Down syndrome awareness. He has lobbied for disability rights legislation in Washington, D.C., helped organize a restaurant event staffed entirely by people with Down syndrome; and worked as an usher at the Fox Theatre in Atlanta.

The National Down Syndrome Congress this year awarded him its Christian Pueschel Memorial Citizen award for his advocacy work, and its Brandon Gruber Scholarship to help him pursue his dreams of performing on stage, his mother said.

Bradley and Grace met when they won their awards and subsequently started a new relationship, Shadrix said.

Attorney: Lawsuit says BD's air emissions led to women's cancer

 Two area residents allege that longtime exposure to a chemical a Covington industry emitted into the air led to their cancer diagno-

Gena McClendon says in a lawsuit filed in State Court of Gwinnett County that her exposure to ethylene oxide emitted from the BD Bard plant led to her July 2019 diagnosis of multiple myeloma.

She additionally served as an active member of the Sargent Newton D.A.R. for 30 years, where she held many positions, one of which was working as the publishing representative to the U.S Congress in Washington D.C.

Irene was best known for her writing and cooking. She spoke on cooking panels in five different states and wrote the local garden column for the Covington News on a weekly basis. She was the author of four cookbooks and the television host of two local shows, Taste of Newton and Calling All Cooks. She was featured multiple times in Southern Living Magazine and on-The Food Network.

When Irene was not in Georgia, you could find her on her beloved Daufuskie Island in South Carolina. There she was a member of the Daufuskie Island Women's Organization, Daufuskie Island Historical Society, and an Associate Member of First Union African Baptist Church on the Island. 


deeply missed.

Local parent questions Newton County Schools re-entry plan

COVINGTON, Ga. — While Walton County Schools, Social Circle City Schools and area private schools returned to in-person instruction in August, one local parent believes Newton County Schools should be back in class, too.

Michael Sugg, of Covington, addressed the Newton County Schools Board of Education and Superintendent Samantha Fuhrey under public participation Tuesday, Sept. 8, to see "what is taking so long" for the district to allow in-person instruc-

Recently, the district

unveiled a plan to allow students to return for in-person instruction through a staggered method beginning Sept.

According to the system's plan, all students who chose instruction option 1 (in-person) should be back at school by Oct. 13, if the COVID-19 community spread level remains low. The plan calls for four phases:

Phase 1: Pre-K, Kindergarten, 1st Grade, 8th Grade, and 12th Grade

Phase 2: 2nd Grade, 3rd Grade, 6th Grade and 9th Grade

Phase 3: 4th Grade, 5th Grade, 7th Grade, 11th Grade

Phase 4: 10th Grade According to survey results released in August, more than 6,200 students opted for in-person instruction. Fuhrey said those

students and parents would begin receiving email notifications for the return Sept. 11.

Sugg said students, including his own children, shouldn't be waiting so long to get back to school, especially if wearing masks have been proven to be successful. "I know you're

reopening. I see that you're reopening. You have a plan in place, finally," he said. "But my question for you is, why is it going to take

another five weeks? You have metrics that show that these things work — that masks work.

"If you believe [Piedmont Newton Chief Medical Officer Dr. [Norris] Little saying that the masks work, then why aren't we accelerating this plan?" Sugg said he under-

of students' health hand safety, but it didn't make sense to him that several businesses could be open, yet Newton County Schools could not.

stood the importance

Sugg's question went unanswered, but the board is not required to answer questions under public participation,

though comments are permitted.

After the meeting, Sugg said he was disappointed by the lack of response.

"I felt like I completed a 'check the box' for them so that they say they had public participation," he said.

Sugg also sent several emails to the board and superintendent but garnered sparing conversation, he said.

"In the 15 emails I have sent to board members and Fuhrey, I received six responses from Fuhrey on various questions, one from Abigail Coggin, and one from Trey Bailey," Sugg said. "None of the emails, though,

answered the question about accelerating the return to in-person learning and why they continue to look at worthless metrics that all other businesses and local schools seem to be ignoring."

When The Covington *News* reached for comment, Fuhrey responded with the following statement:

"The school system's re-entry plan was shared several weeks ago and can be found on the school system's website. In the plan, the metrics are identified as it is critical to monitor our community's transmission COVID-19.

Bradley's mother was the on-call hospital support person for the Down Syndrome

Association of Atlanta – providing information and encouragement to parents of children born with the condition. They met at what is now Children's Healthcare of Atlanta near Emory University.

"I was the person who met with new families," Shadrix said.

Because of the distance between her former residence in Covington and the Keys' home in Cherokee County they never were able to find time to get together until reconnecting at the 2018 event, Shadrix said.

The video presentation is an annual tradition for the National Down Syndrome Society and its followers. It is set to include photos highlighting children, teens and adults with Down syndrome and seeks to highlight the contributions and milestones of people with the condition, said an organizer of the display.

"This video is a terrific way to showcase some of the incredible individuals with Down syndrome living in our communities across the country," said Society President and CEO Kandi Pickard. "It is something the community looks forward to every year."

It will be followed by the New York City Buddy Walk, which will be done virtually due to COVID-19, a news release said.

"There are a lot of people who are scared," Geoffroy said. "We're doing everything we can to get justice."

BD and its predecessors have operated the facility for more than half a century, since 1967, in Newton County. It employs a total of about 1,000 at three different locations in northeast Covington.

McClendon's lawsuit states BD stored the chemical in the Covington plant, used it in its processes and emitted it from the facility into the air during the 27 years she worked at two Newton County health care centers.

Her lawsuit says BD Bard was negligent when it emitted excessive volumes of ethylene oxide and used it instead of safer options for sterilizing medical equipment.

She alleges that the plant was a public nuisance because its operator failed to warn residents and those working near the facility of the dangers associated with the chemical.

It also accuses the company of violating the state's Racketeer Influence And Corrupt Organizations (RICO) law because company officials and others associated with BD misrepresented to state officials the amount of emissions from the plant.

McLendon, a Conyers resident who formerly lived in Covington, worked at Merryvale Assisted Living three miles from the BD Bard plant for 23 years between 1996 and 2019, said attorney Darren Penn.

This followed her employment from 1988 to 1996 at what is now Piedmont Newton Hospital less than one mile from the Covington

Penn said McClendon had no genetic "predisposition" or inclination toward the disease. She has undergone radiation treatments and a bone marrow transplant, he said.

facility, the suit stated.

The lawsuit seeks damages set by the court and demands a jury trial.

A second lawsuit by Dr. Lisa Miller, a Covington pediatrician, states her exposure to BD emissions led to her breast cancer diagnosis, Penn said.

Penn said Miller, 58, operated her medical office less than a mile from the BD plant for 11 years after working at the Newton hospital for an additional seven years.

She was diagnosed with breast cancer in July and has undergone chemotherapy and a double mastectomy, he McClendon's lawsuit

said the federal Environmental Protection Agency (EPA) in 2016 completed a 10-year study of ethylene oxide and found the chemical was 30 times more likely to cause certain cancers than scientists had previously believed. A report by the EPA,

the "National Air Toxics Assessment," found Georgia had three areas of increased cancer risk from ethylene oxide, the lawsuit stated.

One of those areas was Covington where the increased risk was about 170 of the extra 214 cases of cancer for every million people exposed during their lifetime.

The EPA has ruled the pollution risk is unacceptable when it surpasses 100 cases for every million people exposed to a chemical, the lawsuit stated.

The initial filings in the case are on behalf of a "small number of almost 200 clients" diagnosed with cancer in the two locations, a news release stated.

Penn said neighborhoods most affected in the area include Settlers Grove and Covington Mill, which are predominantly Afri-

can-American. He said the lawsuit was filed in Gwinnett County because the company's registered agents are located there.

A spokesman for BD said the company does not comment on pending lawsuits.

However, a statement from the company said "there are vast amounts of air monitoring data that provide insights to actual levels of ethylene oxide present in greater Atlanta and across Georgia."

It said Georgia **Environmental Protec**tion Division's latest air monitoring data showed that average levels of ethylene oxide (EtO) in Covington "are exactly the same as the levels found" in General Coffee State Park in south Georgia and below levels found at EPD's background monitoring station in south DeKalb County, about 30 miles from

BD's Covington facil-

"The data also show that average levels across the greater

Atlanta area are about the same in areas where there are EtO sterilization facilities and areas where there are not EtO sterilization facilities.

"The data suggests that those who live in communities with sterilization facilities are exposed to similar amounts of EtO as those who do not live near the facilities because of other sources of EtO, including naturally occurring sources," according to the statement.

Disclosures of unreported releases of ethylene oxide from the BD plant and Sterigenics in Cobb County in late 2019 led to public

calls for tighter regulations of such facilities.

State Sen. Brian Strickland, R-Mc-Donough, whose district includes Newton County, introduced legislation earlier this year that was signed into law by Gov. Brian Kemp in early August.

The new law requires manufacturers using

ethylene oxide to report any waste spills or gas releases to the Georgia **Environmental Protec**tion Division within 24 hours. The Division's director then must post the information on the

agency's website.



COVINGTON, Ga. — An industrial expansion announced Tuesday, Sept. 8, was years in the making and "helps solidify" a longtime industry's continued presence in Newton County.

General Mills will boost production of one of the country's most popular cereal brands by expanding their Cinnamon Toast Crunch operations and adding 40 jobs in the process, Gov. Brian Kemp an-

Increased operations are set to begin next week at the newly expanded Covington facility at 15200 Industrial Park Blvd. NE, stated a news release from the governor's office.

David Bernd, executive director of the Newton County Industrial Development Authority, told *The Cov*ington News his agency "is extremely excited for the Covington General Mills team" at the 30-year-old plant.

"The Newton County IDA is extremely excited that, over the past four years, we have been able to navigate and overcome severe headwinds, ensuring a 30-year career staple in our community is able to flourish and expand," Bernd said. "This expansion,

and capital investment helps solidify a second generation of General Mills employees right here in Newton County."

Bernd said in the news release the Cinna-

Former Covington 911 director named to help lead state's disaster response

COVINGTON, Ga. — The city's longtime former E-911 director is now a leader of the state government's response to future natural and manmade disasters.

Mike Smith recently was named as chief of staff for the Georgia Emergency Management and Homeland Security (GEMA/HS) agency. Gov. Brian Kemp

announced his appointment of Smith as he named Georgia State Patrol Capt. Chris Stallings as the agency's new director Sept. 1.

Smith left his role as deputy director of the Georgia Emergency Communications Authority to serve in his new job. He said he was "humbled that I was even considered." "It wasn't something

I was looking for," Smith said.

Kemp said during a Sept. 1 press conference that as Stallings "transitions into this new role, he'll need a strong partner at his side to lead this agency and tackle the challenges ahead.'

"Mike Smith will bring years of public safety experience from his time as a police officer in Covington and Newton County and extensive work in emergency communica-

tions," Kemp said.

"I know that Chris and Mike will ensure

a smooth — but quick transition. They will conduct business with the professionalism and integrity that citizens want and deserve."

Smith said his decades of work in law enforcement and emergency response in Newton County prepared him for the job in a number of ways.

His varied career includes working as Covington-Newton County 911 director for 17 years, from 2001 to

He also worked as a commander with East Metro Drug Enforcement task force from 1995 to 1998; a deputy and lieutenant with the Newton County Sheriff's Office from 1984 to 1995; and as an officer with the Covington Police Department, where he began his career as a dispatcher in 1982.

Smith said his experience with 911 and other agencies allowed him to see the impact of his work firsthand. It also showed him how to prepare for major emergency situations,

he said.

He also learned the "politics" of the position — teaching him to make contacts that would be vital to doing his job well, he said.

Smith, 57, said he was "excited" to be coming into an agency whose employees work so well together.

According to its website, GEMA/HS coordinates the state's preparedness, response and recovery efforts in times of disasters.

It also works with local, state and federal governments, in partnership with the private sector and faith-based community, to prevent and respond to natural and manmade emergencies.

In addition, GEMA/ HS employees are on 24-hour call statewide to assist local authorities when disaster strikes.

Smith said Stallings' predecessor, Homer Bryson, brought the agency "years ahead of where it was" when he took over in 2016.

"We both have big shoes to fill," Smith

Bryson was credited with improving the agency's organization and communication with other state and local emergency agencies during his four years in the post.

Through My Launch Pad, Fuhrey said, there were more than 34,000 $\log ins - 23,000 \text{ were}$ "unique users" and there were 170,000 app launches.



Grand jury proceedings to resume in Georgia

ATLANTA – Court proceedings in Georgia will start back toward some semblance of normalcy under an order issued Thursday, Sept. 10, by state Supreme Court Chief Justice Harold Melton.

The order authorizes grand jury proceedings to resume immediately, even though jury trials are still suspended.

Melton's order extends until Oct. 10 the statewide judicial emergency he first declared back in mid-March, as the state virtually shut down to discourage the spread of coronavirus. Today's was the sixth 30-day extension of that original order.

While jury trials remain on hold, Melton indicated today he intends to order trials to resume when he issues the next 30day extension next month.

"As explained in the last extension order, this broad prohibition cannot continue, even if the pandemic continues," the chief justice wrote in Thursday's order.

Covington amends mask mandate

COVINGTON, Ga. — The Covington City Council approved two amendments to its current mask mandate Wednesday, Sept. 9.

Effective immediately, everyone age 9 and older is required to wear a face covering if unable to maintain six-foot distancing. The age requirement first approved Aug. 27 was age 8 and older. Mayor Steve Horton said the change was made to coincide with a similar amendment made on the county level.

The second amendment was to clarify how anyone who did not comply with the order would be penalized.

Before, the city approved a civil penalty of no more than \$50. The amendment passed Wednesday night changed the penalty to a criminal fine of no more than \$50 for disorderly conduct — a misde-

As a civil penalty, city police were unable to properly enforce the order, but the amendment making it a criminal penalty gave them full authority.

When asked if there had been any issues trying to enforce the mask mandate, police said everyone had been compliant to date.

The mandate requires residents to wear a face covering on city properties but excludes private and residential properties. Masks are not required while eating or drinking, or if socially distanced at least six feet apart. Masks are not required to be medical grade, so long as they cover the nose and mouth, according to the resolution, and bandanas, scarves or other similar fabrics are sufficient.

The mandate remains in effect until the governor's executive order allowing local governments to institute such ordinances expires or the city decides to revoke the ordinance.

General Mills recently announced it is giving away up to 1 million boxes of Cinnamon Toast Crunch via rebate during the month of September to help launch the opening of the new Covington production line.

Through Sept. 30, those purchasing a box of Cinnamon Toast Crunch online

or in-store can receive a rebate for the cost of the box - up to \$6.50 — when visiting FreeCTC.com and uploading the purchase receipt.

Newton starts season with dominant win over county rival Tigers

COVINGTON, Ga. — Make it seven in a row for the boys in

blue.

Newton and Alcovy met on the gridiron for the 11th time at Sharp Stadium on Friday night. After a slow start, the Rams continued their dominance in the series by powering their way to a 27-0 victory — their seventh consecutive win over their cross-county rival and eighth in 11 meetings.

Newton started the year off 1-0, but the coaching staff was far

from satisfied with the team's execution against the Tigers. The Rams continuously found themselves in their own way through penalties, dropped balls and missed tackles.

"We've just got a lot of work to do to get ready for Eastside next week. I'm not happy at all with the way that we played," Newton head coach Camiel Grant Jr. said. "The scoreboard is not what tells us if we're being successful. It's our effort, our focus. The effort was good, but the focus was completely lacking."

After squandering a scoring opportunity late in the second quarter, Grant and his staff were looking for a wake-up call to start the second half.

And that's exactly what they received.

Senior Nyland Green fielded the second half kickoff on his own 3-yard line and sliced through a cloud of white jerseys unscathed on his way to a 97-yard touchdown. Green, the two-way blue chip recruit, finished the night with two touchdowns while also locking down Alcovy receivers from his cornerback

position.

"Every time he touches the ball, a simple play can be an explosive [play,]" Grant said of Green. "You don't have to do something huge with him; just get it to him."

Newton's final strike of the night came midway through the third quarter. Making his first start at the varsity level, junior quarterback Jevarra Martin Jr. dropped a dime pass in the hands of Tyrell Floyd for a 47-yard touchdown to put the Rams up 27-0 with 5:01 remaining in the period.

The Rams' defense would stand pat for the remainder of the game, but so, too, would Alcovy's.

"We can't use the fact that we got shut down and we were behind for a couple weeks as an excuse," Grant said. "That was just sloppy."

Alcovy received the opening kickoff but was unable to capitalize. The Tigers ran three plays and promptly punted the ball away to the Rams, who took over on their own 20.

Atlanta kicks off 2020 season against NFC rival Seahawks

ATLANTA — The offseason program was virtual. There were no preseason games to work out the kinks or gauge the opposition. Any familiarity will be welcomed in Week 1 of the NFL season.

In that respect, there should be a bit of comfort when the Atlanta Falcons host the Seattle Seahawks in a mostly empty stadium Sunday.

These teams are certainly well acquainted with each other.

Atlanta coach Dan Quinn used to be the defensive coordinator in Seattle, so he's got a good feel for his former employer. Likewise for the Seahawks, who are quite familiar with Quinn's tendencies.

If that wasn't enough, this will be the fifth meeting in five seasons between the teams.

"We've seen these guys before," Seahawks coach Pete Carroll said. "We pretty much know their staff, and they know us too. It's not like there's a brand-new coach and it's the first game and we haven't seen anything."

Still, it will be a most unusual opener.

The Falcons are not allowing fans into 71,000-seat Mercedes-Benz Stadium for at least their first two home games because of the coronavirus pandemic.

"It's definitely going to be

different," Falcons quarterback Matt Ryan said. "But I think the intensity level will be there. When you look at other sports — what's gone on in basketball, what's gone on in hockey, what's gone on in baseball — the quality of play has been really good. The intensity has been there."

The Seahawks, who went 11-5 in 2019 and reached the divisional round of the NFC playoffs, feel like they're positioned to make another run at the Super Bowl.

"I'm excited about our group," All-Pro linebacker Bobby Wagner said. "We have a really good, talented group."

Coming off their second straight 7-9 season, the Falcons are eager to get off to a good start. A year ago, they lost seven of their first eight games before rebounding to go 6-2 over the rest of the season.

"Nobody wants to start 1-7," Falcons defensive tackle Grady Jarrett said. "But for us to finish the way we did last year does say a lot."

Some things to watch for when the Falcons host the Seahawks is Matty Ice's new

Running back Todd Gurley was signed in free agency to bolster the running game, which ranked 30th in

the league a year ago with just 85.1 yards per game. If Gurley can stay healthy, that should make the play-action passing game much more

effective. Which brings us to tight end Hayden Hurst. Acquired from Baltimore in a trade, Hurst has good speed for his position and gives Ryan an intriguing option in the middle of the field, especially with receivers Julio Jones and Calvin Ridley drawing so

much attention on the outside. "It's really, really difficult for defenses to key in on all three," Ryan said.
