Woman charged in infant daughter's death

COVINGTON, Ga. - ACovington woman has been charged in the death of her 4-month-old daughter.

According to a spokesper-

son from the Newton County Sheriff's Office, deputies responded to a call Sunday, Sept. 13, about an infant that went into cardiac arrest at a home on Edgefield Lane. The child was later pronounced dead at the

After the Georgia Bureau of Investigation performed an autopsy, the infant's mother, Lakristy Jdeon White, 22, of Covington, was charged with murder and first-degree cruelty to children.

White was arrested and booked into the Newton County Jail on Monday, Sept. 21, according to a report from the sheriff's office. She was being held without bond.

Chairman, judge say county owes them \$180K each

County attorney disputes 40% increase in differing interpretations of state law

COVINGTON, Ga. — The county attorney is disputing claims by the government's top elected official and Probate Court judge that miscalculation of their pay over four years meant the county owes them each more than \$180,000 in back pay.

County Attorney Megan Martin said the government "stands behind its interpretation" of a state law written for Newton County in calculating the salaries of County Commission Chairman Marcello Banes and Probate Judge Melanie Bell since each took office in 2017.

Banes and Bell hired Covington attorney Stephanie Lindsey, who said she interpreted the law differently.

She said the chairman and judge should have received salary increases based on the highest minimum annual salary for any "county officer," defined as the tax commissioner, sheriff, clerk of courts and Probate Court judge.

The county used the sheriff's salary to determine the pay but should have used the salary of Clerk of Courts Linda Hays, including any longevity pay, cost of living adjustments, local supplements and any tax appeal supplements she receives. Hays has been in office 38 years, Lindsey said.

She said Banes' salary for 2020 should have been \$145,000 but the county's calculations meant he is receiving \$101,000 this year. Bell is receiving \$103,000 but should be re-

ceiving \$148,000, the attorney said. "On behalf of Chairman Banes and Judge Bell, we request that a Special (called) Meeting be set, as soon as practicably possible, to handle this matter and review all the applicable laws, documentation and calculations," Lindsey wrote in a letter to Martin.

Martin, whose law firm represents the county government, said the county has historically interpreted the law as calculating the officials' pay based on a formula that did not include cost of living allowances and longevity for other county officials.

"This historic interpretation remains



Mr. Jenkins was born in Decatur to Hoyt and Izora Jenkins. He became a pharmacist and





Mrs. Cason loved to dance, she enjoyed



State agency OKs \$3M loan to extend life of Newton County landfill

COVINGTON, Ga. — Newton County will use a \$3 million loan from a state infrastructure financing program to extend the life of the county landfill after a state agency gave its approval recently.

Georgia Environmental Finance Authority (GEFA) approved the loan for a project planned to add about 740,000 cubic yards of volume and almost seven years of additional life to the Lower River Road landfill south of Porterdale, a news release stated.

Additional space was needed after county officials predicted it would reach its capacity by December 2021, said Curtis Reynolds of Harbin Engineering Co. A "cell" refers to an area of a

landfill designed with extra features such as a rubber lining to stop water runoff from polluting the surrounding environment.

The Newton County Solid Waste Management Authority which operates the landfill will pay back the loan from user fees, officials said in June.

It is a 20-year loan with an interest rate of 1.44% — which is reduced because Newton County participates in a program focusing on water conservation,

according to information from the state agency.

Newton County Board of Commissioners applied for the loan and is backing it because the relatively new solid waste authority has not had time to build up enough "debt service ratio" to qualify for the loan, Reynolds said during a June 3 board meeting.

GEFA approved the loan from its Georgia Fund, which is a state-funded financing program for water, wastewater and solid waste infrastructure.

Newton County also is in the midst of a project it began in January 2019 to move garbage from an older part of the landfill that does not have a lining installed.

The garbage is being moved to a lined area of the Lower River Road landfill so a lining can be installed in its former location by 2022, officials said.

Newton County's landfill loan follows GEFA loans in recent years totaling more than \$50 million to three local government entities for expansion and upgrade of water and sewer systems serving areas countywide.

GEFA approved a \$25 million loan from its federally-funded Clean Water State Revolving Fund in 2019 to Newton County Water & Sewerage Authority.

The loan was to be used to build the Little River Water Reclamation Facility and an access road, convert an existing force main system to a gravity sewer main system, and install a new sewer main to help encourage commercial development in east and northeast Newton County, records showed.

The county agency will pay 1.93% interest on the 30-year loan for the project to provide sewer service to parts of eastern Newton County including the Stanton Springs Business Park, according to state records.

GEFA also approved a \$2.5 million loan from the same fund to the city of Porterdale in 2018 for replacement and rehabilitation of sewer lines and manholes.

In October 2018, GEFA approved a \$23.2 million loan from another federally-funded program to Newton County government for improvements to the county's water system.

The project includes modifications and improvements to a pump station on the Alcovy River, an intake on Lake Varner, and the Cornish Creek and Williams Street water treatment plants.

Organizations are permitted to submit one application per grant cycle, with the exception of schools that may apply for multiple grants.

Bailey is currently running unopposed as a Democrat for the District 4 seat in the General Election on Nov. 3. No Republican candidate qualified.



"The Court has earlier, based upon the open court agreement by the County, made the agreement an Order that mandated the statue not be removed until further order of the Court," Ott wrote.

He said Tuesday's order was issued "to cement what the Court has already ordered.'

"The sheriff of Newton County, who enforces the orders of the court, is obviously empowered to arrest anyone now attempting to remove the statue," Ott wrote.

However, Ott stopped short of issuing any other action against

Humphries sought the injunction the day before the Newton County Board of Commissioners narrowly approved the statue removal on a 3-2 vote July 14.

Local and state Sons of Confederate Veterans groups joined Humphries in seeking an injunction soon after the board's decision to remove the 114-yearold memorial from the center of

the Square.

Kyle King, attorney for the Sons of Confederate Veterans, said Ott "made it clear at the hearing and in his orders that he appreciates the gravity of the legal issues involved and is committed to ensuring that all interested parties get the full benefit of a fair process."

"We appreciate — as we believe all citizens should — Judge Ott's conscientious insistence upon making certain that all sides will be heard and that the rule of law will determine the ultimate outcome," King said.

Humphries' attorney, Walker Chandler, said the order was "great" and he appreciated that Ott "acted promptly" upon hearing about the possible removal.

He said the county would incur "tremendous expense" if the government removed it, lost the case on appeal and was ordered to erect the statue again.

"There's no rush to take it down," Chandler said. Banes declined comment.

For the love of Georgia, take the 2020 Census

time and time again over the last several. months: everyone needs to complete the U.S. Census. But why? Some of you may be wondering, what's so important

t has been preached

about being counted? Why is it important enough to flood my physical and digital mail boxes with reminders about it? Why is it important enough to send strangers to my door during a pandemic to make sure we com-

We'll tell you why. First of all, its required by the U.S. Constitution. It mandates a count of all persons across America be conducted every 10 years.

But it is much more than a head count. Everyone in Newton

County and the great state of Georgia needs to respond to the Census because the results impact us on national, state and local levels, shaping our future for the next decade.

Your response will help determine how billions of dollars in federal funding will be allotted over the next 10 years. This includes funding for hospitals and first responders.

It influences highway planning and construction, as well as grants for buses, subways and other public transit

Census results influence how much money is allotted for education grants and programs that support teachers and school systems across the state.

And that only scratches the surface. Other programs to help provide housing for elders, support rural areas and even aid in the fight against child abuse are included.

The deadline to complete the census is Wednesday, Sept. 30. As of Sept. 21, Georgia was considered one of the lowest ranking

states in its progress on the count.

A report from the Capitol Beat News Service stated "nearly 91% of households in Georgia had completed the census either on their own initiative or after census takers tracked them down via doorto-door visits or phone calls."

And that's a good thing. According to the report, that's an increase from the 81% completion rate seen earlier this month. Unfortunately, we're still lagging behind every other state in the country except Alabama, Louisiana, Mississippi, South Carolina and Montana.

It's really easy and there are multiple ways to respond: online, mail or over the phone.

To respond online, visit 2020Census.gov.

By mail, use the paid postage envelope provided by the Census Bureau. You likely received the paper questionnaire by mail in

To respond by phone, call 844-330-2020 and follow the instructions.

Either option you choose, it only takes about five minutes to complete the question-

Additional information can be found at 2020Census.gov.

If Georgians don't step up and respond to the census, our state and its communities could be suffer for the next 10 years.

We don't want that, and neither do you. so, for the love of Newton County — for the love our great state of Georgia — be counted. Complete the census.

Bipartisan hypocrisy

the Honorable Ruth Bader Ginsburg died last week at the age of 87.

She had been battling metastatic pancreatic cancer.

She was a great judge — a trailblazer though I didn't see eye-to-eye with all of her decisions. Since the sad news of

her passing, I've found unfortunate amusement from the fallout — you know, like it's so bad you can't help but look. Almost immediately

after her death, intentions to appoint Ginsburg's successor before the Nov. 3 general election were announced. Those intentions were and continue to be led by Senate Majority Leader Mitch McConnell.

President Donald J. Trump said he planned to announce his nominee Saturday, after The Covington News' deadline for the weekend edition.

McConnell and his Republican comrades have been adamant in saying they would do everything in their power to approve the nomination before the

presidential election. Democratic senators have been adamant in saying they would do everything in their power to block the nomination. The reason I find

amusement in these recent proceedings started in 2016. Barrack Obama was in the White House and former Supreme Court Justice Antonin Scalia had died. His seat needed to be filled and, wouldn't you know, the Republican-controlled Senate's stance was totally different than it is today. Republican leaders said the Senate should wait and allow the winner of the 2016 presidential election make the nomination.

But it isn't just the Republicans. Democrats have flip-flopped,

In June 1992 — before I was born then-Sen. Joe Biden suggested if a Supreme Court vacancy were to occur before election day and the president made a nomination, the Senate could wait until after the election to take action. But then he also changed his mind. In 2016, then-Vice President Biden argued Republicans should not wait until after the election to move forward once Obama submitted

Several reports said her dying wish was that she not be replaced until a "new president" is installed. Does that mean the winner of the Nov. 3 election or the person that succeeds Trump? And while Ginsburg was a great justice, are we inclined to honor this wish, 'just because?"

In 2016, Ginsberg took a different stance, calling on the Senate to vote on Obama's nomination.

"There's nothing in the Constitution that says the president stops being the president in his last year," she told the New York Times in 2016.

Ladies and gentlemen, this is bipartisan hypocrisy at its finest, and it's disgusting. Why is it that seem-

ingly every decision made by government leaders always points back to a reason being for political gain? Why can't decisions

be based on what our

When it comes to instances such as Supreme Court vacancies, if a precedent is set, our leaders should be held accountable and stick to it. If there isn't a precedent, then set one and, again, stick

No more flip-flopping because it benefits Democrats' or Republicans' agenda.

We don't research candidates for office because we know we are going to vote "R" or "D" based on our ideology or identity. We delete or block people on social media who we disagree with, effectively sealing ourselves in echo chambers that comfortably reaffirm our ideas. We do all of this in the name of being at peace and preserving our mental health. Meanwhile, the preservation of our Constitution and its protection of freedom hangs in the

America recently marked 225 years since the founding fathers signed the Constitution and began this great experiment. This Constitutional Republic has survived wars, pandemics, economic depressions and more. Through it all, Americans have shaped our country and its values

o much is at stake by disagreeing, debating, marching and voting. The persistence of former generations have been centered on preserving our fundamental natural rights as humans. English philosopher John Locke described those as "life, liberty and property." Thomas Jefferson and the signers of the Declaration of Independence later refined Locke's thesis on natural rights as "life, liberty and the pursuit of happiness.'

Today, we are faced with great challenges – from a global pandemic and the devastating economic pressures in its wake to a racial awakening and mounting challenges from a changing climate. These challenges are compounded by an ever increasing political and social divide that has been exacerbated by the prevalence of social media and the evolution of national news outlets to partisan communications machines. Amidst the cacophony of partisan yelling, voters are increasingly weary.

On top of the sheer exhaustion we all feel in this environment, we're also isolated by the pandemic and by an epidemic of loneliness in the personal bubbles we create with technology. We are at risk of

mass apathy – includ-

ing not taking seriously matter your political the sacred obligation to participate in the most fundamental action in a democracy: voting. When we retreat into ourselves, we are allowing the divine rights we have been given to be sacrificed. If we care about addressing the set of challenges that our country faces, we should care about how we cast our vote — and not just for president.

As a Georgian and a Newton County resident, you also have the opportunity to vote for two Senate seats, likely a U.S. House seat, two seats on the Georgia Public Service Commission, representation in the Georgia General Assembly, and a host of local seats for District Attorney, Probate Court, Sheriff, Tax Commissioner, Coroner, County Commission chairman and board of education. In addition, you will be asked to vote on two state constitutional amendments, a statewide referendum and a 1% sales tax on transportation.

When we approach the ballot box on Nov. 3, we will etch into the official record our individual beliefs about the challenges we face. It is a critical moment in our collective lives that will define the course of our governments for years to come. So, no

affiliation, we must not take this responsibly lightly. We must search our hearts and learn more about why we believe what we believe. We must research and educate ourselves so that we can challenge the people who are asking for our votes.

Don't retreat into your shell. Register to vote or check your registration status before Oct. 5. Don't simply rely on a candidate's party affiliation. Research candidates and compare their views and policies to your own beliefs. Discuss the election with your friends and family. Make plans to vote early or mail in your ballot, or if you have to vote on Nov. 5, make plans with your employer to wait in line. The preservation of our Constitution and the protection of our natural rights is at stake. Don't take this moment lightly.

How to know when you should stop mowing

Each weekend in spring, summer and fall, millions of homeowners fire up their mowers and cut the grass in their yards. A few hours spent mowing the lawn can be a great time to get some sun and some exercise in the great outdoors.

As fall gradually transitions to winter, homeowners may wonder when to stop mowing their lawns. Each lawn is different, and when to stop mowing may depend on a host of factors, including local climate and the type of turf. In addition to climate and turf, homeowners can keep an eye on these conditions to determine when the time is right to put their mowers away for the winter.

• Frost: Warm-season grasses typically go dormant after a couple of significant frosts. Homeowners can jot down each frost during fall. Frosts are most noticeable in the early morning hours, so be sure to check lawn conditions each morning as the weather begins to grow cold. Frost may be noticeable without even going outside,

but homeowners may need to go outside to check on chilly mornings or on days when the previous night was especially cold. If you must go outside, stay off the grass to protect it. Two or three frosts might be enough to

make warm-season grasses go dormant for the winter. Cool-season grasses may keep growing and require moving even after a few frosts, so it's imperative that homeowners determine which type of grass is in their yards.

• Soil temperature: If it's hard to determine if frosts have occurred, homeowners can try checking the temperature of their soil to decide if they need to keep mowing. The lawn care experts at Pennington recommend

homeowners continue mowing warm-season grasses so long as they keep growing. Lawns may not grow as quickly in fall as they do in spring or summer, and growth may not be as visible to the naked eye during this time of year as it is in other times. Homeowners can routinely check soil temperature to determine if their grasses have stopped growing. Warm-season grasses tend to stop growing once the soil temperature is consistently at 55 degrees or below, while cool-season grasses tend to stop when temperatures are 45 degrees or lower.

Falling leaves have long been a barometer used by homeowners to determine if they need to keep mowing their lawns. That's not necessarily a reliable metric, as grass can still keep growing even if leaves have been falling for weeks. In addition, using a mulching mower when leaves begin falling is a great way to provide the lawn with nutrients it can use throughout the winter. Some trees shed their leaves more quickly than others, but it's a good rule of thumb that lawns will need to keep being mowed if trees are still retaining more than half their leaves.

A host of factors can help homeowners determine when it's safe to put their mowers away for the winter.

Ways to prepare your garden for cold winter months

following are some general maintenance suggestions that can keep gardens safe this winter.

• Remove weeds and debris. Weeds and debris are unsightly and detrimental to plant life in spring, but they also can be harmful in the winter. Weeds and debris left to linger in gardens through the winter provide overwintering spots for insects and can contribute to disease. So it's imperative that weeds and debris are removed before the ground hardens in winter. Don't wait until the ground hardens, as that can make it hard to remove the roots of weeds, adversely affecting the garden as a result.

• Prepare the soil. The Farmer's Almanac

advises homeowners to gently till the soil in their gardens so they can expose any insects before they settle in for the winter. Once garden soil is exposed, add a layer of compost, leaves, aged manure, and, if necessary, lime, gently tilling it into the soil. According to the North Carolina Cooperative Extension, the only accurate way to determine if lawn or garden soil needs lime is to test it. Lime makes soil less acidic and reduces soil pH. Low soil pH makes it hard for certain plants to grow, but acidic soil is ideal when growing blueberries. Test the soil for lime and amend it depending on what you hope to grow in the spring so it's ready to thrive when winter

nds.

• Remove dead or diseased plants. Dead or diseased plants should not be left in the garden through the winter. These plants can attract insects and are vulnerable to disease, which can make it hard for the garden to thrive in the spring.

• Protect fruit trees.

If you have fruit trees, install mouse guards around the base to prevent mice and voles from killing the trees over the winter. If left to their own devices over the winter, mice and voles may eat the bark of fruit trees, killing the trees as a result. The Farmer's Almanac notes that mouse

guards made of fine mesh hardware cloth can effectively protect fruit trees from hungry mice and voles over the winter.

A gardener's work is never done, and the work to create beautiful spring gardens begins in the fall.

Covington approves more funding for COVID-affected businesses

Gutierrez wins Clerk of the Year award

COVINGTON, Ga. Covington City Council members have approved taking more than \$31,000 from budget reserves for businesses left out of a previous round of grants to help cover losses due to COVID-19.

Council members voted Monday, Sept. 21, to transfer \$31,115 to the Covington Development Authority for the Stabilization Fund grants.

The Authority's board will consider approving a total of 50 grants for entities which applied in a first round earlier this year but were left out because all funds had been given out, said William Smith, economic development manager for the city.

Businesses operating inside the Covington

city limits with 20 or fewer employees can receive up to \$2,000, and sole proprietors and one-employee businesses can receive up to \$1,000.

The Authority will decide the amounts for each applicant based on factors considered in the first round.

Priority will be given to businesses employing up to 20 full- and part-time employees; and those that operate outside the central business district, provide space for independent contractors, or which have operating expenses exceeding \$2,000 per month.

Mayor Steve Horton said the grant money would be taken from surplus funds in the budget. Finance officials predicted they could make budget adjustments in October to replace the money, he said.

The Covington Development Authority gave \$121,496 in the first round after using money from the city's Electric Fund and reimbursing it with federal CARES Act funds, Smith said.

In other action at the meeting, council members unanimously denied a special use permit for a personal care home at 5128 N. Emory St. near the I-20 overpass.

The home is adjacent to the Conyers Haitian Church of God, which owns the building.

Applicant Micheline Joseph told the council the 95-year-old building would be staffed round the clock and be home to four individuals.

However, the planning commission

recommended denial because it did not believe it was a compatible use for the area, officials said.

Councilwoman Fleeta Baggett said she did not believe the house's location on the halfacre lot would make it accessible to ambulanc-

Sheriff's Office to hire deputies, buy equipment with two federal grants

Newton County Sheriff's Office will be able to hire seven new deputies and buy more equipment with two new federal grants.

A \$1.1 million COPS Hiring Program Grant will allow the sheriff's office to hire the new deputies and meet response time goals for priority calls, a news release stated.

The Newton County Board of Commissioners recently approved the Sheriff's Office to accept the FY20 COPS Hiring Program, a three-year grant funded by the U.S. Department of Justice.

Board members voted Aug. 4 to accept the funds in the amount of \$1,122,792.

"The Newton County Sheriff's Office has been on the forefront of seeking out grant

opportunities to assist with the needs of our agency and the community," said Sheriff Ezell Brown in a news

"The \$1.1 million will afford us the opportunity to hire seven new deputies to patrol the Newton County community. With the effects of the COVID-19 pandemic causing unemployment for many, being able to open up additional job opportunities is truly a blessing."

Under the COPS Hiring Program, the Sheriff's Office will be able to:

- Hire seven entry-level deputies
- Meet response time goals for priority calls;
- Maintain adequate visibility as a deterrent to crime in neighborhoods:
- Improve the office's ability to enhance its

community policing efforts with county residents;

- Field two-officer responses to dangerous calls for services;
- Sufficiently lower the crime rate through the use of consistent and comprehensive interdiction tactics;
- Adequately enforce traffic laws, which in turn affects mobility of its units

Additionally, the FY20 COPS Hiring Program will allow the Sheriff's Office to increase its manpower on each shift, allow for more visibility during high peak times, and allow for better execution of day-to-day work assignments.

Through the program, the Sheriff's Office will continue to build positive relationships with its community," a news release stated.

Meanwhile, Newton County will receive \$27,636 in a Edward Byrne Memorial Justice Assistance Grant (JAG) if the grant is accepted by the board of commissioners, according to a news release from U.S. Sen. Kelly Loeffler, R-Ga.

The annual grant award will be used for purchase of equipment for Newton County Sheriff's Office deputies and detention officers "to effectively execute assigned

duties," according to information the Sheriff's Office gave county commissioners.

Newton County was among 33 Georgia counties and cities approved for a total of \$1.76 million in U.S. Department of Justice grants to help states and local governments prevent and control crime based on local needs and conditions.

Loeffler announced the grant awards, which counties and \$1 million for cities. "Everywhere I go in

totaled \$766,000 for the

Georgia, I hear about increases in crime and concerns about public safety," said Loeffler. "These grants will go a long way to helping our communities prevent crime, break up gang networks, stop domestic violence and hold criminals accountable."

The Edward Byrne Memorial Justice Assistance Grant (JAG) Program provides funding for programs or initiatives including drug and gang task forces, crime prevention and domestic violence programs, courts, corrections, treatment or other programs aimed at reducing crime or enhancing public safety.

Neighboring counties, including Henry at \$26,532, and Rockdale at \$13,710, also were approved for grants.

EASTSIDE ESCAPES

Eagles' last-second field goal seals comeback against Alcovy

COVINGTON, Ga. – Eastside didn't hold the lead for a single second of regulation against Newton County rival Alcovy in Friday night's matchup.

And yet it was the Eagles who stormed the field victorious in the end.

Knotted up at 31 points apiece with less than a minute to go, Eastside's defense forced the Tigers to punt the ball away from inside their own end zone. The Eagles set up shop on the Alcovy 34 and inched their way down the field, positioning themselves for a 36-yard field goal attempt with just two ticks remaining on the clock.

Lined up on the left hash, junior kicker Jaydon Fain took three steps and promptly drilled the ball through the upright to lift Eastside to a 34-31 win as time expired.

"We're not playing to the scoreboard. You play every play, you play with relentless effort, and you keep doing that for the duration," Eastside head coach Troy Hoff said. "[Friday] we made enough plays down the stretch and put ourselves in position to win the football game."

The final kick spelled victory for the Eagles. It also spelled redemption for Fain.

With his team facing a seven-point deficit in the first half, Fain lined up for an eerily similar 36-yard field goal, but pushed it wide right for a miss. When Eastside's defense came up with a late stop, the coaching staff had no question about who was going to get a shot to win it.

"I just told [Fain] to get ready," Hoff said. "He's been solid all week, solid in pregame. I know he missed the one earlier in the game that he's going to kick himself for, but we trust him. He's put in the work. He takes a lot of pride in what he does, and the guys trust him."

Fain's game-winner sent

the Eagles to 2-1 on the year while dropping the Tigers to 0-4. Eastside has now won seven straight in the series dating back to 2013.

The night ultimately belonged to Hoff's Eagles, but second-year head coach Jason Dukes had his Tigers rolling from the jump.

After winning the coin toss and electing to receive, Alcovy marched straight down the field during its first possession. The Tigers capped off an eight-play drive with a 1-yard rushing score from junior Tristian Mayweather to go up

They found success on the ground again early in the second quarter. A drive that begin on their own 27-yard line ended in the end zone when sophomore Joseph Seay punched it in from six yards out. The Tigers held a 14-0 advantage with 10:37 to go in the half.

Coming off six straight losses to their county rival, it appeared as if the tide had suddenly shifted in Alcovy's

SOCIAL CIRCLE, Ga. — The Social Circle Redskin stays put. That's the message from Social Circle City Schools, which issued a statement explaining why the

traditional Native American imagery, which has proven controversial especially in recent months, will remain for the time

being. The mascot proved

a lightning rod for conflict in the weeks following the announcement of the NFL's Washington Football Team — previously the Washington Redskins — to abandon its mascot after years of protests over the term, which many in the Native

American community

consider a slur.

Similar protests began to emerge in local meetings of the Social Circle Board of Education, as student, teachers and alumni banded together to demand the Redskins mascot be retired. This, in turn, inspired counter-protests from those who defended the mascot as traditional and insisted

"During the last three board meetings, several individuals addressed the board regarding our high school mascot," city schools Superintendent Robbie Hooker said.

it stay right where it is.

"While some speakers have requested that we change the mascot name, others have asked that we maintain it. We have listened intently and respectfully to both sides."

Hooker said the mascot would remain, due in part to budget constraints and pan-

Putnam County War Eagles 45, Social Circle Redskins 0

Putnam spoils 'Skins homecoming

Putnam County's stifling defense held Social Circle scoreless Friday night, handing the Redskins their third loss of the season.

SOCIAL CIRCLE, Ga. — There was no time for the Redskins to catch up Friday night as the Putnam County offense ran wild for four straight quarters.

Social Circle lost to the War Eagles by a score of 45-0, dropping their third game of the year while also matching their record four games into the 2019 season.

The War Eagles had no trouble moving the ball on the opening drive of the game, using flat routes and outside runs to gash the Redskins defense early. After passing midfield, quarterback Gerald Kilgore tossed it to halfback Cedrion Brundage who took it 42 yards for a long touchdown run to put Putnam County

up early. On Social Circle's first drive of the game, sophomore quarterback Logan Cross was not missing his targets. Cross opened the game completing seven of his first eight passes, but the Redskins eventually turned the ball over on downs inside of the 10-

yard line. After a promising opening drive on offense for Social Circle fell flat, the War Eagles took the momentum right back. After getting Putnum County back into the red-zone on a big run, Brundage took the carry at the goal line for the one-yard touchdown run to extend the lead over the Redskins 14-0.

After a quick threeand-out, the drive got worse for the Redskins as the long snapper sent the ball over the punter's head and into the back of the end-zone for a safety, giving both the ball and points to the War Eagles.

After once again stopping Social Circle on offense, Putnam County capitalized on good field position by letting Kilgore take the quarterback keeper 21-yards for the touchdown, extending the War Eagle lead to 22-0.

Before the end of the half, the War Eagle's duo converted two more rushing touchdowns as Kilgore and Brundage got in for scores and gave Putnam County the 36-0 lead over the Redskins going into halftime.

Trailing by 36 and having the running clock looming in the second half, it was clear that the Redskins would need a quick answer coming out of the locker room in order to stop the high-powered War Eagle offense while also breaking through their stout defense.

Things did not end up turning around for the Redskins as the third quarter got underway. On the first play of the second half, Cross was picked off on the deep ball to junior wide out KJ Reid.

The War Eagles found the end zone for the final time of the

night on the ensuing drive, as Brundage would find the touchdown on a 26-yard rush to give Putnam County the 43-0 lead.

During the fourth quarter, another punt team miscue bit Social Circle as the snap went under the punter this time and trailed out the back of the end zone for their second safety of the game, giving the War Eagles their final points of the game.

Social Circle is now 1-3 after the tough loss, and they will look to get back in the win column as they go on the road next week to take on Oglethorpe County on Friday, Oct. 2.

Dawgs are ready to ball

No. 4 Georgia opens season at Arkansas

Ark. - A nearlymonth-long postponement to the start of college football in the

Southeastern Conference may feel different, but it won't look much different.

Georgia, as has it has been for much of the last decade or so, is projected to finish near the top of one of the best conferences. Arkansas, has it has been for much of the last few years, is predicted to finish near the bottom. The two will open their seasons against each other Saturday.

The Bulldogs are No. 4 in the nation. The Razorbacks are not anywhere near that, having not beaten a fellow SEC member since October 2017 (Ole Miss). Georgia has hopes of a championship. Arkansas has hopes to win a game.

Their mutual commonality is Arkansas coach Sam Pittman. An offensive line coach with the Razorbacks from 2013 to 2015, Pittman left to take the same job at Georgia and was hired last December to run things at Arkansas after Chad

Morris was fired. Pittman and his old boss, Georgia coach Kirby Smart, remain

"Going against a very good friend of mine in coach Sam Pittman, who did just an unbelievable job while he

was here," Smart said.

As expected for a team seemingly in a neverending rebuild, the roster is light at Arkansas. Smart doesn't have that issue and, in fact, has multiple op-

tions at quarterback. Southern California transfer J.T. Daniels was expected to take a majority of the snaps this season, but an injury has kept him limited. D'Wan Mathis, a carryover from last year's team, has shined in the preseason and may provide Smart and the Bulldogs with a two-man look in the opener.

Quick Facts

The Bulldogs are 96-27-3 in season openers including 20 of their past 23. Georgia is 4-0 in season openers under Kirby Smart. Last year, the Bulldogs defeated Vanderbilt 30-6 in Nashville, Tennessee, to open the 2019 season.

Arkansas is hoping its quarterback problems have subsided after 15 interceptions and two fumbles at the position a year ago. Former Florida quarterback Feliepe Franks' primary directive from Pittman has been ball security.

"I think he has more confidence in his wideouts that they're going to run the proper depth, make the break at the proper time," Pittman said. "He's throwing the ball very well right

As for the friendship and familiarity between Pittman and Smart, it is a talking point before

the game and little else. "They're doing the best job they can to prepare their team and we're doing the best

job we can to prepare ours," Smart said. "It usually boils down to what the players do on the grass, not what we do as coaches."

OLD FRIEND, **NEW FOE**

Pittman left Georgia on positive terms. Having coached college football full-time since 1991, 2020 is the first year he has had an opportunity to have full control of a program as

head coach. Smart holds no grudges for a live-it, breath-it football guy like his former offensive line coach.

"He helped build the foundation of what we have now," Smart said.

ONE-SIDED

Georgia has dominated the series with Arkansas since the Razorbacks joined the SEC in 1992, winning eight

of 10 matchups and the last loss coming in 2010. Saturday's game will be the first meeting between the Eastern Division Bulldogs and Western Division Razorbacks since 2014.

STRENGTH vs **STRENGTH**

Arkansas will rely heavily on Rakeem Boyd, who ran for 1,133 yards for an offense that was ranked 13th in the 14-team SEC. The Bulldogs may not have much issue with that. Georgia led not only the SEC, but all of FBS, last year in rushing defense, allowing just 74.6 yards per game on the ground and the Bulldogs had eight players named to the various preseason All-SEC teams.

> SO CLOSE, YET SO FAR Georgia has been

ranked in the preseason Top 25 each of the last 10 years. The Bulldogs have finished a season in the top 10 five of those years. Only once, however, has Georgia made a College Football Playoff. Arkansas is by far the easiest early-season opponent this year as the Bulldogs' next five opponents are all currently ranked in the Top 25, including three in the top 10.

FOOTBALL IN A

PANDEMIC Capacity at Donald W. Reynolds Razorback Stadium, which can normally hold upwards of 76,000 spectators, will be limited to about 16,000. Pre- and post-game tailgating, a common Saturday tradition, is also not permitted on campus,

SEC football opens minus big crowds, tailgating, some stars

Southeastern Conference football games won't have their normal scenes of packed stadiums and partying tailgaters.

Gone, too, are some of the league's best players, including LSU wide receiver Ja'Marr Chase and much-anticipated new Georgia quarterback Jamie Newman. In the season of COVID-19, SEC teams finally open their 10-game league only schedule on Saturday.

It mixes excitement with a healthy dose of uncertainty. How many games will be canceled or postponed? Which teams can avoid being decimated by positive tests at a certain position or losing their starting quarterback?

Even SEC Commissioner Greg Sankey said Wednesday: "I still am in the hold my breath moment a bit."

So are coaches. Players are still opting out leading up to the first games, including Vanderbilt linebacker Feleti Afemui and Texas A&M linebacker Anthony Hines III.

Sankey, meanwhile, does have a new definition of what qualifies as a successful season.

"Being in Atlanta on Dec. 19 naming a conference champion, I would

define that as a success," he said. Most SEC coaches are playing it close to the vest in identifying players who will miss the game because of COVID-19, if they have any. Their silence is as much about a competitive edge as players' privacy.

As Florida coach Dan Mullen said: "You'll find out Saturday."

The situations could be fluid, with testing continuing during the week. Alabama's coach, Nick Saban, said Monday there weren't any players for the second-ranked Crimson Tide out for the game with COVID-related issues.

"But we're testing every day so that's kind of an ongoing process as to how that goes," Saban said.

No. 8 Auburn had a half-dozen players returning from quarantine on Tuesday, coach Gus Malzahn said.

Aside from which players will be available, another adjustment will be the mostly empty stadiums.

Most teams are allowing 20-25% capacity at games, though Vanderbilt won't have fans through at least October. There's also no tailgating on campus, or band performances.

There's no way to measure the impact of COVID-19 will have on this weekend, much less for the season. But there have already been some winners and losers with players opting out, creating unexpected

challenges for teams. Texas A&M has had at least five players opt out, including leading receiver Jhamon Ausbon, who had 66 catches for 872 yards last season. Hines, the No. 2 tackler last season, just announced his decision on Sunday. Wide receiver Camron Buckley is also out for the season with a knee injury. Also sitting out is projected starting cornerback Elijah Blades, along with backup quarterback James Foster and safety Derrick

 Losing Chase was a big blow for an LSU team already replacing Heisman Trophy-winning quarterback Joe Burrows. Chase set SEC records with 1,780 receiving yards and 20 touchdowns en route to winning the Biletnikoff Award as the nation's top receiver. Safety Kary Vincent (47 tackles, four interceptions) and standout defensive tackle Tyler Shelvin are also opting out.

Coach Ed Orgeron is hoping his

team is largely in the clear for much of the season because "most of our players have caught it." He said those players who have recovered from COVID-19 don't have to be tested again for 90 days under SEC

 Georgia might be just fine without Newman, especially with former USC starter JT Daniels eligible for the season and joining the competition with D'wan Mathis. But it's still a blow for a team that must replace Jake Fromm. Plus, as of late Wednesday morning, coach Kirby Smart said Daniels has "not been medically cleared" to play while re-

covering from an injury last season. —Fans and tailgating traditions are taking a big hit, too. With mostly empty stadiums and no pre-game walks through cheering fans. Even The Grove at Mississippi will be closed for tailgating and the Walk of Champions.

Vandy center Grant Miller said it's not altogether new, comparing losing those players to teammates suddenly going down with injuries.

"You just have to have a next man up type of mentality," Miller said.

Atlanta faces Bears after nightmarish loss

Falcons still vying for first win of 2020 season

ATLANTA — Let's see if the Atlanta Falcons can put another nightmarish loss behind them.

The team that infamously squandered a 28-3 advantage in the 2017 Super Bowl suffered an improbable defeat in Week 2 of this NFL season, blowing a 20-point lead to the Dallas Cowboys and giving up an onside kick that set up a game-winning field goal on the final play.

The 40-39 stunner turned up the heat on coach Dan Quinn, especially when owner Arthur Blank said it looked as though the Falcons (0-2) didn't know the onside kick rules.

Quinn urged his team to turn its attention to Sunday's game against the Chicago Bears (2-0), but he conceded that it wouldn't be easy to get over such a disappointing outcome.

You have to recognize the emotion," Quinn said. "Yeah, you're (ticked). We have to put it into another space, but it's important to acknowledge why you're so

(ticked). That's the life of a competitor. It's hard, but you have to get past mad, you have to get past frustrated if you're going to have the season you want."

The Bears have a shot at their first 3-0 start since 2013, though they've hardly dazzled in their first two games.

In Week 1, Chicago rallied from 17 points down to beat the Detroit Lions 27-23. Last weekend, the Bears nearly blew a 17-point lead of their own, hanging on for a 17-13 win over the New York Giants.

"You're always happy about the win, but not too happy because

we haven't played a full game together," Bears quarterback Mitchell Trubisky said. "We know what we're capable of if we do play four quarters, so that's gotta be the goal."

The Falcons would like to second that sentiment. They appeared to

be cruising at Dallas, taking advantage of three early turnovers on the way to a 29-10 halftime lead.


Even after the Cowboys rallied, the Falcons were up 39-24 with 5 minutes to go. But the defense couldn't hold, giving up a pair of touchdowns that gave Dallas hope. Even then, the Cowboys had to pull off an onside kick — a real longshot given rule changes that were designed to improve player safety.

The Falcons backed away from the spinning ball, simply watching until it had carried 10 yards. That allowed the Cowboys to make the recovery and win the game, turning Atlanta into the sort of national laughingstock that brought back memories of the Super Bowl meltdown.

Quinn insisted that his players understood the rules, but were simply befuddled by the strange kick.

"Arthur and I can disagree on how we talk about it, but what we 100% agree on is that it shouldn't have happened," the coach said. "We've got to work to make sure it doesn't happen again."
