# Fulton deputy shot, killed in Covington

# Newton County Sheriff's Office investigating alleged domestic violence incident

COVINGTON, Ga. — The Newton County Sheriff's Office is investigating the death of a Fulton County sheriff's deputy who was killed Wednesday night in an alleged domestic incident in Covington, authorities said.

Shakeema Brown Jackson, who became a Fulton sheriff's deputy just more than a month ago, died in the

incident, said Fulton County Sheriff Patrick "Pat" Labat.

Her brother, Levoy Brown, also died in the incident after they were

shot "multiple times," FOX5 News reported.

Jackson was off-duty in

the Covington home she shared with a man and her 17-month-old child. The child was not harmed, two Atlanta news outlets report-

Investigators said the pair was killed Wednesday around 10:30 p.m. A K9 unit searched the home's backyard but it was unclear what they were searching for, WSB-TV reported.

The Newton County

Sheriff's Office is actively investigating and asked that if anyone had information on the incident to contact Investigator Joshua Hicks at 678-625-1455 or jhicks@ newtonsheriffga.org, according to a posting on the agency's Facebook page.

"Sheriff Ezell Brown and the Newton County Sheriff's Office send their condolences to the victims' families and to Sheriff Pat Labat

and his staff members," the social media post stated.

Detectives are interviewing witnesses and have not yet named a suspect, a spokesperson said.

Her mother, Zona Inman, told FOX5 News her children were both very religious and she wanted their killer brought to justice.

Labat said Jackson had

# **SKC expanding**

# Plans to invest \$473 million, employ 400 in 'first of its kind' Covington semiconductor part plant

tspigolon@covnews.com COVINGTON, Ga. - SKC

Inc. will create more than 400 new jobs as it works with several business partners to manufacture a part for semiconductor chips in a new facility on its Covington site.

The company will invest more than \$473 million in this "unprecedented venture" to create glass-based substrates for the chips in Newton County, the governor's office announced Thursday, Oct. 28.

SKC expects to ramp up production by late summer 2023, a news release stated.

The new facility will be developed on the SKC property at 3000 SKC Drive and will primarily be hiring high-tech engineers, skilled technicians and other semiconductor field-experienced talent, the release stated.

Lanier Sims, chairman of the Newton County Industrial Development Authority, said, "Since the 1996 headquarters announcement, SK has been an integral business in Newton County's business mix."

"SK is a key community partner through their commitment to service and education locally," Sims said.

"SK is truly a pioneer that we are honored to have a long-term relationship with Newton County. The Industrial Development Authority is grateful for this

announcement, and we believe this is a continuation of strong partnership and perseverance together."

Serra Hall, executive director of the Newton County Industrial Development Authority, said the facility will be a new one on the SKC site.

She said COVID delayed the project but the company was glad work on it was able to continue in partnership with state and local economic development

"We are grateful to the city of Covington for their partnership," she said.

# Low turnout for early voting period

Council seats in Covington, Porterdale referendum to be decided on Election Day

Covington and Porterdale voters should be able to get in and out of their voting locations in a hurry Tuesday if advance voting numbers in the two cities are indications of how heavy turnout will be in this year's elections.

Numbers for the three weeks of early voting in the Covington and Porterdale elections showed relatively sparse turnouts in each city, election officials said.

### COVINGTON

Angela White-Davis is director of Newton County Elections and Voter Registration, which conducted advance voting for Covington.

She said turnout at the advance voting location in the Newton County Administration Building had been light with a total of 519 casting ballots

in-person and 44 absentee ballots returned through about 11:20 a.m. Friday morning.

About 31 per day had voted in-person, according to the numbers.

The total number of in-person and absentees equated to about 5.5% of the 10,163 registered voters in Covington.

In-person voters included 371 from the East Ward and 148 from the West Ward, with Advance In-Person voting ending at 5 p.m.

Meanwhile, a total of 74 absentee ballots had been requested - 25 in the East Ward and 49 in the West Ward — and 44 returned.

The cutoff date for requesting an absentee ballot to be mailed was Oct. 22, which was 11 days before the election date of Nov.



# Covington council OKs studies for 'roads of concern'

COVINGTON, Ga. — A proposal from Keck & Wood, Inc. to conduct more traffic studies throughout the city was unanimously approved during a special-called city council meeting Wednesday, Oct. 26.

The engineering firm had already been contracted by the Covington City Council to conduct a traffic analysis and parking study of the downtown area for approximately \$100,000, which affects the Square and various streets leading into the Square. Results of downtown study are expected to be presented in the coming weeks.

At the request of Covington Planning and Development

 Roadway analysis of City Pond Road, Covington Bypass and Turner Lake Road, where engineers will evaluate the existing condition of these thoroughfares and help determine what changes (if any) are needed to best serve the areas as new developments are welcomed.

## Two men sentenced to life in prison for separate Newton murders

COVINGTON, Ga. — Two men in their 20s will spend the rest of their lives in prison after they were sentenced for separate murders they committed in 2018 and 2019 in Newton County.

A 20-year-old Decatur man was sentenced Tuesday, Oct. 26, for the murder of a Covington resident following a home invasion in April 2019.

And a Newborn man received three life sentences after he was found guilty of murder and other charges for the shooting death of a Newton County resident in November 2018.

A Superior Court judge sentenced Keyondre Bernard Preston to Life Without Parole plus 15 years after a jury last week found him guilty of the April 2019 murder of Shelvis Hillman and other crimes, including multiple armed robberies that

occurred during the incident at the victim's Washington Street

"In addition to these crimes, the state presented evidence at trial of two armed robberies previously committed in DeKalb County," District Attorney Randy McGinley said.

'The testimony showed that Preston had shot at the victims in those cases. He was out on bond for these offenses when he committed the Newton County crimes."

During the sentencing hearing in Newton County Superior Court, a judge also heard victim impact statements from Hillman's children, mother and wife,

"Additionally, the state presented evidence of Preston's criminal activity as a juvenile, including a robbery," McGinley

The jury on Thursday, Oct. 21, found Preston guilty of Malice Murder, Felony Murder, three counts of Armed Robbery, three counts of Aggravated Assault, two counts of Burglary, and three counts of Possession of a Firearm During the Commission of a Crime.

His DeKalb County armed robbery victims and law enforcement officers that investigated the crimes testified during the trial, McGinley said.

Preston's conviction and sentencing follows an incident that

**WORLD SERIES: Economic impact** estimated to be in the millions

Cobb County can expect an economic windfall of at least \$5 million each night that Truist Park hosts the World Series, says an Emory economic and business professor.

"It could go up to

about \$10 million per night, but that figure might be on the high side," said Tom Smith of the Goizueta Business School. "But I think you're looking at somewhere between \$15 million and \$30 million if all three of the scheduled games are held."

Games 3 and 4 of the World Series between the Atlanta Braves and Houston Astros are set for Friday and Saturday at Truist Park, with Game 5 set for Sunday.

The Astros and Washington Nationals played in the 2019 World Series, which was the last Major League Baseball championship to be held before live, sold-out crowds before the pandemic. In 2019, Destination DC, the official destination marketing organization for Washington, D.C., was estimating an economic impact of \$6.5 million with two home games at Nationals

Park. Smith said the series won't have as much economic impact on the rest of metro Atlanta other than Cobb Coun-

"When you have an event taking place in town and most of the people going to the game live in the area, there's just a transferring of spending from one activity to another," Smith said. "Instead of going to Ponce City Market in Midtown, you go to the Battery."

The Battery is also holding watch parties for the series when it is played in Houston, which Smith called an amazing opportunity for those businesses.

"These are days when usually there hasn't been anything else going on at this time of year," he said. "It's going to be insane there. You're going to

have 50,000 to 100,000 people in your backyard for a few days in October."

The Cobb Chamber of Commerce doesn't have a predicted economic impact from the games, but President and CEO Sharon Mason said all of the hotels in the Cumberland Community Improvement District (CID) are

In 2018, the chamber commissioned a Georgia Tech economic impact study that showed the Braves bring more than \$18 million into the immediate area around the stadium, an area that does not include the CID.

Of that amount, \$14 million goes to Cobb schools, Mason said, and \$4 million goes to the local government.

### **WORLD SERIES: Attorney general** warns of ticket scams

Hoping to watch the Atlanta Braves in their first World Series since 1999?

The Georgia attorney general's office issued a consumer alert Monday, warning that fans might fall prey to ticket

Attorney General Chris Carr said major sporting events such as the World Series which was to begin Tuesday night in Houston and moves to Truist Park in Atlanta for Games 3 and 4 Friday and Saturday, and a Game 5 Sunday if necessary - present an opportunity for scammers to try and make an easy buck off unsus-

pecting fans. Carr said the scams pose a risk not only for financial theft, but also identity theft if financial and personal information is provided

as part of the deal. The Atlanta Journal-Constitution reported Monday that the lowest price on StubHub, the official fan-to-fan ticket marketplace of Major League Baseball, was \$925 plus fees.

### **WORLD SERIES:** Kemp takes swing at MLB after **Braves advance**

Gov. Brian Kemp took a big swing at the MLB after the Braves advanced to the World Series.

Georgia and the Braves were snubbed earlier this year when the MLB yanked the All-Star game from Truist Park earlier this season in protest of a new Georgia election

"While Stacey Abrams and the MLB stole the All-Star Game from hardworking Georgians, the Braves earned their trip to the World Series this season and are bringing it home to Georgia," Kemp tweeted, then followed with, "Chop On, and Go Braves!"

The new law includes a new ID requirement for mail-in votes, curbs the use of ballot drop boxes, bans outside groups from handing out food and water to voters in lines, and ex pands weekend voting in some rural counties.

A lawsuit was filed in June by the U.S. Justice Department to challenge the law. President Joe Biden called it, "Jim Crow on steroids.'

Monroe mayor, councilman swap accusations weeks before election

Monroe Councilman Norman Garrett re-

cently posted images of credit card receipts to a social media page, accusing Mayor John Howard of misusing his city-issued purchasing card by buying alcohol in 2019.

One receipt was to Indio Brewing Company in Sugar Hill, Georgia, for \$14.33. Another was for food and drink, including a Long Island iced tea, with a total of \$88. The third, also for food and drink listing two orders for Ketel One vodka, totaled \$95. City Administrator

Logan Propes verified in an email that the three receipts "do appear to be charges to the city on the purchasing card back in 2019." "I hate to plead igno-

rance but there's no ill intent there," Howard said of the three receipts Thursday. Howard said several dinners early in his tenure had unexpected-

ly turned into business meetings. He pointed out that one receipt was "basically a wash," because it was for a Municipal Electric Authority of Georgia function where he didn't take the per diem.

Propes told The Tribune in September that the mayor asked to have his P-card use cut off in mid to late June 2021. The mayor has since been putting these types of charges on his personal credit card, according to Propes.

Garrett alleges that the city's Finance Department cut Howard's P-card use off and accused Propes of covering for the mayor.

Howard categorized Garrett's accusations of P-card misuse as aggressive partisan tactics. Howard is running for reelection in the nonpartisan city races Nov. 2.

Garrett, Howard said, is head of the Democratic Party in Walton County. Democrats are attempting to use local elections as a way to "turn the state blue," he

Howard also pointed out Garrett's past as a convicted felon. Garrett was convicted in the robbery of the Good Hope post office in the early 1990s, convicted in U.S. District Court in Athens in 1994. He was sentenced and served time, and his State Board of Pardons and Paroles restored Garrett's civil and political rights in July 2013. Garrett was elected to the city council without opposition two years later.

The mayor, who was on a break from a budget meeting, said he's been to five such recent meetings. The city has begun its annual budgeting process for the coming fiscal year.

"Out of the five, Norman Garrett hasn't been to one," Howard said. "We're trying to do the business of the city."

Garrett said mu-

nicipal elections are nonpartisan and that the Democratic Party in Walton County does not "have a lot of say-

"It's a Republican

(majority) county," the councilman said. "It has nothing to do with him being Republican."

Garrett accused Howard of being divisive. "I know we have a

liar-in-chief, someone that has no credibility whatsoever," Garrett said. "John will say basically whatever you want to hear."

Alcohol purchases are prohibited under the city's P-card policy, which was updated in December 2016 to include elected officials. The policy states P-cards can be used to buy items for official city use that fall within the policy. These officials can use P-cards for lodging, fuel, food, non-alcoholic beverages or education and training materials while

on city business. Howard is running for a second term, opposed by Emilio Kelly.

# Braves at risk to get chopped?

just don't understand some people's way of thinking these days. You've likely seen

Atlanta Braves in the news over the last few of days. but

I'm not talking about their chase for a World Series title. I'm talking about their name. Yep. Their name.

Apparently it's become an issue that Atlanta's baseball team is called the Braves, and "The Chop" has also become a topic of criticism again. But, of course, none

of this is new territory. It was July 3, 2020, when the NFL's Washington Redskins — now simply named, "Football Team" officially announced it would undergo a thorough review of its team nickname.

Only 10 days later, the team announced it would retire the former name and determine a new one.

On July 23, 2020, Washington ushered in the new era by an-

nouncing it would be known as the "Washington Football Team" until a new nickname could be determined.

In recent months, team executives reportedly said they were close to a decision on the new nickname and would reveal it in early 2022, just in time for next season.

Around the same time Washington announced the team would review its use of "Redskins," the Cleveland Indians baseball team announced they, too, would work to "determine the best path forward" regarding its nickname.

In December 2020, national media reported the Indians would be no more after the 2021 season. Then, this past July, Cleveland announced they would become the Guardians, but even that's become a sticky situation. Apparently, the city has a men's roller derby team with the same name — who knew? I guess not the

So, why did these teams make a change? It wasn't just the public outrage, because we've heard that before. In fact, the cry for Washington to change its name had started years prior.

baseball team.

But this time was different.

The Washington and Cleveland front offices, including their owners, were starting to feel some pressure from major sponsors, which meant they were at risk of losing millions of dollars in revenue.

Don't get me wrong. I get it. While it's often said to be the root of all evil, money is everything in the world of business.

Fortunately, it appears the Braves won't succumb to the pressure and make a name change anytime

# Bumper sticker shows bias against the media

The message printed on the bumper sticker was clear, and it imme-

caught my eye as I walked by it recently in the

parking

lot of an area grocery

"Defund the media," it declared, and I admitted to offering a sly smile. As someone who had made a career from working in the media, even at the community level, I found the message on the sticker completely misguided.

There is no denying there is a bias against the media these days.

Note that it is a completely different thing than "media bias" which is a phrase often thrown about on opiniated talk shows on cable news stations.

Yes, newspapers offer opinions on a variety of subjects. It's called the opinion page

Some will agree with the thoughts offered, and some will disagree. There is nothing wrong with that, of course, although we have unfortunately become a nation of "you agree with me all the time or you are wrong." Even a discussion of ideas seems no longer welcome by

The publication you are currently reading certainly offers a great service to its readers. You have news of what government officials are doing. There are crime-related stories. You have the obituaries.

There is also plenty of local sports coverage, which is something I have always enjoyed reading and writing. In many issues there are letters to the editor where readers offer their thoughts on a variety of topics.

The message displayed on that bumper sticker was certainly wrong about this publication being funded by tax dollars. That is not the case. Newspapers make their profits from advertisers and subscriptions. There is no weekly or monthly check from the U.S.

Treasury.

People are free to support the local publication or not. There is no requirement to subscribe or place an advertisement, or to even buy a single copy. You don't even have to acknowledge its existence.

It's what free enterprise is all about.

In theory, the person displaying the bumper sticker could have been referring to public broadcasting. However, I kind of doubt it.

In reality, it was a blanket accusation that all media are biased against Donald

Trump or conservatives or anyone else the person supported politically. (Based on other bumper stickers, it appeared the owner

was a conservauve.) The opinion page is such a small portion of a newspaper, especially one such as this. There have been plenty of opinion pieces I have disagreed with. From my point of view, that is fine.

Through the years, I've typically disagreed with George Will, but I almost always read him. The reason? He was one of the best opinion writers in the business. While I might not have agreed with what he was saying, I always liked to see how he structured his argument. Plus, there is nothing wrong with reading something you disagree with. To only read what echoes our own thoughts gets pretty boring pretty quickly.

As I walked away from the "defund the media" bumper sticker, another one entered my mind that I placed my eyes on a couple of weeks earlier. It proclaimed, "I express my individual thoughts through mass-produced bumper stickers."

Indeed.

Long-time Georgia state representative and arch-conservative Don Parsons, of Cobb County, responded, "I believe it is important that people know that Donald Trump does not speak for this Republican in his statement about Gen. Colin Powell. Even after what he, who has never served one day in the uniform of the Armed Forces of our nation, has said about the late Sen. McCain, as well about Gen. Mattis, Gen. Kelly and others, I was somewhat taken by surprise by his statement. Gen. Powell was a great soldier and a man of character and integrity. He loved our nation and served it well." Amen.

Colin Powell is an American success story. He didn't inherit millions of dollars from his daddy's real estate empire in Manhattan. He was the son of Jamaican parents – a shipping clerk and a seamstress. He didn't attend a fancy boarding school. He attended public schools in the South Bronx.

Upon graduation from the City College of New York, Colin Powell joined the United States Army. After a short tour of duty in Vietnam in the early '60's, Powell returned in 1968 as a major and assistant chief of staff of operations. He was decorated for bravery after surviving a helicopter crash and then rescuing three others from the burning wreckage.

That same year, following four earlier deferments for education, Donald Trump, 22, was exempted from the draft after being diagnosed with bone spurs in his heels.

We hear the word "patriot" tossed around a lot these days. I looked the term up. It is defined as "A person who vigorous-

ly supports their country and is prepared to defend it against enemies or detractors." Somehow, it has been coopted by right-wing groups who believe themselves to be the only true patriots and those who disagree as the enemy. Trump even referred to those who stormed the Capitol on Jan. 6 as "patriots."

Let me offer another view of patriotism. Oliver Halle is a retired FBI agent, a Vietnam veteran and an unabashed liberal. We have had many spirited political discussions over the years and have come to the conclusion that about the only thing we can agree on is the time of day. And not always that.

Halle was a Swift Boat commander in Vietnam. He and his five-man crew patrolled the narrow inlets and canals within the country, helping get Navy SEALS and Green Berets on shore, providing them gunfire support and emergency extraction if needed, as well as intercepting North Vietnamese and Viet Cong contraband. Extremely dangerous business.

While we don't see eye-to-eye on politics, Oliver Halle is by my definition a patriot, and, not surprisingly, one with a different opinion about the country he defended than that of some of the self-described patriots.

He says, "I strongly believe the reason America is exceptional is because it is the one country that protects the right to be different, the right to dissent, the right to express outrageous opinions — all without a knock at the door at midnight. That includes burning the flag in protest, among the many activities and forms of expression that don't sit well with 'patriots.' And while not sitting well with me, necessarily, we wouldn't be America without the most important of all amendments,

the First Amendment.' The privilege to express outrageous opinions, therefore, extends to Donald Trump. He can demean the legacy of a Great American like Colin Powell. That is his right. I can also express my opinion that he has shown a lack of class and thumb-sucking petulance in doing so. Now you have the right to express your opinion of my opinion of Donald Trump's opinion. This is what Colin Powell, Oliver Halle and thousands of other fought and risked their lives for. They are the true patri-

# State agency suggests how to avoid deer collisions

SOCIAL CIRCLE, Ga. -State wildlife resources officials are urging drivers to watch out for deer on and near roads because this time of year is the peak activity season for the animals.

Deer breeding season in Newton County is generally Nov. 3 to 9 when the animals increase their movement compared to other times of the year, said officials with the Georgia Department of Natural Resources' Wildlife Resources Division.

Charlie Killmaster, state deer biologist with the Wildlife Resources Division, said, "Motorists should be alert and pay close attention to roadsides as we are nearing the annual peak time of year for deer movement."

"Keep in mind that deer often travel in groups, so if a deer crosses the road ahead of you there is a good chance that another will follow," he said. "In many cases, that second deer is the one hit as the driver assumes the danger has passed and fails to slow down.'

Adult deer can weigh anywhere from 70 to 250 pounds, which means a collision with one could cause serious damage to a vehicle and injury to motorists, officials said.

The Wildlife Resources Division gave some tips and information to help avoid potential collisions:

• Deer are unpredictable. Always remember deer are wild and, therefore, can be unpredict-

A deer calmly standing on the side of a road may bolt into or across the road rather than away from it when startled by a vehicle.

• One deer usually means more will follow. Slow down when a deer crosses the road in front of the vehicle because deer usually travel in groups and others may follow.

same times most people are commuting to and from work.

• While deer-car collisions can occur at any time of year, the fall breeding season is a peak time for such events.

During the fall breeding season, deer movement increases and this often brings them in contact with roadways that cross their natural habitats, Division officials said.

Plants favored by deer for food often grow on road shoulders and they may be looking for the plants during extremely dry times of the year and following a long, hard winter.

• If it is too late to avoid a collision, drivers should slow down as much as possible to minimize

"Resist the urge to swerve to avoid the deer, as this may cause further damage, sending drivers off the road or causing a collision with another vehicle," Division officials said.

State Farm Insurance Co. esti-

mates it received more than 1.5 million animal collision insurance claims in the U.S. between July 1, 2019, and June 30, 2020.

The company on its website gave some additional suggestions if a collision occurs, including moving the vehicle to a safe place, calling the police, taking photos of the damage to document the incident, and double-checking the vehicle to see if it is still drivable.

"Look for leaking fluid, loose parts, tire damage, broken lights, a hood that won't latch and other safety hazards. If your vehicle seems unsafe in any way, call for a tow."

It also warns to stay away from the animal because "a frightened, wounded deer could use its powerful legs and sharp hooves to harm you."

An "excellent tool for motorists to determine local peaks in deer movement" is a Georgia deer rut map available at http:// georgiawildlife.com/rut-map, Division officials said.

Deer mating season occurs between October and late December, depending on location. Male deer begin actively searching for mates which leads to an increase in movement and across roadways.

"Bucks move more and become less secretive, making them easier to hunt and more susceptible to being hit by motor vehicles," according to information from the Division.

Researchers at the University of Georgia and biologists with the Wildlife Resources Division found a strong correlation between peak deer-vehicle collision timeframes, deer conception dates and the hourly movement rates of deer tracked by GPS, the Division reported.

Based on that information, deer-vehicle collision data provided by the Georgia Department of Transportation was used to map the timing of peak deer movement in Georgia, it



brand polyester films on four production lines, according to the company's LinkedIn page.

Throughout the COVID-19 pandemic, the facility also pivoted manufacturing to produce face shields and other PPE safety products.

In total, the services of Keck & Wood Inc. could cost the city up to \$31,000 based on the fee schedule. Without "concept level recommendations" for City Pond Road, Covington Bypass and Turner Lake Road, the cost would be only \$22,000.

During a presentation Oct. 18, Thomas suggested studies at City Pond Road, Covington Bypass and Turner Lake Road because he considered them to be "roads of concern."

"Not so much City Pond Road now, but it will be heavily traveled," he said. "We have a lot of development going over there as you know with Covington Town Center and other things. Turner Lake Road, you know, is very busy. We've got additional development that will be coming in over there. And then, of

course, the Bypass is, needless to say, we need some help over

After Wednesday's meeting, City Manager Scott Andrews said that the special meeting was called in urgency to "get the ball rolling" as the city is on the

"The primary reason we had the called meeting was because it was time-sensitive, as we are under a time crunch during our moratorium," Andrews said, "and every day counts."

In September, the council voted to extend a moratorium on the acceptance of rezoning applications, preliminary plat petitions and special-use permit requests for residential development until Feb. 20, 2022. Mayor Steve Horton then explained the moratorium would allow city

staff time to review current zoning ordinances and infrastructure concerns in regards to current and future residential projects, and then make recommendations to the council.

An emergency 30-day moratorium was first approved in August after Andrews said there were more than 5,000 residential units either approved or in the process of being approved to be built in the city. Andrews said the city needed time to review its infrastructure and zoning regulations to ensure Covington was adequately prepared for

such growth. At the conclusion of Wednesday's meeting, the council entered into executive session to discuss "land opportunities, potential litigation and personnel matters."

This year's advance voting turnout through Friday morning appeared to be closer to 2017, when 666 Covington voters cast ballots early. A total of 860 voted early in the 2019 election, White-Davis

On Tuesday, Election Day voting will take place from 7 a.m. to 7 p.m. at the City of Covington Courtroom at 2116 Stallings St.

On the ballot are:

- Incumbent Councilwoman Susie Keck and challenger Carla Ferry for East Ward Post 1;
- Two political newcomers, Charika Davis and Scotty Scoggins, vying for West Ward Post 2 - a seat held by

longtime Councilwoman Hawnethia Williams who chose not to seek reelection.

 Incumbent Councilman Anthony Henderson the only candidate for West Ward Post 3, as no one qualified to oppose him.

### **PORTERDALE**

Porterdale had seen an average of about two in-person voters per day up to Friday morning, officials said.

About 30 residents -2% — of the 1,311 registered voters in Porterdale had cast ballots by Friday morning, said City Clerk Kathy Bouttry.

A Special Referendum Election is the only item on the ballot in Tuesday's election and asks voters if the Porterdale City Council should be authorized to issue licenses for "the

package sale of distilled spirits" in liquor stores.

The ballot asks: "Shall the issuance of licenses for the package sale of distilled spirits be approved?" and gives voters the choice of either "Yes" or "No."

City Manager Frank Etheridge said he was unsure Friday morning about final voter turnout in the election.

"We'll see how Tuesday goes," he said.

Porterdale City Hall at 2400 Main St. is the only voting location Tuesday from 7 a.m. to 7 p.m.

State law formerly required at least 35% of the registered voters in a city or county to sign a petition to initiate a referendum for retail liquor sales. The General Assembly earlier this year approved legislation that allowed a city's governing body to pass an ordinance to place the referendum for retail liquor sales on a ballot. The city council began considering a referendum earlier this year after Rebekah Ali asked the council to consider annexing the site of a convenience store her family operates at the corner of Brown Bridge and Crowell roads.

She said she wanted to operate a package store in the same building, which prompted city officials to consider placing the question on the ballot. Liquor by the drink and retail beer sales already are allowed in the city.

If the referendum is approved, the council would need to amend its zoning and other ordinances to add package stores and could set the conditions for their operation.

began April 3, 2019, when Preston fired a shot at Stanley Hillman's dog. Hillman's son, Shelvis Hillman 40, confronted Preston about the shooting, FOX5 News reported.

Later that day, Preston, who was 18 at the time, and two other suspects forced their way into Shelvis Hillman's home and tried to rob him and the other residents. During that robbery, police said Preston shot Hillman in the abdomen.

A Covington Police Department Facebook posting said Preston was known to have gang affiliations and had the nicknames "Peanut" and "Neph-

A tri-county SWAT team assisted CPD detectives in making the arrest of Preston a few days later in a Cordele motel, Covington Police spokesman Capt. Ken Malcom said.

In the other case, a

judge sentenced Trea Johnson, 23, to Life Without Parole and two additional Life sentences plus 15 years after his Sept. 16 conviction on Murder and other charges.

A jury had found Johnson guilty of Murder, multiple armed robberies and other charges Sept. 16. He was sentenced to the maximum allowed under the law., according to information from the DA's office.

Johnson was charged with assisting in the armed robbery of two individuals he had invited to his home in Newborn in the early evening hours of Nov. 5, 2018, the Newton County District Attorney's office reported.

After the armed robbery, Johnson went to Moody's home, used a brick to break through the glass back door and entered the home without permission.

Moody, 22, called

911 to get assistance due to the break-in. On the 911 call at least one intruder can be heard and Moody says, "It's Trea Johnson, it's Trea Johnson."

A gunshot then can be heard and Moody tells the operator, "He shot me, he just shot me, I'm bleeding," the DA's office said in a post on its Facebook page. Moody died of the gunshot wound he sustained.

During the investigation, it was discovered that Johnson and Moody had argued on social media and via text messages a few

days prior to the mur-

Johnson, while knowing that police were looking for him, ran for approximately two days from law enforcement and was apprehended in Kennesaw on Nov. 7.

The case was prosecuted by Chief Assistant District Attorney District Attorney Eliazette Johnson, Investigator Josh Shumate and Victim Advocate

Investigator Jeff Alexander led the Newton County Sheriff's Office's initial investigation.

# Help for domestic violence survivors available through Project ReNeWal

By DENISE ETHERIDGE

MONROE, Ga. — If you call, they will listen.

That's the message Project ReNeWal wants survivors of domestic violence to hear.

"When someone is calling us in the middle of the night they generally come in with only what's on their backs," Project ReNeWal Executive Director Ashley Dykes said. "We try and make them feel that

this is their safe place."

The domestic violence intervention program serves residents in Rockdale, Newton, and Walton counties. The organization was founded 26 years ago as the area's first tri-county shelter for victims of domestic violence.

Dykes said the organization served more than 3,500 people in 2020, and 808 of those were Walton County residents.

Dykes attended a regular Monroe City Council meeting on Oct. 12, when Mayor John Howard read a proclamation recognizing October as Domestic Violence Prevention

Howard shared some sobering statistics contained in the proclamation. In the U.S. an average of 20 people

experience intimate partner physical violence every minute which equates to more than 10 million abuse victims annually, according to the mayor.

"Of those victims, nearly 1 in 4 women and 1 in 7 men have experienced severe physical violence by an intimate partner in their lifetimes," he said.

"Domestic violence traumatizes children in these families," Howard continued. "Anyone can be a victim of domestic violence regardless of age, race, sex, ability, ethnicity, sexual orientation, socioeconomic status or religion."

Dykes told The Walton Tribune this week that any time a child is present during a domestic violence situation, they are considered to be a victim of abuse.

"In 2018 in Georgia, 37% of domestic violence victims were children," she said. Over 15 million children nationwide are affected by domestic violence each year, according to Dykes.

Dykes said domestic violence's impact on children is sometimes discovered through the schools.

"You see them acting out in school," she said.

Small children might revert to infantile be-

havior like bedwetting and thumb sucking, and older kids may withdraw or suffer physical symptoms like headaches, Dykes said. Teenagers may bully others or engage in risky behaviors.

"Girls may become withdrawn and depressed," she said.

Dykes said that 21% of teenage girls and 10% of teenage boys experience physical and/or sexual dating violence. She added that children who experience domestic violence in the home are at greater risk of developing health issues as adults.

"It's cyclical and generational," Dykes said. "They are more likely to get into domestic violence situations as adults because they think it is acceptable behavior." Dykes said she

earned her degree in psychology and has a background in social work having worked for the Georgia Division of Family and Children Services.

"It's all about power and control for the abuser," Dykes said.

She said it takes a survivor an average of seven attempts to successfully leave their abuser.

"And we'll help them each and every time," Dykes said. "Even if they go back, they can call us again."

Dykes and her staff help clients develop safety plans and find them emergency shelter if needed.

"We try and help them get back on their feet," she said. "So when they leave, they know they can survive without their abuser."

Project ReNeWal helps clients with job search and resume building, and assistance with rent, utilities and moving expenses. Domestic violence victims often deal with emotional and financial abuse, as well as physical abuse, Dykes said.

"Even through COVID, we didn't shut down," she said. "We've had to socially distance and follow CDC (Centers for Disease Control and Prevention) guidelines for that purpose."

Project ReNeWal offers clients case management services, such as connecting survivors to additional resources and providing transportation to medical appointments.

'We have a child specialist that helps with the children," Dykes said. The organization also provides clients clothing and toiletries

when needed.

"We have a transition coordinator," Dykes said. "We follow them for a year even after they leave the shelter. We have outreach services and peer support groups throughout all three counties."

Project ReNeWal received some CARES Act funding, and receives federal and state grants as well as donations. The shelter is a United Way agency in Walton County.

The organization also holds an annual Dancing with the Stars fundraiser. "We were unable to

do our 2020 Dancing

with the Stars in March 2020," Dykes said. "We are planning on having our next one on Feb. 26, 2022. We have dancers from all three counties."

The fundraiser will be held at the Porter Performing Arts Center in Newton County. Event sponsorships are available and attendees can vote for their favorite dancer.







# Series shifts to Atlanta for next three games

# Dawgs aim to party on

Georgia puts No. 1 ranking on the line against SEC rival Gators

JACKSONVILLE, Fla. — The "Cocktail Party" has provided little drama in recent years.

Seven of the last eight games between Southeastern Conference rivals Florida and Georgia have been decided by at least two touchdowns. Even the one relatively close matchup, in 2019, was a 14-point contest before the Gators scored with a little more than 3 minutes remaining.

Most fans probably wouldn't be shocked to see another lopsided affair Saturday.

Top-ranked Georgia (7-0, 5-0 SEC) enters "The World's Largest Outdoor Cocktail Party" as a 14½-point favorite, according to FanDuel Sportsbook. It's just the third time in the last 30 years that the Bulldogs were favored by double digits against Florida (4-3, 2-3). Georgia split the first two, getting upset in 2014 and winning big three years later. The Bulldogs have

even more to play for this time around. They are ranked No. 1 against Florida for the first time in nearly 80 years and can move a step closer to winning the league's Eastern Division for the fourth time in the last five

"We all know what's at stake," Florida defensive end Zach Carter said. "Right now, we're playing to finish strong and end the year on a good note. Getting this win would mean a lot, especially knocking off the No. 1 team. I wouldn't necessarily say ruining their season because I'm sure if we beat them, they still might end up in the playoff somehow. But just getting that win, it would mean a lot, for

Georgia has won 11 in a row since getting steamrolled in Jacksonville last year. The Gators racked up 571 yards – the most in Bulldogs coach Kirby Smart's tenure – against a defense that played without massive nose tackle Jordan Davis and two other starters.

said Smart, whose defense leads the nation by a significant margin. "I have never had great experiences with that. You count on emotions to do that. I don't want the players emotional the whole time. That's what the fan wants, but I want them thinking about what they have to do to win this game, and last year's game has nothing to do with this year's game."

Georgia will be the fifth team to carry the No. 1 ranking into the annual rivalry game in Jacksonville, and three of the previous four fared well. The top-ranked Bulldogs dominated Florida 75-0 in 1942. No. 1 Florida won 47-7 in 1996 and 41-17 in 2009. The lone upset came in 1985 when No. 17 Georgia stunned the top-ranked Gators 24-3 and ended Florida's 18-game unbeaten streak.

Now, the Gators are

trying to play spoilers.
"The intensity levels are going to be high and the emotions are going to be high," Florida running back Malik Davis said. "I love it."

Jones was benched in Florida's 49-42 loss at LSU. Richardson is bigger, faster and might give the Gators a better chance against Georgia's vaunted defense.

### BACKFIELD DEPTH

Georgia's running back depth took a hit when Kendall Milton, third on the team with 243 yards rushing, suffered what Smart described as a "slight" knee injury in practice last week. Milton is not expected to play Satur-

"I don't know how many weeks it will be," Smart said.
