

#### Stewart Community native talks music dreams coming true

COVINGTON, Ga. — Drew Parker is not one to sit around and wait for "dreams" to materi-

He's been working toward a certain goal from age 12 when he began traveling to area churches and performing as a Southern gospel singer, or sought to hone his skills as a young baseball

## Weekend crash kills 2 on I-20

Taste of Ireland

Incident between Covington, Social Circle caused major delays

COVINGTON, Ga. — The Georgia State Patrol began an investigation this week into a Sunday, March 14, wreck in which two died on I-20 between Covington and Social Circle.

Kuan Zheng, 63, was the driver of a vehicle that crossed the center median and struck another vehicle Sunday, March 14, at about 4:30 p.m. on eastbound I-20 between the exits for state highways 11 and 142, said GSP spokesman Lt. Mark Riley.

Identities of the two victims were not being released before the newspaper's deadline because next of kin had not been notified, Riley said.

GSP's Specialized Collision Reconstruction Team was assisting in the investigation that was not complete, Riley said.

Preliminary results of the investigation showed the incident occurred after a silver Toyota RAV4 driven by Zheng was traveling

Topaz Hotel Group, a division of Starlight Hotel Group LLC, announced in 2020 that it would be investing more than \$32 million to build a 123-room Residence Inn, followed by a 99-room Courtyard by Marriott, which is also expected to break ground later this year.

## COVID-19 vaccines now available for more Georgians

Georgians ages 55 and older, as well as those with a variety of health issues, are now eligible for COVID-19 vaccines amid a recent boost in supplies, Gov. Brian Kemp announced recently.

Vaccines could also potentially be available for all Georgia adults starting next month if the current number of shots that federal officials are sending weekly to the state continues to increase as it has in recent weeks, Kemp said at a news conference.

"Provided we continue to see increasing vaccine supply, it is our intent to open up vaccination to all adults the first part of next month," Kemp said.

Along with adults age 55 and older, vaccines were made available to Georgians with health conditions including cancer, moderate-to-severe asthma, heart conditions, diabetes, cystic fibrosis, hypertension, liver disease, COPD, chronic kidney disease,

cerebrovascular disease and compromised immune systems, starting Monday, March 15.

Kemp said he was expanding eligibility to keep pace with the increasing supply of vaccines Georgia is receiving from the federal government and to avoid seeing lagging demand among currently eligible people. Georgia is currently receiving weekly shipments of 223,000 vaccine doses.

cluding school teachers and staff, health-care workers, nursing home residents and staff, first responders, those with mental and behavioral health issues, parents of children with medical conditions and people ages 65 and older.

Nearly 2.5 million vaccines have been given so far in Georgia, including to roughly two-thirds of all people 65-years and older in the state, according to Kemp's office. Vaccination rates have climbed as the state receives more doses of the Pfizer, Moderna and recently approved Johnson & Johnson vaccines.

Kemp, who said he will get the vaccine soon, urged teachers and others who are already eligible for vaccines to sign up for appointments now with demand about to spike from the newly eligible group of Georgians starting next week.

"This is your opportunity, these days ahead, to get in the queue and get your vaccines," Kemp said. "This is going to move rapidly, especially in certain parts of the state, and what we want is for people to get vaccinated."

Georgians can pre-register for a vaccine appointment at myvaccinegeorgia. com even if they do not yet qualify under the governor's eligibility criteria. They will be notified once they qualify and scheduled for an appointment.

The governor also said his administration is aiming to quickly expand eligibility further to Georgians who have been hit hard by the pandemic including restaurant, agriculture and grocery workers. How soon those groups will be able to get the vaccine depends on supplies holding steady.

"We want to move that population as quickly as we can and try to protect them and keep our economy going," Kemp said. "All of this helps get us back to normal."

Georgia has been ratcheting up to distribute vaccines since the first Pfizer and Moderna doses started arriving in mid-December, particularly through moves to open several mass vaccination sites in different regions throughout the state.

So far, state officials have opened four mass vaccination sites in metro Atlanta, Macon, Albany and Habersham County, and are set to open another five sites next week in Savannah, Columbus, Waycross and Bartow and Washington counties.

The vaccine ramp-up comes as COVID-19 positive case rates and hospitalizations continue falling after a surging outbreak that swept over the Georgia around the winter holiday season. Hospitals have seen a fall in COVID-19 patients from around 5,700 during the winter to 1,500 currently, Kemp said. Deaths traced to the virus are also starting to decline, he

added. "Every metric in the COVID-19 pandemic is headed in the right direction," Kemp said.

west on I-20 in the left lane, two miles west of Ga. Highway 11 at mile marker 96, Riley said.

The RAV4 failed to maintain its lane, struck a silver Chrysler 200 traveling beside it in the right lane, and the RAV4 driver steered left, a report stated.

Riley said the RAV4 traveled into the grass median, turned onto its side and traveled into the eastbound lanes of I-20.

It entered the right east lane, struck a Toyota Tacoma traveling east on I-20 and both vehicles came to rest on the south shoulder, he said.

The Toyota Tacoma's driver and front seat passenger died, while the driver of the RAV4, identified as Zheng, sustained serious injuries and was transported to Atlanta Medical Center, Riley said.

Investigators closed both lanes after the 4:30 p.m. incident, which tied up traffic for hours on I-20 before all lanes were opened by 8:40 p.m., according to GDOT.

No charges had been placed in the incident Tuesday, Riley said.

A Social Circle resident who identified herself as the driver of the Chrysler 200 said she and her daughters, ages 2 and 9, were not physically hurt but were shaken by what they


"I somehow managed to maintain control of my vehicle while seeing all of this in my peripheral vision, she said. "We pulled safely to the side of the road.

"I knew we got lucky." She asked for prayers for those who died and their families.

## Court approves bond issue for new Stanton Springs data center

MADISON, Ga. — A judge gave her approval for the \$42 billion bond deal that will bring a data center to Stanton Springs.

Judge Amanda S. Petty signed off on the project in a validation hearing Monday morning in Morgan County Superior Court. No one spoke against the deal, nor had any objections been filed with the court or the Ocmulgee Circuit district attorney beforehand.

The Joint Development Authority of Jasper, Morgan, Newton and Walton Counties and Baymare LLC asked the court to validate the bond agreement, which was reached last month.

The agreement showed a data center is coming to the Stanton Springs development near the junction of I-20 and U.S. Highway 278, and will sit in unincorporated Social Circle in parts of Morgan, Newton and Walton counties.

According to the agreement pre-

pared by JDA attorney Andrea Gray of Monroe and approved by Petty, the bonds will be used to finance the costs of acquiring, constructing, equipping and installing a "capital project, in one or more phases."

The bond agreement shows the project will be a data center, similar to the one the JDA also issued \$42 billion in bonds for in 2018 to Morning Hornet LLC. That was the key financing component in the deal that a couple of months later was announced as the Facebook Newton Data Center.

Gray said the JDA and its member counties will not be liable for the debt. The bonds will be issued at an annual interest rate of 6% and reach final maturity no later than Dec. 31,

Baymare will pay rent to the JDA and make payments in lieu of taxes, or PILOTs, to the four counties. Newton and Walton counties each receive 37.5%, Morgan County 15% and Jasper County 10%.

## Coffee versus tea

I add many flavors to
my preferred morning or
afternoon healthy beverages. My additions depend on
the time of

the day.
In my research, I've learned coffee is good for you.
Coffee

Coffee contains an-

tioxidants and other active substances that may protect against diseases, says Diane Vizthum, M.S., R.D. research nutritionist for Johns Hopkins University School of Medicine.

Coffee is a brew which has benefits for our health. Researchers have also found coffee drinkers are less likely to die from the leading causes of death in women: coronary heart disease, stroke, diabetes and kidney disease.

Do coffee drinkers live longer? I can't say. Your body may process glucose. That's the theory behind studies that found that people who drink coffee are less likely to get type 2 diabetes.

Drinking one to two cups

of coffee a day may help ward off heart failure. A weakened heart has difficulty pumping blood to our bodies. You are less likely to develop Parkinson's disease. Your DNA will be stronger. Dark roast coffee decreases breakage in our DNA.

In my research I read your odds of getting colon cancer will decrease. One in 23 women develop colon cancer. But researchers have found that coffee decaf or regular were 26% less likely to develop colorectal cancer.

After I read this, I was't completely sold. My mother developed colorectal cancer. This study also stated you may decrease your risk of getting Alzheimer's disease. Both my mother and two of her siblings were diagnosed with Alzheimer's.

So, how much coffee should a person drink each day?

Of course I can't say. It is said too much of a good thing may or may not be good for you. If you are pregnant or breastfeeding check with your obstetrician before adding caffeine in your diet. Should children drink coffee? The Ameri-

can Academy of Pediatrics recommends caffeine consumption is not appropriate for children and adolescents. Coffee is a stimulant drug.

Tea!

I must. I drink more teas than coffee. My teas are kept in their own special wooden container; rectangular with a lid. Teas are special to me. I love their aromas. Their aromas are distinctive. Tea is a healthier choice. The history of teas go back centuries.

Are teas healthier? I believe so. Green tea is one of my favorites. My doctor recommended. I drink it. Since I have been a researcher for two major universities, it is natural I research everything.

There are so many teas in the world, I haven't drank them all. Take, for instance, maitake mushroom (grifola fondosa) "Maitake" means "dancing mushroom" in Japanese. For thousands of years, this mushroom has been prized by Japanese herbologists for its ability to beef up the immune system and strengthen overall health.

I have brewed peppermint

leaves (mentha piperita) as well as rose hip, senna, Vitamin C and sugar cane just to name a few.

Teas have been used in ceremonies, unlike coffee. It was been said green tea is a medicine. "Anywhere a person cultivates tea, long life will fellow" — Eisai.

This article isn't to provide medical advice, but to impart a bit of information.

There is no question these

beverages are consumed and enjoyed by billions of people.

As a little girl, I can remember my tea sets. It was pretend tea. But I felt like I was drinking real tea. Four cups and four saucers. Setting on the floor or setting around my small table. With friends or not. It was tea time.

Still today, I have a lovely bone china tea set on my kitchen table. Even in churches they have tea programs.

## House Bill 479 passes in rare form

Senators. The most important bill we accomplished last week was the governor's initiative to overhaul the Civil War era citizen's arrest law in Georgia. This was in response to the horrific murder of Ahmaud Arbery last year. Current state law allows any citizen who believes they have seen a crime to arrest the suspected offender, essentially taking the law into their own hands. HB 479 will repeal that law, leaving the authority to arrest to law enforcement. It has nothing to do with stand-yourground provisions, and it does not curtail Second Amendment rights. The bill passed unanimously with a standing ovation — one of the few important bills to do so this year.

I wanted to highlight some good news in the budget regarding behavioral health, which received an additional \$58 million this year. \$2.7 million of additional monies went to addictive diseases, \$6.5 million went to mental health services, \$12 million will go to a pay increase for these providers, and \$4.6 million for family support. \$7million will go to a first-in-the-nation crisis center and \$2 million to expand our APEX Program

for schools.

There is also some good news with the COVID-19 vaccine. Many of you know that the governor is now allowing anyone older than 55 to get the vaccine. Also, most people with disabilities are eligible, as well as people above the age of 16 with certain high-risk medical conditions. These include asthma, cancer, COPD, cystic fibrosis, diabetes, liver disease, hypertension, obesity, and sickle cell amongst others. Also, healthcare workers, teachers, residents of long term facilities, law enforcement and fire fighters, and parents with high-risk children

I realize that the vaccine rollout has been difficult. I hope that everyone is grateful that we have a vaccine at all. Most vaccines take years to create. No one had ever created a vaccine for the 18 prior versions of COVID. Operation Warp Speed beat everyone's expectations, when it created a vaccine for COVID-19 in less than a year.

On a completely different subject, it appears that the latest \$1.9 trillion Federal CARES package will block a small income tax cut Georgia passed this year. While we are grateful for the additional \$4.25 billion that K12 Education will receive, it is unfortunate that Washington has included this provision to hurt economically sound states. The enormous debt that this bailout will incur is also very troubling. 91% of this budget-breaking package did

NOT go to COVID relief.

## 'Future's so bright, I gotta wear shades'

woke up today with a much brighter outlook than I had a year ago. I remember the fear, the uncertainty, and the eerie

quiet in my neighborhood. The sounds of school buses chugging by, and folks going to work had been re-

had been replaced by stillness. The era of masks, distancing, and elbow bumps had begun.

My daily journey to the TV station came to a screeching halt. A production crew transformed my den into a home studio, with intimidating technical gear. I've never been good at changing a light bulb, and suddenly I was asked to transmit a broadcast signal. It took only one snafu to keep me off the air, and I created a new one each day.

A writer for the Los

Angeles Times summed it up: "We are not working from home. We are living at work."

One year later: Like flowers blooming in the spring, our smiles are gradually returning. Day by day, the masks will disappear. The vaccines are working. Many people who were misled by misinformation spreaders finally came around. My friend Matt Haase put it this way: "I'm amazed that people I know from high school that couldn't pass algebra suddenly became experts in viral medicine."

It isn't completely over, and the new variant strains could still wreak havoc. Still, we are moving forward with a positive attitude. Our post-COVID world will be different, but in some ways it might be

When I asked readers how the lessons of the pandemic would change their lives, one woman wrote, "I will always use curbside grocery pick-up. I have never liked strangers breathing down my neck while I'm standing in line."

Others added the joys of porch sitting, outdoor dining, cleaner hotel rooms, and improved personal hygiene habits. One mentioned a new landscape. "Why would anyone build a multi-story office complex?" he asked. "We've proven we can get just as much work done at home." He makes a good point.

A woman added, "I'm glad I won't have to wear a mask ALL the time, but at least I will have that option without being stared at. I like to hide behind mine. It's nice not to have to wear makeup when I leave the house. Plus they feel good on cold days." I totally get that, but I hope eye contact makes a comeback. I miss making a connection with new people.

I can also relate to this person's opinion: "My challenge will be keeping my home as uncluttered as it is now. It has never been cleaner. I have used the pandemic as an excuse to weed out clothing and other items that have gone untouched for years, or even decades. Yes, I really was that bored, but it has paid off. My home seems bigger now, because I have created more space."

Opinions are mixed on Zoom gatherings and conversations that have largely replaced office meetings and family visits. One reader said, "I hope we continue to have them. I hate in-person meetings, and I hope people continue to stay six feet away from me." Of course, not everyone feels that way. Here's a polar opposite point of view: "As soon as it is permissible, I will smother my family and

friends with hugs, and they had better get ready, because it's gonna be big!"

Many readers say they are looking forward to the spontaneous moments that disappeared in 2020. "I feel like I have been in prison," one man wrote. "I can't wait to go to a live music concert again."

Another person said, "I have really missed last-minute invitations. I love it when a friend calls and says, hey let's go downtown and get some dessert and see a show. I used to take things like that for granted. Never again!"

A female reader wrote, "I should be ashamed to say this, but I miss trying on clothes in stores. It may sound silly to some people, but it's important to me."

I am in full agreement with this comment. "I look forward to driving more. I'm paying an outrageous amount for car insurance, and the odometer is about where it was a year ago. I might as well get my money's worth."

And this one: "I used to think I wanted peace and quiet. Well, I've had enough of that. I need some noise and fun."

and fun."

Maybe the best words of all come from Samantha Dmochowski, a registered nurse: "Surround yourself with those you love and make your home a place you love to be. That way if you're ever 'stuck' with them again, it's the best place to be."

This renewed optimism is why I'm singing along to one of my favorite oldies. "The future's so bright, I gotta wear shades." I wish the same for you.



He later changed the kind of music he wanted to perform country — after being inspired by musicians like the late Keith Whitley and his classic hit, "Don't Close Your Eyes."

However, in Parker's younger days he also had a passion for baseball.

One of his "earliest dreams" was playing professionally and he grew up in leagues at City Pond Park and elsewhere in Newton County.

He then went on to play for Alcovy High School before an injury ended his playing career his senior year, Parker recalled.

That was a turning point because he then turned his focus solely to becoming a professional musician, he said.

"It's funny that a moment like that something as small as getting injured — can change what you had planned for your life," Parker said.

He knew he needed some way to support himself while earning enough to make the move that any serious country music artist must make to the heart of the country music

industry — Nashville. Parker earned certification as an X-ray technician from the School of Radiologic Technology at Grady Hospital in Atlanta. He then worked part-time for two years at what is now Piedmont Newton Hospital while working on his music and performing around the

In 2014, he was invited to audition for "The Voice" and ultimately traveled to Los Angeles to perform for the NBC-TV music competition show but was not chosen to move on.

The two hit it off and led to Parker finding success as a songwriter and a songwriting deal with River House/Warner Chappell in September 2017.

Parker was co-writer on Combs' platinum-selling debut album "This One's for You," and Combs' hit "1, 2 Many," as well as Jake Owens' No. 1 single "Homemade."

He also continued his quest to become a performer in his own right and continued to support himself with live shows at venues like the legendary Ryman Auditorium — until they stopped in March 2020 because of safety concerns surrounding COVID-19.

The songwriting deal. though, helped him get through the past year because it allowed him to earn money without performing — which has become the main source of income for most musicians in the digital age, Parker said.

He said he was looking forward to performing in Rome and Athens this month and Texas in April, before embarking on a series of festival shows and as part of Combs' national

summer tour. "I'm excited to get out there," Parker said.

Those who want to have their songs played on country radio stations nationwide need to move to Nashville, Parker said.

He said "anybody can share this dream" of being a country star but it requires hard work and sacrifice.

"It's the hardest work I've ever done in my life," he said.

Musicians seeking to make a career out of country music could make a "good living" performing in nightclubs and street festivals, he said.

"It depends on your plan," he said. "I want to share my story with the world."

The support of his family — many of whom still live in the Newton County area and owners of local businesses like Jimbo's Grill at the Mill in Porterdale provided the encouragement he needed to keep working toward his goal of making a career in music, Parker said.

He wrote on a Facebook post in February that he thanked his wife and family for helping him gain his record deal he announced in February.

"Thanks for pushing me all these years, and for not telling me I was crazy to chase this dream," Parker wrote. "Thanks for the sacrifices that you've made so that I could run this dream down."

Georgia Tech men's basketball team wins first ACC title since 1993

GREENSBORO, N.C. (AP) — Jose Alvarado couldn't contain his emotions as the horn sounded, collapsing in disbelief as his Georgia Tech teammates mobbed each other near midcourt.

He quickly ran to the celebration that included coach Josh Pastner
— still sporting that can't-miss-it clear face shield.

"Coach, you're a champion, man!" Alvarado yelled as he joined him for a postgame TV interview amid fallen-from-therafters balloons and confetti.

The Yellow Jackets have their first Atlantic Coast Conference Tournament title in nearly three decades after beating No. 15 Florida State 80-75 in Saturday night's championship game. Just as importantly, they've secured an automatic NCAA Tournament berth to end an 11-year drought.

"A lot of emotions: joy, happiness, everything," said Michael Devoe, the tournament MVP. "I mean, this goes down in history for us."

Devoe scored 20 points for the fourth-seeded Yellow Jackets (17-8), who shot 52% after halftime and repeatedly capitalized on mistakes by the Seminoles to win their first ACC Tournament crown since 1993 and fourth overall.

ACC player of the year Moses Wright and Jordan Usher each had 11 of their 15 points after halftime for Georgia Tech, which got off to an 0-2 start this season with home losses to Georgia State and Mercer. The Yellow Jackets stood 9-8 after a loss at Clemson on a last-second shot Feb. 12 to

bubble uncertainty.

But they haven't lost since. And there's no doubt about the NCAA tourney now after a remarkable climb, not after a strong finish against the second-seeded Seminoles

find themselves facing

(16-6).

"Our guys have just scrapped, fought, kicked, clawed — whatever they had to do to find a way to get wins this year," Pastner said. "And I'm just so darn proud of these young men."

Scottie Barnes had 21 points on 8-for-10

shooting for Florida State, which shot 56% but committed 25 turnovers that led to 31 points for the Yellow Jackets.

They came in all kinds of ways, from the Seminoles bobbling catches and having passes deflected to just throwing balls straight out of bounds. The 25 turnovers fell one shy of tying a tournament title-game record since the league began tracking the number in 1961, while Georgia Tech's 15 steals — five by Alvarado — was a title-game record since the league began chart-

ing it in 1976. "We did turn the ball over a couple of times ourselves, what we call self-inflicted turnovers." FSU coach Leonard Hamilton said. "But for the most part, I think that they forced us into turnovers. ... I want to give them credit because they did an unbelievable job of just stripping us from the ball, and their defense created a mindset with us where we were unsure as to what we were supposed to do."

The Yellow Jackets avoided such trouble with just seven turnovers. But they were particularly steady down the stretch, making six of eight shots over the final eight minutes as well as 11 of 12 free throws in the

final 90 seconds.

That included Alvarado knocking down a pair with nine seconds left after shaking off a hard fall, which had come right after Barnes' 3 pulled the Seminoles to 76-73.

The only thing that didn't go according to plan was the Yellow Jackets' celebration. Alvarado stripped RayQuan Evans and fed Devoe for a layup with 0.6 seconds left. but the Georgia Tech players began spilling onto the court early to celebrate. That led to a technical foul and two free throws for FSU, though the outcome was decided and the Georgia Tech party had

begun.
Pastner kept that face shield in place, too, even as he stood atop a ladder — socially distanced from his team below — and cut down

the final strands of net. It was an unusual final pairing in a tournament altered by the coronavirus pandemic. No. 16 Virginia and Duke withdrew after positive COVID-19 tests within their programs. The title matchup marked the second finale without a North Carolina-based team, the other being Georgia Tech's win against Virginia in 1990.

Now the Yellow Jackets finally have another.

Caffeine is a vital component of many people's daily routines. A morning cup of caffeinated coffee provides the boost people need to get out the door and on their way

The history of caffeine and its use in beverages is mired in mystery and myth, though the U.S. National Library of Medicine notes that the historical origins of caffeinated tea and coffee are relatively recent. The US-NLM indicates that coffee did not become widespread in Europe until the 18th and 19th centuries, remaining something of a luxury until somewhat recently. And while England's love of tea is widely known, caffeinated tea did not become common in Britain until the 18th century.

While it might have taken its time to take root in many cultures across the globe, there's no denying the prevalence of caffeine in the 21st century. A bitter substance that occurs naturally in more than 60 plants, caffeine can be found in coffee beans; tea leaves; kola nuts, which are used to flavor sodas; and cacao pods, which are vital to the creation of many chocolate products.

Many people get their caffeine from beverages, and the amount of caffeine such people consume may depend on which beverages they choose. For example, the USNLM says that an eight-ounce cup of coffee typically contains anywhere from 95 to 200 milligrams of caffeine. A 12-ounce can of soda is considerably less caffeinated, containing about 35 to 45 milligrams of caffeine on average. The extra boost people get from sodas might be due to sugar, as sodas are notoriously high in sugar.

Caffeine has various effects on the body, some of which are beneficial. For example, the USNLM notes that caffeine is a diuretic, which means it can help the body get rid of extra salt and water by increasing the need to urinate. Caffeine also stimulates the central nervous system, providing that morning boost of energy that so many coffee drinkers rely on every day.

But not all side effects of caffeine consumption are beneficial. Because it increases the release of acid in the stomach, caffeine can sometimes contribute to upset stomach or heartburn. In addition, caffeine can interfere with the absorption of calcium in the body, though the organization American Bone Health notes that such interference may only occur among heavy coffee drinkers who consume upwards of four cups of

coffee per day.

The USNLM notes that most people can consume up to 400 milligrams of caffeine per day without suffering any ill effects. But exceeding that amount may contribute to a number of unwanted side effects, including restlessness, insomnia, headaches, dizziness, dehydration, anxiety, and rapid or abnormal hearth rhythm. It's also important to recognize that some people are more sensitive to caffeine than others, so what's good for the goose is not necessarily good for the gander.

Caffeine plays a vital role in many people's lives, and understanding its effects can help people make smart decisions regarding their caffeine consumption.

Directions:

In a large bowl, cream one cup peanut butter, butter, brown sugar, and sugar until light and fluffy. Add eggs, one at a time, beating well after each addition. Beat in the applesauce and vanilla. Combine the flour, oats and baking soda; gradually add to the creamed mixture and mix well
