## MASKS OFF IF VACCINATED

CDC guidelines change as COVID-19 case count continues to dwindle across Georgia

COVINGTON, Ga. — People who are fully vaccinated can finally ditch their masks.

Unless in areas mandated by federal, state or local governments, or if required by local businesses or employers, new CDC guidelines announced Thursday, May 13, suggest masks are no longer required for anyone who has been fully vaccinated.

For anyone not vaccinated, masks are still suggested by the CDC for most indoor/outdoor activities. The CDC states unvaccinated people would not have to wear masks if walking, running, wheelchair rolling or biking outdoors with members of your household; or attending a small outdoor gathering with fully vaccinated family and friends.

Masks are still suggested for unvaccinated people if dining outdoors at a restaurant with friends from multiple households; or attending a crowded outdoor event. Masks are recommended to be worn for all indoor events if unvaccinated.

The CDC states fully vaccinated people may also go without social distancing, in addition to dropping their masks. They may also resume domestic travel and "refrain from testing before and after travel or self-quarantine after travel.

Fully vaccinated people may also refrain from testing and

self-quarantine, if asymptomatic, with few exceptions.

However, if a fully vaccinated person experiences COVID-19 symptoms, they are still encouraged to be tested for the virus.

According to the Georgia

Department of Public Health, the seven-day moving average of confirmed cases is currently the lowest since nearly the pandemic's beginning more than one

### Heroic action

Covington officer praised for reviving choking infant

COVINGTON, Ga. — A Covington Police officer is receiving praise after his recent action that likely saved the life of a choking

Officer Matt Holbrook was nominated for a departmental award after the May 2 incident in which he was able to clear the airway of a choking 15-month-old infant.

Holbrook was among Covington officers on May 2 at 7:30 p.m. called to a location on North Street about an infant choking, said

department spokesman Capt. Ken Malcom. "When officers arrived, the infant was unresponsive, and his airway was obstructed."

Malcom said. "Officer Holbrook grabbed the infant and began giving back thrusts. This quick action helped dislodge the obstruction enough for the infant to begin to respond," Malcom said.

The boy, Adrian Tovar, was turned over to medical personnel who transported him to an area hospital. He was released the next day, Malcom said.

He said Adrian's family later thanked Holbrook and other first-responders in a letter.

"This letter is to thank and show all the appreciation to Officer Holbrook and officers,

#### Newton pump prices rise to meet national average By TOM SPIGOLON

Newton County was at the national average and above the statewide and Metro Atlanta averages for regular gas Tuesday as stations continued to recover from surging demand from Colonial Pipeline's shutdown.

Some Newton County gas stations also were still without fuel Tuesday — especially along the U.S. Hwy. 278 and Crowell Road corridors, according to the fuel-monitoring website gasbuddy.

However, others on Hwy. 278 and around the I-20 Alcovy Road interchange and locations on Brown Bridge Road and Covington Bypass, had all grades of gas, the website reported.

Newton County's average price for a gallon of regular gas was \$3.041, which was at the national average but above the statewide average of \$2.96 and the Metro Atlanta average of \$3.024, AAA reported. The county is typically below the national average.

Averages in Metro Atlanta Monday were \$3.020 for regular, \$3.318 for midgrade, \$3.628 for premium, and \$3.098 for diesel.

Montrae Waiters, spokeswoman for AAA-The Auto Club Group, said the Wednesday, May 12, restart of the pipeline that serves almost half of the fuel for the U.S. East Coast was

choice, the national Jack Kent Cooke (JKC) Foundation announced.

The scholarship provides each recipient up to \$40,000 per year for up to three years and is designed to help the nation's top two-year college students seeking to complete their bachelor's degrees at four-year institutions.

Melvin is a Covington resident and student on the Newton Campus. He is an Honors College student studying political science

who plans to pursue a law degree after completing his bachelor's degree.

He has applied to Yale University and

Georgia State and said the award would relieve the financial burden of paying for his next few years of college.

"Now that I have the Jack Kent Cooke support, it really puts me in a place where I can exhale," Melvin said.

"I'm happy to be in this position, and I'm so grateful to the Jack Kent Cooke Foundation. I'm really honored and wowed right now," he said.

The JKC Foundation selected 72 recipients nationwide to receive the scholarship this year. Cisse and Melvin were chosen from more than 1,300 applicants attending 398 community colleges.

Melvin is also the third Jack Kent Cooke Scholar to come out of the Newton Campus in recent years, a news release stated.

Cisse, a biology student at the Dunwoody Campus who wants to pursue a degree in medicine, is considering attending Yale University, Vanderbilt University and several Georgia universities, including Georgia State.

"It's life-changing in all aspects," Cisse said of winning the scholarship. "I still can't process it."

In addition to financial support, Cisse and Melvin will receive comprehensive educational advising to guide them through the process of transitioning to a four-year college and preparing for their careers.

Scholars will receive opportunities for internships, study abroad and graduate school funding and be connected to a network of Cooke Scholars and alumni.

This year, eight Perimeter students were named semifinalists for the Jack Kent Cooke scholarship. The Jack Kent Cooke Foundation evaluated applicants on their academic ability and achievement, financial need, persistence, leadership and service to others.

Cisse and Melvin learned about their award from Perimeter College Dean Nancy Kropf during a surprise announcement on the Clarkston Campus.

In recent years, the Honors College at Perimeter has provided technical assistance to students wanting to apply for the JKC scholarship by helping them with the applica-

tion process. "The Honors College is so happy to be a part of this process for Perimeter students," said Lauri Goodling, associ ate dean of the Honors College at Perimeter. "We love seeing them succeed and watching the doors open!"

Kropf said she is proud of Perimeter's strong history of producing Jack Kent Cooke scholars.

"That's a tremendous, tremendous designation for our college," she said.

Since 2002, the Jack Kent Cooke Foundation has award 23 Perimeter students the undergraduate transfer scholarship.

The students have gone on to achieve success in bachelor's degree programs and beyond at institutes such as the Massachusetts Institute of Technology, Georgia Tech, Emory University, Howard University, The University of Southern California, Stanford University and

Agnes Scott College. The 2020 JKC scholarship recipients, Diana Ha and Matthew Wessler, chose to continue their undergraduate education at Georgia State.

### SPLOST Oversight Committee questions aquatic center costs, location

COVINGTON, Ga. SPLOST Oversight Committee members questioned the recurring costs and the planned location of a proposed aquatic center as they recently discussed adding it to the projects for funding with a 1% sales tax up for renewal in 2022.

The committee, which recommends projects for funding with the county's Special Purpose Local Option Sales Tax, met for its quarterly meeting May 10 and discussed the proposed aquatic center project.

District 2 County Commissioner Demond Mason has pushed for construction of an aquatic center on county-owned land at Denny Dobbs Park since taking office in 2019.

Cost estimates for the facility have been in the \$30 million range, though no formal design studies have been done.

However, some SPLOST committee members said they had problems with the plan because of the recurring costs to maintain and staff such a facility, and its planned placement in west Newton rather than a more centralized location within the county.

Chairman Baxter Bouchillon said the operating costs after its construction

typically include personnel and maintenance, which can be costly.

Aquatic centers also often operate in the red meaning whoever builds them typically have to supplement their operations because user and rental fees do not cover expenses, Bouchillon said.

Its proposed location is on county-owned land at Denny Dobbs Park on Georgia Hwy. 212 in western Newton near the Rockdale County line, he noted.

"Location will be a topic of debate," Bouchillon said

He said he knew county commissioners typically vie for major projects in their districts but their preferred locations may not always be the best sites for facilities planned for countywide use.

However, he said an aquatic center would provide a number of services needed in the county, such as swimming lessons or other water-related programs.

Mason has said he is working to find a mix of financing for the project, including everything from county bond financing and SPLOST to grants and corporate sponsorships.

He said Monday he is still working on financing plans and declined comment on the committee's discussion.

The Special Purpose Local Option Sales Tax, also known as SPLOST, is a 1% tax on all sales and uses in Newton County. Its proceeds can only be used for infrastructure and to pay

off debt. By state law, the county must share the proceeds of any SPLOST with the cities within its borders based on an agreed distribution plan.

The Newton County Board of Commissioners established the SPLOST Oversight Committee in 2017 with members representing each of the five commission districts.

The 2017 SPLOST was approved during a special election in March 2017. It is anticipated to raise an estimated \$64.8 million for county and municipal projects within Newton County before it expires in June 2023.

Committee members appeared to agree the referendum should go before voters during a regularly scheduled election like the 2022 General Election.

Choices for governor, a U.S. Senate seat, Secretary of State and other high profile offices will be on the ballot and draw a heavier turnout of voters than a single-item special election, said County Manager Lloyd

year ago. As of Monday afternoon, the state's seven-day average was 607 the lowest since May 19, 2020 (585.9).

Within the last two weeks, 9,029 cases of COVID-19

have been reported in Georgia, which is 83 cases per 100,000.

In Newton County, only 98 cases have been confirmed within the last two weeks.

As case numbers continue

to decline, officials are still encouraging the public to get vaccinated.

torists. "While the impact was not seen immediately, Georgians can expect to see a few more days of limited fuel supply but can rest assured that re-

lief is coming," Waiters said. Gasoline sales were report-

edly two to three times stronger than normal last week as drivers lined up at pumps to top off their tanks.

By Monday, gas prices had increased at the pump compared to a week ago. Georgia motorists were paying an average price of \$2.96 per

gallon for regular unleaded gasoline.

Monday's state average was 21 cents more than a week ago, 26 cents more than last month and \$1.30 more than this time last year.

It cost motorists \$44.40 to fill a 15-gallon tank of

gasoline; that is \$7.50 more than what motorists paid in January of 2020 when pump prices hit their peak of \$2.46 per gallon.

Most expensive Georgia metro markets were Atlanta (\$3.03), Athens (\$2.99) and Gainesville (\$2.98). Least

expensive Georgia metro markets were Warner Robins (\$2.85), Albany (\$2.86) and Valdosta (\$2.87), AAA

reported. "AAA will continue to monitor the latest news concerning the Colonial Pipeline," a news release stated.

# Newton County's young high achievers offer hope for future

n the relatively short time I've reported on news here in Newton County, I've seen enough

alleged juvenile mayhem to last a lifetime.

Some county residents, 18 and

younger, have listened to the wrong voices in their communities and done things that scarred them for life — in ways seen and

Why someone whose whole life is ahead of them would commit violent criminal acts — giving them little but prison or menial jobs to look forward to the rest of their days – is for the young perpetrators themselves to answer.

Sociologists and psychologists probably could write whole books about the root causes of teen violence and crime — which is doing nothing to enhance the quality of life in Newton County or Metro Atlanta as a whole.

But there is another, less visible group of young people in Newton County who

are quietly going about their daily lives, focusing on what will prepare them for careers in all fields of endeavor and giving them skills they can use the rest of their lives.

These are the young people who will be leading us into the mid-21st century, who give us hope a bright future awaits.

A number of our county's top students intend to enter the ever-expanding field of medicine.

Consider Alcovy High School senior Aderonke "Esther" Adewumi. She intends to major in biochemistry and molecular biology at Mercer University in the fall. Maybe she will be part of a team that tackles some of our most daunting medical mysteries, beginning with coronavirus?

Newton High School Valedictorian Nathaniel "Skye" Nash said he worked to be the school's top student in part to be positioned to earn the scholarship money he needed to attend the college of his choice without it being a financial burden for his

Nash plans to begin his college studies at Oxford

College and go on to its parent campus, Emory University in Atlanta, for pre-med studies to become a cardiologist.

"I'm trying to give back to my family and the community," Nash said, noting he wanted to tackle heart disease which runs in his family.

Social Circle High Valedictorian Emily Hardwar has already done dual enrollment work at Georgia State University's Perimeter College campus near Social Circle. She plans to pursue a doctorate in Nursing Practice (DNP), although she admits that's "subject to change."

One of Alcovy's two valedictorians, Logan Dobar, also already has been taking college courses as a dual enrollment student at Georgia State University's Perimeter College campus to prepare himself for studies in electrical engineering.

He said he's been too busy focusing on his studies to worry about whether he was in the running for Alcovy High's valedictorian honors this year which he will share with another student — or Alco-

vy's STAR Student award denoting the school's highest score on the SAT college entrance exam.

Dobar, who also attended classes at Newton College & Career Academy (NCCA), also did not hide under a rock while working toward his academic goals. He was a member of the NCCA Electrathon car team, the VEX Robotics Team, and the Technology Student Association throughout high school.

Natalia Sanchez is sharing Alcovy's valedictorian honors with Dobar. She plans to attend the University of Georgia in the fall and is considering International Business as her specialty.

She credited her parents with supporting her academic efforts after she was among the first in her family to graduate from high school. They wanted to support her academic efforts after they did not receive the same level of support for their education from their parents, she said.

There's Joyce Li, who is Eastside High School's valedictorian and the STAR Student for the entire county.

She plans to attend Georgia Tech this fall and major in computer science. She admitted she may have been a little better than others comprehending the course work but she had to work hard to make that understanding pay off.

Newton's top students also see their futures in other areas.

Aeryn Barrentine of Alcovy plans to study worship arts and sound tech at Toccoa Falls College

Fellow Alcovy senior Taylor Stevens is the first student in the school's 14-year history to earn All-State Band accolades. She is headed to the University of Alabama to study music.



#### Lt. Gov. Duncan won't seek reelection

Lt. Gov. Geoff Duncan announced Monday he will not seek reelection to another term as Georgia's second-highest state elected official, opening the door for a fierce 2022 campaign between Republicans and Democrats vying to replace him.

In a statement, Duncan – a Republican – said he plans to create a political organization called "GOP 2.0" aimed at "healing and rebuilding" the national Republican Party amid the fallout from former President Donald Trump's continued claims of voter fraud in the 2020 elections.

Duncan's pivot away from Trump via public statements and television news appearances since the November 2020 general election pitted him against the former president and his allies who continue to hold a large influence over the state's Republican Party and conservative voters.

"The national events of the last six months have deeply affected my family in ways I would have never imagined when I first asked for their support to run for lieutenant governor in

2017," Duncan said Monday. "Through all of the highs and lows of the last six months, they have never left my side and are once again united behind me in my pursuit of a better way forward for our conservative party – a

GOP 2.0." Duncan, a former healthcare executive and Minor League Baseball player who served three terms in the Georgia House of Representatives, has focused much of his tenure as lieutenant governor pushing for investments and policy initiatives to position Georgia as what he calls "the

technology capital of the East Coast."

He has presided over three legislative sessions as head of the Georgia Senate since winning election over Democrat Sarah Riggs Amico by a narrow margin in 2018. Duncan said Monday he plans to preside over redistricting efforts in the Senate later this year as well as during the 2022 legislative session.

Several Democratic contenders have thrown their hats in the ring including state Reps. Erick Allen of Smyrna and Derrick Jackson of Tyrone. Democrats have already

rolled out a roster of candidates for statewide offices beyond lieutenant governor including attorney general, secretary of state, insurance and labor. Democratic 2018 gubernatorial candidate Stacey Abrams has not yet announced if she will run against Gov. Brian Kemp again in 2022.

"I expect Gatewood to play a lot of 'small ball' in the series," Britt said. "They are going to bunt a little more against us since we are so good on the

Of course, finding a way to push runs across home plate will be key.

"We are playing better on offense but it seems it takes a while to get going," Britt said.

Piedmont will be led by three seniors including Cameron Mobley, Jeb Satterfield and Tanner Locklear. Each are eager to return the Cougars to previous state championship glory.

"This is what we've

been after," Mobley said. "If we keep doing what we have been doing then we should be fine."

Locklear said he is excited about the series.

"This is my second time going for the championship," Locklear said. "I am going to try and approach it like any other game. If we can delivery offensively, I know our pitching will be fine."

Satterfield said playing for a championship is a great way to conclude his high school career.

"I think the key for us will be to start hot at the plate and then let our pitching do what it has always done this season," the first baseman said.

The series will feature a matchup of head coaches who were also high school baseball standouts during their playing careers. Britt helped lead George Walton Academy to the 2001 GISA Class AAA state championship.

"Probably the thing I remember most about that final game now is how I was on the bottom of the dog pile," Britt said. "At first that seemed like a good idea but the longer I was

there I was just hoping everyone would get back up."

Britt is aiming for his first championship as a coach. He guided both Flint River Academy and Windsor Academy to the GISA AA finals in recent years only to finish second to Pied-

The 2020 season, Britt's first with the Cougars, was cut short due to the COVID-19 crisis so Piedmont players and coaches alike are glad to be able to have a postseason in 2021.

Gatewood's Brandon Moss was a standout

player at Loganville High School, and helped guide the Red Devils to the state finals his senior season. Moss went on to a long professional career before entering the high school coaching ranks. This is his first season directing the Gators.

The Cougars swept Brentwood in the semifinals at home last Thursday. Piedmont took the opening game 9-1 behind a 17-strikeout performance by Mobley. Britt's team earned the sweep with a 4-0 win in the second game behind the pitching of Gavin Mask who recorded 10 strikeouts.

Mask and Mobley also contributed offensively with homers in the semifinal series. In the series clinching contest, Mobley, Locklear and Hudson Reed each drove in runs.

The first game was close until Piedmont scored seven runs in the bottom of the sixth. The Cougars have now won nine consecutive games and 13-of-14 overall. Gatewood has won six consecutive games with its last loss at the hands of Piedmont.

"It was a great series for us," Britt said of the semifinals. "The kids really did well."

The Gators swept Terrell Academy in the other semifinal series 12-4 and 6-2. Britt was able to scout the series in person. Both teams are undefeated in the postseason.

### Bill to limit cutting police budgets in Georgia signed by Gov. Kemp

Gov. Brian Kemp signed legislation recently to limit how much local governments in Georgia can cut funding for police agencies.

The bill, sponsored by Rep. Houston Gaines, R-Athens, forbids cities and counties from cutting the budgets of most police agencies in the state by more than 5% over a fiveyear period, except during times of financial trouble such as seen during the COVID-19 pandemic.

Its passage largely along party lines in the General Assembly came as Republican lawmakers moved to block efforts to reduce police budgets in the wake of last summer's nationwide protests against police brutality and racial injustice.

Democratic leaders slammed the measure as a power grab by the state over local governments, noting also

that criminal-justice advocates have largely called for shifting some budget dollars from law enforcement to other areas like mental health and housing rather than outright gutting police agencies.

Kemp framed the bill as a show of support for Georgia police officers who he said "continue to sacrifice their lives for the sake of others" despite growing backlash from local leaders and communities over recent high-profile killings by police including the death of George Floyd in Minneapolis last year.

"The defund-the-police movement seeks to vilify the men and women who leave their families every day and put their lives on the lines to protect all Georgians," Kemp said at a bill-signing ceremony in Barrow County Friday where he was flanked by several officers.

Besides limits on budget reduc-

tion, the bill also allows state and local public-safety employees including police, correctional officers, firefighters and EMS operators to deduct pay from their salaries to secure legal representation if they are sued or prosecuted for their actions on the job.

On another criminal justice front, Democrats joined Republicans during the 2021 legislative session to pass legislation overhauling Georgia's citizen's arrest law following last year's killing of Ahmaud Arbery near Brunswick. Kemp signed the measure May 10.



According to the online cheese purveyor Cheese.com, American cheese is a semi-soft, processed product made from pasteurized cow's milk and has a creamy, mild flavor. American cheese can come in yellow or white varieties.

American cheese is made from a mixture of cheeses, including colby and cheddar. Each slice of American cheese today contains less than 51% of curds, which means it doesn't exactly meet the definition of cheese as defined by the Food and Drug Administration. To be a true "cheese," a product has to be more than 50% cheese. American

cheese is made from a base of cheese and combined with whey, milk proteins and emulsifying salts. This blend of ingredients helps American cheese melt without breaking or turning greasy the way a traditional cheese does.

According to the resource Serious

Eats, the process for making American cheese was invented in Switzerland. In an effort to reduce cheese waste, scraps from various batches of cheese were melted together and formed into a new product. In 1916, Canadian-American cheese salesman James Kraft perfected and patented the technique. He produced and sold the first American cheese.

While American cheese has cheese in it, labels on the American cheese typically sold at the deli counter typically say pasteurized processed cheese. Those individually plastic-wrapped slices sold in the dairy case often go by pasteurized cheese food. The latter has a higher percentage of added ingredients that affect texture and meltability.

While true cheese connoisseurs may scoff at American cheese, the product certainly has had staying power and stands up in many recipes.

be conducted. Though the effects of soyfoods on heart health may or may not be as significant as researchers once suggested, soyfoods can still make for nutritious additions to a healthy diet. The health care experts note that the following foods that contain soy provide a variety of nutritional

• Edamame: Edamame is a dish of green soybeans that are boiled or steamed in their pods. UCSF Health notes that edamame are

high in protein and fiber. Tofu: Tofu is made by pressing curdling soy milk into a solid block. Tofu has been linked to lower risk for various diseases, including osteoporosis. Tofu contains plant estrogens, and women's estrogen levels go down after menopause, leading to a loss of bone mass that makes them vulnerable to osteoporosis. According to WebMD, plant estrogens in tofu can make up for some of the estrogen drop-off related to menopause.

• Soymilk: Soymilk is produced when soybeans are soaked, ground fine and strained. The resulting fluid is soybean milk. UCSF Health notes that unfortified soymilk is an excellent source of high quality protein and B vitamins. However, unfortified soymilk lacks calcium and vitamin D, both of which are found in traditional milk. Fortified soymilk contains both calcium and vitamin D.




