Newton deputies to increase park presence after shooting

Sheriff's office confirms 3 teens shot during June 4 incident

By TOM SPIGOLON

COVINGTON, Ga. — The Newton County Sheriff's Office says a third teen received injuries in a nighttime shooting incident Friday, June 4, at Denny Dobbs

And a sheriff's office spokesperson said the agency will increase its daily "presence" at the park on Georgia Hwy. 212 after the event in which two other teens also were hit by gunfire right before the park's closing for the day.

No suspected shooters had been identified or taken into custody and no motive had been confirmed Friday.

The sheriff's office was encouraging anyone with information regarding the shooting to call its lead investigator at 678-625-1465, or contact the sheriff's office crime tip hotline at 678625-5007. Callers can remain anonymous, officials said.

The victims were girls, ages 16 and 17, and a 15-year-old boy. The boy left the scene to get treatment, said spokesperson Caitlin

One girl was shot in the arm and the other in the foot and were reportedly taken to a local hospital for treatment.

No details were given about the boy's injuries following the 8:15 p.m. incident. Deputies responded soon afterward to a report of a "penetrating trauma" at 9 p.m. at a location about 10 miles away on Gross Lake Parkway and found the boy with injuries related to the park incident, Jett said.

A Covington resident, who asked to remain anonymous, told The Covington News her family was inside the park's basketball

Teens arrested after knife attack, phone threats on family members

COVINGTON, Ga. — Two separate incidents related to cell phones reportedly helped contribute to two Newton County teens' arrests recently.

One teen was upset about a phone being taken away before he allegedly slashed an older sibling with a knife early Tuesday, June 8, a report stated.

The other reportedly told a mother by text message Monday night she planned to travel to the woman's house to fight her daughter before the suspect showed up to do so.

In the first incident, sheriff's deputy reported responding to a report of a family fight on Prince Edwards Way early Tuesday, June 8.

The deputy met a woman who said her 14-yearold son had tried to stab his 18-year-old brother at around 1:45 a.m.

"I spoke with the older brother who stated that once he picked up his little brother from his girlfriend's house on Milton Way, they had got into a verbal argument," the deputy stated in a report.

"The older brother stated he was mad because

his little brother was out past midnight without telling anyone where he was going. Also stating his little brother was mad because he had his phone taken away.

"Older brother also stated that they went to their grandmother's house and fought each other in the front yard. Stating that once back home his little brother was told to go inside and to his room.

"The older brother stated he heard doors slamming and when he went inside to investigate he walked upstairs and saw his little brother exiting their mom's bedroom with a knife.

"The older brother stated the little brother came at him with the knife and that is when he tried to get the knife away."

The deputy reported the 18-year-old had visible cuts on his body from the knife and "a mark on his neck from a bite." The older brother said he placed the 14-year-old in a "sleeper-type hold and he finally dropped the knife," according to the report.

The deputy arrested the 14-year-old, who was was charged with Aggravated Assault and transported to the Rockdale Youth Dentition Center.

• In the other incident, a 17-year-old girl was arrested and booked into the Newton County Jail Monday night, June 7, after sending texts to a woman threatening harm to her daughter and then showing up at her Frankie Lane home.

The mother told a deputy that a boy and girl with whom their 16-year-old daughter was acquainted "came to their house to fight their daughter" at about 8:25

"The complainant stated the female had sent several threatening messages to the mom's phone telling her what she is going to do to her daughter before actually showing up at the house," the deputy reported.

Hayly Marie Spence of Cambridge Way in Covington was arrested and charged with Aggravated Assault and Terroristic Threats and Acts.

The deputy seized a pink Apple iPhone with a cracked screen and clear case was seized as evidence.

The boy who reportedly accompanied her was charged with Terroristic Threats and Acts and also arrested. His name was not disclosed because he was a juvenile, the report stated.

Newton commissioner affirms millage rate not set yet; budget approval Tuesday

COVINGTON, Ga. — Residents complained about higher property assessments and the need for more effi-

ciency in government operations during the first public hearing on the 2022 county budget June 8.

Five property owners told the Newton County Board of Commissioners they were concerned about property assessment increases doubling in some cases without new services being

planned in the proposed

county spending plan.

District 1 Commissioner Stan Edwards said he knew assessments were much higher than previous years but the board "in all likelihood" would not need the increased revenue that higher

values would produce. He

said the board had neither approved the 2022 budget nor set a property tax rate, also known as the millage

"No one's taxes have gone up yet," Edwards said.

The proposed 2022 county government budget is slightly larger than the current year and includes 32 new full-time positions — half of which will not be hired until Jan. 1 to staff a new east Newton fire station.

The total budget, including all funds, is \$119.1 million that is 1.6% higher than the current budgeted amount of \$117.3 million for 2021.

The General Fund totals \$78.1 million for 2022 and is a 2.5% increase from the 2021 total of \$76.2 million.

Jay Lowery of Mansfield told commissioners Tuesday he believed any extra income that exceeded expenditures in past years should have been used to lower property taxes. He said the county needed to undertake efficiency studies to determine if the amount of work required by the county justified the number of employees being added in such areas as public works.

Douglas P. Johnson of south Newton County and Kim Pecylek of Oxford said notices they recently received showed higher assessments meant increases in their tax bills were coming.

see more spending planned on health care or other county services to justify any tax increases. Edwards said the "anxiety

Pecylek said she wanted to

over the assessed increases is real (and) it's real for me."

"(It is) all market-driven,"

he said.

Commissioners annually set a millage rate to fund most of the budget after receiving the 2021 county tax digest from the tax commissioner's office. Taxpayers see it in addition to a separate property tax rate to help fund the county school district annually.

Edwards said any estimates taxpayers saw on their assessment notices were not based on a tax rate for the 2022 budget. "When property values

are here like they are now for whatever reason," he said, gesturing with his hand above his head, "Then we have to set a millage rate for a budget that is down here."

"The only control we have is the budget and the millage rate," Edwards said.

Veteran Commissioner J.C.

Henderson said sales taxes also are imposed on property taxpayers and they have asked him what the board

can do about keeping property taxes low. "I care," Henderson said. "I'm not supporting no tax

increases. I'm sick of it." He said \$2.6 million the county recently received from the sale of land in the Stanton Springs technology park should have been used for direct tax relief for property owners.

County Manager Lloyd Kerr has said the money is being used to reduce the money needed from taxpayers for capital purchases that would have been included in the 2022 budget if the sale proceeds had not been given

Adoption of the budget is tentatively set for June 15.

work career as a teacher in the school system after almost all of her years as a student in NCSS.

classroom. Ballard said kindergarten was the last grade to receive electronic white boards, which allow the teacher to write on the screen as well as import online

images. She said she was unsure at first if it could work with her teaching methods. However, she said she eventually knew it would be an effective tool for her young students.

"Now, I don't know how I could teach without technology,"

she said. Another change since she began has been state education leaders' emphasis on a more standardized approach requiring specific time frames for teaching parts of the curriculum to kindergarten students. She said she formerly was able to adjust her teaching to meet each student's in-

dividual learning speed. "There's not as much personal input," Ballard

Now, Ballard is considering going overseas to teach English.



A 'walk in the park' is no longer that

f you haven't heard, a pregnant woman this week was reportedly stabbed in the back by a man while walking

along a trail in Brookhaven, near Atlanta. She had her 3-year-old son with her can you imagine the

terror this child witnessed? Unfortunately, the woman was forced to undergo an emergency cesarean section to not only save the baby's

life, but her own. She was

only five months into her pregnancy.

Reports out of the ATL say both will be fine, but the road to recovery will be a long one to traverse.

The truly cringeworthy part of this story was that the suspect had tried to strike up a conversation the woman and her son while walking, but as they walked away, the man ran up behind them and stabbed her. Reportedly

nothing was said or done to provoke the suspect, who was finally located and arrested Thursday. In other words, the attack was completely unexpected. Apparently mental illness "played a role" in the incident.

Before the stabbing, the park had no history as a site of crime, much less something as significant as this.

This incident has rattled many, including myself, despite living here in Newton. Walking around my own neighborhood, I can't help but find myself looking over my shoulder every few minutes, senses heightened. It's not that I don't feel safe, per se. Maybe I'm just more timid considering recent events. After all, I have two toddlers to look after.

The Brookhaven incident highlights two major problems that not only the city of Atlanta is facing, but our entire state and country faces.

The first problem is the obvious, ever-rising crime rates. According to online

crime data tracker NeighborhoodScout, a person's odds of being the victim of a crime anywhere in the state of Georgia are currently 1 in 294. The odds of becoming the victim of a crime right now in Atlanta is currently 1 in 121 — more than doubled. The same data projected Atlanta as safer than only 3% of all other cities within the U.S. That is not good.

I've also read statistics showing crime rates have increased by 60% within the last year alone.

I listen to Atlanta-based radio shows, watch Atlanta-based news stations and read Atlanta-based newspapers. Nearly everyone has something to say about it, whether it be the alleged reason — or reasons — for the increase of violence or how they need to handle the situation. But the bottom line is that I've seen no real, legitimate action taken. And I'm not sure when we'll see action. The issue is expected to be a major political talking

point for Atlanta's mayoral race this year, so does that mean we'll just keep hearing a bunch of talk til then? When talking about the

root cause of the crime spike, I've heard a lot of different theories. Early on it was because of civil unrest due to pandemic restrictions brought on by the federal government. Another was no kids having to go to school in person. Then there was more unrest related to instances of racial injustices and police brutality. I've heard now that it's due to a shortage of police officers and lack of law enforcement presence. In relation to that, I've read where a lack of support and respect for law enforcement from not only civilians, but government leaders, could be damaging,

All of those reasons are plausible, but here's one I haven't read much about — parenting; or these assailants' home-life. Do they have a support system? A

job? How can we help them? And a question that brings us to our second fleeting problem: what is their mental

health status?

Now, I'm not a big fan of people playing the "crazy card" or claiming "the devil made me do it," but I also understand and realize mental illness is real, and, just like in the Brookhaven incident, it has proven to play a major role in violent crimes nationwide.

I can't tell you what the solution is to the raging war on crime and mental health. What I can tell you is that it's time for our leaders not only here in Georgia, but nationwide — to put their money where their mouth is. It's time they start taking action to address these issues. Until then, well, it's sad to see a "walk in the park" is no longer that.

Biden is traveling abroad in the United Kingdom and Europe. Meanwhile, the vice president has just returned from a trip through Central America, where she claims to have been "dealing with root causes" of the border crisis. If she truly wanted to uncover the "root causes," she never had to leave Washington... The #BidenBorderCrisis was caused entirely by the reckless "open border" policy decisions made in the White House. President Trump left his successor a safe and secure southern border – an inheritance that Biden has trashed in just a few months.

t's been busy couple of weeks here in Georgia and in Washington since I last wrote.


Not only did I attend the centennial recognition of

court at the time of the incident when

she saw three men shooting guns.

She said teens were there celebrating the last day of the school year for graduation and "going around squirting each other with squirt guns and throwing water balloons at each other, having a good time."

She said she was unable to see a suspect's face but saw three men shooting, including one standing out of the sunroof of a car and another standing outside of the same car. A third stood on the back of a truck shooting from behind the car, she

said.

The witness said the shooting happened around 8:15 p.m. and several people were still at the park.

According to the Newton County government website, Denny Dobbs Park is open to the public from "daylight until dusk, seven days a week," meaning it had not yet closed before sunset at 8:42 p.m. when the shooting reportedly occurred.

The park has seen increased daytime use in recent weeks with the opening of a weekly farmers market and the county's new SPLOST-funded Splash Pad. A skateboard park also is nearing completion on the park's east side.

Jett said the sheriff's office would increase its daily presence at the park.

In addition, Sheriff Ezell Brown plans to discuss with the Newton County Board of Commissioners ways "to enhance public safety" at the park, Jett said.

"As always, our top priority is ensuring the safety of our community, and we want the Denny Dobbs Park to be a safe spot for families this

summer and every summer thereafter," Jett said.

Since Jan. 1, 2019, the sheriff's office has responded to a total of seven violent or drug-related incidents at the park, she said.

Deputies responded in the twoand-a-half-year period to the Friday night "penetrating trauma" and to one sexual assault, one fight, one discharged gun, and three drug-related incidents, Jett said.

but that could not be immediately verified.

Since its creation on June 6, the page's administrator has made a series of claims and allegations against Banes and other county officials, Covington city officials, and a local attorney tied to Banes.

In a series of posts, the administrator questions numerous P-Card payments Banes listed on his reports.

The questions provide little context but speculate if they are related to such issues as Banes' 2020 lawsuit against the county government seeking back wages.

They also refer to numerous charges listed at area car washes for his county vehicle, and at area restaurants for meals with constituents, current and former county officials, and employees.

Among the meals listed were at least three with his personal attorney, Stephanie Lindsey, who is representing him in the back wages lawsuit against the county that is under appeal to the state Court of Appeals.

Banes said in a posting on his Facebook page that he uses his P-Card "for the entire Board of Commissioners' training, travel, meals and hotels."

"It is also used to pay for staff training, continuing education classes and for some supplies for the chairman's office," he wrote.

The report lists payments for lodging and related costs with attending Association County Commissioners of Georgia meetings, which typically are held in the Savannah area.

Banes admitted he used his P-Card to buy plane tickets for his wife to travel with him but he repaid the county each time.

"Whenever my wife traveled with me my office purchased her ticket on the P-Card so that we could sit together on the flight and I immediately reimbursed the county the funds for her ticket," Banes said in a post.

He also provided a list of about \$1,400 in reimbursements he

made to the county for personal purchases using the card between 2017 and 2020.

"Anytime, I incurred expenses above the county amount, I paid the difference," he said.

The reports published on "Newton Exposer" have "been redrafted to mislead the public," Banes said.

Documents posted on the week-old Facebook page that lists his P-Card expenses had been altered, he said.

"As you look and compare the original reports to the reports presented to the public you will see the person providing the fake reports removed important information about the items," Banes said. "They also added items that are not in the original reports and not on my P-Card."

A total of 51 county officials from 14 county departments; the tax commissioner, district attorney and public defender's offices; and juvenile and superior courts have P-Cards they use to make needed purchases.

The cards are linked

to the county computer system and effectively pull funds from the cardholder's part of the county budget — not allowing them to use the cards if their limits are exceeded, finance officials have said.

Limits range from \$500 to \$20,000, which is the amount of Banes' card limit. The county govern-

The county government has some history in recent years of employee abuse of the purchasing system.

Banes said he had "suggested" to Board of Commissioners members that they make "all" of their P-Card reports public by publishing them online monthly.

Kevin O'Brien, a former county fire chief, was indicted in January 2016 after an investigation by the Georgia Bureau of Investigation into his use of a county P-Card for personal purchases.

O'Brien pleaded guilty to four counts of Theft by Taking later that year and was fined and sentenced to one year in prison and 20 years on probation.

Social Circle ranks sixth in Class A athletic prowess

It was a banner year for Social Circle ath-

The Redskins finished sixth overall in the Georgia Athletic Director's Association (GADA) Director's Cup for Class A-Public with a cumulative point total of 693 points. Commerce captured the Cup with 1,239 points, followed by Armuchee (835) and Lake Oconee Academy (819).

Introduced in 2000, the GADA Director's Cup exists to recognize outstanding achievements by GHSA athletic departments across all classifications. A total of 26 sports are taking into consideration, with points being accumulated via wins, region and state championships, and individual placements in region or state events.

During the course of the 2020-21 school year, Social Circle saw several of its athletic programs produce success in their first complete seasons since the school reclassified from AA to A-Public.

"On behalf of the Social Circle administration, we would like to congratulate all of our student-athletes on a great 2020-2021 school year," Social Circle Athletic Director Craig Hargrove told scredskins.com. "Thank you to all of the coaches for putting in countless hours to promote their programs and athletes.

"We also want to thank the parents for supporting your children in extracurricular activities at Social Circle. We look forward to the opportunities to compete in the upcoming 2021-2022 season."

Things got off to a hot start for Social Circle in the fall.

The Redskins' cross country program hosted its annual Redskin Invitational, as well as the Region 8 A-Public Championships. They proved a worthy host as two of their runners qualified to advance and compete at the **GHSA State Cross** Country Championships in Carrollton.

Meanwhile, with

first-year head coach Rob Patton leading the way, Social Circle showed significant signs of improvement on the gridiron. The Redskins went 5-5 in the regular season and made their first football state playoff appearance since 2009.

The Social Circle softball team earned a runner-up finish in region play, locking up a spot in the postseason. They took down Taylor County, 8-1 and 13-5, in the opening round before getting knocked out by eventual state champion Gordon Lee in the second round.

The Redskins' competitive cheerleading also showed out in the fall, placing eighth at sectionals to clinch a spot in the state competition, where they finished sixth.

In the winter, Social Circle made a splash in boys' and girls' basketball, wrestling, swim and bass fishing, while the GHSA-sanctioned literary team also excelled.

The Lady Redskins cracked the top four in region standings at various times during the basketball season, but ultimately came up short of a playoff berth. The Redskins, however, continued their recent run of dominance by rolling to a Sweet 16 appearance.

Social Circle's wres-

tling team won its area tournament and finished in third place as a team at the State Dual Tournament. A month later, nine individual wrestlers medalled in the GHSA State Traditional Tournament as the team earned a fourth-place finish.

Rounding out the Redskins' winter success were swimming the Boys' 200 and 400 freestyle relay teams and a pair of individual swimmers advanced in the postseason — and the literary team, which finished third at state and won individual state titles for girls solo and girls trio.

Lastly, this spring was one of growth for Social Circle's athletic teams.

The Redskins rifle team closed out the regular season with a 9-1 record. They placed second in the area, securing a trip to the GHSA State Finals, where finished in fifth overall.

On the diamond, Social Circle baseball exceeded expectations with a young squad that fielded just two upperclassmen. The Redskins won 11 of their first 12 games in region play and ultimately slipped into the postseason as a No. 3 seed. They pulled off a first-round upset of Taylor County and put up a valiant fight against top-seeded ACE Charter — a state semifinalist — in a losing effort in the Sweet 16.

Social Circle's boys' and girls' soccer teams both enjoyed strong seasons that led to Sweet 16 appearances. Meanwhile, both the girls' and boys' golf teams had representation at their respective state tournaments.

In tennis, the Redskins and Lady Redskins worked their way into the state playoffs.

The Social Circle track program was spectacular as it hosted the Region 8-A meet and qualified for the GHSA State Championships in the 4x400 boys' relay, boys' high jump, 110 and 300 hurdles, girls' 800, 1600 and 3200.
