

High school bands

Into a New Era'

The Pride of Eastside adjusting to new director, show, practice areas

COVINGTON, Ga. — Eastside High School's marching band has worked to get accustomed to a number of new things this year — new practice field, new school building, new show and new director.

Nevertheless, the 110-member The Pride of Eastside (TPOE) band has adjusted pretty well in providing its usual high quality musicianship and performances, said director Elijah Clark.

Clark assisted longtime director Alan Fowler before assuming the reins of Eastside's marching band this year after Fowler's retirement in July after three decades.

In addition to performing at Eastside High football games this fall, the band earned a First in Class award at the Oconee Classic Marching Contest Sept. 25 in Milledgeville. It competed in Class 3A against other bands its size, Clark said

TPOE also recently performed its "Soaring into a New Era" show in the Peach State Marching Competition in Rome, Georgia; and played a

marching band exhibition in Athens.

Clark said the band worked to do rehearsals in a parking lot at the new school campus on Ga. Hwy. 142 but was unable to fully utilize it because the lot still was not completed on the new school's campus.

TPOE also does not have a full practice area on which to train, he said. However, in rehearsing

for its new show, "the kids have taken it and done a really good job with it," Clark said.

The first-year band director is an Eastside graduate who performed in The Pride of Eastside under Fowler's direction.

Numerous Pride of
Eastside members have
gone on to play in college
bands nationwide — including many with UGA's
famed Redcoat Band.

Clark went on to become a member of the Auburn University Marching Band before graduating and returning to Eastside as an arts educator.

Clark noted all high school marching bands in Newton County saw their numbers dwindle during the pandemic. However, he said TPOE is "right on track" to regaining its previous size with 110 See ERA, A2 Confederate statue

Covington resident says case now can be 'tried on the facts'

COVINGTON, Ga. — Those seeking to stop Newton County's removal of a century-old memorial to Confederate soldiers praised the

Georgia Supreme Court's ruling that

"Today's decision is proof that our system works," Humphries said Tuesday.

The state's highest court overturned a state Court of Appeals decision and ruled that Humphries was the only plaintiff who could continue a lawsuit seeking to enjoin Newton County from removing the "To the Confederate Dead of Newton County" statue from the park in the middle of the Covington Square.

Election 2022: Advance Voting

Newton County early voting up 18% from last mid-term election

COVINGTON, Ga. — Newton Countians casting ballots through the first seven days of Early Voting this year followed the statewide trend of being considerably higher than the

election in 2018.

A total of 8,264 voted in the first seven days — Oct. 17 to Oct. 24 —

same period before the last mid-term

that advance, in-person voting was offered at two locations in Newton County, said Phil Johnson, chairman of the Newton County Board of Elections

The seven-day total exceeded by 18% the 6,956 votes cast during the first seven days of the 2018 advance voting period, according to statistics from the Newton County Board of Elections and Registration.

This year's heaviest voter turnout day was on Monday, Oct. 24, when a total of 1,291 voted at the county's two locations at Turner Lake Center near downtown Covington and Prospect Church on Ga. Hwy. 212 in west Newton.

By Thursday, Oct. 27, almost 12,000 Newton Countians had voted in person in advance of the Nov. 8 See VOTING, A6

members, including 20 ninth-graders. A total of 30 graduated in May, he said.

The ninth-grade band members have been able to overcome the physical and mental challenges of playing music in tune while marching in time with other band members, Clark said.

"It takes a while getting used to marching and playing at the same time," Clark said.

He said band members "do a lot of conditioning" — such as cardio and calisthenics — to prepare for a football and com-

petition season that begins in summer heat and generally ends in near-freezing weather.

Band members performing a halftime show are required to learn to control their breathing while marching continuously for 10 minutes.

"It's very close to sprinting for 10 minutes," Clark said.

TPOE is led by drum majors Sarah Dalton, Dakota Cooper and Kendi Dublin.

Its new show is updated for 2022 and includes music from "Top Gun" and "How to Train Your Dragon," as well as the song "Defying Gravity" from the musical "Wicked."

"The kids have played the heck out of it," Clark said.

Its future performances are scheduled to include the annual Covington Lions Club Christmas Parade and, tentatively, the Black History Month parade first organized in 2021.

It also is raising money to perform in the National Cherry Blossom Festival Parade in April 2023 in Washington, D.C., he said.

Breast Cancer Awareness Month

Lawmaker spreads 'early detection' message

COVINGTON, Ga. District 113 State Rep. Sharon Henderson, D-Covington, has worked to spread the word this month about the law she authored that requires women to be reminded about getting annual mammograms.

Henderson has spoken to groups ranging in size from the 2,000-member New Birth Missionary Baptist Church in Lithonia, to the Reign Over Cancer event at the State Capitol as part

of observances of Breast Cancer Awareness Month.

The most recent event was the Colors of Cancer event in Locust Grove Oct. 23. It was to feature Henderson, whose House Bill 937 earlier this year required insurance companies in Georgia to inform their customers above age 40 to have mammograms to detect breast cancer.

Henderson was a keynote speaker during the opening session of the Georgia Primary Care Association's 45th annual conference Sept. 28-30 in Atlanta. Also at the event was State House Speaker David Ralston.

She also was a featured speaker at a cancer awareness event hosted by Reign Stevens and her nonprofit Reign Over Cancer Oct. 3 at the State Capitol in Atlanta.

The event Oct. 9 at New Birth — one of the largest churches in Metro Atlanta — was titled Great Cancer Awareness Pink Sunday and included Pastor Jamal Bryant's description of Henderson as a "force to be reckoned with."

It culminated with the release of 1,000 balloons in honor of cancer victims and survivors, she said.

Henderson also was to attend and speak at "Pink Out Day" hosted by Rockdale County Clerk of Courts Janice Morris and Conyers Mayor Vince Evans in Olde Town Conyers

Oct. 18.

She also was a featured speaker at the Colors of Cancer event in Locust Grove Sunday, Oct. 23, that benefited the Atlanta Hope Lodge.

She said her message during speeches at all the events was "early detection saves lives.

Henderson noted she was diagnosed with breast cancer that was detected early.

However, she got the idea for the bill after speaking with a fellow patient who had not known to get a mammogram before her breast cancer advanced and put her at risk, Henderson said.

She said she was encouraged by fellow lawmakers from both sides of the aisle — as well as lobbyists — for the legislation during the General Assembly session.

The Democratic state lawmaker from Coving-

Ground broken on massive Hyundai EV plant

Georgia political and business leaders joined with their Korean counterparts Tuesday to break ground on the largest economic development project in the state's history.

Hyundai Motor Group is about to begin construction on a \$5.5 billion electric vehicle and battery manufacturing plant in Bryan County expected to create 8,100 jobs when fully built out. "We are excited to

be your neighbor and partner," José Muñoz, president and CEO of Hyundai Group North America, said during a groundbreaking ceremony held at the plant site. "This is going to be a massive operation with a scale that's hard to comprehend."

Gov. Brian Kemp said the Hyundai plant is part of \$13 billion in investment for electric mobility projects Georgia has landed since 2020. Those projects will create more than 18,000 jobs, Kemp said.

"Businesses know we're not only a sure bet today," he said. "We will continue to build on these achievements for years to come."

Deputy U.S. Com-

merce Secretary Don Graves said the Hyundar plant dovetails with the Biden administration's efforts to combat climate change by stepping up EV production. The president's goal of EVs making up half of U.S. car sales by 2030 would help the nation achieve net-zero carbon emissions by 2050, he said.

But Taeyong Cho, the Republic of Korea's ambassador to the U.S., injected a note of caution. He said a provision in the Inflation Reduction Act Congress passed in August making EVs and EV batteries not fully manufactured in North America ineligible for a new federal tax credit disadvantages Hyundai.

"It is not good for the U.S.-Korea partnership or the state of Georgia,"

Cho said.

U.S. Sen. Raphael Warnock, D-Ga., who attended Tuesday's groundbreaking, introduced legislation in September to delay the made-in-North-America requirement until 2025 for batteries and 2026 for electric vehicles to give Hyundai a chance to ramp up the Georgia project.

State's reading scores on par with pre-pandemic results

New results from "the nation's report card" show that Georgia fourth- and eighth-graders stand about on par with their pre-pandemic performance in reading, but eighth-grade math scores dropped from pre-pandemic levels.

The National Association for Education Statistics administers the reading and math tests every other year to fourth and eighth graders in sample schools across the country. The last time the tests were administered was in 2019 due to the COVID-19 pandemic. The results, out this week, show how students are faring after major disruptions to school over the past several years.

The Georgia results on the 2022 National Assessment of Educational Progress tests show that average fourth grade reading and math scores and eighth grade reading scores hovered around pre-pandemic rates.

Though Georgia's average scores for these three tests are a few points lower than in 2019, the differences are "not significantly different," according to reports released by the U.S. Department of Education's National Center for Education Statistics (NCES).

But in eighth-grade math, Georgia's average score dropped from 279 in 2019 to 271 this year, a significant decline.

This year, only about 59% of Georgia eighth graders were considered to have basic skills in math, while 67% met that bar in 2019.

Nationally, scores declined across the board for fourth grade and eighth grade reading and math, according to the NCES.

While many states saw drops from 2019

levels across the board or in many categories, Georgia bucked that trend, with its only significant decline coming in eighth-grade math.

The results come as Georgians gear up to vote for state school superintendent. Democrat Alisha Thomas Searcy is challenging incumbent Republican Richard Woods for the role.

Woods said he was pleased with the results.

"[It's] a testament to the hard work of teachers and students across this state," he said. "Knowing that there is still work to be done together, we will remain laser-focused on academic recovery and providing the resources schools and teachers need to invest in students and their success."

Searcy Woods set the bar too

"As a parent of three school-age children and a former [local school] superintendent, I am troubled," she said. "Our goal can't be to compete for the bottom. My vision is for Georgia students to rise to the top."

Advocates urge Georgians to "vote for mental health"

Mental health advocates urged Georgians Tuesday to "vote for mental health" at a press conference at the state Capitol.

"Mental health is not a Democratic issue or a Republican issue. It is a Georgia issue," said Kim Jones, executive director of the National Alliance on Mental Illness-Georgia. "Make sure your voice is heard and vote. ... Every elected official ... has influence on issues impacting people who are impacted by a mental health condition."

Kristen Petillo, area director for the Georgia chapter of the American Foundation for Suicide Prevention, praised the steps Georgia has already taken to address its mental health problems, such as passing a major mental health reform law during this year's legislative

session. The new law requires insurers to treat mental health conditions on par with how they treat physical conditions, along with many other new measures.

But still more is needed, Petillo said, especially given widespread mental health problems among Georgia youth.

Petillo cited a recent study that found more than half of Georgia's middle- and high-schoolers reported feeling depressed, sad or withdrawn at least once in the prior month, and that one in eight have seriously considered suicide within the past year.

"Although many Georgians are remarkably resilient, those who are exposed to unfavorable circumstances are at higher risk of experiencing behavioral health conditions," Petillo said.

Petillo pointed to racial and ethnic minorities, LGBTQ+ community members, low-income groups and people living in rural areas as groups who face multiple socioeconomic and health challenges that can lead to greater mental health burdens.

For example, people niving in rurai Georgia are about twice as likely to die by suicide as people living in suburban and urban areas because of the wider availability of lethal means, greater social isolation and less access to care in many rural areas, Petillo said.

Petillo outlined several key priorities for going forward, such as working to increase access to mental health providers, holding insurers accountable for treating mental health conditions and focusing

on health equity and disparities.

Darlene Lynch, head of external relations for the Center for Victims of Torture in Atlanta, said that

more culturally and linguistically accessible care is needed to meet the needs of the one-in-10 foreign-born Georgians.

Newton County can be a national example for civility in Confederate statue case

in case you missed it, the Georgia Supreme Court passed down a ruling Tuesday on the matter of whether the Confederate memorial statue located in the Covington Square should or should not remain.

If you were looking for a nice, neat bow of a ruling that brought the mat-

ter to a swift, hard conclusion, then you might have been a bit disappointed as Tuesday's ruling only signaled that the matter is not over.

In fact, the meat of the matter may just be getting started. And, if you ask me, that's quite alright. I'll tell you why.

Newton County hasn't been the first community to have to deal with the sharp controversy and strong feelings that elicits from discussing the removal or remaining of Confederate monuments. It won't be the last. But what we can be is the model.

We can be the model for handling a sensitive subject with wildly differing viewpoints in a spirit of civility, if not congeniality.

We can become a shining example to a politically polarized and divided nation that differences don't have to be detrimental to our ability to live and co-exist in an otherwise amazing community.

Tuesday's ruling only served as a setup to a renewed round of discussion and litigation about the statue that's been standing at the Square's center since 1906.

Regardless of what side of the fence you're on here, that isn't necessarily a bad thing.

The best thing that could've happened in this case happened back in July 2020 when Newton County Superior Court Judge John Ott said, in so many words, that nothing should be done to the statue until all sides of the case could be heard and all appeals exhausted so that "the rule of law" will provide the final say.

I'm prepared to take a few hits for saying that that is exactly the way it should be. I, like you, have my own personal thoughts and opinions about Confederate memorials and their place in public spaces. But ultimately, our thoughts and opinions — while important can't alone be the deciding factor in how things happen with regard to this matter.

That is, if we want to be that shining example that I spoke about earlier.

And, in many ways, we already have been. The way Judge Ott ruled on this 2-1/2 years ago proves that we can be that. It's better, for the sake of civility, than how other communities have gone about handling Confederate memorials.

As recently as August, a Confederate monument in Enfield, North Carolina, was bulldozed in front of a Facebook Live broadcast shared by Enfield Mayor Mondale Robinson. The town's board of commissioners voted 4-1 to remove the statue in an Aug. 15 meeting,

SPLOST an investment that enhances quality of life

Dear Editor:

Newton County voters have endorsed the Special Purpose Local Option Sales Tax (SPLOST) for 36 years. For all those years, this 1% tax on anything spent in Newton County – including by our thousands of visitors each year – has provided funds to improve transportation, build and rehabilitate capital projects, enhance public safety, reduce debt and improve and add to quality of life projects such as parks and trails. These are investments that would not be possible within the confines of regular city and county budgets built on property tax collections.

In early voting through Nov. 4 and on Election Day Nov. 8, Newton County citizens will be asked to vote for another six-year SPLOST referendum projected to produce \$84 million for the county and another \$24 million for our five municipalities and Social Circle, roughly

a 78% county/22% city allocation. State law is specific about how this con-

sumption tax must be used. It is not a referendum on the popularity of a local governing body. Passage of SPLOST means that anyone who eats, sleeps or spends money in Newton County helps to fund measures that promote local progress and contribute to the quality of life for those of us who live here. There is no

good reason to vote against SPLOST.

A priority transportation project in the 2023 SPLOST is \$12 million dedicated to the widening of Brown Bridge Road, a daily nightmare for hundreds of drivers on the west side of the county. This cannot be postponed. Other countywide road improvements will receive \$8 million, with another \$8.3 million for resurfacing. The Highway 278 Community Improvement District will receive \$1 million. Public safety gets its due on the SPLOST with \$9.5 million committed to replacing aging vehicles and another \$2.4 million recommended for fire protection.

Parks will see an additional \$3.5 million, and Newton Trails an additional \$1 million. The library is recognized as a quality of life enhancement and is slated for some \$900,000. The county's expanded animal shelter is set to receive another \$1.07 million to further its improved facilities and services. The county will receive \$10 million toward debt service.

Other enhancements to the quality of life our citizens enjoy include parks on the west side, south side, District 5 and a community waterpark. R.L. Cousins Community Center is earmarked for \$8 million for needed renovations to maintain this historical landmark while

Vote 'yes' for Referendum B to support family farms

Dear Editor:

My name is Chuck Berry and my family owns Berry's Tree Farm in Covington, Georgia. The Berry family has been farming in the Almon Community of Newton County since 1894. We have definitely seen the changes in and the challenges faced by local farming operations. We have been fortunate to maintain our family farm for more than 125 years. Without tax incentives for family farms and the support of our community, this would not have been possible.

This November when you head to the polls to vote, you will also vote on a statewide referendum that could benefit family farms like ours. Referendum B asks Georgia voters if they support extending the ad-valorem tax exemption family farms currently receive when they purchase certain farm products and equipment,

But as I started going through our things, and stopped letting my built-in anxiety controll me—that stops me from starting something if I don't think I can accomplish it—I did start to see things a bit more clearly. As my laundry room started to resemble a place where clean clothes could reside in order, and as I sought assistance in getting my spaces cleaned and organized, I did realize how many things we could do without. And that while I should give my best, sometimes just giving what I have to offer at that moment is

While I started this quest as a way to organize our home and to teach my children how our living spaces should be treated, I was surprised by the other areas of my life that were impacted. Before this summer, after I dropped my kids off at school, I would jump right into my work. Get on the computer, start answering emails, and focus on a task that I felt could

be achieved in that day. But just as my spaces needed to be de-cluttered, I realized my mind and my spirit needed the same

It was easier to do a work task that was manageable than it was to start one with unforeseen results. And in that way, work also started to take over in my priorities—working on vacations and weekends when I should have taken the time to be with my family. Dem ex-governor endorses Kemp

ATLANTA — Former Georgia Gov. Joe Frank Harris, a Democrat, endorsed Republican Gov. Brian Kemp Wednesday.

"Gov. Kemp is a proven leader," Harris said in a prepared statement. "I am proud of the tough decisions he has made during these challenging times."

Kemp, who is seeking a second term in office, is being opposed by Democrat Stacey Abrams, who narrowly lost to Kemp four years ago.

Harris, a businessman from Cartersville, served two terms as governor from 1983 to 1991. He later spent seven years as a member of the University System of Georgia Board of Regents. "Georgia is better off today thanks to Gov.Joe

Frank Harris' dedicated leadership and service to our state," Kemp said Wednesday. "Thanks to his foresight and investment in our state's education system, Georgia's best and brightest days are ahead. We are honored to have Gov. Harris' endorsement and support."



according to the Charlotte News Observer.

Several others in places like Jacksonville, Florida; Baltimore, Maryland and on the campus of the University of Texas-Austin saw similar monuments removed in the middle of the night.

Closer to home, a Confederate statue in McDonough in Henry County was removed in similar fashion, in the middle of the night, as was one in DeKalb County after Superior Court Judge Clarence Seeliger ordered its removal in March 2021 following a complaint filed by the

City of Decatur. They got what they wanted. But at what cost? Did the way it happened do more to unify or did it create deeper wedges of division and make everyone on either side dig their heels in just a little deeper?

For me, the matter of civility and the law doing its work isn't about whether or not I personally believe the statue should come down. As stated, I have my own personal beliefs about such memorials. I've got my own personal feelings about what goes on

in my heart and mind when I see Confederate flags flying freely in various parts of the state — a sight once foreign to a Nebraska boy who grew up in the Midwest in the 1980s and '90s.

This is about due process. This is about being able to restore some sort of faith in an America that can actually stand in the middle of hard matters, have dissenting viewpoints, not always getting our way and still be able to walk away not feeling as if the "other side" hates our nation.

Covington resident Tiffany Humphries — the one whose lawsuit was able to persist after the dismissal of a Sons of Confederate Veterans' complaint expressed excitement that, due to the Court's ruling, "our case will now be tried on the facts and the law."

She went on to say that, "Today's decision is proof that our system works."

I know some who will wholeheartedly agree with that statement, while others will meet it with far less enthusiasm. But here's the thing: Both sides of the spectrum should be allowed to feel what they feel. Both sides shouldn't have to be crucified for what they believe.

Both sides should be able to, at least hear and seek to understand the other. That's what is supposed to separate the United States from other countries and governing bodies. It's also what's been eroded from our discourse over the last 15 years of political unrest in this nation.

The middle has all but disappeared, and in some cases, is presented as a hiding spot for the spineless. That couldn't be further from the truth. In fact, the truth is often residing in the middle, waiting for people from either extreme to stop trying to win the shouting match long

enough to come and find it. This case is far from over. But Newton County's time in the spotlight to show a polarized nation how civility in the face of tension and controversy is done is just beginning.

Covington motorist charged after shot fired at state troopers

COVINGTON, Ga. - ACovington man is facing an array of charges after he allegedly used a handgun to fire at state troopers as they tried to stop his fleeing vehicle outside a shopping center after it reached speeds of up to 97 mph on I-20.

Khalil Marshaun Jackson, 27, was charged with Fleeing, Aggravated Assault on a Law Enforcement Office, Distribution of Marijuana, Interference with Government Property,

Possession of a Firearm during a crime, DUI and other traffic-related charges in connection with the Saturday, Oct. 22, incident in a parking lot at U.S. Hwy. 278 and Turner Lake Road.

A preliminary report stated Georgia State Patrol troopers were operating a speed control device near the Almon/Crowell Road interchange on I-20 eastbound Saturday around 8 p.m. when a Volkswagen Jetta was clocked at 97 mph in the posted 70 mph zone.

Troopers caught up to the

vehicle as it traveled onto the ramp for Exit 90 on to U.S. Hwy. 278, a report stated.

However, a warrant stated the vehicle almost struck other vehicles as the driver attempted to flee from the troopers on the curved ramp and reached speeds up to 125 mph, the warrant stated. "Immediately after exiting, the VW turned into a shopping center parking lot. The driver continued through the parking lot in a reckless manner," the report stated.

Troopers performed a pre-

cision immobilization technique, or PIT, maneuver to stop the VW which caused the vehicle to rotate. However, the suspect continued to flee and troopers performed a second PIT maneuver that caused the VW to rotate out of control. the report stated.

A warrant stated the suspect then pointed a Smith & Wesson handgun out of the driver's side window at one trooper, shot at the patrol car and struck it in the radiator which left it immobilized.

"Troopers did not return

fire, nor did any other (law enforcement) officers," the preliminary report stated.

The suspect then ran on foot and Covington Police officers prepared to deploy a K-9 officer in an area the officers believed he had fled, the report stated. "The suspect surrendered without incident before the canine was deployed. Troopers were not injured but one patrol vehicle was incapacitated from the PIT maneuvers. Jackson was being held without bond in the Newton County Jail.

tiffs — including Humphries and the local chapter of the Sons of Confederate Veterans — must have had legal standing to sue the county by showing they

resided in Newton County and would be harmed in some way by the county government removing a monument in violation of state law.

only Humphries had shown she was a resident of Newton County, the justices stated in the ruling. The Confederate

Veterans group's Georgia division said in a statement it was "pleased with the opinion as it clarifies the law as to standing and paves the way for successful litigation in the future."

"It also makes clear that injunctive relief is a valid remedy for plaintiffs, ending those defenses raised by a number of county and city governments."

Professor Fred Smith Jr. of the **Emory University** School of Law said he believes the ruling opens the door for the Confederate Veterans groups to find individuals willing to file injunction lawsuits similar to Humphries.

He said he did not believe Newton County can appeal the ruling to the U.S. Supreme Court because the state Supreme Court acted on an alleged violation of state law.

The Court decided Humphries had legal standing for the injunction based on past interpretations of how legal standing is established in Georgia courts — rather than the standard established in federal courts used by the Superior Court and Court of Appeals, he said.

"They're saying our traditions differ." Smith said.

The justices noted in the ruling that the state law in question, OCGA 50-3-1, "prohibits the relocation, removal, concealment or alteration of a monument, and makes liable any conduct that damages, destroys, loses a monument or removes one without replacement."

"Government at all levels has a legal duty to follow the law ... and the violation of that legal duty constitutes an injury that our case law has recognized as conferring standing to those community stakeholders, even if the plaintiff suffered no individualized injury," the ruling stated.

"Applying that framework to this case, (Tiffany) Humphries, as a private citizen, has standing to assert a claim for injunctive relief against her local county government for its planned removal of a Confederate monument in alleged violation of (state law).

"But the other plaintiffs — the various Sons of Confederate Veterans entities have not shown that they are members of the communities the governments of which they seek to sue, and they have alleged no other cognizable injury sufficient to establish their standing.

"The various Sons of Confederate Veterans groups did not allege that they are citizens,

residents or taxpayers of any county, much less the counties that they sued.

"The Court of Appeals was therefore wrong to affirm the dismissal of Humphries's complaint for a lack of standing as to her claim for injunctive relief, but it was right to affirm the dismissal of the complaints filed by the various Sons of Confederate Veterans groups."

But the ruling also stated that none of the plaintiffs could collect damages they sought in their original lawsuit — first filed in July 2020 from Newton County government because they could not prove they had been harmed in some way by the Covington statue's removal because it is still standing, they

Newton County government officials did not return requests for comment on the ruling.

General Election featuring heavily contested and highly publicized races for governor and a U.S. Senate seat representing Georgia.

Some voters reported needing only about 40 minutes to wait in line and complete a somewhat lengthy ballot.

However, others in Newton County may have needed more time to read the ballot and make their choices.

The General Election ballot included contested races for seats

in the U.S. Senate and U.S. House; top state government positions including governor and lieutenant governor; seats in the Georgia General Assembly, Newton County Commission and School Board; and a SPLOST referendum for all voters living within Newton County, a homestead exemption question only for city of Covington residents, and two state constitutional amendment questions.

Statewide, voters had recorded record-breaking turnout by Thursday after more than 1.1 million voters casting their ballots during Early Voting, Secretary of State Brad Raffensperger reported.

A total of 118,489 voted on Wednesday, Oct. 26, which was 22% above the Day 10 total of early voters in 2018 midterms, Raffensperger reported.

The entire 10-day total in Georgia was nearly twice the number of the first 10 days of Early Voting in 2018, he said.

"Georgia is demonstrating to the nation why our election system is the gold standard for security,

accessibility and accuracy," Raffensperger said. "County election directors are our everyday heroes."

In addition, as of Thursday, 118,312 ballots had been returned to county election offices. Only 851 ballots have been rejected statewide, the Secretary of State's office

said in a news release. "Reports of long lines were rare, with some lines in the metro areas being reported. No substantial delays were reported yesterday," the release stated

Thursday. Turnout is expected to increase during the last week of the Advance Voting period, the release said.

Johnson went for another big gain of 55-yards on the next drive to help the Rams get into field goal range to go up 10-0.


Following the field goal, the Rams and Comets got into a defensive slug fest as the two teams traded punt after punt. The Comets were able to convert after a blocked punt

No. 1 Bulldogs enter toughest part of schedule today against Florida

The defending national champion Georgia Bulldogs have won nine consecutive games and 25 of 26 since losing to Florida in 2020 in the rivalry dubbed the "World's Largest Outdoor Cocktail Party."

Georgia is entering the toughest part of its schedule, a four-game stretch that begins against the Gators and includes No. 3 Tennessee at home and then Mississippi State and 19th-ranked Kentucky on

If the Bulldogs win them all, they would be a virtual lock to return to the College Football Playoff. Florida, meanwhile, has lost 11 of its last 14 conference games.

KEY MATCHUP

Florida's third-down defense has been dreadful all season. The Gators rank 130th out of 131 Football Bowl Subdivision teams on the so-called "money down" and now face Georgia, which leads the SEC and ranks ninth nationally in third-down conversions. Florida has allowed a 52.6% conversion rate; Georgia has converted 52.4% of the time.
