Local civic group 'goes green' through bee hives project

COVINGTON, Ga. — Scott A. Emmons Water Reclamation Facility in Stanton Springs is buzzing after the Rotary Club of Covington recently wrapped up a bee hive project.

Part of the initiatives for the Rotary District 6910 the district that Covington's club falls under — for the 2021-22 year was "Go Green." In conjunction with various local partners, the Rotary Club of Covington answered the call to complete an environmental-minded project with the bee hives. Bryan Fazio, president of the Covington Rotary Club, said the idea to bring hives to the area came after Marcus Pollard, who leads the Agriculture Education Department at the Newton County College and Career Academy, spoke to the club.

Program allows area professionals to help young people navigate school, life

COVINGTON, Ga. — Superior Court Judge Cheveda Mc-Camy is hoping her work in the Newton Mentoring Program helps give some young people the tools to safely navigate personal challenges before they show up before her in criminal

And Samorya Evans, a federal food scientist and budding actress, hopes her work with the mentoring program helps some young people navigate their ways through school to a brighter future and career.

Both are participants in a program that is a nonprofit founded and developed in 2008 by the late Superior Court Judge Horace Johnson Jr.

It is designed to help provide some support for public school students in grades kindergarten through 12, said program coordinator Ruth Banks.

Newton Mentoring Program Inc. places an adult volunteer with a mentee after the adult

Spencer Hudson

Spencer Hudson, the beloved son of longtime Covington residents Felton and Jennifer Hudson and friend to so many, passed away suddenly and unexpectedly into never fading memories on March 20, 2022.

Besides his mother and father, Spencer leaves behind his love, Ellie Kang and many close relatives too many to enumerate here. He loved them all dearly and they know well of their place in his heart. Spencer's grandparents Charles and Quigg Piper and Charles Hudson and Ann Townley preceded him in death but not in his love.

Spencer was born on Sept. 29, 1975, and though his life was cut short by a random act of violence, his 46 years of life was full by any standard of measure. He traveled the world over and visited

concerned with the care

over 90 countries-making two trips around the earth-once going east and once west. He never counted airport stops or layovers as visits and would often stay months if he was stirred by the country to give more of his time. He was a man of the earth, especially

of our only residence; overpopulation, ecology and the need for all our caring for it. This was evidenced by his visits to over 25 National Parks. Litter was an anathema to Spencer and he routinely picked up trash in reverence to mother earth.

Spencer loved sports and participated in many, including basketball, golf, soccer and tennis. His love of soccer and world travel was manifested in attending the last five World Cups held in France, Germany, Russia, Brazil and South Africa. Sadly, he will miss the world cup being held in Qatar this year. Spencer's knowledge of college basketball was impressive. His travels, studies and mastery of words made him a very formidable trivia player.

Spencer's education includes a Bachelor of Science degree majoring in History from the University of Massachusetts in Boston. He also attended the University of Georgia (though he always remained a strong Georgia Tech football fan,) and the University of Montana as part of his undergraduate experience. His post graduate efforts included significant course work at the City College of New York and the University of New Orleans. Spencer's personal quest of knowledge was ongoing and not limited to college classrooms. He possessed a personal library of over 1,045 books of value and substance. Of his library books, he had read, by count, over 972 books with the remaining 73 on his queue for future reading.

Spencer's death resulted from a senseless and random act of violence we see often in America today and happened as he worked hard in his job on Bourbon Street in New Orleans — a city he loved and had resided for many years. It was not a case of being at the wrong place at the wrong time. Our hope is that his death will have some positive influence in changing this lack of respect for human life and dignity we see pervading and destroying our country.

A memorial service will be held locally for family and friends and will be announced. His death has left a giant hole in the hearts of all who had the privilege of knowing this magnificent man.

State Senate sends tax break bills to Gov. Kemp's desk

The Georgia Senate gave final passage Wednesday to several bills offering tax breaks to various types of businesses.

House Bill 1041, which passed unanimously, would increase the annual cap on the state's rural hospital tax credit program from the current \$60 million a year to \$75 million. The original version had called for raising the annual limit to \$100

Eight rural hospitals in Georgia have closed during the last decade for lack of operating funds, said Sen. Billy Hickman, R-Statesboro, who carried the House bill in the Senate.

"Without a rural hospital, a community is not viable," he said. "And without being viable, a community

The rural hospital tax credit offers dollar-for-dollar credits to taxpayers who donate to a rural hospital in their community.

Hickman said the \$60 million cap on the tax credit last year was reached in August. This year, donations to rural hospitals are running 75% ahead of last year,

Lt. Gov. Geoff Duncan, who was instrumental in creating the tax credit in 2016 as a member of the state House of Representatives, said the key to its success has been its flexibility.

"We don't try to sit in this building and tell [rural hospitals] how to spend those dollars," said Duncan, who presides over the Senate

The Senate also voted 48-6 to exempt from state sales taxes the purchase of tickets to nonrecurring major sporting events held in Georgia.

Sponsors of events including the Super Bowl, college basketball's Final Four, the college football playoffs and soccer's World Cup demand tax breaks on ticket sales from host states, said Sen. John Albers, R-Roswell, who carried House Bill 1034 in the

Senate.

The Final Four generated more than \$100 million in economic impact in 2013, the last time it was held in Atlanta, Albers said.

"We know the economic results of getting one of these," he said.

Senators also voted 50-1 to offer Georgia's timber industry the same exemption from property taxes on equipment used in timber harvesting that already goes to the purchasers of farm equipment.

"This bill is long overdue to bring equity and relief for our forestry community," said Sen. Larry Walker III, R-Perry, who carried House Bill 997 in the Senate.

The tax break will be subject to a statewide referendum before it can take effect.

All three bills now head to Gov. Brian Kemp for his signature. —Capitol Beat News

Georgia suing feds over transportation mask mandate

Georgia is challenging a mask mandate the Biden administration has imposed on public transportation and at transit hubs.

A lawsuit filed by Attorney General Chris Carr and Gov. Brian Kemp charges the mandate is an unconstitutional overreach of

federal power. The suit comes even as the federal Centers for Disease Control and Prevention (CDC) has walked back similar masking guidance, the White House itself has ended its mask mandate for federal buildings and states with some of the most restrictive COVID-19 policies have lifted their mask

mandates. "This mask mandate was unlawful from

the very beginning," Carr said. "Yet, the Biden administration has once again inexplicably extended its policy despite recent science-based developments that would indicate otherwise.

"The CDC does not have the authority to force everyone, including children, to wear a mask on public transportation, and to continue to do so is unnecessarily burdensome to both travelers and the industry alike."

The mandate applies to airplanes, trains, buses, ships and other modes of transportation. Specifically, the rule requires that masks be worn by all personnel and passengers two years of age and older.

"Though it is just one of many egregious federal mandates imposed by their heavy government hand, this mandate in particular has caused a rise in tensions and incidents between personnel and customers and unnecessarily divided people," Kemp said. "At this point where cases are dropping and more and more people are taking advantage of the vaccine, travelers should be able to make the choice for themselves about whether or not they want to wear a

mask.' Kemp also has fought mask mandates at the state level. Legislation introduced into the General Assembly on the governor's behalf prohibiting school districts in Georgia from imposing mask requirements gained final passage last week, and Kemp signed the bill on

Tuesday. With the new federal lawsuit, Kemp and Carr have now filed five separate legal challenges to the Biden administration's vaccine and mask mandates. In

one of those cases, the U.S. Supreme Court overturned a vaccine mandate applying to businesses with 100 or more employees.

Twenty other Republican-led states have joined Georgia in the new federal suit, including Alabama, Florida and South Carolina. The suit was filed in the U.S. District Court in Tampa.

Georgia Senate committee abandons controversial election law changes

A state Senate Committee Tuesday scrapped every part of a controversial Republican-backed election bill, leaving only a provision that would expand Georgians' ability to vote.

The version of House Bill 1464 the Senate **Ethics Committee** approved unanimously would require employers to give their workers up to two hours off to cast a ballot during the early voting period prior to an election. That would expand upon legislation the General Assembly enacted last year allowing employees time off from their jobs to vote on Election Day.

"This just broadens the ability to vote," said state Rep. James Burchett, R-Waycross, the bill's chief sponsor.

"It's certainly good for the voter and good for the employer," added Sen. Max Burns, R-Sylvania, the Ethics Committee's chairman.

When the bill left the House two weeks ago after passing on a party-line vote, it contained provisions aimed at ensuring ballot security through tighter controls on the transfer and custody of ballots. It also would have authorized the Georgia

Bureau of Investigation to investigate complaints of voter fraud without being asked by local authorities, derided by critics as the "election police" provision.

Voting rights groups and local elections officials packed committee rooms during hearings on the bill, reminding Republican lawmakers that GOP Gov. Brian Kemp had promised not to push for further election law changes this year after last year's comprehensive overhaul of Georgia's election laws.

Senate Republicans responded by backing away from the bill's controversial provisions, at least for now.

"This is one of the most politicized issues across the country," Burchett said. "We'll just continue working on these issues that were in the bill and try to find some middle

Kemp delivers Crime **Suppression Unit's** first year results

The multi-agency Crime Suppression Unit Gov. Brian Kemp put together last April to fight a crime wave apprehended 26 murder suspects and made 214 drug arrests during its first year in operation.

Kemp gave a progress report on the unit on Wednesday. The state and metro-Atlanta law enforcement agencies that make up the unit also arrested 451 wanted persons, made more than 23,600 vehicle stops – including 588 for driving under the influence – and impounded about 1,300 vehicles, the governor reported.

"We're going to keep chopping, keep up the good work and go even harder in taking the fight to the street gangs and criminals," Kemp

America's looking for fresh programming

ndrew Jackson and John Quincy Adams did it. So did Martin Van Buren and William Henry

Harrison. Grover Cleveland and Benjamin Harrison, too. Also William Jennings Bryan and William McKinley.



And of course, Dwight D. Eisenhower and Adlai Stevenson.

Presidential election reruns are not unknown in our history; they happened frequently in the nation's early years. But there hasn't been one in twothirds of a century, though we may be approaching one in 2024. Joe Biden versus Donald Trump: The Sequel.

We may yearn to see the

oldest hitter (Albert Pujols, 42) face the oldest pitcher (Justin Verlander, 39) this season, and if the Cardinals end up facing the Astros in the World Series, we may have the chance. We would have loved to see the two oldest Grand Slam champions (Ken Rosewall, 37 at the time, and Roger Federer, a youthful 36) face each other, but they are of different eras and, in a way, different eras of men's tennis. And what might you give to see the two ancient hockey mariners from Saskatchewan, Gordie Howe (52 in his last outing) go up against goalie Johnny Bower (45 in his) once more?

Biden and Trump? Not so

Despite their efforts at appearing youthful and exuberant, the president and the pretender look tired right now. And in truth, the American people are tired of both of

Seldom if ever — reliable public-opinion polls aren't even a century old — have two leading politicians been so poorly regarded by the

public. Biden's approval rating is 43%, according to YouGov. Trump's favorability rating is 38%. (Ukraine President Volodymyr Zelenskyy stood at 67% among Americans in a poll taken before his poignant remarks to Congress more than two weeks ago.)

Ballotpedia's polling average indicates that Biden's ratings are about 7 percentage points above Trump's at this point in their respective presidencies. But that is hardly good news for the president. The rate of Americans who believe the country is going in the right direction is about the same for both leaders.

Biden at least has the chance to improve his ratings; Ronald Reagan stood at about the Biden level just after the midterm congressional elections of 1982, but by the eve of his reelection in 1984, he stood at 58%.

Trump has fewer opportunities for boosting his approval ratings, and in historical terms he is in dangerous territory far worse than the last two presidents who were defeated for reelection.

At this relative point after his presidential defeat, Jimmy Carter — the president to whom Trump ardently resists comparison - recorded a 54% favorability, according to the Los Angeles Times poll. George H.W. Bush — a figure Trump reviles with special enmity — stood at 76% in the Times Mirror poll. That is exactly twice the figure Trump receives from a public he hopes will return him to the presidency. (Both defeated presidents gracefully left politics, Carter becoming the personification of good works, and Bush becoming the personification of a good

Bryan was 48 the third time he ran for president; Richard Nixon was 59 the third time he sought the office, and Hen-

ry Clay was 67. Trump would be 78. Democratic Rep. Alexandria Ocasio-Cortez of New York is less than half his age. GOP Rep. Madison Cawthorn of North Carolina, who argues Trump prevailed in 2020, won't even be 30 in 2024. Age, of course, is no deter-

rent to greatness in leadership; Winston Churchill was 65 when he became British prime minister and was 80 when he finally left office, the same age of Nelson Mandela when he left the presidency of South Africa.

But the contenders of 2020, both angling for a 2024 rematch, oftentimes look like spent forces.

The American public may like the policy Biden is pursuing with regard to Ukraine, for example, but they like the man less. (Though his ratings have inched up since the war there began, he is not experiencing the rally-round-theflag phenomenon that customarily occurs during crises; both President Bushes enjoyed robust poll ratings after Desert Storm and the Sept. 11, 2001, terrorist attacks, respectively.) Trump is attracting smaller crowds at his rallies, and many of the candidates he has endorsed in Republican primaries have dim prospects to be nominated. This is especially true in Alabama,

Georgia and Michigan. There is in all this a distinct advantage for Republicans. The Democrats may control both houses of Congress, but their high-profile bench is thin. Quick: Name four Democrats, besides the 80-year-old Bernie Sanders of Vermont and the 12-year-old Elizabeth Warren, who could plausibly run a strong presidential race. You might come up with Transportation Secretary Pete Buttigieg, who is 40. And of course Vice President Kamala

It was a labor of love when I served 15 years as treasurer of the Joint Development Authority (JDA) of Newton, Morgan, Walton and Jasper Counties. The JDA was created to bring to fruition the vision of my good friend, the late Davis Morgan, Chairman of the Newton County Board of Commissioners (BOC), who foresaw a multi-county technology park that would bring high-tech investment and well-paying jobs to this rural regional community. Each Board of Commissioners named one of its own as members to the JDA, then selected citizen members, and Morgan County chose Alan Verner, a native with a sterling family reputation. Alan

would serve 21 years, 15 of those as chair. No one was paid for his or her time and

There was a clear delineation of duties: the BOC's of the four counties directed and were aware of all activities of the JDA board. The public had access and transparency, if they chose to follow developments and meeting agendas. None of the board members actively recruited any industries. That job was left to the state and local economic development officials. When it came to Rivian, the EV manufacturer, the land assembled was done at the request of the State of Georgia economic development officials. The JDA was simply the vehicle, and Alan

Verner stepped down when the intentions of the state and Rivian became clear. He would not sully the Verner good name acquired over generations in Morgan County, and surely not for the percep-

tion of ill-gotten gains. Alan Verner did everything in his power to avoid any conflict of interest and never once promoted his family's land. There was no secret, and there is nothing suspect about Alan Verner's behavior. Those who question Alan's motives and actions would best review their own. A good man is being improperly and unjustly maligned.

Russians share thoughts on Ukraine invasion

inden Longino is a retired Atlanta banker who should have Nobel Peace Prize recipient next to

his name. In 1995, Longino started a program in connection with the Carter

Center called International Paint Pals, an idea simple, ingenious and oh-so needed – inspire children to promote peace, friendship and human rights by creating personal artwork.

Since its inception, International Paint Pals has involved more than 200,000 kids, ages 5-19 from over 125 countries. Their art has been displayed in venues around the world from universities, museums, Nobel Peace Summits to the Olympic Games.

His organization was considered for the Nobel Peace Prize in 2020. In my opinion, no one was more deserving. I have seen examples of the works from young people of all races and religions from across the globe. All creatively expressing their hopes for Peace on Earth through their art.

Longino describes his organization's mission this way: "Children everywhere have natural seeds of tolerance and peace in their minds and hearts. Our goal is to nourish these seeds." In other words, let's teach them to love before they learn to hate.

Currently, he has a group of young people making welcome cards for Ukrainian cancer patients, who are arriving at St. Jude Children's Cancer

Hospital in Memphis. Unfortunately, for Vladimir Putin art is about the art of war, a feeling not necessarily shared by the Russian people. In the midst of the invasion of Ukraine, Longino told me he had reached out to several Russian friends who had assisted him over the years with his International Paint Pals work.

"Since Putin invaded Ukraine a month ago," he said, "I have been in regular email contact with eight of them — good people in a desperate country taken over by an evil president. One asked me to let my friends here know their feelings and I want to honor that request with you." And I, in turn, share with you.

The group consists of eight men and women ranging in age from 39-75, all involved in Russia's arts industry. Seven live in St. Petersburg and one in Rostov-on-Don, only 400 miles from Russia's border with eastern Ukraine which Longino says is "terrifyingly close

if the bombed Ukrainian nuclear power plant had exploded and may still."

Here are some excerpts from their comments to him: "Unfortunately I cannot tell you all, I think via email. I believe you know what I meen (sic.) It is like one brother comes against other one. Believe me, I would be happy out of this country, but I am stuck here."

"Today I met with a business partner who is from Ukraine. I had never met her before. I do not know anything about her life. But we hugged and cried together. We are all the same."

- "It is very sad and troubling time indeed. The work of our Art Institute in St. Petersburg is stopped. I hope so very much that peaceful solutions will be found very soon." "Hope these terrible

times will finish as quick as it's possible. And we will meet again in free and peaceful world." - "The world's got ab-

solutely mad, mad, mad, mad! But we do believe that reason will prevail and common sense will make people stop fighting against each other.'

 "It is a pity that today humanity has lost the qualities that man was original ly endowed with. And it's only getting worse."

"I am clearly understand that if some country will use nucliar (sic) weapon it is the end of the world. The main thing right now is to stay calm and believe in friendship and peace."

— "I seriously think about escaping from Russia, but where and how is really serious question for us."

To Longino's dismay, one correspondent has bought into Putin's propaganda that he is getting rid of Nazis who control Ukraine. "I know that the media are trying to portray Russia as an aggressor. Russia has to fight against Nazism, which flourishes in Ukraine thanks to the support of the West." There is always

one in every crowd. Vladimir Putin was born in 1952, 43 years before the formation of International Paint Pals. You have to wonder what the world might be like today if as a child, Putin had been inspired by someone to create and share with the world his own personal artwork promoting peace and friendship. It is Linden Longino's hope that we will never have to ask a question like that in the future.

Mitch Landrieu? The Republicans are loaded, as envious Big Ten college football coaches say when they contemplate a conference rival with 17 returning starters. (This year that's Iowa, whose nine returning offensive players include quarterback Spencer Petras.) There are six plausible GOP nominees under the age of 60: governors Ron DeSantis of Florida and Chris

Sununu of New Hampshire, senators Ted Cruz of Texas and Marco Rubio of Florida, former Gov. Nikki Haley of South Carolina, and former Secretary of State Mike Pompeo. Former Vice President Mike Pence is 62.

But presidential campaigns are factories of familiarity. Who outside Indiana had heard of Buttigieg before his 2020 campaign? Who -- again outside Indiana, though you could add Wall Street -- had heard of Wendell Willkie in 1939? (He was the 1940 GOP presidential nominee a year later.) Dean requests removal of inaccurate signage around Oxford College

OXFORD, Ga. — During a city council meeting Monday, Oxford College Dean Doug Hicks asked councilmembers to consider removing certain signage around the campus that have been flagged by students and community members as historically inaccurate.

The recommendations are a result of conversations held during Emory University's Twin Memorial Project's work sessions,

which Hicks co-chaired along with Associate Professor of Pastoral Care and Counseling Gregory C. Ellison II.

The Twin Memorial Project seeks to honor the enslaved people who built the campus and address the university's racist past. In the past couple months, the university has hosted over 10 conversations with current students, community members and descendents of enslaved peoples who worked at the university, with the goal of

erecting two memorials on each campus.

"We've had wonderful ideas for what a memorial could look like," Hicks said. "We've had some hard conversations, but a whole lot of hope and excitement of people coming together to do this work.'

Hicks mentioned three signs he would like the councilmembers to consider removing: the plaque at the Confederate cemetery on the campus, the plaque at Kitty's Cottage and a plaque on Whatcoat Street. Hicks said he has had students in "both my office and in public forums" telling him about their negative experiences encountering these signs around campus and the discomfort such

Kitty's Cottage is the former residence in the 1840s of Catherine "Kitty" Andrew Boyd, who was enslaved by Methodist Bishop James Osgood Andrew, the first chair of the university's Board of Trustees. The plaque outside of the cottage, which was created only three decades ago, states that Andrew offered to send Boyd to Liberia but that Boyd "preferred to remain with the Andrew family rather than be sent to

Students and Oxford community members have taken issue with and said that it paints an inaccurate view of history.

"Those are hard

words that don't seem to reflect where our thinking is and where our understanding of history is," Hicks said. "That she chose to be

a slave, that she was a mulatto and that she was only technically a slave and that she was as free as the law and society would allow. "We all know that the

law and society at that time did not allow her to be free. So, she may well have been loved and a part of the community, but freedom is not a term we should use. Those are the kind of sentiments that my students share with me."

Additionally, community members have taken issue with the plaque in the Confederate cemetery on Oxford's campus, which refers to the Confederate soldiers buried there as "our soldiers."

The sign on Whatcoat Street, which gives an overview of the college's history, makes no mention of the enslaved peoples who built the campus buildings and reiterates the incomplete truth told on the plaque at Kitty's

Cottage. "I wanted to come and share some of the things that we are doing at the college and ask that we might be partners in this work and invite citizens to stand with you all as leaders to remove signs that are relatively recent but are inaccurate, or at least not complete, in what

McCamy also said mentoring someone one-on-one was a new experience for her. She said she had mentored groups of law students and others in her previous role as a chief assistant district attorney in Henry County before Gov. Brian Kemp appointed her to a Newton County Superior Court judgeship left vacant by Johnson's death in July 2020.

She said it may not have "dawned" on her mentee that her mentor decides cases involving serious crimes or bitter divorces.

McCamy also said she wanted to mentor an older student because it would better suit her personality.

"I tend to be kind of direct," McCamy said.

Evans mentors two students in widely different age groups — an Eastside High School student and a Flint Hill Elementary School third-grader with which she recently began working.

The Waynesboro native's career as a U.S. Department of Agriculture commodity grader and Farm Service Agency administrator took her throughout the country before she returned to Georgia and settled in Newton County.

She is now pursuing acting as a second career but also continues to seek fellowships and remain active in the food science industry.

Evans' experience growing up showed her "it takes a village" such as church leaders and coaches — to help young people remain on paths that will lead them to success in life and career.

Those early influences led her to become an honors graduate of Fort Valley State University where she earned degrees in Food & Nutritional Sciences and Animal Sciences.

Evans said she knows there are few Black women working in the field of food and animal science. She said she hopes to be an example of someone who pursued a career path that interested her and achieved it by maintaining "good character," working hard and

getting educated. She said she knows events of recent years the pandemic, a changing economy, the rise of social media have resulted in young people "hurting emo-

tionally." Evans said she also knows young people often will turn to someone they trust rather than their parents for guidance.

She said she tries to help her mentees face a range of challenges from dealing with personal problems to developing homework strategies.

Evans said she works to encourage her 11thgrade mentee to pursue higher learning and apply for scholarships.

"I tell her I'm proud of her," she said.

Georgia Assembly authorizes study committee to plan rollout of EV charging stations

ATLANTA — The General Assembly has decided it needs more time to prepare for the coming wave of electric vehicles.

The state House of Representatives voted unanimously this week to create a joint study committee to develop a plan for rolling out a network of electric vehicle charging

stations across Georgia. The Georgia Senate passed the resolution two weeks ago, also in a unanimous vote.

"EVs are here. We see them all around us," House Transportation Committee Chairman Rick Jasperse, R-Jasper, told House members shortly before Wednesday's vote. "But one part that's lacking is charging infrastructure in this state."

The U.S. Department of Energy has allocated \$160 million to build EV charging stations in Georgia during the next five years, primarily along interstate highways.

Several bills were introduced in the General Assembly this year setting regulations governing the construction of charging stations. But when none of the bills made it through

either legislative chamber by the mid-March Crossover Day deadline, lawmakers decided to form a study committee to do a deep dive on the issue this summer and and potentially come up with legislation for consideration next year.

Rep. Alan Powell, R-Hartwell, said time is of the essence if Georgia is to keep up with the growing proliferation of electric vehicles.

"The future of this country in transportation is all-electric vehicles," he said. "We need to get our ducks in a row so we're not in the same situation we were in with broadband.'

The joint committee will will have until Dec. 1 to make recommendations.

to protest at the State Capitol in Atlanta on Friday to bring attention to allegations about lack of information on environmental impacts and their complaints being "all but ignored" by Gov. Brian Kemp.

It plans to hold a "peaceful protest" from 11 a.m.-2 p.m. at the state Capitol so state legislators can hear them before the end of the 2022 session of the Georgia General Assembly, said spokesman Chas Moore.

"Since the state took ownership of the proposed EV (and) battery plant in February there have been no permits issued yet transfer of ownership of property to the JDA is due to start in April and construction is rumored to be scheduled immediately after that," he said.

He said many who live near the site are still waiting on an Army Corps of Engineers environmental impact statement as well as site locations, wetland permits and plans for waste management, among other required documents,

Moore said. In addition, Moore said Say No 2Rivian

plans to hold a prayer vigil about their environmental concerns at the planned Rivian site Sunday.

Group members plan to gather at the site on Davis Academy Road near Rutledge "and stand together shoulder to shoulder in unity as a community to use the power of prayer and ... focused intention to stop the land from being used for toxic industrial use," Moore

"We are a caring community that want God's will to be done and for there to be peace in our communities, that we have done everything we can to protect our precious resources," he said.

The Rivian project was announced in December. It will create 7,500 jobs and be a \$5 billion capital investment, company officials said. A new Technical College System of Georgia training center and a new interchange on I-20 will be included.

The state government took charge of the Rivian project in February in agreement with the Joint Development Authority (JDA) of Jasper, Morgan, Newton

and Walton Counties, officials said.

State Economic **Development Commis**sioner Pat Wilson said the state of Georgia will work "collectively with all four counties to ensure a unified and streamlined approach to project development to ensure consistent, uniform conditions across the site."

The action also allows state officials to work on the planned 16-million-square-foot project without having to go through local planning agencies.

However, Wilson said the state of Georgia will ensure the project planned for a site straddling the line between Walton and Morgan counties — follow locally required standards pertaining to water quality, groundwater recharge and runoff, and all local environmental ordinances.

Wilson also announced committees would be formed to meet in public and focus on Workforce Development; Local Business Engagement; Site Design and Environmental; and Quality of Life.

Moore said Sunday's vigil will be adjacent

to the former farmland owned by the Verner

family. Opponents have questioned the involvement of one member of the family, Alan Verner, in negotiations with Rivian while he served as chairman of the Joint Development Authority (JDA) of Jasper, Morgan, Newton and Walton Counties.

The JDA worked throughout 2021 to negotiate the deal for Rivian Inc. to plan an EV production and research facility and state government job training center on the 2,000acre site straddling the line between Walton and Morgan counties along I-20 near U.S. Hwy. 278.

JDA officials have said Verner recused himself from all land negotiations with Rivian and said he "was not involved in any decisions regarding the project (and) had no inside knowledge or influence on this situation."

The JDA followed state law which governs development authorities engaging in transactions with its members, said JDA attorney

Andrea Gray. The Development Authority of Walton County marketed the site starting in 2018 and the JDA never marketed the East Atlanta Megasite where Rivian plans to build, Gray said.

"The JDA created and began marketing Stanton Springs North, which is 665 acres in May 2021," Gray said. "The 665 acres owned by the JDA does not abut property owned by Alan Verner.'

JDA bought that land last year to build a frontage road as part of an agreement with Baymare LLC (now Morning Hornet LLC), which said last year it would build a data center at the original Stanton Springs South

in a \$42 billion deal. "Rivian's interest

in the site was not the main reason the JDA purchased the 665 acres," Gray said. "At that time, Georgia was only one of the many sites on Rivian's list of potential choices. Without Rivian, the JDA would have constructed the frontage road and marketed it for industrial tenants."

Gray also defended the JDA against the allegations by Rivian opponents that the authority acted unethically in pursuing the company. She called those accusations "completely without merit," saying the JDA followed open meetings laws and other best practices.

sponded to the 10:42 p.m. report of a fire at the Thai restaurant and found an ongoing blaze, said Covington Fire Marshal Joe Doss.

He said city investigators have determined the fire began in the kitchen area. However, the cause of the fire is listed as "undetermined" because the probe has been turned over to investigators working for an attorney, Doss said.

"Our investigation ... we have an origin, a location, but the cause is going to be 'undetermined' because the private investigators are taking that over. It's in their hands right now," Doss said.

The restaurant, which specializes in geniune Thai cuisine, is located on the south side of U.S. 278 near the highway's I-20 interchange. It opened in 2009.

The restaurant's owners did not return a call for comment.

Employed residents, labor force increased in Newton

COVINGTON, Ga. — Newton residents who found jobs in February more than offset the increase in unemployed county residents and kept the jobless rate below pre-pandemic levels.

However, more county residents also made themselves available for work in February which kept the unemployment rate from dropping compared to the previous month, the Georgia Department of Labor reported.

The county's labor force — all Newton residents working or making themselves available for work — increased by 506 residents in February to 54,962, the state labor department said.

An additional 480 found work in February and increased the number of employed Newton residents to 52,944.

An additional 26 Newton residents were listed as unemployed which increased the total to 2,018 looking for work.

Newton County's February 2022 jobless rate of 3.7% did not change from the previous month. It dropped from February 2021 when it was 5.2% in the midst of the COVID-19 pandemic.

The February 2022 rate also was lower than the February 2020 rate of 3.8% — one month before the COVID-19 pandemic — and was lower than the pre-pandemic era rate of 4.4% in February 2019.

Newton County residents filing claims for unemployment benefits in February (302) also

rose slightly from January (296). It was down significantly (74%) from 1,163 filing claims in February 2021.

In comparison to neighboring counties, Newton's February 2022 jobless rate was lower than Rockdale (3.8%) but higher than every other neighbor.

Neighboring county jobless rates included Henry, 3.4%; Butts and Morgan, 2.9%; Walton, 2.8%; and Jasper, 2.7%.

Newton's rate was higher than the 29-county Metro Atlanta area (3.2%) and Georgia's statewide rate (3.3%), but was below the national rate of 4.1%.

Georgia Labor Commissioner Mark Butler praised gains he saw statewide in February for keeping Georgia's unemployment rate at 3.3%.

"Thanks to the hard work of many Georgians, February saw gains in jobs, labor force and the number of employed for much of the state," Butler said in a news release. "As we look towards the spring and summer months, we remain committed to working with employers as they continue to fill open positions with suitable job seekers."

The labor force increased in Metro Atlanta by 29,205 and ended the month at an alltime high of 3.2 million — up 106,667 since February 2021.

The number of employed was up 30,023 to 3.12 million, an all-time high, in February from January, the news release stated. From February 2021 to February 2022, the number of employed

was up 150,089.

The number of unemployed decreased by 818 to 103,736 from January. From February 2021 to February 2022, the number of unemployed was down

43,422. Metro Atlanta ended February with 2.9 million jobs. Jobs were up 34,100 (1.2%) over the month and up 174,400 (6.4%)

over the year. Job numbers were at an all-time high in Information, 116,400, Financial Activities, 192,400, Professional and Business Services, 583,600, including the Professional, Scientific, and Technical sector, 255,700, and the Administrative and Support Services sector, 249,500, and in Education and Health Services, 385,100, including the Health Care and Social Assis-

tance sector, 317,800. The sectors with the most over-the-month job gains included Administrative and Support Services, 9,300, Accommodation and Food Services, 6,300, Professional, Scientific, and Technical Services, 3,300, Retail Trade, 2,400, and Health Care and Social Assistance, 2,000.

The number of initial unemployment claims went down by 7% in Atlanta in February. When compared to last February, claims were down by about 79%.

Employ Georgia, the GDOL's online job listing service at employgeorgia.com showed about 90,200 active job postings in metro Atlanta for February.

County gas prices continue steady decline

- Average fuel prices across Newton County are approximately 12 cents lower than compared to just more than a week ago.

As of Wednesday, March 30, the average price for a gallon of regular gasoline in Newton was \$3.97, according to AAA. On Monday, March 21, the average price was \$4.18.

Statewide, the average Wednesday was \$3.93 compared to \$4.12 on March 21.

Part of the the decrease could be attributed to the temporary suspension of the state gas tax, which was reportedly expected to save Georgia motorists about 29 cents per gallon. Another contributing factor is a drop in oil prices; but, experts say that could change in the coming days.

"Georgians continue to see savings at the pumps compared to a week ago," AAA spokesperson Montrae Waiters said in a March 28 news re lease. "However, if oil prices continue to rise, gas prices will likely follow suit, possibly reversing course from the current downward trend."

According to data from the Energy Information Administration (EIA), total domestic gasoline stocks fell by 3 million barrels to 238 million barrels last week. Gasoline demand also decreased from 8.94 million barrels a day to 8.63 million barrels a day.

At the close of last Wednesday's formal trading session, WTI increased by \$5.66 to settle at \$114.93. Crude prices climbed after EIA's weekly report revealed that total domestic crude stocks declined last week by 2.5 million barrels to 413.4 million barrels, approximately 18% lower than the level in mid-March 2021. The current inventory level highlights tightness in the market, contributing to rising prices.
