Georgia Votes 2022

Election officials talk changes to absentee ballot deadlines, drop box, advance voting locations

COVINGTON, Ga. — Elections officials recently gave information on changes to state elections laws since 2020 concerning absentee ballots and Newton County's two advance voting locations May 2 for the upcoming primary elections.

The deadline is approaching to apply for an absentee ballot for the upcoming General Election primary.

However, changes the Georgia General Assembly approved in 2021 to the state's voting laws mean the system of casting an absentee ballot has changed for the 2022 elections.

Deadline for applications for absentee ballots for the upcoming primary election is Friday, May 13. Voter information and absentee ballot applications can be found on www.mvp.sos. ga.gov/MVP/mvp.do.

Absentee ballots can be mailed as usual. They also can be placed in a drop box, which is only accessible during business hours inside the Elections and Voter Registration office during the advance voting period May 2-20, according to

elections officials. The ballots can be placed in the box located inside the front office of the Elections office in Suite 103 on the first floor of the Newton County Administration Building at 1113 Usher St. in Covington Monday through Friday, May 2-24, from 8 a.m.

The two churches replace advance voting locations used in the 2020 elections, including the Newton County Administration Building and Porter Memorial Library on Ga. Hwy. 212.

Both lacked adequate parking and indoor voting space, said Board of Elections Chairman Phil Johnson. Lines around both buildings and long waits were common during the three-week advance voting period.

This year's advance voting also includes a new Sunday voting day and an additional Saturday voting day.

We have expanded from one Saturday to two Saturdays and added a Sunday voting time," Johnson said. "That gives people the opportunity to have a day to early vote congruous with their work schedule."

"They could hear the engine trouble. Suddenly, the plane veered to the right and immediately went right down and crashed into the lot behind us — the General Mills plant that produces cereal here in our area.

"The plane went down in an isolated area here on the lot behind us near where they store tractor-trailers. The plane came down into four, what appeared to be, empty trailers.

"There's a lot of charred metal back there," he said.

However, no one on the ground was injured and it occurred in a fenced area that was roughly 400 yards away from General Mills' production plant which operates around the clock.

Malcom said he did not believe that workers had to be evacuated from the plant.

"The fire was contained in the isolated area," he said.

A witness, identified

as Roger Boyd, told reporters he was driving home from Home Depot when he saw the plane was "going real slow."

Boyd said he noticed the twin-propeller plane was not operating normally because it was about 50 yards in the air and "kind of floating."

"It was gliding very, very slowly," Boyd said. "I thought they were doing some sort of training exercise."

Malcom said plane crashes involving fatalities around Covington Airport have been rare in his three decades with the city police department.

He said firefighters from agencies in addition to the two local agencies responded to the scene because of the possibility the crash formed a wide debris field or struck multiple structures.

However, most turned back after seeing it was contained in a comparatively small area, he

Walton BOC hires first county manager The Walton County Board of Commissioners took a significant step forward when they hired John Ward III as the county's first professional manager

County Commission Chairman David Thompson told his fellow commissioners early this year he wanted to hire a manager to handle day-to-day operations of the nearly \$65 million county government.

on March 1.

Thompson said Walton was by far the largest county in Georgia that had long relied on an elected chairman to manage the daily operations of the county government rather than an appointed manager.

"It was wonderful timing," Ward said. "It was an opportunity to return to Georgia and work in a community with so many opportunities before it.

Ward will help develop and implement policies and procedures at the direction of the Board of Commissioners. He will work with the commission chairman on the county's annual budget and oversee SPLOST funds and major capital improvement projects from initial planning and design through to completion.

The new county manager said with new industries coming to the area more people also are expected to move here, as a record number of new jobs will become available. Ward said the cities, along with the county, are involved in making major enhancements to

meet coming growth. During his time in Boone, North Carolina, Ward executed a \$42 million water intake and water treatment plant upgrade project. This project was marked as the town's largest infrastructure project.

He also partnered with the Appalachian Theatre of the High Country to restore Boone's downtown 600-seat historic theatre providing cultural programming for the community.

In Jefferson, Ward oversaw construction of the 100-acre Mayor Jim Joiner Recreation Complex, the Jefferson Civic Center, the Jefferson Public Library and the Jefferson Police Department.

"My background has also been involved in securing grants for public safety (EMS) and quality of life projects (parks and recreation)," he said.

Ward said he would be involved in seeking federal and state funding to offset costs for county projects.

He holds a Master of Public Administration from Columbus State University and a Bachelor of Science in Education from the University of Georgia. His BS degree focused on Natural Resource Management. He belongs to several professional organizations, including the International City/ County Management Association as a Credentialed Manager.

Ward has had memberships in the North Carolina City & County Management Association, the Georgia City-County Management Association, the Georgia Academy for Economic Development, the Georgia Association of Chiefs of Police, the International Code Council and the Georgia Recreation & Parks Association.

"I'm excited about this new role in Walton County," Ward said. "It's a big county. There are a lot of challenges. But I see it as an opportunity. I look forward to it.

Walton County Democratic Party chair under internal investigation

Committee of the DPG is scheduled to meet regarding complaints that were brought against Mr. Garrett earlier this year," Todd said. "Until the full committee meets and renders a decision, we can't comment on internal investigations."

Todd said the county's Democratic Party is still a chartered member group of the state party.

Aside from the DPG's internal investigation, Garrett had a run-in with municipal law enforcement earlier this month following a traffic stop. Garrett was arrested by Monroe police on misdemeanor charges of obstructing an officer, no brake lights or working turn signals and removing or affixing a license plate

with intent to conceal. Garrett previously declined to comment on the misdemeanor charges against him. However, Garrett did allege before the conclusion of a Monroe City Council meeting on April 12, that he was being "targeted" by police. Garrett made the accusation after District 3 Councilman Charles "Chaz" Boyce commented that residents in his district told him they often do not feel "welcome" in their town. Boyce said he hopes the City Council can work together to

address such pressing issues as poverty and lack of affordable housing in Monroe.

Inflation putting strain on state road projects

Highway projects across Georgia are being squeezed by the increasing cost of construction materials brought on by the war in Ukraine and other inflationary pressures, a state Department of Transportation engineer said Wednesday.

The war has destroyed the Ukrainian city of Mariupol's ability to continue functioning as a major steel center, Mark Mastronardi, a deputy chief engineer with the DOT, told members of the State Transportation Board.

The U.S. imports 66% of its pig iron from Ukraine and Russia, which is now under economic sanctions imposed by the West as punishment for its attack on Ukraine, Mastronardi said.

"Ukraine is offline immediately," he said. "With the sanctions, Russia is also offline."

With strong state tax collections coming out of the pandemic, Georgia's budget has been good to state agencies, including the DOT.

The fiscal 2023 budget that takes effect July 1 earmarks \$2.2 billion for the DOT, up from \$1.7 billion in the original fiscal 2022 spending plan. About 48% of the agency's budget — just over \$1 billion — will go toward capital projects

in the coming year. Rising construction costs, however, are a growing concern, and not just for steel.

Mastronardi said the costs of other construction materials including

asphalt and concrete also are soaring, which is driving up highway contractors' bids for road resurfacing and other projects.

"That's having a real impact on us as an agency," he said.

Georgia Commissioner of Transportation Russell McMurry said while it's important to keep needed transportation projects moving forward, the DOT has a responsibility to taxpayers.

Mastronardi said the agency also is considering extending the length of contracts on existing projects to spread out the costs and in some cases may be forced to reject some project proposals altogether as unaffordable.

Kemp signs bills benefiting Georgia's military members, retirees

Gov. Brian Kemp has signed a series of bills

benefiting members of the military, their spouses and military retirees.

Monday's signing ceremony took place at the National Infantry Museum in Columbus before an audience of active-duty service members and retirees.

Kemp signed legislation providing the first military retirement income tax exemption in Georgia history. He also signed bills to expedite the issuance of professional and business licenses to military spouses and allow veterans to use their Veterans Health Identification Card when they seek the service of a public notary.

A fourth measure, named in honor of the late state Sen. Jack Hill, will allow taxpayers to donate all or part of their annual state income tax refund to scholarships for disabled veterans.

Hall, who is executive director of the Newton County Industrial Development Authority and one of the lead recruiters for the Joint Development Authority of Jasper, Morgan, Newton and Walton Counties. Not only is she the consummate professional and spectacular at what she does, but Serra is also genuinely a great person who embodies what a Community Spirit Award winner is. She is a wonderful friend and colleague, and I believe she's a shining example of what all young ladies should strive to

Our Unsung Heroes included Duane Ford, Janet Goodman and Mike Hopkins. Unsung Heroes are the people who work behind the scenes making significant contributions to society that make life better for those around them, but are no less deserving of accolades. And I could not think of a better trio to be honored

this year.

Ford is chairman of Newton Trails, which is a nonprofit that includes about 40 volunteers and 30 additional people who regularly participate on its numerous projects and activities. The group, led by Ford, is dedicated to building, maintaining and linking an extensive system of bicycle and pedestrian trails throughout the county — with a major focus on completing a continuous 15-mile route for the Cricket Frog Trail from Covington to Mansfield.

In 2021, Ford led the nonprofit as its volunteers refurbished former railroad bridges, installed trailside benches and pet waste stations, saw local governments pave many miles of the trail, and began an ambitious fundraising campaign to renovate the final, and largest, bridge on the trail.

Goodman is a former member of the Covington City Council. Despite facing racial and gender discrimination in her younger years, Goodman

Center and the United Black Front. In 1978, Goodman was the first African American female to be voted onto the Covington City Council, and she served on the council until

Hopkins, who is director of the Newton County Water & Sewerage Authority, serves as chairman of the Friends of the Miracle League committee. He plays an integral role in maintaining the county-owned facility built especially for its unique players.

Our Youth of the Year was awarded to J. Harrison Kirkham.

The Youth of the Year Award is presented each year to an individual 21 years old or younger who has made an impact in Newton County by way of significant contributions, community-oriented projects and simply aiding others. And there is no doubt, Kirkham has done these

In 2017, Kirkham spearheaded the initiative to get a splash pad built in Newton County as part of his project to achieve the rank of Eagle Scout in the Boy Scouts. He put in countless hours of work to bring the unique opportunity to Newton County, and after four years of planning and laboring, the vision became a

Kirkham has since graduated from Eastside High School and now attends Brigham Young University in Provo, Utah, where he is a member of the marching band and pep band. As for what's next? Kirkham said, "Whatever I end up doing in life, I want to do my part to help make the world a better place."

And finally, our Employer of the Year was awarded to Snapping Shoals EMC.

The Employer of the Year award is presented each year to a local business or industry that has shown an outstanding investment in the Newton County and displays tremendous involvement in the enrichment of our community. Local business leader against **PRO Act**

To the editor:

I am the president of a utility construction company in Covington, Georgia. We do difficult work. specializing in water and sewer infrastructure construction, and we employ 37 employees to help get the job done.

These are challenging times to run a business. The costs of supplies have gone up significantly over the past year. So has the time it takes to get materials from suppliers. The labor market since the pandemic hit has not rebounded and doesn't appear to be in the near future. It's hard to hire people right now and, because of inflation, people are asking for more just

to tread water. Meanwhile, Congress is considering a bill called the PRO Act that would make matters even worse.

The PRO Act is designed to help unions organize workplaces like ours, regardless of worker sentiment. It grants new powers to union leaders and federal bureaucrats that would make unionizing workplaces a virtual certainty.

Among the most detrimental provisions of the PRO Act is its nullification of every state right-towork law, meaning all workers in a union shop would be required to pay dues. Union dues in Georgia, a right-towork state, average almost \$1,000 per year. Does Congress really think Georgia workers can afford another \$1,000 out of pocket during the worst inflation crisis in a generation?

The PRO Act passed the U.S. House of Representatives last year. To date, the Senate has not taken action on the bill despite President Biden's advocacy for the bill during his State of the Union Address. I strongly urge Georgia's delegation to stand with small employers by opposing the PRO Act.

Council denies request for residential solid waste rate increase

COVINGTON, Ga.

— Due to what city leaders and community residents deemed as questionable service, the Covington City Council voted to deny a proposed rate increase on residential garbage pick up.

Latham Home Sanitation Co., who is contracted to handle the city's solid waste collection services, requested a rate increase due to various factors, including inflation and increasing operational costs. When the company began serving the city in 2019, the monthly contracted price was \$16.15 per residential unit, \$8 per additional can and \$23.50 for businesses utilizing residential containers.

Despite the hardships of COVID and the restrictions that came with it, Barbara Jarvis, who is a representative of Latham Home Sanitation, told the council April 4 that her company had not requested an increase before and, instead, chose to absorb operational increases. But now that fuel costs have risen, not much more could be ab-

sorbed, she said.

The company proposed a \$1.60 increase per month, increasing the cost per residential unit to \$17.75 per home and \$25.10 per commercial account. The proposed extra can rate was increased to \$8.80.

Several residents took issue with the proposed increase. Coving-

Nearly \$3 million in electric supplies approved amid supply chain issues

COVINGTON, Ga.

— Costs and lead time amounts on electric supplies nationwide are skyrocketing, and the city's electric department is experiencing this firsthand.

In his recent request for purchasing transformers, Covington Electric Director Joel Smith told the city council that the market has been "tricky." Typically, Smith said during the April 4 meeting, his department sends out a request for proposals to purchase transformers, but in today's market, few will give out pricing. And those that will can commit to given prices for only a few

"So, no one will give us the pricing because mainly due to the lead time on transformers, which is anywhere from one year to — I had some come back at 135 weeks, or two-anda-half-years," Smith

said. "So trying to figure out this one has been tricky."

After sending out a request to four vendors for only "projected" pricing and "potential" lead times, Smith said vendor Stuart Irby gave the best price and lead time at about \$722,695 for 90 transformers, which were expected to be delivered no later than the first quarter of 2023. But Smith said he was told to expect up to a 30% increase on the cost, rising upwards of \$1 million.

"We're growing, and we're growing fast," Smith said. "A lot of these have already been allotted to different projects going on right now ... And this is not giving us the cushion that I really would like to have. This is just getting us by. We do have a cushion, but it's not as much as I would like, but I'm not comfortable paying these prices when I feel like the market will probably drop back down in the next two years."

Smith said the transformers would be mostly for upcoming and ongoing projects including Wildwood Phases 1 and 2; the Lakeview Landing development; the Ashford Park project off Washington Street; the Martin's Crossing development at U.S. Hwy. 278 and Covington Bypass Road; the Quinn Residence homes in Covington Town Center; the Cottages at Studio Village; and the recently announced Cinelease Studios-Three Ring expansion. Smith said the Neely Farms development was not part of the projects included for this order.

Smith said there used to be a market for reconditioned transformers, but considering the market as a whole, "most people are hanging onto them and having them reconditioned for themselves."

Councilwoman Fleeta Baggett suggested the council consider that lead times may only get worse in the

Georgia Votes 2022: Race for Newton County Commission District 2

Opponents sound off on congressman's endorsement of incumbent commissioner

— One candidate said it was a "shame" District 4 U.S. Rep. Hank Johnson did not talk to any other candidates before announcing he was endorsing one of four seeking the Demo-

cratic nomination for a

Newton County Com-

mission seat.

Johnson, D-Stone-crest, said this week he was endorsing incumbent County Commissioner Demond Mason for reelection to the commission's District 2 seat representing south-

west Newton.

Johnson's 4th Congressional District includes western Newton County.

"I want to go on record as endorsing Demond Mason for Newton County District 2 County Commissioner," Johnson said in a statement released by Mason's campaign.

"Reelecting Demond Mason would offer Newton County and the District 2 residents a continued opportunity to make Newton County a great place for community, economic and workforce develop-

nent

"His business acumen, his professional demeanor and his way of establishing the right business partnerships will continue advancing Newton County as a great place to live, work and play."

Mason, in his first term on the Board, is facing opposition from IT professional and former Recreation Commission member Steven Rhodes, former commissioner Earnest Simmons, and pastor Dwayne Stephens, a political newcomer, for the Democratic nomination in the May 24 primary election.

In 2018, Mason won a crowded Democratic primary that included Rhodes and Simmons. He defeated Simmons in a runoff that year.

Mason said he was "honored to be endorsed by Congressman Hank Johnson, because he has represented the 4th Congressional District since 2007.

"I met him back in 2018, when I was running for District 2 Commissioner, as a first time electoral candidate. Congressman Johnson was approachable and we instantly made a professional connection, during the first time we met at a Family Fun Day being held by local, state and federal officials.

"Once I was elected as the District 2 Commissioner, we were able to work together in 2019 for the same Family Fun Day event where we initially met for the first time.

"Since meeting, he has become like a father figure to me, in the governmental arena. He

has guided and coached me through some very challenging moments I incurred, as an elected official.

"He has been someone that has encouraged me a lot, therefore this endorsement means a great deal to me. I personally respect him and I look forward to his continued mentorship while striving to be the best elected official that I can become."

ton resident Lamonté Buchanan opposed the request and said his garbage wasn't being picked up. Resident Thelma Nolley also was against the increase because her garbage had not been picked up correctly. The increase was not warranted because she was being overcharged, Nolley alleged.

Councilwoman Fleeta Baggett said she had received more calls about trash than any other issues in the city. She asked city staff to conduct a quality control assessment after a route is run.

Councilwoman Susie Keck

said she also received calls and photos of trash issues, but she also said there was always an immediate response to her petitions. She believed Latham was doing a good job.

After further discussion, Keck made a motion to approve the requested increase without passing the cost along to the customer, but the motion died for a lack of second.

Councilman Kenneth Morgan then motioned to approve the rate increase as initially requested by Latham. After a second motion from Keck, the council voted 4-2, denying the request. Keck and Morgan were the only 'yea' votes.

The council also heard a request from Waste Management for a rate increase on commercial solid waste services. After Baggett discussed issues she has witnessed concerning inconsistent dumping of dumpsters and bags hanging on dumpsters, no action was taken by the council.

The council is expected to revisit the increase requests at a later date.

short term considering hurricane season was approaching. She also talked about her family's experience in the electric supply business and how pricing and lead times were affecting them, too.

"Anything that Joel needs that we can get our hands on, get it," Baggett said. "Because they are literally holding [my family's] purchasing agent to the price while she's on the phone with them. If she hangs up, goes to talk with my brother, and then goes to call them back, the price might be different ... So if there's anything we can get, please get it."

"It's a nationwide thing," Smith said. "It's not just Georgia or the Southeast. It's nation-

wide."
Smith said the cost of the purchase would be figured into next year's budget.

After further discussion, the council voted unanimously to approve the purchase of the transformers from Stuart Irby, as requested.

In addition to the transformers, the council also approved the purchase of 618 Itron meters through Tantalus from Anixter in the amount of \$2,134,310.15, and the purchase of infrastructure from Anixter in the amount of \$68,565 for reading meters.

Couple puts agricultural education to use in Newton

Has operated Nation's Farm in Porterdale since the midst of pandemic

PORTERDALE, Ga. Malachi and Alayjah Muhammad have seen the challenges of starting a business from scratch in the midst of a pandemic.

Even more challenging was its reliance on good weather and learning how to keep unwanted nighttime visitors from taking its merchandise.

The Nation's Farm has operated since late 2020 on 6 acres south of Porterdale on Lower River Road.

The Muhammads

grow a variety of crops while also raising sheep and chickens. They are working toward being a certified organic farm while also developing a customer base, Mr.

Muhammad said.

They also will operate a farm that is one of the few Black-owned, certified organic farms in Georgia.

Mr. Muhammad

said he is reminded of that fact when he sees others working in the agricultural sector in the area.

"Most of the time I meet farmers who don't look like me," he said. Mr. and Mrs. Muhammad met while students at Tuskegee University in Alabama — famed for Booker T.

Washington's leader-

ship in promoting post Civil War higher education for southern Blacks and for famed botanist and professor George Washington Carver's work in agriculture.

The Muhammads earned undergraduate degrees in Plant and Soil Science and began operating the farm a few months after he completed a master's degree at Tuskegee.

Muhammad said they made a business decision to begin their farm in Georgia rather than his native northern Illinois because of such factors as a longer growing season and more temperate climate.

However, the farm started with livestock while the Muhammads worked to plant crops and develop its soil.

DNR shares what to do when you see a snake

As spring hits full stride, Daniel Sollenberger will field more calls and emails about snakes. And most will involve two questions: What species is this and what should I do?

As for the first question, seldom is the snake a venomous species, according to Sollenberger, a senior wildlife biologist with the Georgia Department of Natural Resources.

Whether it's venomous, of course, is the worry or fear underlying most of the questions. Chances are it's not. Only six of the 46 species native to Georgia are venomous and only one – the copperhead – usually thrives in suburban areas, which is where many Georgians live.

"While at least one of the state's six species of venomous snakes could be found in each county in the state, seldom are they the most common species encountered," Sollenberger said.

Now to the second question: What should you do, or not do, if

you see a snake? • You can try to identify it from a distance. Resources such as georgiawildlife. com/georgiasnakes, which includes DNR's "Venomous Snakes of Georgia" brochure, can help.

 Do not attempt to handle the snake. Give it the space it needs.

 Remember that snakes are predators that feed on small mammals, amphibians, insects and even other snakes. There is no need to fear non-venomous snakes. Also, Georgia's native non-venomous species are protected by state law, and one – the eastern indigo – is federally

protected. • If a clearly identified venomous snake is in an area where it represents a danger to people or pets, consult georgiawildlife.com/ nuisancewildlife for a list of private wildlife removal specialists. Most bites occur when a snake is cornered or captured and defending itself.

Non-venomous

snakes such as scarlet kingsnake, eastern hognose and watersnake species are frequently confused with their venomous counterparts – coral snakes, rattlesnakes and water moccasins, respectively. Although pit vipers, which include all venomous species native to Georgia except for coral snakes, are often identified by their broad, triangular-shaped heads, many non-venomous snakes flatten their heads when threatened, which can make their heads appear triangular-shaped. Also, some non-venomous species have color patterns similar to venomous snakes. The bottom line:

While it's likely not venomous, use caution around any unidentified snake. For more on Georgia's snakes, visit georgiawildlife.com/ georgiasnakes. "Amphibians and Reptiles of Georgia" (University of Georgia Press) also provides a comprehensive reference.

"It's crazy that in my first year we had animals. I majored in Plant and Soil Science. I learned just from raising them," Muhammad

He said starting a new business in the midst of the pandemic was "scary for me personally."

"I was in fear of catching the virus," he said. "My wife

"I couldn't afford to get sick. I had life depending on me," Muhammad said, in reference to his livestock.

Muhammad said the couple works jointly on the farm operation — though his wife often will take up the slack on days when he has worn himself out.

He recalled one specific instance when he was unable to keep working after a 12hour day of planting blueber-

"There were times when I just didn't have it," he said. "But she'd still be out there."

The farm grows two acres of crops, such as blueberries, tomatoes, eggplant, peppers, apricots and lettuce though its fruit trees are in their early stages.

It also has set aside the rest of the land for its livestock to

graze. A recent \$3,000 grant from Food Animal Concerns Trust — a national nonprofit that seeks more humane treatment of farm animals will allow the Muhammads to install a perimeter fence to increase access to pasture for its broiler chickens and laying hens and to sheep for grazing.

It also will be designed to keep out predators, "which has been a huge problem on our farm," he said. Wild foxes have feasted on their chickens, he said.

The Nation's Farm is now working on developing a network of customers, such as restaurants and grocery stores, while offering

"U-Pick" services for the public to buy its blueberries and selling leftover crops at farmer's markets, Muhammad said.

It also hopes to offer workshops on organic farming and has collected donations for construction of a steel building to host such events year-round and store supplies and materials for each workshop.

The Nation's Farm also tries to offer community events, titled "Farm Night Out," such as a karaoke event planned for May 21 and free movies.

The events are designed to show the public a farm can be an "enjoyable" place to

live and work, he said.

He said he hoped more Black Georgians enter the agricultural sector and see it as a viable way to make a living.

WHY THEY DO IT

Mrs. Muhammad, who also works as a parapro in Newton County schools, wrote on the farm's website, www.thenationsfarm. org, that they both "knew at early ages that we wanted to become farmers."

"We set out to make a difference in our community and begin a cycle of generational wealth for our family.

"What began as a vision of simply providing healthy, organic, wholesome produce to families, quickly turned into a vision of also educating people, sharing what we know, and providing handson exposure to all things

agriculture. "We love what we do and want to share our love for agriculture with as many

people as we can!" Muhammad, a Chicago native, grew vegetables in his backyard while growing up "but the cold weather did not permit him to grow everything throughout the year."

Mrs. Muhammad said Carver's legacy — and her husband's passion for agriculture - inspired Muhammad to attend Tuskegee.

"It must have been destiny because they both majored in Plant and Soil Science with Alayjah graduating with her bachelor's (degree) and Malachi continuing on to complete his master's."

She said the mission of The Nation's Farm is growing food that is "wholesome, hearty" and certified organic.

"This extremely strict process ensures our customers that our products contain no GMOs, pesticides, herbicides or other toxic chemicals," she said.

• Prevention: To reduce the potential for snakes near your home, remove brush, log piles and other habitat features that attract mice, lizards and other animals on which

He said he devised the project after seeing the lack of water recreation facilities in Newton County. He then began planning it as a project required for his Eagle Scout rank.

"I really wanted to do something that would impact the community positively," Kirkham said.

During Thursday's ceremony, Harrison thanked County Chairman Marcello Banes and county Recreation Department director Dwayne Mask for acting upon his plans for the splash pad — which opened in May 2021 after four years of planning and construction.

Kirkham also encouraged the community to give its young residents opportunities "to accomplish their dreams."

EMPLOYER OF THE YEAR

The Employer of the Year award is given to a business "that has shown an outstanding investment in Newton County and displays tremendous involvement in the enrichment of our community," Beck said.

Snapping Shoals provides electricity to 99,000 homes and businesses in Newton and seven other counties. Beck said the electric cooperative "places a special focus on being 'plugged in' to the community."

He said one of the missions of electric co-ops was to play an active role in the community.

Askew said Snapping Shoals was the second co-op for which he worked but was "the best."

UNSUNG HEROES

The News gave Unsung Heroes awards to Newton Trails board chairman Duane Ford, Friends of the Miracle League chairman Mike Hopkins and former Covington councilwoman Janet Goodman.

Beck said Unsung Heroes awards are given to "the people who work behind the scenes making significant contributions to society that make life better for those around them, but are no less deserving of accolades."

Ford said he was representing the numerous Newton Trails volunteers who contributed to bringing projects like the Cricket Frog and Eastside trails to fruition over more than two decades.

He also thanked the hundreds who contributed to fundraisers for Newton Trails' projects "who make me look good," he said.

Goodman participated in marches and protests during the Civil Rights Era before working for years for the county school system and The Covington News — where she was its first Black employee.

In the 1970s, Goodman helped organize the Newton County Voters League, the Washington Street Community Center and the United Black Front.

She then served 37 years on the Covington City Council from 1978 to 2015 — which made her the longest serving councilwoman in Georgia when she left the post.

Beck said her "desire to see her hometown become better than it was when she was a child has driven her to a lifetime of service and dedication to Coving-

ton." "And her valiant efforts have truly made a difference in our community," he said.

Goodman told the banquet attendees at the Life in the City event center that she was seldom at a loss for words but found herself in that position in accepting the award.

"Working together we can change things," she

COVINGTON, Ga. — Throughout the past few years, there has seemingly been a substantial increase in the number of student-athletes being recruited by colleges. As a matter of fact, 36 area athletes across numerous sports signed scholarships to begin their college careers.

So far in 2022, already over 20 area student-athletes have penned their national letters of intent to play at the next level.

At the forefront of that



increase for Newton High School has been football recruiting coordinator Josh Skelton.

Skelton is a graduate from Stephenson High School in

tice.

Now, in his position at Newton High School, Skelton uses his own experience and technique to assist student-athletes, particularly football players, with their recruitment procedure. And, according to Skelton, the wheels start turning right away. "When a kid gets to ninth grade, I try to get that process going as soon as I can,"

Skelton said. Throughout that process are three main areas Skelton

said he likes to focus on. First and foremost, Skelton said he places a huge emphasis on a student-athlete's academics. That helps with the grade point average (GPA)

requirements for colleges.

Skelton also stresses for each of his players to not earn any C's in their classes — only B's or higher.

Next in the process is the weight room and skill work.

Skelton highlighted how physically difficult it is for high school athletes to adjust to college athletics. However, Skelton said that he tries to get players as prepared as possible for the next level.

And, most of the time, work in the weight room helps student-athletes pass
