1. Newton voters keep SPLOST in place

During the November 2022 election, a majority of Newton County voters chose to keep the county's 1% SPLOST in place through 2029.

It will generate an estimated \$108 million over six years for a variety of public needs — from recreation centers to street paving, including widening of Brown Bridge Road.

With all 22 precincts counted, 55% voted "yes" and 45% voted "no" out of more than 41,000 cast in the special election.

With the vote, Newton Countians kept the 1% Special Purpose Local Option Sales Tax in place for another six years through 2029.

It will begin to be collected July 1, 2023, after the current SPLOST expires on June 30,

Potential SPLOST-impacted items include:

• \$12 million for construction of four new recreation facilities, including a new "community waterpark," an enrichment center for the county Senior Services department, and parks in both southwest Newton and

commission District 5, which covers northeast Newton.

- \$8 million for renovations to the historic R.L. Cousins High School building on Geiger Street.
- \$4.65 million for county Fire Services improvements;
 - \$4.5 million for im-

provements at existing parks and walking trails countywide.

- \$1.07 million for expansion of the Animal Services facility on Lower River Road.
- \$900,000 for the library system.
- SPLOST has been used for construction and renovation of

numerous county and city projects since the 1980s, including parks, renovation of the Historic Courthouse and construction of the county's Administration Building and the Judge Horace Johnson Jr. Judicial Building.

Feds approve wetlands permit for Rivian factory

Allows expansion of development to entire Social Circle, Morgan site

SOCIAL CIRCLE, Ga. — A federal agency has given the Rivian project the go-ahead to develop its planned electric vehicle manufacturing facility.

The U.S. Army Corps of Engineers on Dec. 16 issued a federal Clean Water Act Section 404 permit to the Georgia Department of Economic Development and the Joint Development Authority of Jasper, Morgan, Newton and Walton counties (JDA) that was required for development of the 2,000-acre site.

The action will allow development on the entire site rather than on the 500-acre section it already has been grading in recent months.

State Economic Development Commissioner Pat Wilson said the permit's approval "is another critical step for the community and the state in the development of this exciting and transformational project."

But Chas Moore, spokesman for Rutledge-based Our Communities Oppose Rivian Assembly Plant, expressed, "Grief, anguish and a sense that 'The Sovereign Dollar' has exceeded the value of the American citizens' voice.

"Government has stopped listening to the citizen and has become an enforcement and funding arm for CEOs and corporations," Moore said. "Maybe, it always has been."

Section 404 regulates use of fill dirt for site development, water resource projects such as dams and levees, infrastructure development such as highways and airports, and mining projects, according to information from the Environmental Protection Agency (EPA).

It requires a developer to receive a permit before dredged or fill material may be discharged into waters of the U.S. — including wetlands, according to the EPA.

"When you apply for a permit, you must first show that steps have been taken to avoid impacts to wetlands, streams and other aquatic resources; that potential impacts have been minimized; and that compensation will be provided for all remaining unavoidable impacts," the EPA

The Georgia Department of Economic Development said in a statement that, "To earn this approval, the state and JDA have demonstrated that the project planning has avoided and minimized impacts to wetlands and streams to the maximum extent practicable and that all unavoidable impacts will be fully mitigated for.

"As part of its standard public interest review,

the Corps sought and received public comments on the permit application, which the state and JDA carefully reviewed and provided detailed responses to."

The EPA, U.S. Fish and Wildlife Service, Georgia Department of Natural Resources' Environmental Protection and Wildlife Resources divisions, and Georgia Historic Preservation Division joined the Corps of Engineers in reviewing the Section 404 permit application, the statement said.

"Consistent with its environmentally conscious mission, Rivian's site designs show some of the ways the company aims to minimize the



environmental impact of the facility footprint," according to the statement.

"Half of the site acreage will be permeable, vegetative surface that absorbs stormwater, creates wildlife habitat and stores carbon, with building placement and impermeable infrastructure on higher ground

where possible to avoid impacting wetland areas.

"Rivian intends to preserve as much of the existing tree growth as possible. Rainwater will be collected and used onsite, reducing the need for traditional potable water supply.

"Following the company's philosophy for

new construction, the mature site will take into account best practices to limit lighting, stormwater runoff, water quality and noise impacts and to preserve scenic views and natural systems."

Although local regulations do not affect the site because the state government owns the property, the state and JDA included site development guidelines and environmentally driven requirements in the overarching agreement between the Georgia government, the JDA and Rivian, according to the statement.

Rivian will be required to comply with the Social Circle city and Morgan County Stanton

Springs Business Park Ordinance's threshold regulations, the statement said.

It also will limit impervious surfaces to 50% of the site compared to the 75% maximum that is permitted; perform additional hydrology studies; design the stormwater detention facilities for a 100-year storm; comply with the Walton County tree ordinance; coordinate with a local observatory regarding outdoor lighting plans; maintain a 500-foot setback from Old Mill Road; and comply with all federal and state environmental permitting requirements, the release stated.

"As demonstrated by these extra requirements, conserving buffers, wildlife habitat and outdoor recreation around the site

is a priority for the state, JDA and Rivian." The project already has received other per-

2 Rivian begins site development, over residents' objections

The Rivian automotive company got the green light this year to begin site development on 2,000 acres of land partly in Social Circle.

This came after receiving \$1.5 billion in state, local incentives.

An agreement that outlines requirements for such issues as the timing of employing workers and tax payments came into the hands of state and Rivian officials after a regional development authority's approval back in April.

Development authority members also said

Rivian's addition to the JDA-controlled Stanton Springs and Stanton Springs North business parks will increase tax revenues to more than \$900 million shared by the four JDA counties and Social Circle over the next 25 years.

The Joint Development Authority (JDA) of Jasper, Morgan, Newton and Walton counties on Tuesday, April 26, voted to approve a final economic development agreement between the JDA, the state of Georgia and electric vehicle maker Rivian Inc. In that same

meeting, the JDA also approved a resolution to exercise the options to buy 41 parcels of land on the site, pending approval by the state and Rivian.

JDA Chairman Jerry Silvio of Newton County said at the time that his

agency's approval of the documents means "we are taking a significant step toward realizing the original vision of the JDA from more than two decades ago" to develop an industrial park east of



Election-year politics tops Georgia headlines in 2022

With the coronavirus pandemic at last under control, election-year politics dominated Georgia this year.

Voters reelected a Republican governor and a Democratic U.S. senator in a wave of ticket-splitting that drew national attention.

Here's a look at the top Georgia stories of 2022:

• January 7 – The father-and-son murderers of Black jogger Ahmaud Arbery near Brunswick in 2020 are sentenced to life in prison without the possibility of parole.

The case led the General Assembly to pass a hate-crimes bill and overhaul Georgia's 19th-century citizens arrest law. • January 10 – The

Georgia Bulldogs win college football's national championship, defeating the University of Alabama 33-18 in Indianapolis.

• March 1 – The University System of Georgia Board of Regents votes to hire former two-term Gov. Sonny Perdue to become the system's 14th chancellor. Perdue takes up the post

in April. • April 4 – The Republican-controlled General Assembly completes the 2022 legislative session, highlighted by the passage of bills overhauling the delivery of mental-health services in Georgia, allowing Georgians

to carry concealed firearms without a permit and cutting state income taxes by \$1 billion.

• May 20 – Hyundai Motor Group announces plans to build an electric vehicle manufacturing plant in Bryan Couty near Savannah. Expected to create 8,100 jobs, it's the largest economic development project in Geor-

gia history. • May 24 – Gov. Brian Kemp trounces former U.S. Sen. David Perdue by 50 points in the Republican gubernatorial primary. Democrat her party's nomi-

Stacey Abrams wins nation for governor unopposed. • July 20 – The U.S.

11th Circuit Court of Appeals upholds Georgia's "heartbeat" bill banning abortions after six weeks of

pregnancy. The General Assembly passed the law in 2019, but it didn't

take effect until the

U.S. Supreme Court's ruling in June overturning the 1973 Roe v. Wade decision legalizing abortion.

• Sept. 26 – The state signs an agreement with water supply systems in Gwinnett, Hall, and Forsyth counties guaranteeing water from Lake Lanier through 2050.

The deal closes the chapter on a major portion of the tristate "water wars" between, Georgia, Florida, and Alabama dating back to the 1990s.

November 8 – Republican Gov. Brian Kemp wins a second term, defeating Democratic challenger Stacey Abrams.

Democratic U.S. Sen. Raphael Warnock lands in a runoff with GOP challenger Herschel Walker.

 November 16 - Georgia House Speaker David Ralston dies at age 68 after an extended illness.

Two days earlier, the House Republican Caucus had nominated House Majority Leader Jon Burns, R-Newington, to succeed the ailing Ralston as speaker.

• December 6 – Democratic U.S. Sen. Raphael Warnock wins a full six-year term in the Senate after completing the late Sen. Johnny Isakson's unexpired term. Warnock defeats Republican challenger Herschel Walker in a

runoff. —Capitol Beat News

Monroe Council opts for no liquor store referendum

Attempts to get a package store in Monroe continue to

be thwarted. A resolution was prepared for the December City Council meeting but nobody stepped up to propose a vote on it either way and it died for lack of a motion.

As a result, there will not be a referendum on the ballot at the March or July 2023 Special Elections.

Prior to the November Election, the Monroe City Council had voted 7-1 to place the referendum on the ballot.

Councilman Larry Bradley was the only opposing vote.

However, it didn't make it in on time to be on the ballot last month and subsequently the constituents did not have an opportunity to vote

"We had a resolution to allow it on the November ballot but there is a way forward to resolve it so we've crafted a new one for March 2023 that we would be able to have," Monroe City Administrator Logan Propes said prior to Mayor John Howard calling for a proposal.

Propes said there would possibly be a Special Election for the Board of Elections post vacated by the resignation of Simoan Capers Baker and if not March, possibly June or July 2023.

However, that is now a moot point as there was no support for the referendum from any of the city council members at the Dec. 13 City Council meeting.

There had been a move in Monroe to call for a referendum on whether or not to allow for the sale of distilled spirits in the city back in 2020.

Under Georgia law at that time, in order to call for a referendum election to authorize the issuance of licenses for the package sale of distilled a petition had to be presented to the relevant municipality.

It was required to have least 35% of the registered and qualified voters sign on to the petition. For the City of Monroe, that would have required at least 3,000 signa-

Ty Vance had been contracted to obtain the signatures necessary to place the referendum on the ballot in November 2020 and in February he began the task of getting the signatures for an unnamed client.

He had until August 2020 to get the required signatures, but the pandemic shut that down and no more has been done on it since then.

Vance said he had explained that the petition was not to approve a package store in the city, but merely a call for a referendum to let the voters themselves make that decision.

Federal legislation seeks to protect Chattahoochee River President Joe Biden

has signed legislation aimed at protecting the Chattahoochee River.

The first-of-its-kind measure authorizes

\$90 million in feder-

al funds for the U.S. Army Corps of Engineers to work with local partners on water projects throughout the Chattahoochee River system.

Biden signed the bill last week as part of congressional reauthorization of the Water Resources and Development Act.

"This exciting new program will improve water quality, protect essential public works, and restore ecosystems along the river, which supplies much of our state's drinking water," said U.S. Sen. Jon Ossoff, D-Ga., who introduced the bill into the Senate along with Sen. Raphael Warnock, D-Ga.

"Clean water is essential for healthy and thriving communities," Warnock added

"While the Chattahoochee River's water quality has improved in recent years, hundreds of miles of Chattahoochee watershed waterways still do not meet water-quality standards.

"I'm proud to have worked with Senator Ossoff to ensure this provision that will invest in improving, protecting, and preserving the Chatta hoochee River gets signed into law."

According to the Georgia River Network, the Chattahoochee supplies 70% of metro Atlanta's drinking water.

The river is also a key source of water for farmers and an important source of power generation through hydroelectric dams.

However, more than 1,000 miles of waterway within the Chattahoochee watershed do not meet water quality standards, creating potential health risks to humans and wildlife.

In 2019, the National Park Service reported visitors to the Chattahoochee River National Recreation Area added more than \$200 million to the metro region's economy, supporting more than 2,000 local jobs.



What could go wrong by traveling in bad weather?

f Americans had any sense, we'd celebrate .Christmas very differently. In much of the country, it's borderline crazy to jump into the family chariot during the worst weather week of the year to travel hundreds of miles for the dubious

pleasure of argu ing with Angry Uncle Charlie about the 2020 presidential election.

Angry Uncle Charlie's one

of the reasons you moved 500 miles away to begin with. But, hey, it's Christmas!

Meanwhile, countless thousands swarm to airports to stand for hours with a disgruntled mob watching the CAN-CELED signs blink, sleeping on the floor and awakening periodically to see that, yes, we still have no flights scheduled. TV correspondents prowl the aisles interviewing travelers benumbed by fatigue but determined to press on.

Meanwhile, their luckless colleagues on the meteorological beat stand outside in the wind and driving snow to document that, yes, the blizzard continues, and Merry Christmas to all! Then it's back to you in the studio, where the head meteorologist wears a Santa hat and the Action News Team documents the seasonal

death toll. I heard an interview on NPR the other day with a Michigan official who said state police were warning citizens that it was not only too hazardous to venture from home, but anybody who did was on their own. Should they become stranded, rescuing them could be a physical impossibility for at least 24 hours due to howling winds, temperatures well below zero and whiteout conditions. A person could easily get lost in his own neighborhood, the official said. Visibility was maybe 2 feet.

That segment was immediately followed by an interview with a chipper Michigander who said, yeah, the weather was bad, but they'd probably leave that afternoon. It's only a couple of hours' drive, she said. In normal weather, that is. Maybe they'd wait until morning, but she didn't think so.

Ho, ho, ho.

Atlanta "with high-tech, good paying jobs for years to come."

But before and after that agreement, the backand-forth debate on whether or not Rivian was a good addition for the area persisted, sometimes with fever-pitched fervor.

Back in January, opponents of Rivian's arrival into the area hired attorneys specializing in environmental and zoning issues as they prepare for legal challenges to the planned complex.

A group named, "Our Communities Oppose Rivian Assembly Plant" quickly raised more than \$125,000 for the cause at the beginning of the year. And later, in November, a group of Morgan County residents tried to halt grading of the Rivi-

Court ruling keeps statue debate alive

The lone individual allowed to continue a challenge to Newton County's planned removal of a 116-year-old monument to Confederate soldiers in Covington said she and her supporters were "thrilled with the Georgia Supreme Court's ruling" allowing her to continue her two-year effort.

"Our case will now be tried on the facts and the law," said Covington resident Tiffany Humphries Tuesday, Oct. 25.

"There were some very loud voices, that for a time, overshadowed all others," Humphries said. "Today's decision is proof that our system works."

The Georgia Supreme Court upheld the state Court of Appeals' dismissal of a Sons of Confederate Veterans' lawsuit to keep the Confederate statue standing in the middle of the Covington Square but also reversed the Appeals Court's dismissal of Humphries' complaint, seemingly allowing her lawsuit to continue back at the

According to the ruling published by the state Supreme Court,

the court determined that because the Sons of Confederate Veterans groups "have not shown of the communities" wherein the lawsuits were made — the group also had a dismissed lawsuit for similar removal of a Confeder-County — there was no standing for the group to make its claims.

The Supreme Court's ruling did not address the validity of the claims, but rather the legal right for each party

"This case is about

a highly controversial subject: whether local communities must continue displaying and maintaining at public expense, monuments that celebrate the Confederacy and its long-dead supporters, despite those communities finding such celebration repugnant," Presiding Justice Nels S.D. Peterson said in a written statement published on the gasupreme.us website.

"But nothing about issue in this appeal."



Election returns new, old office-holders

The 2022 General Election returned two incumbent county commissioners — including J.C. Henderson to a seventh term and Demond Mason to a second term.

Voters also returned state legislators including District 113 Rep.

Sharon Henderson of Covington, and elected a new state legislator, District 114 Rep.-Elect Tim Fleming of Covington.

They also elected a new congressman for two-thirds of Newton County, U.S. Rep.-Elect Mike Collins, R-Jackson, after redistricting placed a majority of Newton in the Republican-controlled 10th Congressional District.

Incumbent District 10 U.S. Rep. Jody Hice did not seek reelection in order to make an

unsuccessful bid for the Georgia Secretary of State's job.

Fourth Congressional District Rep. Hank Johnson, D-Stonecrest, was reelected but will represent a smaller part of Newton County.

Severe weather bookends 2022 calendar

It was like a tale of two counties this year, as far as weather went.

While 2022 began with the aftermath of a New Year's Eve 2021 tornado that damaged vehicles, a school building and other facilities along a 2.5-mile path in west Newton, the year ended with pipes bursting and power outages from bitter cold weather just in time for Christ-

And even as New Year's Day 2023 arrives, temperatures are forecasted to bounce back into the upper 60s.

Temperatures on Dec. 23 and Christmas Eve fell into the teens and single digits locally and across much of northern and middle Georgia, with patches of black

ice peppering roadways, thanks to rain and some light snow that fell in the area.

The frigid weather caused many to take precautions against frozen and bursting pipes.

Meanwhile, back on the first day of 2022, residents woke up to damage and debris from an EF-1 twister which caused minor injuries to six people and moved at a peak speed of about 90 mph on a 2.5-mile, 75-yard-wide path roughly parallel with

Brown Bridge Road. It damaged 12 homes, Veterans Memorial Middle School, Publix and a Chick-fil-A, where it tossed two cars 100 feet and flipped them in its parking lot, according to a preliminary

report from the National Weather Service (NWS) on Jan. 1, 2022.

The report stated the twister developed from an isolated supercell thunderstorm, which the NWS describes as a storm cloud with an extended upper part that has "a high propensity to produce severe weather" and is the least common type of thunderstorm.

A tornado "quickly developed from that thunderstorm" and first touched down about 5:39 p.m. along Creekside Lane just east of Brown Bridge Road. A few trees were snapped, the report stated.

Both video evidence and ground surveys suggest the tornado was sporadic in its contact with the ground as evident by

small gaps in damage, particularly in the beginning of the track.'

The tornado continued in an east-northeast path along Brown Bridge Road, snapping more trees and blowing down a fence along Glynshire Court and Roberts Road, the report stated.

Two members of the Newton County Board of Commissioners said they were ready to testify in court about being not guilty of discriminating against two former appointed

This came despite the county's insurance carrier making a "business decision" to settle the claims for more than \$1 million by the former county

attorney and former county manager — who are white - against three Black commissioners, Alana Sanders, J.C. Henderson and Demond Mason. The commissioners objected and said they were never given chances to tell their sides of the story.

The county's liability insurer, Charter Oak Fire Insurance Co., decided to pay the settlements and the county admits no liability in connection with the claims, according to the agreements The Covington News received through an open records request.

Also, the former officials, Lloyd Kerr and Megan Martin, agreed not to take part in any class action lawsuits and not seek employment again with the county government

as part of settlements of their discrimination and breach of contract claims.

Copies of the signed agreements showed Kerr, the former county manager, was awarded \$575,000 and Martin, the former county attorney, was awarded \$500,000 in the settlements reached Aug. 10 and Aug. 11.

Both had filed ante litem no-

tices with the Newton County government through federal court in January. An ante litem notice detailing specific claims against a government agency is required to be sent to the agency before a lawsuit is filed.

The claims were, perhaps, a factor in Traveler's Insurance's decision to not renew coverage with the BOC.

the plane took off from Covington Municipal Airport in a northeast direction and crashed about a half-mile away in an isolated area where tractor-trailers were stored on the General Mills grounds, Malcom said.

He said the plane hit some tractor-trailers on the ground about 100 yards east of the Harland Drive entrance to the plant near Industrial Boulevard in northeast Covington. Anyone aboard the plane died after it burst into flames on impact, Malcom said.

Two Gwinnett County residents have been identified as

the victims in an April 21 fatal airplane crash in northeast Covington that occurred the day after they picked up the plane in Texas.

Later, it was determined that Sergio Gill, 45, of Snellville — a private pilot and flight instructor — and student pilot Edward Rodriguez, 33, of Lawrenceville, died in the incident, Covington Police reported.

Rodriguez was identified from dental records, while GBI investigators identified Gill from DNA, a Covington Police Department spokesman

No one on the ground was injured and it occurred in a fenced area that was roughly 300 yards from General Mills' production plant which operates around the clock, police officials said. General Mills spokesperson Mollie Wulff said no employees were harmed in the crash.

FAA records show the Cessna 340 fixed-wing, multi-engine aircraft was manufactured in 1973 and certified as airworthy in 1985. It was owned by Nixon Enterprises Inc. of Portales, New Mexico.

Board OKs using \$1.3M from ESPLOST to install turf

For the first time since 2019, Homer Sharp Stadium is getting a facelift beginning in December 2022. During a Newton County School System's Board of Education on Tuesday, board members voted 4-1 in approval of artificial turf being installed for Sharp

The vote approved a contract for Sourcewell to do the job with Sports Turf being in the company providing the actual playing surface to be installed.

Approving turf instal-

lation comes less than a month after the board's Oct. 25 meeting in which board members approved the purchase of LED lights for the stadium.

School Superintendent Samantha Fuhrey said she was thrilled with the board's approval of such renovations.

"We are incredibly excited that Sharp Stadium will be upgraded with turf and new stadium lights," Fuhrey said. "Both items have been on our wish list for awhile."

The turf installation comes with a \$1.3 million price tag. The price includes all tools, equipment and labor needed to complete the job. Field goal posts, soccer goals, play clock and all maintenance are also accounted for.

Fuhrey credited the ESPLOST as a proponent to make Sharp renovations possible.

"The ESPLOST penny is extraordinarily important to our school system and community; it helps to remove the tax burden for

capital projects from our property owners by distributing the expense to anyone who makes a purchase in Newton County," Fuhrey said. "We remain grateful to those who continue to support projects like these by voting to support E-SPLOST. "

Though ESPLOST will ultimately pay for the renovations, the initial funding source will be from the school system's General Fund budget after the school board approved it Aug. 9, 2022.

According to Barr, installation of turf was to begin in December and be completed in April 2023.

Concerning the LED lights, that project will start in January 2023 and Barr said it "will take a few weeks to complete."

Barr believes the lights will help with the entire facility, which has a capacity for 4,100 people.

"The new LED lights will provide better lighting for the playing surface and surrounding area," Barr said.

Ott retires, Hicks departs, governments hire new managers

Two longtime area influencers moved on from their posts this year, and the Covington and county manager positions also saw change.

Dean Doug Hicks departed from Emory University's Oxford College to take on the presidency at Davidson College in North Carolina.

Hicks, 54, became Davidson's 19th president. His departure was announced in May as he decided to return to his alma mater after six years serving Oxford College.

Meanwhile, Newton County Superior Court Judge John Ott announced in October that he would retire Dec. 31 and end a 32-year career on the Alcovy Judicial Circuit bench.

Ott also asked Gov. Brian Kemp to appoint him as a senior judge "so that I can continue to be of some service to the court system and people of Georgia."

The Walton County resident is the chief judge of the Alcovy Judicial Circuit, serving with four other Superior Court judges overseeing criminal and civil cases in Newton and Walton counties.

"For the past 41 years, I have had the privilege, honor and pleasure of serving the people of my circuit and the

state of Georgia as an assistant district attorney and district attorney for nine years, and a Superior Court judge for 32 years," Ott said in his letter notifying Kemp of his retire-

"I have been supported by superior staff, great sheriffs, police chiefs, clerks of court and by county commissions that have always stood ready to meet any needs of the court

"I've also enjoyed the many fine lawyers that have prac-

ticed before me," he said. Ott enjoyed a retirement celebration in his honor in early December in Monroe.

Walton County attorney and Magistrate Judge Kevin Morris of Monroe will replace Ott.

On Dec. 16, Gov. Brian Kemp named Morris to be one of five Superior Court judges in the Alcovy Judicial Circuit to fill the vacancy.

Morris, 51, of Monroe, has served as the Walton County Magistrate Court judge since 2014.

In January, Newton County commissioners named a Washington, D.C., city official and a former Georgia city official as finalists for the position of interim county manager.

But in March, commissioners approved Jarvis R. Sims — a former top Augusta administrator — as interim county manager after they narrowly voted to agree to a contract with him.

On Tuesday March 1, the **Board of Commissioners** voted 3-2 to offer Sims a one-

year contract at a base salary of \$150,000 — \$15,000 more than former county manager Lloyd Kerr received before he left the job Jan. 1.

Sims' contract was slated for a one-year period to end March 6, 2023, said county Human Resources director Amanda Shoemaker.

Also, on Dec. 12, Covington City Council chose to take the "interim" tag from before Tres Thomas' name and give him the permanent position managing the city government's day-to-day operations.

The appointment followed the May 3 resignation of Scott Andrews who took a position with Bakersfield, California, city government after three years as city manager in Covington.

The council voted to appoint Thomas as city manager after he served in the interim role since May 16.

Before Thomas' appointment, he worked over a two-decade span in a number of roles with the city. He began work as the city engineer in 2001, and subsequently worked as assistant public works director, public works director and planning director.

ate a broader affiliation with Augusta University's Medical College of Georgia (MCG) as AUHS joins the Well-Star system.

"By bringing Augusta University Health System together with WellStar Health System and leveraging our respective strengths, we would improve the health of the community, address social determinants of health

and expand access to quality care for all Georgians," said Candice Saunders, WellStar's president and CEO.

The two systems have been working toward a partnership since 2019.

"AUHS, Augusta University and the WellStar Health System have a shared mission to solve Georgia's health-care challenges," said Sonny Perdue, chancellor of the University System of Georgia. "By joining forces and working together, we can leverage WellStar's clinical platform and leading-edge systems to support patients while providing more opportunities for students to learn, train and care for residents in local communities across Georgia."

If approved, the partnership would focus on expanding digital health offerings to create more convenient access to care and provide more individualized care regardless of location. It

also is aimed at growing Georgia's pipeline of physicians and other health-care providers as well as developing new treatments.

While there are aspects of the proposed partnership yet to be determined, it likely would result in significant investments to improve existing health-care facilities and expand access to care across the state, including a new hospital and medical office buildings in Columbia County.

"Providing health

care has never been as dynamic and complex as it is today," said Brooks Keel, president of Augusta University. "This partnership ... would enable us to extend our mission of improving health through excellence in patient care, education and research for the benefit of Georgians."

A new teaching campus at WellStar Kennestone Hospital could also be established under the proposed partnership. As a result, MCG, which already has the

ninth-largest freshman medical school class in the nation, would grow to become one of the largest public medical schools in the country.

Tuesday's announcement came less than two months after WellStar's Atlanta Medical Center closed its doors, dealing a huge blow to patient care in Georgia's capital

The state responded by sending \$130 million in federal pandemic funds to Grady Memorial Hospital to help offset the impact of the closure.

Businessman guilty of filing false tax return from amusement machine money

ROME, Ga. — Mohammed Ajmal, a Cartersville businessman, has been sentenced for making and subscribing a false tax return.

Aimal failed to report income from over \$2 million in "kickback" payments from the use of coin-operated amusement machines in his service stations and convenience stores, the U.S. Attorney's office stated in a news release.

"Ajmal exploited his relatives in his plan to cheat the IRS out of hundreds of thousands of dollars," said U.S. Attorney Ryan K. Buchanan. "Ajmal is now headed to

federal prison and will be required to pay full restitution as part of his sentence."

James E. Dorsey, Special Agent in Charge, IRS Criminal Investigation, Atlanta Field Office, said, "Consumed by greed, Mohammed Ajmal utilized his family members to hide income generated from kickbacks and filed a false tax return because he failed to report the income.

"IRS Criminal Investigation will continue to pursue anyone who commits tax fraud. Those harboring ideas on cheating the tax system, take note that prison time is a consequence

for such actions."

Michael J. Register, director of the Georgia Bureau of Investigation, said,

"The GBI Commercial Gambling Unit investigated this case along with federal and local partners. This defendant seeking to defraud the government by evading taxes is being held accountable."

According to Buchanan, the charges, and other information presented in court, Ajmal owned several gas stations and convenience stores in the Cartersville area through various corporations. Many of the stores contained coin-operated amusement machines, known as "COAMs." COAMs are regulated by the Georgia Lottery Corp.

Between 2013 and 2015, the Georgia Lottery Corp. issued administrative regulations under Georgia law, which resulted in Ajmal receiving less revenue from the COAMs. In response, Ajmal contacted the company holding the master license for the COAMs and conveyed that the company must pay him additional money, or kickbacks, if the company wished to continue operating COAMs on Ajmal's properties.

To disguise the kickback payments, Ajmal

told the company to write checks to his relatives. Ajmal then used the monies for his own benefit, including to build a new home. From 2015 through 2018, the amount of the kickbacks totaled \$2,292,847. Aimal did not report any of this income on his tax returns for 2015 through 2017. So Ajmal paid less federal tax than he actually owed for those

Ajmal, 49, of Cartersville, has been sentenced to two years in prison to be followed by one year of supervised release and ordered to pay restitution in the amount of \$734,232.05.

He was convicted of making and subscribing a false tax return on July 12, 2022, after he pleaded guilty.

The case was investigated by Internal Revenue Service Criminal Investigation and the Georgia Bureau of Investigation, with valuable assistance provided by the Federal Bureau of Investigation, U.S. Immigration and Customs Enforcement's Homeland Security Investigations, Cartersville Police Department, Bartow County Sheriff's Office, and the Georgia Lottery Corp.



D'Anthony Bell drafted to Browns, first NFL player in Alcovy history

COVINGTON, Ga. — Five years ago, D'Anthony Bell found himself out of football and pushing a wheelbarrow hauling rocks.

Now, Bell is fulfilling his childhood dream of playing in the National Football League as he made the Cleveland Browns' 53-man roster on Aug. 30.

The infamous wheelbarrow Bell used to help his dad, Anthony, in the construction business remains in the backyard of his Covington home.

All of that is behind Bell now as he is officially in the NFL. It was made official after Bell received a phone call notifying him that he made it onto the Browns squad. Bell is one of the team's five safeties.

Bell's journey to the NFL began when he was just 8 years old playing football at the Newton County Recreation Department. He played there as long as he could until he joined Liberty Middle School's football team in the eighth grade.

After that, Bell moved to Alcovy High School where he played football all four years. Bell is the first Alcovy alumnus to make it onto an NFL squad.

Bell graduated from Alcovy in 2015 and signed to play college football at Albany State. He redshirted a year there and transferred to play at Iowa Central Community College for a year.

Bell resumed his football career at Butler Community College in 2018 and then transferred to the

University of West Florida to finish. The 6-foot-2, 205-pound defensive back recorded 63 tackles, forced two fumbles, had five pass break-ups and intercepted two passes in his final season. And, just like with Alcovy, Bell is the first player from West Florida to make it to the NFL.

Upon his college graduation, Bell threw his name in the hat for the NFL Draft on April 30.

Bell's name wasn't called on draft night, but he ended up signing a free agent deal with the Browns afterward. From there, it was all about Bell going out every practice and making a name for himself.



COLUMBUS, Ga. — Back in 2021, eight seniors played their final game for the Eastside Lady Eagles' softball program. That left a lot of slots open for other players to step in and fill right

Of the replacements on the varsity roster, four juniors, four sophomores and five freshmen stepped up for the Lady Eagles.

Despite having a young squad, the Lady Eagles made a run in the 2022 Class AAAAA state playoffs and finished No. 6 in the state.

Eastside found itself in a few low scoring, defensive battles while in Columbus.


formances along the way, too. On Jan. 22, Social Circle defeated Commerce 107-44 marking the most points ever scored in a single contest in program history.

Newton Rams stun Parkview in 20-18 defeat

LILBURN, Ga. — In late October, Newton Rams decided to celebrate Halloween 10 days early with all the trick plays they dished out against Parkview. However, on a night that featured a savvy oftensive showing, it was Newton's defense that made the play to give the Rams the treat of a 20-18 stunner win in the Big Orange Jungle – its

first victory over Parkview... Trailing 20-12 with less than two minutes left and no timeouts, Parkview had the ball at its own 11-yard line. A few plays later, the Panthers found the end zone for just the second time of the night off a 32-yard touchdown pass. "The Blue Swarm" may

have bent, but it didn't break. On the ensuing two-point conversion and 5.5 seconds remaining, the Panthers ran a play action, roll out pass with the running back slipping out of the backfield. Jamarcus Presley was not fooled and stuffed the play at the three-yard line.

Presley's tackle preserved Newton's first Region 4-AAAAAA win of the season.

For this win, it was Marcus Calwise getting the party started. With 2:01 remaining in the first quarter, he took a bubble screen pass from quarterback Deron Benson and appeared ready to run. All of sudden, he geared up for a pass and found Gabriel Williams all alone for a 61-yard touchdown reception.

The Rams weren't finished dealing tricks.

On second and goal at the four-yard line almost at halftime, Deion Lewis took the snap and handed the ball to Calwise. Again, the junior wideout played quarterback and found Lewis who snuck out of the backfield

for a touchdown. Lewis' touchdown reception extended Newton's lead to 13-3

at halftime. While Newton's offense had a full bag of tricks, "The Blue Swarm" was busy getting timely defensive stops.

Numerous times, the Rams defense bent but very seldom did

Two times, they surrendered 33 and 27-yard field goals. But one of the most timely stops came on a fourth and goal from the 1-yard line. A swarm of Newton defenders swarmed Parkview's scoring attempt and

didn't allow a single yard. The only other touchdown Parkview scored came less than two minutes into the fourth quarter when the Panthers pounded it in from two yards out. But they missed the extra point — a miss that ultimately decided the game's outcome.

Parks Association (GRPA).



In a ceremony in Newton High's auditorium commemorating the early period for National Signing Day, Benton made it official, committing and signing to play for the Houston Cougars. The 3-star defensive lineman's


