Area man pleads guilty in drive-by shooting case

21-year-old sentenced to 18 years in prison for March 2021 crime

COVINGTON, Ga. -A21-year-old Covington man recently was sentenced to 18 years in prison after pleading guilty to charges related to a drive-by shooting in March

Zion Shamar Brown pleaded guilty to four counts of Aggravated Assault. one count of Criminal Damage to

Property in the First Degree, and five counts of Possession

of a Firearm During Commission of a Felony.

He was charged after a drive-by shooting in the Ellington subdivision on Spring Lake Terrace on March 22, 2021.

"Brown, in broad daylight, drove past a residence while opening fire numerous times. Multiple people were inside or just outside of the residence at the time of the

shooting. One victim was struck and seriously injured," stated a release from the Newton County District Attorney's Office.

The victim, Elijahwon Jefferies, 21, sustained major injuries in the 5 p.m. shooting and was transported to a local hospital, said sheriff's office spokesperson Caitlin Jett. His mother — in an emotional press conference

soon after the shooting pleaded with the public to find her son's assailant.

An investigation led to the arrest of Brown April 12. Evidence also showed Brown's involvement with the Rollin 60s gang, a subset of the Crips criminal street gang, according to the DA's office.

Brown entered a non-ne-

Auditor praises Newton officials for financial 'improvement'

COVINGTON, Ga. Newton County government's chief auditor praised elected and appointed officials Tuesday for doing a "commendable" job to stabilize finances in the past five years including growing its reserves to a level eight times larger than in 2016.

Miller Edwards of the accounting firm Mauldin & Jenkins said he had seen "a lot of improvement" in such areas as the county government's financial

stability in the five years he had reviewed the audit of the county's financial procedures.

"It's good for you to hear from us that we've seen such improvement," he said.

Edwards spoke during his presentation of the audit of the county government's

finances during the 2021 budget year.

He noted the county budget's General Fund had \$5 million in its reserves in 2016 but increased that amount to \$40 million by the budget year that ended June 30, 2021.

It increased \$17 million in one year between 2020 and 2021. Edwards said.

Auditors generally advise governments to have at least six months of operating capital in their reserves in case of budgetary emergencies such as revenue being diverted for some

Edwards said a \$40 million fund balance gives the county seven months of operating capital — compared to 2016 when its reserves would only give it less than a month's worth.

He noted he first began auditing the Newton County government in 2016 when it was using deficit spending to operate.

"You were tight back then," he said.

In the latest audit of the 2021 budget year, the county had assets






Gypsy was a 32nd degree Mason, a member of The Scottish Rite and a Shriner. He had

She was a former member of Eastridge



Georgia House starts work on comprehensive mental health bill

Bipartisan legislation aimed at improving the delivery of mental health and substance abuse services in Georgia got its first hearing in the General Assembly Wednesday.

The 75-page Mental Health Parity Act would require health insurance companies to treat mental illness in the same way they treat physical illness. The parity provision also would apply to Georgia's Medicaid and PeachCare for Kids programs and to the State Health Benefit Plan for Georgia teachers and state employ-

"If you're covering physical, you've got to cover mental," state Rep. Todd Jones, R-South Forsyth, one of the bill's cosponsors, told members of the House Health and Human Services Com-

The legislation, a major priority of House Speaker David Ralston, also would require care management organizations (CMOs) participating in Georgia Medicaid to dedicate at least 85% of their revenues to patient care.

And the bill contains a workforce development component in the form of a service-cancelable loan program aimed at recruiting mental health and substance abuse workers. The initiative is expected to cost \$8 million to \$10 million.

"Our biggest issue is workforce," said Rep. Mary Margaret Oliver, D-Decatur, another one of the bill's cosponsors and a member of a commission formed in 2019 that included mental health, substance abuse and criminal justice experts. "Workforce issues are critical all across Geor-

gia." The state has a long way to go to improve its mental health and substance abuse care system. In 2019, Georgia ranked 48th in access to mental health and substance abuse

services. "This is an opportunity for Georgia to pick up ... and hopefully leap into the top five," Jones said.

A key reality holding Georgia back is that many people with mental illness or substance abuse issues are behind bars rather than in treatment facilities.

"We've criminalized mental illness," said LaGrange Police Chief Lou Dekmar, also a member of the Behavioral Health Reform and Innovation Commission. "The largest mental health facility in each county is the county jail."

The bill drew strong support Wednesday from many mental health- and substance abuse-care advocates, particularly the parity provision that gives the legislation its name.

"Lack of parity leads to insurance companies denying coverage, long waiting lines, [patients] not receiving early treatment and families paying out of pocket," said Helen Robinson, associate director of public policy at The Carter Center's Georgia Health Parity Collaborative.

But others objected to a provision in the bill that would make it easier for police officers to forcibly take into custody a person in mental health crisis who has not committed a crime. Another sticking point was over a registry the bill would create as a database to give mental health professionals a better idea of where to target services. Some speakers raised concerns the registry could invade patients' privacy and subject them to the stigma associated with

mental illness. But committee Chairman Sharon Cooper, R-Marietta, said the heart of the bill would address that issue

"If we do nothing else ... passing parity will help decrease the stigma," she said. "We as a legislature will be saying, 'Having mental illness is no different from having a medical illness.' "

Cooper said lawmakers will work on incorporating some of the changes in the bill advocates have suggested and return with a new version of the legislation as early as next week.

Bill aimed at giant social media platforms advances

Legislation prohibiting giant social media platforms from censoring content based on the author's viewpoint cleared a Georgia Senate committee Tuesday.

Reining in social media platforms including Facebook and Twitter has become a national issue since the companies suspended former President Donald Trump's accounts a year ago. Republican-controlled legislatures in Florida and Texas have adopted laws prohibiting such censorship, and Georgia could become the third state to take similar action.

Senate Bill 393 would apply only to social media platforms with more than 20 million followers, Sen. Greg Dolezal, the legislation's chief sponsor, told members of the Senate Regulated Industries and Utilities Committee.

"Those are the ones that have near-monopoly status," said Dolezal, R-Cumming. "They're the public- common square."

Adam Candeub, a law professor at Michigan State University, testified that giant social media platforms are driving debate on many pressing issues, including COVID-19 and climate change, but are telling only one side of the story while shutting out opposing

"We see fewer ideas, and they're clearly having a slant," he said. "Voices of moderation are being silenced."

Dolezal said the slanting of information by social media platforms is cutting both ways.

"People on the left and right are concerned about who is doing the censoring," he said.

Dolezal said his bill would still allow social media platforms to censor sexual or violent content if they choose.

The bill now heads to the Senate Rules Committee to schedule a floor vote.

Ex-governor sole **University System** finalist

Former Gov. Sonny Perdue is poised to become the next chancellor of the University System of Georgia.

The system's Board of Regents voted Tuesday to name the Republican from Houston County the sole finalist to lead Georgia's 26 public colleges and universities.

Perdue was Georgia's first Republican governor since Reconstruction, serving from 2003 until 2011. Then-President Donald Trump tapped Perdue, an agribusiness owner, to serve as Secretary of Agriculture in 2017, and he became one of the few Cabinet secretaries to remain in his post throughout Trump's four-year term.

The selection of Perdue came after a nationwide search. The selection committee interviewed many highly qualified candidates, board Chairman Harold Reynolds said Tuesday.

The hiring process stretched out for months after former Chancellor Steve Wrigley retired last year and was succeeded by Teresa MacCartney as acting chancellor. Perdue had the support of some regents, but others were concerned about his lack of experience in education administration.

Gov. Brian Kemp

recently replaced four regents with new appointees who favored Perdue, clearing the way for Tuesday's vote, which was unanimous.

Student and faculty groups also have raised concerns about Perdue's suitability for the

Matthew Boedy, president of the Georgia Association of University Professors, is asking the accrediting body for Southern colleges and universities to issue a second warning letter to the regents. The Southern Association of Colleges and Schools Commission on Colleges (SACSOC) issued a letter last year when Perdue's name surfaced as a candidate cautioning the regents against allowing political interference in the hiring process.

"It is clear that Governor Kemp's shuffling of the board by appointing two new regents in January played a massive role in the speed at which Mr. Perdue's chances of getting the job were resurrected," Boedy wrote in an

email to SACSOC. "While legally allowed to appoint regents, the governor's move could be read as pushing off the board those who

blocked Perdue's path."

While Perdue lacks administrative experience in education, Reynolds said he will bring government management expertise and high-level leadership to his new position.

The regents will take final action on Perdue's appointment at a future board meeting, no sooner than 14 days from Tuesday's naming of the sole finalist.

Jones could bring May surprise

s the the 2022 elections near, campaigns for political seats across all levels is heating up. David Per-

due, Vernon Jones and former president Donald Trump have thrown a wrench into the race for Georgia's 10th

Congressional District.

Just days ago, after Perdue announced he would challenge incumbent Gov. Brian Kemp for the Republican nomination in the May 24 primary, Jones jumped out of the race for Georgia's governor and into the race for the 10th Congressional District seat being vacated by Jody Hice. With their decision, Trump

publicly endorsed both Perdue and Jones. I'll bet some backroom dealings between those three camps led to such a move. I mean, you can't have two "Trump men" pulling votes from each other. That will serve no one well, except maybe a Democrat challenger like Stacey

So now, in the race for our 10th Congressional District seat, there's one question left to be asked: How much Trump should a "Trump

man" stump if a "Trump man" ain't got Trump?

Mike Collins, also vying for the 10th Congressional District, was once considered the favorite to win the seat. He's been down this road before, making the GOP runoff against Hice in 2014. Collins is also a son of the late U.S. Rep. Mac Collins. And, after all, he's been a self-proclaimed "Trump man" from

But now what happens? How does Trump's decision to back Jones affect the other candidates' campaigns? Will all other "Trump men" bow out in respect to the Don? Maybe. But it appears Collins won't be one of them.

Collins sent a clear message after Jones' announcement, calling Jones "a corrupt, carpetbagging, lifelong Democrat from DeKalb County who's been accused of rape."

And although he couldn't get Trump's endorsement, he is still touting his Trump allegiance as a key part of his campaign message — a mistake in my opinion.

Collins' rape comments were in reference to Jones' time as a DeKalb County CEO when a Lithonia woman accused him of such. The district attorney eventually dropped the charges. At the time, The Atlanta Jour-

nal-Constitution reported the woman wanted to avoid the trauma of a trial. Jones declared himself exonerated.

Formerly a Democrat, Jones jumped to the Republican Party in 2020 after he endorsed Trump for reelection and spoke at the Republican National Convention. Trump is certainly returning the favor, isn't he?

Despite a what some see as a checkered past, and the fact he doesn't actually reside in the district, a few people tell me they think Jones might have a real shot to win the 10th Congressional District seat. In visits to counties that make up the district, which includes a portion of Newton, Jones appears to be saying all of the right things and at least looking the part.

Jones' decision to drop out of the race for governor was probably the best decision if he wants to win a race this year. I think his chances against Kemp were pretty slim compared to Perdue.

But in a crowded field of now 12 congressional candidates, don't be surprised if you see Jones in a GOP runoff or even come out on top.

A good Ag secretary unties farmers' hands

Dear Editor:

I grew up on an Iowa farm that had refuge for wild animals in every grove of trees, hedge or fence. Farmers there work hard to keep their water clean, to grow certain areas as wetlands, others as aerable or plowable fields, others to grow hay. Farmers understand diversification so that if one thing fails another can pull you through. We learned to save seed from the biggest best ears of corn and apples to replant and thus increase our harvests.

Your Sonny Perdue and his [cousin] David are well respected all over the nation. Farmers understand rotation of crops i.e., after a field has produced corn for a year or two it is depleted, so you plant it in clover or soybeans to replace the last nutrients. I ran and cleaned the cream separator for milk and cream that we produced too. Farmers understand spreading lime or other nutrients on fields when needed. We all carried a hoe wherever we walked in order to eradicate [weed] and thistles, kill snakes, and ward

off the bull. We fished in our own ponds, ate our own beef and pork and planted a garden of 60-plus feet by 40plus feet, canned about 1,200 jars of fruits and vegetables against winter, and ate our own berries and peaches. Here in Georgia it is blueberry bogs, pecan groves, cotton fields not to mention all the excellent deer/beef/pork processing lockers, chicken farms for eggs and meat, and the dairies here. We ought to be sounding the alarm where Georgia no longer has any huge old trees.

So I'm not too impressed by what New Yorkers know about environment and saving the planet. When government interfered and started requiring quotas of so much land for raising beef and so much for crops, they messed with our production, our seeds, our animals, etc. It is really true that the less regulation you have, the better people do on farms. Four years ago I went to walk the fields with the Iowa State extension people and learned that the government sends

planes over to photograph our farms and they prosecute farmers whose land doesn't have enough wetlands (unmowed areas). Since the 1970's it has gotten worse. The sheriff cannot keep up with the cattle rustlers, the conservationists brought back the cougar cat and diamondback rattle snake to reintroduce them to Iowa farms, streams and rivers because they had become extinct, poor things, So now a full grown cat like that nabs the cats and dogs, piglets and calves or chases down your best milk cow, runs her 'til she falls over from exhaustion and rips out her heart.

We can no longer hunt deer for meat on our own land without a license, because that deer runs across many farms and belongs to the state not to us. A good secretary of agriculture unties the hands of those who produce our food and seed and gets out of the way

GOP fiddles as Biden works to lower costs

"We've been very, very lucky. I just want you to know I believe it's coming," Cotton added. "Then we're not going to be so lucky the luck's going to run out. And I'm very, very concerned about that.'

After a series of shootings in the Nelson Heights community Feb. 4-6, Cotton told the Covington City Council during its Monday, Feb. 7, meeting that incidents involving firearms had been an increasing problem, and it needed to be addressed.

Cotton posed one way to address the issue was for local judges to come down harder on suspects and increase bond amounts. He specifically referenced dealing with two suspects.

"Why this is so worrisome for me is because we had two suspects who were arrested on Jan. 3 for pointing a gun at another individual," he said. "They were in a vehicle with an altered VIN when we got them. They had an AR-15 pistol with them with an extended magazine on it. An AR-15 pistol is basically an AR-15 rifle cut down to the size of a pistol. And they had \$7,000 cash with them. These guys don't have jobs.

"We charged each of them with two counts of aggravated assault, two counts of theft by taking, one count of altered VIN and one

count of possession of marijuana. They received an \$8,000 or \$10,000 bond and had to post 10% of it with a bail bondsman. If you have \$7,000 cash in the car, you probably have \$1,800 to get out of jail, or a family member could have posted a property bond.

"I'm very concerned that our court doesn't see the seriousness of the offenses there and letting them back out."

Cotton said he has spoken with Newton County Sheriff Ezell Brown about the issue, and they plan to talk to judges as well.

People within the communities affected most were not being vocal about the issue, Cotton said, and some would not aid police during investigations out of fear. Cotton requested the mayor and council reach out to community members and help bridge the gap.

"I'm asking your help to reach out to your constituents to get them to understand the situation and understand that we're not just filling out forms," Cotton said. "We're working as hard as we can to try to solve it, we put out a press release, we're offering a reward for information, we're waiting on the technology that will help us, such as an application you can put on your phone where if you see something, you

can send it to us. "We're trying to take proactive measures

to head this off," he continued. "So we need you to reach out to the community and tell them to please help us if they can. If they hear something or see something, call 911."

The chief said there was technology, such as new Flock cameras, on the way that would help law enforcement officers keep an eye on problematic areas. The incoming Flock cameras would have a sound element, "so if someone does shoot, it tells us where that shot came from so that we can probably get there quicker than if someone called 911," Cotton said. He continued to say officers should also be able to review camera footage to find suspects' vehicles and identify tag numbers.

Councilman Anthony Henderson said he was open to looking into expanding the surveillance system even further, specifically for problematic areas. He asked City Attorney Frank Turner, Jr., if it was illegal for the city to install cameras on light poles. Turner said it was OK, considering it was a public space.

While Cotton appeared appreciative of the idea, he told Henderson that type of project would come at an exponential cost. However, Henderson believed it was something worth looking

"We have to do something about it," Henderson said. "Based on what I see and hear daily, if we don't do something about it, someone is going to get hurt. I'm definitely for some type of surveillance in certain areas to prevent crime, because when you have people not talking, we need to do something about it."

Councilwoman Charika Davis agreed with Henderson and asked Cotton to start crunching numbers and find out exactly what that cost would be.

"I definitely think that we need to step in and do something," Davis said. "We need to do more than talk."

Councilwoman Fleeta Baggett said the situation was bothersome, as was another issue she's witnessed personally a lacking ambulance service.

Baggett recalled having a heart attack in December. While at Piedmont Newton Hospital, she said there was a more than 40-minute wait before the next available ambulance could transport her to the hospital in Rockdale for particular services.

"I didn't have 40 minutes," she said. "I could have died on the floor in my living room or at the hospital over here at Newton because we didn't have an ambulance that could transport me."

As an alternative, she was transported in a nonemergency vehicle.

Baggett suggested the

city strongly consider purchasing an ambulance that could be operated out of the fire department.

"I'd like to see it get

on the agenda as soon as possible," Baggett said. "We can't keep throwing up these apartments everywhere and have no way to look after these people ... We can't invite people to live in our city and let them die by gun fire, or whether it be because we don't have an ambulance. We have to do this. We don't have a choice."

Councilwoman Susie Keck was on board to find a solution for both issues.

"I will support anything that won't bankrupt this city so that we protect our citizens, and the same goes for an ambulance," Keck said.

While he felt the city had much work to do, Councilman Kenneth Morgan reminded council members that the shooting issue should not be seen as a racial issue, but rather a community issue.

"I just want to encourage us as a council, a city and community, that we strive to work together and not make this about any other thing than our community," he said. "It has nothing to do with

Black, white, indifferent. This is not what this is about. This is what's best for our community ... and we move forward collectively as a city and not

individuals." Nelson Heights is a predominantly Black neighborhood located in the southern portion

of Covington. Cotton said only a few injuries were reported from the four weekend shootings, but he said it could've been much worse.

"On the last [of the shootings], an officer was actually out taking a report at a person's house [on Collier Street]," Cotton recalled, "and he heard the shots, and then found out later that his car had been struck by the bullets. They were actually trying to shoot at our officer; he just didn't know it at the

"We've only had a few injuries," he continued. "Nobody has been killed, but I am concerned by it because it seems to be ramping up. And it's not just gang activity. It's people mad because somebody said something about them on Facebook ... whatever."

said. "It takes gumption and grit and conviction to be able to put on a show."

The pageant rules also require contestants to have a "social impact" initiative and explain it, she said.

"These girls are so smart," Humphries said. "They have something to say."

The eventual winner, Brittni Evans of Savannah, said she was an advocate for improving young people's financial literacy to prepare them for adult responsibilities. She is a graduate of the University of North Carolina at Wilmington.

"They definitely got the right girl," Humphries said.

Andrea Epps of Grayson was first runner-up. She was an advocate for protecting young girls from being groomed for later roles in life revolving around their sexuality, Humphries said.

Sydney Duren, an Eastside High School graduate and current Georgia State University student, was the only Covington resident in the competition. However, it is common for a contestant not to reside in the geographic area a pageant's title suggests.

Duren was named the pageant's People's Choice award winner, and Evans was its Miss Congeniality award winner, according to the show program.

Humphries is a Covington resident who competed in pageants in her hometown of Statesboro. She said her organization's focus now is preparing Evans and Epps for the Miss Georgia competition.

The family of the late Ida Davis, a longtime

Newton County educator, provided half the money for the \$1,000 scholarship. The rest came from Flash 'n Dash Car Wash, Tessa Fearon and Heartscapes of Covington, according to the program for

the event. Some others providing prizes were Woven Boutique of Covington, Covington Nutrition, Supreme Tanning, and

worth \$400 million compared to liabilities totaling \$100 million — giving it \$300 million in equity.

"If I had a balance sheet like that, I'd be pretty happy," Edwards said.

Blazing Fast

The audit document stated the firm did not find any "material weaknesses" — defined as an organization's ineffective internal controls which cannot prevent irregularities in financial statements.

However, he said one of the few recommendations in the document was adding more money to its pension fund.

Only county employees hired prior to 1995 are on the plan, said Finance Director Brittany White. It includes 20 active employees and 130 retired employees who are receiving benefits, she said.

Edwards said the plan is funded at 65% and the "best plans" are funded at least 85%.

"You won't make it the next generation's problem," he said.

District 4 Commissioner J.C. Edwards said he wanted to consider adding more employees to the pension program. Chairman Marcello Banes said he planned to present such a plan to the Board as part of the 2023 budget

Former county manager Lloyd Kerr was responsible for working with White and her predecessors annually since 2016 to present the annual budgets to Board members before they made their own changes and approved them.

The budget's General Fund increased from \$69.0 million in 2019

to \$76.2 million in 2021 while increasing its reserves and rolling back its property tax rate in 2022.

Commissioners openly praised White for the audit findings.

District 5 Commissioner Ronnie Cowan said Tuesday the audit showed the county is "in good financial shape."

"Y'all remember about five years ago — we were broke," Cowan said. "I think it's indicative that we toed the line on some tough decisions.

"When we took this job, I know Stan (Edwards) and I did, we were elected to solve problems. We're working on that.

"We've not always agreed on things," Cowan told commissioners. "In the long run, we've come out on top so the county's in good financial shape."

District 1 Commissioner Stan Edwards said, "Five years ago when I came into office there was (\$5 million) in the fund balance and we were struggling to make things work financially."

"Fiscal conservatism through a culture change, common sense approaches and solutions has helped moved us to where we are now financially," Stan Edwards said. "County employees adopted this culture as well and they are responsible, primarily, for our financial

status as a county. The Board's challenge moving forward "will be to resist the temptation of 'blowing' our savings (and) returning us to a tenuous financial scenario." Edwards said.

Online registration will be available on the district website, www. newtoncountyschools. org and registration packets may also be obtained at each elementary school.

School System has Pre-K slots available at 13 elementary schools and Newton College and Career Academy for the 2022-2023 school year. Children will not be placed on

the roster for possible selection until all required documents are submitted.

Only custodial parents and legal guardians may register a child for Pre-K. Please note that registration does not guarantee children a slot in the Pre-K pro-

Once registration has concluded, students with all documents submitted will have their names placed in a lottery drawing for their school zone for possible selection.

Only students with completed registration packets will be eligible for participation in the school system's lottery selection process.

Pre-K enrollment is determined by school attendance zones. Once all slots are filled, the remaining names will be placed on a waiting list in the order they were drawn during the lottery process and will be called if and when spaces become available. Children must be 4

years old on or before Sept. 1, 2022, to qualify for enrollment. To register a child for the Newton County Pre-K program, parents should bring a certified birth certificate and two proofs of residence/address — one from each of the two categories

below:

- Category 1: Utility bill such—electric, gas, garbage, or water bill in the name of the person enrolling the child, and,
- Category 2: Current lease, rental agreement, or mortgage statement from the purchase of a

home. Telephone bills, post office addresses, car licenses, credit cards, and Medicaid cards will not be accepted as proof of residence.

If the child does not live with one or both parents, guardianship or custody documents must be presented.

Should the child and parent/guardians live with someone else and not have a proof of address in his/her name, a Statement of Legal Residence/Affidavit of Parent/Guardian is needed.

Bring the affidavit completed, signed and notarized, along with the two proofs of residence in the name of the person who owns the property. An affidavit can be

obtained from any elementary school and the Newton County Board Office. A notary will be

available at registration. If you choose to have your paperwork notarized using the free

"If selected as district winners, the students' names are submitted to the Governor's Office of Student Achievement (GOSA).

The students are next contacted by GOSA to complete a state application in efforts to be selected for state interviews. If selected, students become semifinalists and then compete in state interviews.

COVINGTON, Ga. — Just a few short years ago, Eric Stokes was wearing green and silver for the Eastside Eagles football team. Now, he just concluded his rookie season donning green and yellow as a member of the Green Bay Packers and earned All-Rookie honors.

Stokes' NFL career began on April 29, 2021, when the Packers drafted the Covington native with their 29th overall pick in last year's draft out of the University of Georgia.

Stokes didn't earn a starting role until week three of the NFL season, but he made the most of the opportunity given

During his rookie year, Stokes played close to 1,000 total snaps while recording 52 tackles, 40 of which were solo, and had 14 pass deflections. Stokes also collected his first career interception in week four against Ben Roethlisberger of the Pittsburgh Steelers.

Among rookies, Stokes placed first in forced incompletions as well as pass breakups. He was also third in passer rating for opposing quarterbacks, too.

When the regular season ended, Stokes was one of only two rookie cornerbacks in the NFL to play in all 17 games. He also played 86.7%of all defensive snaps for the Packers, which led all Green Bay defenders in 2021-22.

With the Packers being eliminated on Jan. 22 by the San Francisco 49ers in the Divisional Round, Stokes' rookie campaign, therefore, came to an end as well.

But, at the season's end, Stokes was named to the NFL All-Rookie team for his contributions in Green Bay.
