Deputies: Woman impersonated student at school

COVINGTON, Ga. -A19-year-old Conyers woman allegedly was able to impersonate a student and gain access to Newton High School with a taser before she and a female student threatened a male student Friday, Feb. 3.

The action led to a "brief lock-

down" of the school and multiple charges against the female student and the woman, a school spokesperson said.

Gabrielle Randolph, 19, of Conyers, was arrested on charges of Carrying Weapons in a School Safety Zone, Criminal Trespass and Disorderly Conduct.

A 17-year-old student, Arianna

King of Covington, was arrested and charged with Disorderly Conduct and Terroristic Threats and Acts, both in relation to the 8 a.m. incident.

Sherri Partee, spokesperson for the Newton County School System, confirmed "an unauthorized

Site for Youth **Center stirs** controversy

COVINGTON, Ga. — The courtroom that holds the bimonthly Newton County Board of Commissioners meetings was packed to the brim on Tuesday with a crowd that represented a microcosm of Newton County's diversity, and that not just ethnically speaking.

The array of opinion and discussion surrounding the site for the proposed Westside Youth Facility has been plenteous, but the speculation on where it would be located ended Tuesday.

That's when commissioners voted to select a four-acre site owned by John Addison Jr. at 11869 See SITE, A2

Groundbreaking set for Whataburger at Town Center

COVINGTON, Ga. — Whataburger will bring 150 jobs to Newton County when its new Covington restaurant opens later this year.

Officials with the restaurant chain, franchisee Made to Order Holdings LLC and the Newton County Chamber of Commerce will hold a groundbreaking ceremony on Wednesday, Feb. 15, to celebrate the first Covington Whataburger restaurant scheduled to open in 2023, a news release stated.

The event is set for 2:30 p.m. at the future site of the planned 3,746-square-foot restaurant at 11200 Town Center Drive.

"We could not be more excited to bring Whataburger's fresh, bold flavors and extraordinary hospitality to the Covington community," said Key Operator Scott Jordan-Wheeler. "The Atlanta market has been so incredible and welcoming. We look forward to continuing to serve the area and opening our doors in Covington later this year."

ness license in Newton County or a municipality within county lines.

That call was answered by commissioners voting 3-2 to, making that stipulation a county requirement.

The vote came after Newton Chamber of Commerce Debbie Harper used her time in the meeting's initial citizens' comments portion to make that recommendation.

"As the president of the Chamber, I represent 600 businesses in Newton County that equates to 20,000 employees in and around this area," Harper said. "We know (a county business license) is not a requirement by the treasury, but it is a requirement in the county, and we feel that should be mirrored here."

Harper cited other counties and cities near and around the Newton County area that have a similar policy —places such as Clayton, Henry and Cherokee counties, and the cities of South Fulton, Stonecrest, Conyers and Norcross.

When it came time for item No. 12 on the BOC agenda to be discussed, Commissioner Stan Edwards posed the question of how that Harper's stipulation could be introduced for a vote.

District 3 Commissioner Alana Sanders objected to the requirement, stating that adding it would

"eliminate so many businesses that are in need right now."

Beforehand, the only requirement needed for a local non-profit organization or business to receive ARPA funds was a license recognized by the state of Georgia to conduct business. When the question was asked by Edwards if it was a requirement in Newton County for businesses to have a license in Newton County, county attorney Patrick Jaugstetter provided the desired insight.

"As a general rule, yes, it's required to pay an occupational tax in the county," Jaugstetter said. "Some businesses have multiple locations and wouldn't have to pay for a separate one in each county they operate in, but as a general rule, it's a requirement."

Harper said it was the right thing to do for the sake of congruency.

"The Chamber, as the voice of business in Newton County, felt strongly that since Newton County requires a business license to operate a business here, so should be the requirement to receive ARPA funds from the county," Harper said.

"It's not a federal requirement because some communities much smaller than ours don't require a business license."

individual was reported on campus at Newton High School" Friday, Feb. 3.

"In response, the school was immediately placed on a brief lockdown," she said. "The individual was quickly located by school administrators and school resource officers."

Partee said "a search of the individual was conducted." Officers found what was identified as a pink Vipertek two-pronged taser, according to an incident report.

"Newton High School resumed normal operations within minutes and notified parents of the situation via School Messenger call," Partee said.

She said the "safety of our students and staff will always be our No. 1 priority."
"As such, we appreciate the

immediate support of local law

enforcement, who together with school administrators, quickly located the unauthorized individual," Partee said. Randolph allegedly gained access to the Newton High School building

without checking into the office, according to information on warrants and an incident report.

"She was carrying a book bag

pretending she was a student at the school," a warrant stated.

A school resource officer wrote

in an incident report that Principal Shannon Buff called all administrators and SROs to her office at 8:40 a.m. and "advised us that a male student told her that a female approached him to fight in the hall-way that's not a student here at the school."

He reported Buff later "pulled up

the school's security camera" with the male student present and discovered the location of the suspect in a bathroom on B hall. After the suspect was taken into

custody, she attempted to damage a cabinet in the SRO's office, a warrant stated.

"The offender was yelling and

screaming very loud and using profanity against me and other deputies. She also was refusing to be escorted from my office to the patrol unit ..." the SRO wrote in a warrant.

King was charged after threatening "to use an act of violence against another by stating multiple times that she knew who told on her girlfriend about being on campus at Newton High School and she was going to 'take care of him," a warrant stated.

"Ms. King said she knew where he lived and she would go take care of him," the SRO stated in a warrant, in reference to the male student who was allegedly threatened. "Ms. King made multiple state-

ments in different ways that she

knew who the student was that alerted school staff to an unauthorized person being on campus, causing the school to go on a preventative lockdown. The unauthorized person was Ms. King's girlfriend, Gabrielle Randolph, who was also arrested.

"Ms. King stated multiple times

"Ms. King stated multiple times in front of myself, Deputy Herbert and school staff that she would take care of him and she knew where he lived. Ms. King said she knows where he lives and she will find him and kill him."

King also was charged with Disorderly Conduct when she "pushed against Deputy Simmons multiple times after being asked to sit down multiple times."

"Ms. King had already been placed in handcuffs and was being told to stay in the principal's office while it was determined if she had brought any illegal items on school campus or had any in her belongings. Ms. King yelled and began screaming to let her go so she can calm down her girlfriend. Ms. King also kicked the principal's door."

Randolph and King were each released from the Newton County Detention Center on bond Sunday, Feb. 5.

Brown Bridge Road over the objections of two commissioners, District 3 Rep. Alana Sanders and District 4 Rep. J.C. Henderson, who claimed both retaliation for unilaterally seeking a grant for the project and alleged racism on the government's part.

The board voted 3-2 to select the site with Sanders and Henderson

voting against the plan. But it wasn't just the

commissioners expressing dissension.
The site is adja-

cent to the Trelawney subdivision and backs up to a separate 11acre tract the county government has owned since 2015. That drew the ire of Trelawney Home Owners' Association president Annette Alston.

CITY OF PORTERDALE FISCAL 2023 BUDGET ADOPTION

The City of Porterdale will hold a public hearing on Thursday, February 16, 2023 at 6:30 pm to take public comments on and review the proposed Fiscal 2023 Budget. The adoption of the Fiscal 2023 Budget and Resolution will be considered on Thursday, February 23, 2023 at 6:30 pm. Both meetings will be held at the Porterdale City Hall at 2800 Main St in Porterdale GA.

Alston said she, and some of the residents in the Trelawney subdivision, felt slighted because the decision was made without communicating with Trelawney residents.

"In July 2022, there was a meeting with a number of planners and Commissioner (J.C.) Henderson about a proposal to create a community park utilizing the common area of our subdivision," Alston said. "We listened and made it clear that we were not interested at that time because there were too many unan-

swered questions.

"None of those questions were answered and there was no effort to have any further discussion with the community. Meantime, we find out that, without our knowledge, consultation, anything, that the Addison property

adjoining Trelawney is being given to the Boys & Girls Club."

The Addison property will be donated to the Boys & Girls Club and given to the county for the youth facility at no charge. However, the deal stipulates a 113-year-old house on the property must be retained and included in the Westside Youth Facility building plan, according to a report in The Newton Citizen.

It is the same property commissioners had considered accepting as a donation for use as a park in October 2021, according to a previous report in The Covington News.

Alston said that the biggest issue wasn't the presence of the Boys & Girls Club, but rather the lack of communication to the Trelawney residents.

"Now, to be honest,

I'm not sure our community would be totally averse to a Boys & Girls Club-type facility next

door," she said.

"But that's the point. You didn't ask us. And what makes this particularly sad is the appearance that the Trelawney Subdivision is being used in a sick, mean-spirited political game and we're the pawns. We're not in Sanders' district. We're in District 4."

Henderson said he believed the county was forcing the facility on the area's majority Black residents in a way that was similar to how majority white governments forced such projects on Black neighborhoods in the past in the U.S.

Sanders said she opposed it because residents told her in a meeting earlier this month they did not want it on the site.

The commissioner has lobbied for the facility for months and wanted it built on a separate 60-acre tract near Fairview Road in her district.

However, county officials said the sellers of the Fairview property wanted more than the appraised value of \$2.3

million, according to the

Citizen.

Sanders accused the other commissioners of making her the victim of political payback for pursuing a \$4 million federal grant for the Youth Facility separately from the county

government.

As far as the facility and the grant itself, other residents expressed comments fueled by earlier reports that the \$4 million grant was in jeopardy of being rescinded. That report proved to be inaccurate, but it didn't keep residents from sounding off about it Tuesday.

"I'm standing up tonight for the youth of Newton County and the seniors of Newton County," said Cecily Bell during the meeting's opening citizens' comments portion.

"We need the money for the youth. We need the money for the seniors. We need those finances here in Newton County. We need those community centers to be built. The ones who did not vote for this are causing us to fail."

Senate bill bars blocking access to government services based on vax status

The state Senate passed legislation Tuesday that would prohibit government agencies from requiring proof of COVID-19 vaccination to access government facilities or services.

The bill continues a long debate about what role COVID vaccinations should play in public life in Georgia after they first began to be administered in December 2020.

Last year, the General Assembly enacted a measure barring the use of a person's COVID vaccine status to prevent access to government facilities, services or licenses. The law included an automatic repeal date of June 30, 2023.

The new Senate bill would remove the repeal date, making the provision a permanent part of Georgia law. The bill passed the Republican-controlled chamber by a 31-21 party line vote.

"The fundamental question that this bill addresses ... is whether or not the government should deny services to its citizens based on their COVID-19 vaccination status," said Sen. Greg Dolezal, R-Cumming, the bill's main sponsor.

"Ultimately, by voting 'no' for this [bill], you're not voting for public health. You're voting to allow government to deny a license to someone because they don't have the COVID-19 vaccine."

Senate Democrats opposed the measure, arguing the bill politicizes what should be a public health matter.

Sen. Nan Orrock, D-Atlanta, said vaccines have driven the decline in the severity of the COVID-19 virus.

"Newsflash: That [decline is] because we developed a vaccine," Orrock said. "This nation should take public health measures to protect the population from a

dread disease."

"A permanent ban sets a dangerous precedent, which may lead to erosion of vaccine requirements for school attendance," added Senate Minority Leader Gloria Butler, D-Stone Mountain.

The Georgia chapter of the American Academy of Pediatrics and the American College of Physicians oppose the bill, Butler said.

Georgia has had more than 3 million confirmed COVID-19 cases and more than 42,000 deaths, according to the Johns Hopkins University Coronavirus Resource Center. About 58% of the state is fully vaccinated.

The bill now moves to the state House of Representatives.."

VP touts Biden administration climate agenda

The Inflation Reduction Act (IRA)
Congress passed last year includes nearly
\$370 billion to address climate change, enough to launch a "whole new industry," Vice President Kamala Harris said Wednesday on the campus of Georgia

Tech in Atlanta.

"There are going to be a lot of new jobs, a lot of new work," Harris said during an appearance promoting the State of the Union message President Joe Biden delivered Tuesday night. Biden was promoting his speech to the nation almost simultaneously with Harris during a presidential visit Wednesday

to Wisconsin.

Harris' remarks in
Atlanta were focused
on the portion of the
State of the Union message in which Biden
called climate change
"an existential threat"
that the IRA will begin
addressing with "the
most significant investment ever in climate
change."

Harris, America's first Black vice president, said she approaches climate change from the perspective of the need for environmental justice.

"Some of the poorest air quality zones in our

nation are where people of low income and people of color live," she said.

Harris said the same dynamics are at play when it comes to water policy in America, citing the discovery in 2014 that the water supply in mostly Black Flint, Mich., was contaminated with lead.

"Access to clean water should be a right and not just a privilege to those who can afford it," she said. "Government should be paying to remove those pipes. We shouldn't be putting it just on the residents and homeowners in those communities."

The government is striking another blow for environmental justice in the tax rebates being offered to Americans who purchase not just new electric vehicles but used EVs, Harris said.

"Everyone should be able to participate in this new clean energy economy," she said.

Harris said the Biden administration feels a sense of urgency when it comes to dealing with climate change that is already causing a rise in droughts, wildfires, floods, and hurricanes.

"The clock is not just ticking," she said. "It's banging. It's requiring us to move quickly."

Republicans criticized Harris' trip to Georgia.

"While hardworking Georgians ... are burdened by the high cost of everyday goods, Kamala Harris' visit today proves just how out of touch this administration is," said Ronna McDaniel, chairwoman of the Republican National Committee, echoing Arkansas GOP Gov. Sarah Huckabee Sanders' Republican response to the State of the Union address.

"Instead of spewing more of the same empty rhetoric that Biden delivered last night, Democrats need to take accountability for their failures on everything from rising prices to skyrocketing crime."

Supreme Court upholds referendum opposing Spaceport

The Georgia Supreme
Court Tuesday upheld
a lower court ruling
verifying the validity
of a voter referendum
in Camden County last
March that rejected
plans to build a commercial spaceport.

In the referendum, Camden voters soundly defeated the county's plan to purchase land for the proposed Spaceport Camden. The county, which had gone to probate court before the referendum to try to block it, appealed to the state Supreme Court after the vote.

In oral arguments before the justices last October, lawyers for Camden County argued the Georgia Constitution's Home Rule Paragraph does not allow local voters to veto a county commission's resolution after the fact.

Lawyers for the project's opponents, registered voters who gathered petition signatures to force the referendum, countered that the vote was valid under a plain reading of Home Rule.

In Tuesday's unanimous ruling, the state Supreme Court agreed with Spaceport Camden's opponents, declaring that the county had no legal authority to try to block the referendum.

"The Home Rule Paragraph makes no provision authorizing a county, or any other party, to file a caveat, or any other form of opposition, to an electors' petition," Justice Carla Wong McMillian wrote for the court.

"With respect to

challenging an election, the statute governing contests to elections ... limits the right to contest elections to 'electors.' Because the county is not an elector, it would not be authorized to contest the outcome of the special

Camden County's political leaders have sought to build a space-port for years, claiming it would bring jobs and economic development

to southeast Georgia. The county has spent \$12 million pursuing the project.

Opponents say firing small rockets from Spaceport Camden over populated areas of Little Cumberland Island, just off the coast, would pose a major safety risk.

The National Park Service – which operates the Cumberland Island National Seashore – and environmental organizations worried about the spaceport's impact on a fragile coastal ecosystem have also expressed reservations about the project.

Tuesday's ruling didn't bring to an end to the litigation surrounding Spaceport Camden. A federal lawsuit challenging the Federal Aviation Administration's issuance of a launch permit in December 2021 re-

mains pending.
Opponents of Spaceport Camden also
have filed a lawsuit in
Camden County Court
seeking the release of
public records concerning the project.



our county under the bus. It really is a genuine question I have.

It's a question that's sort of always hung out in the deeper recesses of my mind. I've attended a few BOC meetings in person. I've also watched most of the others I didn't physically attend online, and, I don't know. It just feels as if it could run a little smoother — perhaps a bit (OK, a lot) shorter?

This question pushed all the way to the forefront of my mind after I spent almost four hours with BOC meeting work this past Tuesday night, including the almost three-and-a-half hours spent in the meeting itself

hours spent in the meeting itself.
Now, I am aware that I'm
on the outside looking in on
this. I know that each meeting
is almost sure to be packed
with pertinent and sometimes
complex matters for the greater

Show District 4 the same respect as others

Dear Editor:

Greetings Chairman Banes and Commissioner Mason, thank you for taking some minutes after the meeting to talk to me about the Boys & Girls Club. I'm glad Commissioner Sanders will have a park in her district. Though after all of the work that she's done, it's clear her district deserved more.

I understand that a vote was taken yesterday, Feb. 7, at a special call meeting to use the Addison property for the Westside Youth Center. But it appears this vote was out of order and it needs to be rescinded.

Though it was an open meeting, there was no space on that agenda for public comment. You voted to have this facility placed on a property without reaching out to the community and asking them what they wanted or involving them in any way.

To make matters worse, you shut out the community by voting to have this facility placed on the Addison property during a special session meeting, without to my knowledge, it ever having been an agenda item in a regular board meeting. And even if it was at some time an agenda item, this should have been voted on during the regular meeting. Then, when the community came out to the regular meeting, after sitting through listening to your vote, you forced them to wait more than three hours after the regular meeting to be heard in public comments.

The special called meeting public notice stated the subject as "land acquisition." It was not stated as "the West Side Youth Center location." This is deceptive. Decisions like this should not be kept from



Panel OKs raising truck weights after lengthy hearing

Capitol Beat News Service ATLANTA — Legislation to increase the limit on commercial truck weights in Georgia cleared a state House committee Thursday over the objections of local government officials, traffic safety advocates, and the Georgia Department of Transportation.

The House Transportation Committee approved the bill 18-11 following an afternoon-long hearing that lasted more than five

House Bill 189 would raise the legal limit on commercial truck weights in Georgia from 80,000 pounds to

In reality, trucks weighing up to 95,000 pounds already are being allowed in the Peach State under an emergency order Gov. Brian Kemp signed nearly three years ago at the beginning of the pandemic, said Rep. Steven Meeks, R-Screven, the bill's chief sponsor.

While truck weights have been a contentious issue the General Assembly has debated for years, supporters said the three years of experience with the emergency order are good reason to approve higher truck weights permanently.

A coalition of Georgia's agriculture and timber industries support

Will Bentley, president of the Georgia Agribusiness Council, said the proposed increases in truck weights would let farmers move their products on fewer trucks, saving 172,000 truck trips per year, according to a University of Georgia study.

Fewer truck trips translate into savings for local businesses, said Toby McDowell, who runs a logging company in Butts County.

"I'm one of the few people who can say the pandemic saved my business," he said.

McDowell said his company was struggling before Kemp's executive order allowed him

to reduce the number of trucks he uses to haul logs from nine to five while carrying the same amount of freight.

But local government officials said the legislation would damage local roads and bridges that rural cities and counties on tight budgets would be hard pressed to repair.

"Rural counties have a hard time keeping our roads maintained," said Nancy Thrasher, a county commissioner in Lamar County. "I guarantee you local government officials ... are going to get more calls from citizens complaining about closed bridges

[and] potholes." Georgia Commissioner of Transportation Russell McMurry said his agency would be forced to redirect funds from critical highway projects to repair the damage the legislation would cause.

He put price tags on what House Bill 189 would cost the DOT: \$500 million a year to rebuild state roads that would be damaged because of the higher truck weights and \$7 billion to replace 1,408 bridges that would be posted as unsafe for heavier trucks.

McMurry said the projected growth of freight traffic in Georgia will more than offset any reduction in the number of trucks on the highways that would be possible with heavier

importance to them.

Also, I feel like the citizen's comments portions could be revamped some to help citizens feel more like their concerns are being heard and responded to. In this past Tuesday's meeting, I walked into a packed room with many people wanting to discuss the Westside Youth Facility and ARPA funding processes among other things. I quickly learned that there's no shortage of passion in our county on such matters, and that's a good thing.

I've worked in communities where, regardless of how important the matter, it almost always got discussed in a mostly empty room. The people just didn't care enough to show up and make their voices heard. That's definitely not so in Newton County. And while some may be annoyed about it, I hope it never changes, because community passion that shows up vocally is a sign that you live in a healthy, vibrant community that wants to grow the right way — even if everyone doesn't always agree on the methods to achieve

However, the way citizens comments is done now feels...incomplete.

For example, the citizens comments portion toward the beginning of the meeting limits citizens to comment on agenda items only. One individual stood to talk about a particular item on the agenda. Her comments morphed into a matter regarding the Youth Facility that wasn't on the agenda. She was able to continue her comments.

A couple of people later, another person wanted to share on that same topic but was halted because it was said that the youth facility was not on the agenda.

"But the other person got was just talking about it," was that citizen's reply. And she was right. Therefore, I can see how that someone could've walked away feeling like one person was heard but the other was not.

Also, I'm not a fan of how commissioners are not allowed to provide at least some response to citizens comments - especially when a citizen is asking a particular question. I know that they make themselves available after the meeting to talk with people individually. But, again, when you're meeting goes almost to 11 p.m. in the middle of a work week, how many people can really afford to sit around for

that long? I know you can't answer everyone's concerns, and you certainly can't be exhaustive, because that would likely create a free for all that wouldn't be good for anyone. But I often wonder if the questions and issues that citizens bring up in the comments portion of meetings ever truly get resolved?

It just feels like they say their piece, the commissioners nod and smile, and that's it. My heart went out to one man in particular on Tuesday night who raised a question about being able to have more than one visitor at a time to inmates in the county jail.

He spoke of how his wife, who was in a wheelchair, had a hard time being able to see their son who was an inmate because the one person rule did not allow for someone to wheel her to the area to see her son.

His three-minute time limit came and went before he was fully able to articulate the concern, and it was, again, one of those matters where you just wonder: Does anyone ever pick these issues back up and try to bring resolution, or at least respond in such a way to where citizens

feel seen and heard? Perhaps a regrouping of agenda topics and a streamlining of discussion among commissioners may give a little more time for citizens to be listened

to and responded to. Perhaps adding more work sessions, sort of how the school board does, to allow commissioners opportunities to get some of the questions and discussion out of the way, would cause for a more crisply run Tuesday night with less citizens walking away from

a marathon meeting still unsatisfied with the answers and level of interaction they're getting from the board members who are supposed to be working for them.

As with anything, there's not going to be a perfect solution that makes everyone happy. But, if it isn't something that's already on the minds of our BOC members, I hope it is. It's never a good thing when those whom you work for feel they are being unheard. I know you'll never make anyone happy, but I don't think that absolves us from trying to make things better for the greater good of those who elected our government officials in the first place.



Congressman visits border

EL PASO, Texas — U.S. Rep. Hank Johnson, D-Stonecrest, recently toured El Paso and the border as part of a delegation led by U.S. Rep. Veronica Escobar, D-Texas.

Johnson traveled to Texas Feb. 4 to get a comprehensive look at the challenges migrants and federal law enforcement agents face along the border.

"It was important for me to see for myself the impact of an outdated immigration system affecting both migrants and law enforcement as Democrats continue the fight for meaningful reform in Washington," he said.

Johnson represents Georgia's 4th Congressional District that includes part of Newton County.

People directly affected by the severe storms and tornadoes may visit the recovery center, apply with FEMA online at DisasterAssistance. gov, call 800-621-3362 or download FEMA's mobile app (select Disaster Resources and click on Apply for Assistance Online).

For needs directly related to the Jan.12 weather systems, FEMA may be able to provide Individual Assistance grant money that does not have to be repaid for:

- Rental Assistance if you need to relocate because of storm-related damage
- Personal Property that was damaged or destroyed by these weather events
- Lodging Reimbursement if you had to stay in a hotel temporarily
- Basic Home Repairs for homeowners whose primary residence was damaged by these weather events

State of the Union

Newton reps' reactions vary widely

WASHINGTON — As expected, Newton County's two congressmen had widely varying reactions to President Joe Biden's State of the Union address Tuesday with one highly critical and the other sav-

ing it was "forceful" and "positive." Biden exhorted Congress to work with him to "finish the job" of rebuilding the economy and uniting the nation as he delivered the address aimed at reassuring a country beset

by pessimism and fraught political divisions. The backdrop for the annual address was markedly different from

Collins the previous two years, with a Republican speaker now sitting expressionless behind Biden and newly empowered GOP lawmakers in the chamber sometimes shouting criticism of him and his administration.

In his speech, Biden sought to portray a nation dramatically improved from the one he took charge of two years ago: from a reeling economy to one prosperous with new jobs; from a crippled, pandemic-weary nation to one that has now reopened, and a democracy that has survived its biggest test since the Civil War.

U.S. Rep. Mike Collins, R-Jackson, of Georgia's 10th Congressional District, released a statement after hearing his first State of the Union address as a member of Congress following his November election.

"Two years of Biden's failed leadership and

America last policies have devastated our country, and no amount of lipstick is going to make this pig pretty," Collins said.

"With historically high inflation, an out-of-control southern border, and energy prices remaining stubbornly high, the Biden administration can only be characterized as an abject failure with no intention of changing course."

U.S. Rep. Hank Johnson, D-Stonecrest, of Georgia's 4th Congressional District, said, "Despite the unfortunate and unprecedented level of Republican heckling, (Tuesday) night President Biden delivered a forceful, positive and inspiring message to American people that the state of our union is strong, but

there is a lot more work to be done. "If Republicans and Democrats come together like we did last session, we can finish the job."

"Big 3" has eyes on state title in senior seasons

COVINGTON, Ga. — Hanging at the top of Newton High School's gymnasium are region championship and state playoff banners.

There is an array of Elite Eight and Sweet Sixteen banners in the rafters, but only one lonely state title banner from Newton's boys basketball team — the 1964 state crown won by the Rams.

Nearly 60 years later, Newton's star players

— Stephon Castle, Jakai Newton and Marcus
Whitlock — want to be responsible for giving that
banner some company.

In fact, that's been their main mission since day one at Newton

"It's our last year," Newton said. "It feels like yesterday we came in as freshmen, but the time went by quickly. It's our last go round at it."

The trio has seen the program steadily inch closer and closer to capturing a state championship.

At the end of their freshmen seasons, the Rams finished in the Sweet Sixteen. A year later, Newton progressed to the Elite Eight before being eliminated. And just last season, the Rams were knocked out in the Final Four.

Now, Castle said they're ready to get over the hump.

"I think we can go all the way," Castle said. Castle is a 5-star combo guard committed to UConn basketball while Newton is a 4-star Indiana signee. Meanwhile, Whitlock seems to be the most overlooked of Newton's current "Big 3."

Nevertheless, Whitlock is considered a vital part to the Rams' chances at state supremacy. So much so that, unlike last season, Whitlock is in the starting five.

"I've got a heavier load this year," Whitlock said. "I just come into every game ready to play. This time I feel like I've got to come in and fight more because it's my last year. We want to win."

Meanwhile, Jakai Newton has dealt with a knee injury in his senior season. As a result, he's missed out on most of this year.

But Newton had his triumphant return to the court on Friday, Feb. 3, at Archer. He had a few high intensity dunks that got the crowd on its feet

Now back from being sidelined, Newton is eager to help the Rams the rest of the way.



COVINGTON, Ga. — Eastside's boys basketball program has had possibly one of the best seasons in recent memory. Part of the success has been the fact that the Eagles receive contributions from all over the floor.

There is one player, though, whose play stands above the rest Kassen Saunders.

Saunders' take on what makes this Eagles squad better is sim-

"The biggest difference from last year with my new team is we come together as a team," Saunders said. "We figure out tough battles as a group and we have great chemistry."

It is not a far stretch that one of Saunders' favorite basketball players is Stephen Curry of the NBA's Golden State Warriors. Like Curry, Saunders is a threepoint maestro.

At season's end, Saunders ranked third in Class AAAAA with 46 made three-pointers. His practice regimen isn't anything elaborate, either. Saunders said he aims to shoot 50 three-pointers in practice and before each game.

Throughout his senior season, though, Saunders has been working to improve his ability to penetrate the paint and finish at the rim.

Long before Saunders was

leading the Eagles on the hardwood, he was already hooked on the game.

"I have been playing basketball for 13 years," Saunders said. "I started off at the YMCA and playing with the Choice Management Knights when I started to start loving the game."

There is one person, in particular, that Saunders credits for getting him involved in the sport he now loves and excels at.

"My pops got me interested in basketball," Saunders said. "We played basketball outside all the time and just grew to love it and work harder."

Saunders continued by saying his parents and grandparents are his biggest motivations to do well on and off the court.

The senior guard leads his team in scoring averaging 12.8 points per game with a teamhigh 49% three-point shooting efficiency.

His performance has played a pivotal role in Eastside's 20-5 overall record and 9-3 Region 8-AAAAA mark, which places the Eagles in third place and one game out of first in the region.

One of Saunders' favorite things about this season has nothing to do with the games themselves.

"I love my teammates and coaching staff," Saunders said. "It feels like home off and on the court."

"For our team this year we have to come into the playoffs with 'benengry' and a focused mindset to win." Saunders said. "We want to beat anything that gets in front of us as a team."
