Former manager alleges racial discrimination

Planned lawsuit points to social media posts, conversations as evidence two commissioners wanted Black person to replace Kerr

COVINGTON, Ga. — The county's former manager says in a complaint to a federal agency that two Newton commissioners have "a history of publicly advocating" for African Americans to hold all county government leadership positions and "made comments on both social media and to other

commissioners regarding their intent to hire an African American to replace me."

Lloyd Kerr, who is white, stated in a complaint to

the Equal Employment Opportunity Commission that



commissioners Alana Sanders and Demond Mason, who are Black, "have posted videos on social media taking that position, making clear they harbored racial animus in opposing my holding the position of county manager and voting to non-renew my employment."

In addition, Kerr's attorney, Edward Buckley, sent a notice to Newton County

Tuesday, Jan. 18, that stated Kerr plans to sue the county in federal court because of the Board of Commissioners' action not to extend his contract past Jan. 1 because of his race unless a settlement can be reached.

"If the county is not willing to engage with us to resolve this matter by Feb. 1, 2022, Mr. Kerr will proceed with the investigation of his

allegations," Buckley said. "If we are not able to resolve this matter, we will file a federal lawsuit."

Buckley told The Covington News that "some of these Board members have been very vocal concerning their desire to hire people who are not (Kerr's) race."

"It's illegal to, first of all,

Newton County

Commissioners say no to state proposed district changes

COVINGTON, Ga. — Newton County commissioners Tuesday voted not to approve changes to their district lines that a state panel proposed based on population shifts since 2010.

However, a state senator representing Newton indicated local legislators are also working on a version of the district map and it could be sent for Senate consideration soon.

District 17 State Sen. Brian Strickland, R-McDonough, said Wednesday the county's legislative delegation has been working on a map that should be finalized in draft form.

"I have personally been in conversations with my colleagues in both chambers over this past week in finalizing a draft that I hope we will file in the Senate next week," Strickland said.

He said he was "not certain what is going on with the Board of Commissioners and the map they were considering" but he felt "confident that our legislative delegation will get this done without any

Board extends moratorium on new residential rezonings


Commissioners halt plan for new Dollar General on Brown Bridge Road

COVINGTON, Ga. County commissioners stalled a plan for construction of a Dollar General on Brown Bridge Road after a county commissioner said area residents wanted stores "that fit them" and said the retailer allegedly disregarded customer service and security at

They also voted Tuesday, Jan. 18, to extend a moratorium on new applications for rezonings and preliminary plats for residential developments until April 19 — though new plats that feature minimum two-acre sites would be

its other locations.

allowed to proceed.

District 3 Commissioner Alana Sanders said she was responding to residents' wishes in asking the Newton County Board of Commissioner to vote to deny a condition-

al use permit for the 10,640-square-foot store after a Jan. 6 community meeting that allowed live attendance and was livestreamed.

Sanders said nearby Fairview Road residents have incomes of \$65,000 to \$70,000 "and some making six figures."

"They love growth. They want to have growth. But they want to have stores that are in their area that fit them and that's what they want in the area where they live," she said.

"Dollar General has a culture of a lack of quality customer service and ample security," Sanders said, in quoting residents' complaints.

Residents also com-

plained that no traffic signal was planned at the intersection where the three-acre site is located, she said.

She said they also complained that Dollar General stores on Salem Road and Hwy. 81 each had been robbed at least once in less than five years; and Bell's grocery store already operates nearby on Brown Bridge Road, Sanders said. Dollar General also offers groceries in its stores.

"I'm a commissioner who listens to my citizens who actually voted me in," Sanders said. "They live in the community."

Sanders also said residents complained a Dollar General store was located "less than a mile away" on Salem

However, a check of the distance on Google Maps showed the store at 3227 Salem Road is almost five miles from the site.

Before the unanimous vote for denial, County **Development Services** director Judy Johnson told commissioners the planning staff had recommended they approve the permit based on the developers, SW West Covington LLC and Johnbolt Properties LLC, agreeing to a series of conditions.

Some conditions included installation of an eight-foot wooden privacy fence and landscaping along the north edge of the site to buffer it from a neighboring property on Kirkland Road; and construction of a deceleration lane for vehicles entering the store site from Brown Bridge Road, Johnson said.

A site plan already included a 20-foot buffer area that included a three-foot landscaping area along the east side.

The developers had argued in an earlier meeting that a brick-covered Dollar General with a landscaped lot would have a better appearance than the building now on the

On the moratorium extension, Johnson told commissioners it was needed so the planning

staff could finalize updates to the county ordinance to make badly-needed changes in requirements for new residential develop-

She said one area of concern was traffic flow countywide. Changes were needed to require developers to install deceleration lanes and add more connecting roads between neighboring subdivisions, she said.

A delay until April 19 would allow the planning staff time to prepare amendments to the county ordinance, she said. It also would allow the staff to host Feb. 1 and Feb. 15 work sessions to explain the changes before final approval by the Board March 15, Johnson said.

The Board voted 4-1 to extend the moratorium but allow preliminary plats for new homes on minimum two-acre tracts to proceed.

Commissioner J.C. Henderson — the lone vote against the extension — said he was concerned about those wanting to develop large tracts being told they have to wait three more months to begin the process. The moratorium has been in effect since January

Kemp campaigns in Walton, vows a fight for right

Gov. Brian Kemp said his term has been a fight for conservative values. The campaign for a second term and the next four years, should he win them – would be more of the same, he told Walton County Republicans.

"I can stay in the fight and I'm going to tell you what my record is," Kemp said Monday night in a speech before a friendly crowd 127 days before he faces a challenge in the GOP primary from former Sen. David Perdue.

Kemp said the issues he's basing his reelection bid on won't be changing despite Perdue entering the race, or a looming general election rematch from 2018 foe Stacey

"You've heard them before," he said. "You heard 'em at Roy (Roberts)'s barbecue because that's what I campaigned on."

Kemp has endured


political attacks from former President Donald Trump and his ardent supporters for not overturning the 2020 election that saw Joe Biden narrowly carry Georgia. Trump's obsession with the loss of Georgia, becoming the first Republican nominee to lose here since George H.W. Bush in 1992, led him to rebuke his previous endorsement of Kemp and push Perdue into the race.

The governor didn't talk about the presidential election but said he's proud of the resulting election law, Senate Bill 202, which he signed last year.

"Despite what the left and Stacey Abrams and all these activist groups say, despite the Biden Justice Department suing us, we have the toughest election integrity law in the nation, per Heritage," Kemp said.

"I was proud to sign it and I did over 100 interviews pushing back on the lies on our law,'

Kemp said he navigated the pandemic, getting Georgia businesses and schools back

He said the Kemp administration has fought to support law enforcement and balance budgets. In the coming year, he plans to support a "constitutional carry" measure that would eliminate the need for Georgians to obtain a weapons carry license to carry a concealed weapon in

public. "It is a public safety issue that I think the time is right for because of what we've seen in our capital city," he said. "It is time we pass constitutional carry to let people protect themselves without a piece of paper from the government."

Kemp also said his 2023 budget proposal includes an income tax refund for Georgians.

State Agriculture **Commissioner Gary** Black also spoke with the local Republicans, asking them to return the U.S. Senate seat on the ballot this fall to

Reputation matters. Three minutes on Fox News will never get a veteran the help he needs from the VA. None of these charades will help beat Raphael Warnock. Serving in the United States Senate is a job and you are a member of the hiring committee, and I am asking you to hire me."

State Sen. Bill Cowsert of Athens introduced Kemp — his brother-in-law — Monday night by saying the governor has faced difficult times including the aftermath of Hurricane Michael, riots in the wake of the "George Floyd and Ahmaud Arbery incidents," the COVID-19 pandemic "and the hits keep coming."

"My prayer for Brian is he will have the tailwinds to enjoy his accomplishments the next four years as he has the headwinds the past four years," Cowsert said.

The senator, whose district includes much of Walton County, hailed the governor for bringing Rivian Inc. to Social Circle. Cowsert said it likely is "going to be the biggest economic development project in the state of Georgia."

Kemp, however, did not mention the \$5 billion project that will bring 7,500 jobs to Walton and Morgan counties but also has stoked intense criticism, particularly on the Morgan County

Walton County man charged with killing mother

A Walton County man has been charged with murder in the shooting death of his mother.

The Georgia Bureau of Investigation announced 42-year-old Shane Samuel Stark has been arrested and charged with murder, possession of a firearm during the commission of a felony and six counts of aggravated assault in the death of 73-year-old Makhyal Stark Pohlel.

Walton County sheriff's deputies were called to perform a welfare check Tuesday night at a home in the 4800 block of state Route 20 south of Loganville, after an initial call for medical help was canceled.

Deputies made contact with Stark and Pohlel and found no need for emergency assistance. However, in the early morning hours Wednesday, Stark reportedly called 911 and said he had killed his mother.

Sheriff's deputies returned to the home and engaged in a standoff with Stark, during which time he allegedly fired several shots at law enforcement.

Stark eventually surrendered and after deputies entered the home, found Pohlel dead from an apparent gunshot wound.

An autopsy at the GBI medical examiner's office is pending.

The GBI said its investigation is ongoing and anyone with information may call 800-597-8477 or submit them online through the bureau's website or the See Something, Send Something app.



to prospective voters. Just this week, Gov. Brian Kemp made a stop in Walton County to speak to local Republicans and rally his supporters.

Days before, a couple of congressional candidates for Georgia's 10th District were in Newton County to try and win over a few votes. Many others have stumped all across the

It's still really early in the game, but I've noticed a terrible campaign trend that, I imagine, may only get

For the longest time, I've always felt that a smear campaign, in which a candidate spends all of their time talking trash about other candidates, was the worst form of campaigning. But now there's something that could "trump" it.

So, for any candidates interested in winning over my vote, and possibly others: campaign for yourself, not Trump.



Georgia's pandemic test scores a no-brainer

typical SAT questions. The SAT is widely used in assessing students readiness for college admission in the United States. That is unless you are six-four, weigh 250 pounds and run a 4.6 forty. Then the SAT is pretty much irrelevant. Kind of like CNN.

in correctly answering

According to Cherry Digital, the website I'm-a-Puzzle.com tested 5,000 adults around the country on their proficiency in math and EBRW (a fancy name for how well we read and write.) The concern was whether or not the pandemic has caused us to begin losing whatever brain power we may have had before being asked to mask-up and wash our hands.

"If you felt as if you were losing your mind during the pandemic, you're not alone," Cherry Digital observed in a news release. "What with being constantly bombarded by bad news, unable to go to work and having stimulating conversation with your colleagues, or, if you're a parent, only having had toddlers or little kids to talk to all day, it might well have felt like your brain was deteriorating. And in fact, because people's minds were so dormant over the whole period, it has given rise to a condition known as 'pandemic brain.""

Obviously, I'm-a-Puzzle.com successfully avoided "pandemic brain" because they thought up the idea of testing 5,000 adults about reading and writing and arithmetic. Neal Taparia from I'ma-Puzzle.com says, "It's great to see that, overall, most adults across the country haven't got too much to worry about when it comes to their post-pandemic brain sharpness."

An example of the questions posed in the SAT quiz was this one: "If x +6=9, then 3x + 1 equals: (A) 6, (B) 10, (C) 4, or(D) 12." And this: "What does 'burgeon' mean?: (A) To rapidly shrink, (B) to become tired, (C) to make, or (D) to rapidly expand."

I have an addition question: Who cares? When you can once again attend a cocktail party and feel compelled to tell folks that you know what 3x +1 equals, you are likely to find them burgeoning to avoid you like a bat out of Wuhan.

By the way, the answer to the math question is: (B) 10 and the EBRW answer is: (D) "to rapidly expand." But since you are smarter than the know-it-alls in New York (25th) and the Socialist State of California (30th), I suspect you knew that already.

Cherry Digital says the best overall scores came from New Jersey and surmises that is because a lot of Princeton University alumni live there. Obviously, they don't have anything better to do with their time than take quizzes. What else in there to do in New Jersey?

Arkansas finished at the bottom of the 50 states in both categories in the SAT test. Cherry Digital doesn't say so but in my opinion it's because a lot of Arkansas alumni live there that wear plastic pig hats to football games, wiggle their fingers and yell, "Woooooooo, Pig! Sooie!" Even someone with pandemic brain could have figured that one out.

Georgia exceeded the national average of 55% in math with a score of 59% and had a 61% mark in EBRW which was the national average. Our overall mark of 60% was above the national average of 58%. Not quite National College Football Championship rankings but better than Joe Biden's approval ratings.

I think it is only fair to say that our state's respectable scores were due in part to the fact that I'm-a-Puzzle.com didn't ask me to participate. I still count on my fingers and have yet to figure out "i before e, except after c, or whatever my neighbor weighs." I could have single-handedly gotten us down into Arkansas

territory. I find the news reassuring that COVID-19 hasn't turned us all into a bunch of brain-mushed zombies. but I am taking no chances. I will still mask-up when I feel it necessary. I will still wash my hands often and I will continue to try and maintain a little space between me and others. But I still refuse to eat broccoli. As I'm-a-Puzzle.com will tell you, I haven't lost all my pandemic brain power yet.



hire based on race and, secondly, it's illegal to fire somebody based on their race," Buckley said. "It's pretty straightforward really."

Kerr was hired as interim county manager in early 2016 and promoted to the permanent position later that year. The Board in 2019 unanimously voted to renew his contract in 2019 for three years

The ante litem notice sent to Newton County Tuesday, Jan. 18, stated that Sanders, Mason and J.C. Henderson posted videos on social media or expressed in conversations with public officials that made "clear they harbored racial animus in opposing Mr. Kerr holding the position of county manager and voting to non-renew his employ-

"Commissioner Sanders even made a recording where she specifically addressed the county manager position, noting she wanted to do a national search for a county manager with the intention of reflecting the changing demographics of the county," the notice

ment contract."

stated. The action not to renew his contract based on race violated part of the federal Civil Rights Act, Buckley said.

"Mr. Kerr served as the county manager for Newton County for nearly six years. Despite Mr. Kerr's excellent performance and dedication to his job, on Nov. 2, 2021, the Board voted not to renew his contract for an additional term. Accordingly, Mr. Kerr's contract expired on Ian

1, 2022. "Ultimately, the decision not to renew Mr. Kerr's contract is merely an extension of the unlawful racially discriminatory policies and practices that the **Board of Commission-**

ers has fostered." Newton County also did not increase Kerr's salary to the level other area county managers make as required in his contract, the notice

stated. Kerr's contract required an increase in pay from \$137,500 because it was below the market rate for county managers based on a study showing five area county managers earn between \$175,000 and \$200,500. The notice stated the county breached Kerr's contract because it did not raise his pay.

"The county never

proffered any reason for breaching Mr. Kerr's contract, leaving the only conceivable explanation to be aligned with the reason for his nonrenewal: race discrimination and retaliation," the notice stated.

Buckley also proposed a settlement in which the county would pay Kerr \$700,000 plus compensatory and punitive damag and attorneys' fees. The \$700,000 is equal to three years of pay, benefits and the salary adjustment, the notice

stated. State law requires that an ante litem notice be sent to governing agencies in Georgia before a lawsuit is filed.

The notice and EEOC complaint follows a similar notice and complaint from former, longtime county contract attorney Megan Martin who alleges the Board of Commissioners discriminated against her based on race and age for not hiring her after making her a sole finalist for a new position leading a newly created in-house county legal depart-

Sanders also is specifically named in Martin's notice for illegally interfering in a

contractual relationship after the commissioner allegedly contacted Martin's law firm, Jarrard & Davis, to "disparage" the then-county attorney which led to her termination from the firm.

Buckley, who also represents Martin, stated she is seeking a settlement of \$850,000 plus compensatory and punitive damages.

The Board of Commissioners has not hired anyone for the in-house position and would need to hire conflict counsel to represent it in the Martin case.

The county government still employs Jarrard & Davis for legal needs. Its attorney assigned to Newton County government, Patrick Jaugstetter, would be unable to represent the county because the firm is Martin's former employer and would constitute a conflict of interest.

tration, car seats reduce fatal injuries by 71 percent among infants and by 54 percent among children ages 1 to 4 years in passenger cars. Car seats offer the best protection for children in the event of a crash, and they are most effective when installed and used correctly. Nearly three out of every four car seats are not used properly, placing children at unnecessary

"It's our responsibility to keep our children safe," said Missy Braden, a certified Child Passenger Safety Technician instructor at Piedmont Newton

Hospital. "The Car Seat Mini-Grant is a great opportunity to help our community and help protect our children from serious injuries or death in motor vehicle crashes."

In Newton County, Braden educates parents and caregivers on how to properly install and use car seats, offers car seat inspections and provides car seats and booster seats to financially eligible families. Through the Car Seat Mini-Grant, agencies supporting more than 120 counties are working to keep Georgia's children safe. delegation includes two state senators and four representatives whose districts includes parts of Newton. Members are split evenly between Republicans and Democrats.

Republicans control both houses of the General Assembly, which likely will give final approval to any map favored by Republicans in the delegation.

The Constitution requires the General Assembly to pass an updated redistricting map every 10 years to ensure population is roughly equal in each

district based on the latest federal Census count.

Newton commissioners voted 3-2 along political party lines Tuesday not to approve the proposed map, which was drawn by a legislative reapportionment committee. It moves neighborhoods in eight separate areas into neighboring County Commission and School Board districts.

The largest land transfers occur in northwest Newton where Newton High School and nearby neighborhoods connecting to

Kirkland and Crowell roads would be shifted from District 4 to District 3.

Other large-scale changes include moving industrial areas around Avenue of Champions in northeast Covington from District 4 to District 5 - achange the reapportionment panel made to an earlier version to keep the city of Oxford entirely within one district, said county GIS

director Tim Lawrence. In addition, primarily rural areas around Poplar Mill Road would move from District 1 to District 5; an area around Laurel Way off Georgia Hwy. 81 would move from District 1 to 2; and a small area west of Salem Road and north of Old Concord Drive from District 2

to 3. Before the vote, Jaugstetter told commissioners they were considering a resolution that would "indicate to the local legislative delegation and to the Georgia General Assembly your approval of the map," Jaugstetter said.

"It will request that they introduce that map during this current session and support it through the process," he said.

He said the law does not require a unanimous Board of Commissioners vote for the map but the county's legislative delegation generally "expects" full support before sending it for approval by the full General Assembly.

"I would expect and I can't say this with absolute certainty

 that if it's less than unanimous, your local delegation may not pursue it diligently," Jaugstetter said.

Commissioner Stan Edwards said the version of the map the county was considering already had been given to the Newton delegation.

However, some commissioners still appeared unhappy with some of the changes and all Democratic commissioners, including Alana Sanders, J.C. Henderson and Demond Mason, voted against recommending

The legislative delegation has the power to draw a new county district map regardless of a local board's opposition, a state government expert said.

Charles Bullock, a political expert at the University of Georgia, recently told the Athens Banner-Herald that a county district map could only be challenged in the court system in two areas.

A population challenge could be done based on the general rule that districts have to be within plus or minus 5% of the average population; or if any changes make it more difficult for an area represented by a minority candidate to continue electing minority candidates.

However, Newton County officials have said the maps the state reapportionment office produced do not appear to violate either of those areas.

Chickens tend to be hypersensitive to colder weather

Although chickens are totally fine in the winter, they tend to be hypersensitive to the cold weather.

Most flocks will stay in the coop, egg production will slow, and birds may get lethargic. As backyard flock owners, you want your animals to thrive year round. So how do we make sure our chickens are happy and healthy all winter?

A well insulated coop with great ventilation can "make or break" your flock. I always recommend putting in windows to allow for sunlight and extra

Your coop matters!



For backyard flock owners who want to see their chickens thrive year-round, condition of the coop bears significant impact.

ventilation. Moisture in your coop plus freezing temperatures can cause your chickens to get

frostbite. Frostbite is not the easiest thing to prevent, yet we want to do everything we can.

For an extra layer of protection, apply petroleum jelly to the chickens comb and wattle.

Also give chickens an elevated place to sleep. Chickens love to roost, so add a few extra

roosting bars to encourage your flock to stay off the floor.

Change your feeding time, feed your flock mid morning and late at night. The mid morning feeding will keep them warm throughout the day. Late night feeding is the most important, with the drop in temperature means your birds have to stay warm longer. Giving corn right after dark will help the birds stay warm throughout the night.

Newton's UGA Extension Office encourages residents to test for radon

January is national radon action month. Many Georgians spend these cold months huddled inside waiting for a warmer spring. This makes it even more important that we test our homes for radon, a colorless, odorless gas that is the second leading cause of lung cancer.

In Newton County, about 22-28% of homes have elevated levels of the naturally radioactive gas, radon. Over the course of many years, exposure to this gas can cause lung cancer even in non-smokers. In fact, radon is the leading cause of lung cancer among non-smokers. Smokers, current and former, exposed to radon gas have an even greater risk of develop-

ing lung cancer. Radon is a naturally oc-

curring gas that comes from the breakdown of uranium in soil and rock. Often granite rock naturally has high levels of uranium, which is part of why radon is such a persistent problem in Georgia.

The gas seeps out of the soil and up through crawlspaces, foundations, and basements into a home. About 800 Georgians die annually from radon induced lung cancer. Fortunately, testing for

pensive. You hang a shortterm radon test in the lowest living level of your home for three to seven days, then mail it to the laboratory for analysis. In a few days you will receive the test results. If the radon level in your home is high (4 picocuries per liter or above), you can have a certified radon mitigation professional install a radon reduction system that will reduce the indoor radon level. The system most frequently used is a vent pipe system and fan that pulls radon from beneath the house and vents it to the outside.

radon gas is simple and inex-

A radon test kit can be obtained from the UGA Radon Program (radon.uga.edu) or a hardware store. During the month of January, Georgia residents will receive \$5 off the cost of purchasing a

radon test kit online by using the code NRAM2022 at checkout.

Radon may also be found in drinking water. This is primarily a concern with private well water. In Georgia, wells drilled into granitic crystalline rock aquifers, usually in the northern part of the state, are at risk of naturally occurring radon contamination. This is where the uranium that decays to radon can be found at higher levels. To learn more about radon in water in your county visit aesl.ces.uga.edu/water/map/. You can have your well water tested at the UGA Agricultural and Environmental Services Laboratories in Athens.

nounced a new program to explore careers in conservation.

The Georgia DNR Career Academy, a week-long, overnight summer camp, will be held July 17-23, 2022, at Charlie Elliott Wildlife Center in Mansfield and Georgia 4-H at Camp Jekyll on Jekyll Island. High school students will have the opportunity to learn about DNR career paths, and visit wildlife management areas, hatcheries, state parks, and the coast, said Lindsey Brown, the Career Academy's

director. "Throughout the week, students will get hands-on experience as they learn from DNR game wardens, wildlife, fisheries and marine technicians, park rangers, and support staff," Brown said. "They'll have the opportunity to go behind the scenes with DNR staff and see what it takes to conserve Georgia's natural resources."

The Career Academy's activities will include trail blazing and hiking, land navigation, state park hospitality, hunting incident investigation, fishery management, urban wildlife and deer aging, and other programs. Throughout the week, students will interact with full-time DNR staff and have the chance to ask questions, learn about professional paths, and education requirements.

"Our goal is for students to have a genuine experience with DNR staff and see what their day-to-day jobs are like, whether that's conducting a prescribed burn, helping find a lost hiker, or gathering data that's used to open and close the state's commercial shrimping season," Brown added."

Mark Williams, commissioner of the Department of Natural Resources, said he hopes the Career Academy will provide students with a path to pursue employment with the department, and a clear understanding of the educational requirements necessary.

"Georgia is home to a diverse and growing workforce, and as the state's lead natural resources agency, we want to make sure DNR is a competitive and enjoyable place to work," Williams said. "This program will give young Georgians the chance to see how they can turn their passion for the outdoors into a career that conserves

our resources and ben-

efits present and future generations."

The Georgia DNR Career Academy is open to high school students in the fall of 2022. Students do not have to be residents of Georgia. The cost is \$100 and includes all meals and lodging. Scholarship opportunities are available to students who qualify on a financial-need basis. Applicants must include a letter of permission from parent or guardian, a letter of recommendation from a teacher, school counselor, school administrator, or club advisor, and complete a virtual interview with a DNR employee. Eligible students may also opt to earn technical college credit upon completion of the camp that can be used toward a future education in wildlife management.





How to maintain *'SMART' lifestyle*

Q&A with Piedmont Newton Hospital dietitian Megan Jaimes-Arias

COVINGTON, Ga. — To help readers maintain a healthy lifestyle, The Covington News recently reached out to Megan Jaimes-Arias, RDN, LD, for professional guidance.

Arias is a dietitian at Piedmont Newton Hospital where she has served for four

years. She earned her bachelor's degrees in Biology and Dietetics at the University of Georgia as well as an internship at Winthrop University in Rock Hill, South Carolina.

Q: What are some common things that people can do to maintain a healthy lifestyle?

MJA: It's the same stuff that people don't want to hear. Eat healthy, exercise and make good choices.

Q: What diet do you recommend to someone who wants to lose weight?

MJA: I think we all know someone who's dieted and been unsuccessful. There've been people who have been successful in the short term, reach their goal and go off their diet. Then, they do what? They gain all their weight back.

So, we want to create more of a lifestyle change than just a diet change. Instead of going on some low carb or no carb diet, step back and look and see what kind of patterns you have in your daily life. Then, set some goals on how to improve on that.

We're all about setting S.M.A.R.T. goals. Things that are specific, measurable, achievable, relevant and time bound. So, being very specific so that we set ourselves up for success instead of having overarching goals. Like saying, "I'm going to go on a low carb diet," without having any specifics to what that means.

Q: What are some common myths about losing weight?

MJA: Getting hung up on "I want to lose 15 pounds by my vacation." Then thinking, I can just cut out all of these things and I'll lose weight. Sometimes that's true, but it's not going to be that long term. So, when we get into patterns of weight loss, weight gain and those "yo-yo" diets, then that's when we're not able to achieve that sustained weight loss and improvements in our health long term. I think a lot of people cut out a lot of things

most of us are looking

over a short period of time to lose weight, and that's true. But it's not going to have the lasting health effects that

for when we want to lose weight.

Q: There are healthy ways to lose weight, but then there are unhealthy ways to lose weight. What are some common unhealthy ways that you've seen people try and lose weight and how can they avoid those unhealthy ways?

MJA: Most of the time, diets that eliminate an entire food group is usually an unhealthy way to lose weight. You're going to be missing out on some nutrients if you're eliminating, say all carbohydrates.

Skipping meals is also not a healthy way to lose weight. Typically, when you skip meals, you start eating more at the meals you are eating. So, say you only eat one meal a day, by the time you get to dinner, you're probably going to eat a lot more than you would have if you had eaten all throughout the day. And when we get really hungry, we tend to make

bad choices. Another one is you can't lose weight just by exercise or just by diet. They have to really work together. There's no quick switch, easy way out. If it sounds too good to be true, it usually is.

Q: Veganism has become more well known in recent years. How would you assist someone who is a vegan in losing weight? Is there anything different for that type of person?

MJA: I think as veganism has become more popular in today's culture, there's more products being made to fit in that lifestyle. So, some of those, they do add more fat to them. Just because it says it's vegan doesn't necessarily mean it is healthy. It just goes back to the basics of reading nutrition labels and looking to see what's in those

foods.

You really have to balance a vegan diet, because you do miss out on some key nutrients. They can be replaced, but you have to be more thoughtful on how you put your meals together and what you're eating throughout the day to make sure you're getting enough protein, calcium, B-vitamins and other things that we don't get when we take animal products out of our diet. But I think mostly, a

lot of the products that they come out with that are meat replacements, they want it to taste good. When they're trying to sell a food product, if it doesn't taste or look good, then you're not going to buy it. Sometimes they add more sugar or fat to not make it a healthy choice even though you think, "oh, it's vegan, it's healthy."

Healthy habits worth making your routine

person's habits can have a strong impact on his or her overall health. Unhealthy habits like smoking and living a sedentary lifestyle can increase a person's risk for various conditions and diseases. On the flip side, healthy habits like eating a nutritious diet and getting enough sleep can bolster a person's immune system and reduce his or her risk for various ailments.

Some healthy habits, like daily exercise, can be time-consuming. Busy adults may not have time to exercise vigorously each day, though the U.S. Department of Health and Human Services urges men and women to find time for at least 150 minutes of moderate-intensity aerobic activity each week. But not all healthy habits take up time. In fact, adults can incorporate various healthy practices into their daily routines without skipping a beat.

- Take the stairs. Taking the stairs instead of the elevator can have a profound effect on overall health. According to Duke University, climbing just two flights of stairs combined per day can contribute to six pounds of weight loss over the course of a single year. In addition, a study from the North American Menopause Society found that stair climbing can help postmenopausal women reduce their risk for osteoporosis and help them lower their blood pressure.
- Drink more water. The Centers for Disease Control and Prevention notes that water helps the body maintain a normal temperature, lubricates and cushions joints, protects

the spinal cord and other sensitive tissues and helps to rid the body of waste through urination, perspiration and bowel movements. Adults who are thirsty can choose water over soda or other sugary beverages. The CDC notes that sugary beverages like soda and sports drinks contain calories but little nutritional value, making water a healthier way for individuals to quench their thirst.

• Go for daily walks. Walking benefits the body in myriad ways. For example, the Harvard School of Public Health notes that women who walk 30 minutes per day can reduce their risk of stroke by 20% and potentially by 40% if they walk briskly. In addition, researchers at the University of Virginia Health System found that men between the ages of 71 and 93 who walked more than a quarter mile per day had half the incidence of dementia and Alzheimer's disease as men who walked less. • Eat more greens. Eating more greens is another healthy habit that doesn't require a major overhaul of an individual's lifestyle. The U.S. Department of Agriculture notes that dark green leafy vegetables, such as spinach, are rich in vitamins A,C, E and K. The Mayo Clinic notes that vitamin E alone can help people maintain their vision and promote a healthy reproductive system while also improving the health of the blood, brain and skin. The USDA also notes that green vegetables contain very little carbohydrates, sodium and cholesterol. 

Exercising safely after recovering from COVID-19

the number of people who have been infected by the novel coronavirus COVID-19 is difficult to determine, as millions of people may have had the virus but been asymptomatic. But as of April 2021, the Center for Systems Science and Engineering at Johns Hopkins University reported that more than 31 million people in the United States have had confirmed coronavirus infections, and Canada reported 1,087,158 confirmed cases with 80,204 considered active at that time. Thousands of new cases are reported daily nationwide, and many others have occurred around the world.

Even though COVID-19 is widespread and highly contagious, the silver lining is that a very high percentage of people recover from the disease. WebMD says that recovery rates fluctuate between 97 and 99.75%. However, COVID-19 can affect various parts

of the body and pro-

duce long-lasting side effects.

A study from the Korea Disease Control and Prevention Agency found that 91 percent of people who recovered from COVID-19 reported at least one

long-lasting symptom, and fatigue and trouble concentrating were the most common. With this in mind, individuals who have recovered from the illness and want to get back to their daily activities

including exercising — may need to be especially careful.

Health experts recommend a slow, phased approach to resuming exercise after recovering from COVID-19. It's also worth noting

that it may take some time to regain pre-illness fitness levels, so individuals are urged to go easy on themselves if they cannot meet certain milestones.

David Salman, Ph.D., a clinical fellow in primary care at the Imperial College London, was lead author of a report published in the British Medical Journal that aimed to answer questions about returning to exercise. One of his recommendations is to wait for seven days after major symptoms nave stopped before beginning to slowly build up physical activity. One should start with light-intensity exercises, such as walking or yoga. Gradually, more challenging activities, including brisk walking, swimming or light resistance training, can be introduced. Each phase should be maintained for at least seven days.

People should be mindful of getting out of breath or feeling too fatigued by exercise. If this occurs, they should move back a phase until exercise

feels comfortable. Pay attention to body cues while doing normal daily activities, as these can help determine if you need to rest.

The University of Colorado Boulder Health and Wellness Services says exercise should not continue if people experience chest pain, difficulty breathing, shortness of breath, abnormal heartbeats, or lightheadedness. Individuals are urged to consult with their doctors if these symptoms appear.

Within a few weeks of infection, many people with mild cases of COVID-19 can typically be back to their normal fitness routines. says Anthony S. Lubinsky, MD, clinical associate professor at New York University Grossman School of Medicine. But slow and steady is the key to getting there.

Detailing the trending ketogenic diet and measuring its safety, effectiveness

ietary trends typically exhibit varying degrees of staying power. So-called "fad diets" may not withstand long-term scrutiny, while approaches like the Mediterranean diet appear to be more effective and beneficial to short- and long-term health.

Low-carb diets tend to garner lots of attention. One such diet making waves of late is the keto diet. Keto diets may vary, but many are built on a foundation of low carb intake and high protein consumption. While these diets are referred to as "keto diets," the Harvard Medical School notes that a true ketogenic diet is different from the keto diets that have

become so popular.

What is a ketogenic diet?

A ketogenic dietary plan focuses on fat rather than protein. A ketogenic diet is low-carb and relies on fat to supply as much as 90 percent of a person's daily calories.

How does a ketogenic diet work?

The ketogenic diet tries to force the body into using a different type of fuel known as ketone bodies, which are a type of fuel produced by the liver from fat stores. This differs from other diets, which rely on glucose from carbohydrates to fuel the

Getting the liver to create ketone bodies and reach a state of ketosis, in which the body is breaking down

protein and fat for energy,

isn't necessarily easy, as it requires people to consume fewer than 20 to 50 grams of carbs a day. To put that in perspective, the Harvard Medical School notes that a medium-sized banana typically contains 27 grams of carbohydrates. In addition, WebMD notes that reaching ketosis typically takes three to four days, and eating too much protein can interfere with the body's ability to get there.

alorie-counting and watching one's weight is often seen as a young person's game. But even aging men and women should recognize the importance of maintaining a healthy weight.

Older adults may experience weight gain or unintentional weight loss. Understanding how to address each in healthy ways is important.

Weight loss tips

More than two-thirds of Americans, including adults age 65 and older, are overweight and obese, according to U.S. News & World Report. A combination of factors can contribute to weight gain in older adults, including a slower metabolism and a tendency to be more sedentary with age. Empty nesters also may be less likely to cook their own meals, relying on convenience foods — some of which may be high in fat and/or calories.

Sustained healthy weight at any age is linked to improved heart health, mental health benefits like increased self-confidence, healthy joints, and much more. These tips can help aging individuals maintain healthy weights.

• Incorporate strength or

resistance training into your weekly routine. Hormone production slows down as the body ages, and that may result in a loss of muscle mass. Lifting weights or engaging in resistance training with elastic bands or body weight can restore muscle tone and speed up metabolism. Adults should

aim for strength training

twice a week. Monitor sugar and starch intake. Many older adults have elevated blood sugar levels due to insulin resistance. When cells become resistant to insulin, glucose doesn't get used up and remains in the blood. Eventually this can lead to pre-diabetes, metabolic syndrome and type 2 diabetes. Many people with these conditions have a hard time losing weight. Avoiding added sugars and extra carbohydrates could help.

 Practice portion control. A 60-year-old can't eat the same way he or she did at age 30 or 40. Nutritionists say that, with every decade that passes, people generally need about 100 fewer calories a day to maintain their weights. Cutting calories slowly and steadily helps people maintain healthy weights, especially when they couple this with

Avoiding malnutritionrelated weight loss

Malnutrition is a common component in unintentional weight loss in aging populations. Reduction in senses of small and taste, smaller appetites and lack of desire to make meals can contribute to malnutrition and weight loss. Underlying health problems also may lead to unwanted and unhealthy weight loss. Tracking weight loss and getting sufficient nutrients is vital to aging adults'

overall health. A 2014 study published in the American Journal of Clinical Nutrition found that having a body mass index at the lower end of the recommended age for adults increased risk for mortality more so than being overweight. Individuals whose BMI is less than 23 could be putting themselves in jeopardy.

Older adults need to adjust their routines as they age in order to maintain healthy weights. Such adjustments can reduce seniors' risk for disease and improve their quality of

"Keep in mind, some physical activity is better than none. Older adults who sit less and do any amount of moderate-to-vigorous intensity physical activity gain some health benefits.

"Your health benefits will also increase with the more physical activity that you do," according to the CDC website. The agency recom-

mends a mix of aerobic activity ("anything that gets your heart beating faster counts") and muscle-strengthening activities ("activities that make your muscles work harder than usual").

It suggests activities ranging from moderate-intensity walking for 30 minutes a day for five days a week, to a mix of vigorous-intensity jogging and moderate-intensity walking coupled with muscle-strengthening

activities. However, the CDC warns that older adults with chronic conditions

should understand whether and how their conditions affect their ability to do regular physical activity safely.

"When older adults cannot do 150 minutes of moderate-intensity aerobic activity a week (for example, 30 minutes a day, five days a week) because of chronic conditions, they should be as physically active as their abilities and conditions allow."

At the Newton County Senior Center, walking, exercise and a sport called pickleball are among daily activities available to center users for a basic membership fee of \$50.

Just being mindful of those types of choices. Q: A popular diet

that has become well known has been the Keto diet. What are your thoughts on the Keto diet and its effects on maintaining a healthy lifestyle?

MJA: It is a very restrictive diet. The biggest concerns I have with it are that sometimes people use it as a way to put bacon and butter on everything. That has a lot of cardiovascular risks that we're taking upon.

Another thing is, it's not making long term changes in our lifestyle and our diet. It's something that's not sustainable. You can't be on that the rest of your life.

It makes it difficult in our social life, too. Eating is a whole aspect of all of our lives. So, if we can't go out to dinner with our friends because we're on the Keto diet, that isolates us from those social aspects, too.

I don't think it's something we can really sustain. I'm not a big fan of the Keto diet. I think that it puts us in this very restrictive diet lifestyle. Q: A lot of scams

scour the internet nowadays. What are some of the best programs that you would recommend for people to avoid those scams?

MJA: There are so many self-proclaimed nutritionists out there. You have to really be careful and look for sources and information about these people. Just because they've been successful in losing weight or they're a bodybuilder, doesn't make them a nutrition expert.

Looking for registered dietitians when you're looking for nutrition information is helpful. Just because it's on the internet

doesn't mean it's true. Something I always tend to look for is, are they selling you something? Are they trying to sell you a whole plethora of nutrition supplements? Are they trying to sell you pre-packaged meals? Usually, there's some gimmick there. If their program works, then you wouldn't need to continue to buy whatever they sell.

As far as nutrition programs, I feel like when a lot of patients come to me, they've been through a lot of them. Maybe they've had some success, but ultimately failed in the end. [Those programs] can be successful but, again, it's still teaching you to be reliant on the program instead of teaching you how to make those healthy

choices on your own. I think working with a registered dietitian when you're able to is helpful and looking for information on dietitians can be helpful,

Q: Each year, people make new year's resolutions to lose weight. But, for the most part,

those resolutions seem

to fade as we progress

through the year. If

someone came to you discouraged about their new year's resolution, what advice would you give to help them keep pushing for that goal?

MJA: So many of us make these resolutions of, "I'm going to lose 25 pounds," and don't have any plan on how to get there. So, we start off January 1 and we're like "I'm just going to eat salad." Then, all you eat is salad for a week and you're like, "okay, this has gotten old." Then you go back to what you were doing before and kind of let it go.

Instead, I like to make these S.M.A.R.T. goals. So, let's sit down and specifically say, "this is where I'd like to be," but what is something that's going to set me up for success?

You're not going to lose 20 pounds in a week. You might like to, but it's not going to happen that way. Healthy weight loss is going to one to two pounds a week. It'll be slow and steady. That's the kind of weight loss that's going to be sustained.

We know people who have lost 20 pounds in a week, but usually they've gained back 30 pounds in two months.

So, getting back to setting goals that are realistic, then let's talk about what you're doing right now.

I usually set three goals with people and we'll set those goals for about six to eight weeks. Once we're being successful with those and there are actual changed habits, then we might add some more.

Are you drinking a lot of sugary drinks? Then that's a way to cut out some calories. Just saying specifically, "I usually drink five cokes a day. So, I'm going to try and cut back to drinking two cokes a day." If you really love coke and every time you turn around you're going to want a coke, you probably can't just cut them out cold turkey. So, try to set a specific goal that you can be successful at and it also sets you up to make those good choices again and again instead of saying, "Man, I drank a coke. Now I can't check this off my list. So, I might as well go back to drinking all the cokes I was before."

Also, if you're not exercising at all, it's unrealistic to say, "starting tomorrow, I'm going to exercise for two hours for four days a week." It's just not going to happen. And, if you say, "I hate walking on the treadmill," then find something you enjoy doing. And, if you're not exercising at all, maybe 15 minutes twice a week is where you need to start. Start small then build it.

As much as we're all living in an instant gratification world, it's not something that's going to happen overnight. Not if we want to make

those lasting changes.
