Players of The Oaks reminisce, bemoan loss of county's historic course

PORTERDALE, Ga. Some members of The Oaks golf course generally said they were sorry to see the 32-year-old facility go but understood why the owners were selling the historic site.

The Oaks golf course has closed after operating since 1989 on land on Brown Bridge Road continuously used as a golf course for more than 80 years. It will make way for a \$215 million residential and retail development set for completion in

On Nov. 19, members Gary Hackney of Social Circle and Joe Casatelli of Covington teed off on the fourth hole near a pile of uprooted signs that formerly stood on each of the course's 18 holes

describing their layouts. Hackney called the closing "very depressing" and noted the historic link it has to famed golfer Bobby Jones, who reportedly was a designer of the course when it was built in the 1930s.

Newton County

BOC votes down interim county manager plan

Attorney: Hiring former rec director without chairman submitting candidates could violate charter

COVINGTON, Ga. — Newton County commissioners began moving toward hiring a new county manager to replace Lloyd Kerr Tuesday night but narrowly rejected a plan to hire a former recreation director for the job beginning Jan. 2.

In addition, the county chairman recommended that commissioners vote to keep Kerr in the job as part of a one-year transition plan in part because of a dearth of qualified candidates and the need to begin the 2023 budget process by February.

Board of Commissioners members voted 3-2 against a motion by Commissioner J.C. Henderson to hire former county recreation commission director Ternard Turner as

interim county manager beginning Jan. 2 until a permanent manager could be hired in six to 12 months.

Commissioners voted after hearing County Attorney Patrick Jaugstetter say the action would not comply with the county government's operating charter that requires the chairman to submit a list of candidates for a majority of Board members to appoint.

Henderson pointed out it was Jaugstetter's "opinion" that an interim manager be named according to the process in the charter but Henderson failed to sway commissioners Ronnie Cowan, Stan Edwards and Demond Mason who voted against the move.

Commissioner Alana Sanders said

Investigation confirms no 'scheme' in CHA's involvement of proposed Conyers Street facility project

COVINGTON, Ga. — Results of an internal investigation by the city attorney recently confirmed the Covington Housing Authority's involvement in the proposed redevelopment of Baker Field and Conyers Street

Gym was in good faith.

In a statement to *The* Covington News on Tuesday, Nov. 23, Councilwoman Susie Keck said that after further review, it was determined there had been no "ulterior scheme" on the part of the housing authority to hide its involvement in a

\$14 million proposal from Alpharetta-based developer John Adams of The Revivalist Guild, on behalf of

Covington Historic Places,

Adams' plan for the development called for the con-

struction of 40 apartments and retail space while preserving the history and integrity of the facility. But after the city hosted a town hall to get the community's input, it was revealed in October that the housing authority was involved — Covington Historic Places was a limited liability company that was created for the Covington Housing Authority (CHA).

Keck, then, said she had discovered the mayor, city council and city manager were unaware that the housing authority had funded the renderings for the proposed renovation, spending approx-

imately \$75,000. In a statement, Keck said she and her colleagues were "decidedly angry" about being "kept in the dark" and called for an investigation.

"There will be a reckoning," Keck stated.

After Keck's discovery, the city soon announced its decision to pass on the development and pursue other avenues for the facility's renovation.

Days after Keck's statements, CHA Executive Director Shamica Tucker sat down with *The Covington*



The partnership, being launched ahead of the holiday travel season, will promote the foundation's 43 Key Seconds safe driving initiative together with the DOT's Drive Alert Arrive Alive campaign in an effort to reduce the number of crashes and fatalities in Georgia caused by unsafe driving.

\$340 million metal recycling, copper smelting plant coming to Augusta

A \$340-million copper smelting and recycling plan is coming to Augusta.

Germany-based Aurubis, one of the world's largest recyclers of copper and precious metals in the world, is building a 150-acre metal recycling plant in Augusta Corporate Park. The plant is expected to open in 2023, with hiring to begin next summer.

The company said the new facility will be the first of its kind in the U.S., and will create 125 jobs in the Augusta

Aurubis company processes complex metal concentrates, scrap metals, organic and inorganic metal-bearing recycling materials, and industrial residues into high-quality metals.

It produces more than 1 million tons of copper cathodes annually, and from them, makes a variety of products such as wire rod, continuous cast shapes, profiles, and flat rolled products made of copper and

copper alloys. 'Aurubis will now join more than 500 German companies with operations in Georgia, and this project underscores the strengths of our exceptional state and local economic development teams," Gov. Brian Kemp said

Wednesday. From Augusta, the company plans to produce materials found in lithium-ion batteries and other electronics.

"With this investment, we are setting a clear example of sustainable growth and will become a forerunner for multi-metal recycling in the U.S. as well – a role that we already have in Europe now," said Roland Harings, CEO of Aurubis

"The Georgia Ports Authority is happy to play a role in bringing jobs and investment to Georgia," GPA Executive Director Griff Lynch added. "Exports produced by the Aurubis recycling operation will strengthen the state's global position via Savannah – already one of the nation's most balanced ports in terms of import-export trade."

The scammers are using spoofed law enforcement phone numbers, along with the names, positions, and addresses of officers. The scam is largely targeting women with lucrative careers that have an online pres-

The following is a list of suspicious activity to look out for related to

- this scam. Calls from local law enforcement stating an individual has fines for
- outstanding warrants. • Calls from local law enforcement stating the court is holding the individual in contempt for failure to appear for jury duty.
- Calls from local law enforcement stating an individual has

been placed under a "gag order" and is not allowed to speak with anyone else regarding the matter. • Calls from local law

- enforcement demanding you remain on the line until the "bond" is paid. Requests for monetary gift cards (visa/
- green dot etc.) bank deposits, and voucher purchases to clear court fines or avoid jail time.
- Requests for videos or pictures of individuals conducting a personal strip search of themselves to clear court fines or avoid jail time.

If you receive a voicemail from local law enforcement demanding a call back, do not respond. Instead, call your local police department's general phone number or go in person to verify the call. Please remember, law enforcement will never call you if you have an arrest warrant for missing jury duty, nor will they ask you to send money to clear a warrant. Lastly, they will never ask you to send pictures or videos of yourself for any reason.

Before moving to Covington, my wife and I lived in Alabama, just a stone's throw from our families, but now we're hundreds

A change I still haven't come to grips with is Thanksgiving without my Mawmaw Beck. She passed away in the spring of 2020, and every holiday and momentous occasion has felt odd since. But, for me, Thanks-

giving hits differently. Since I could remember, my family would gather at her house to celebrate Thanksgiving, Christmas and all the other major holidays with a big meal and "get-together." Mawmaw would spend days ahead of time preparing and cooking up some mean dishes of turkey and dressing along with several other food items. And she had to do that, because when you have six children, more than a dozen grandchildren and even more great-grandchildren, well, they all need something to eat, right?

Mawmaw Beck was always the sweetest host. She always

had plenty to eat and a comfortable place to crash after the feast was finished. And, now that I really think about it, I don't remember ever seeing her actually eat. She always insisted to wait to fix her plate last, but then she would go around and check to make sure everyone had what they needed before worrying about herself.

But that's who she was — selfless.

Though I painfully miss her every day, I'm so thankful for the life my precious Mawmaw Beck lived. She was a God-fearing, kindhearted person —the kind of person I strive to be today, yet find a way to fail.

Boy, if only I could share one more Thanksgiving dinner with her. Now that would be perfect.

usually lands somewhere between late November and late December each year. This minor Jewish holiday is relatively well known in the United States due to its proximity on the calendar to Christmas. However, this Jewish observance of a miracle and historic event

is completely sepa-

rate from and has no relation to the Christian celebration of the birth of the Christ child.

The story of Hanukkah took place over 2,000 years ago in the land of Israel, when the small and ill-equipped Jewish rebel army led by the Maccabees triumphed over their Syrian-Greek oppressors. The Jews revolted after King Antiochus IV Epiphanes outlawed their religion and ordered them to worship Greek deities. Antiochus's soldiers killed thousands of Jews and desecrated the second Temple by slaughtering pigs — a non-kosher animal — inside the sacred site. (Kosher

refers to what is acceptable under Jewish

religious dietary law.) The miracle occurred when the Holy Temple was rededicated. The Jews found only one vial of oil left to light the menorah, or large lamp, in the Temple. The oil is said to have lasted for eight full

days. To remember the miracle of the oil Jews today light a candle each night of Hanukkah on a menorah or Chanukiah. The menorah has nine place holders, eight for the eight nights and one candle called the Shamash, or servant candle, used to light the others. We Jews add

one candle to the menorah each night, until all the candles are lit on the final night of Hanukkah.

We retell the story of Hanukkah, sing songs, eat special foods like latkes (potato pancakes) and jelly donuts. These foods are fried in oil, to remind us of the miracle of the oil. And

we play dreidel. Dreidel is a gambling game using a four-sided top. There's a Hebrew letter on each side of the top: Nun, Gimel, Hey and Shin. Together they spell out the phrase, "Nes Gadol Hayah Sham," which means, "A great

miracle happened

Families often play for pennies, nuts or chocolate coins wrapped in foil called "gelt." The game seems harmless today, but served a clever and lifesaving purpose for those who were forced to study Judaism in secret under Antiochus's brutal rule. When the Syrian-Greek soldiers searched Jewish homes for evidence of outlawed religious activity, Jews would make sure their legal gambling games were seen. This distracted the Jews' oppressors from spotting illegal activity like religious instruction.

For me, Hanukkah has gained importance in recent years due to the significant and troubling increase in anti-Semitic incidents across the globe. We Jews must hold on to our distinct identity and precious faith — as did the Maccabees and stand firm against rising hatreds.

The Anti-Defamation League reported in 2020 that there were over 2,100 anti-Semitic acts of assault, vandalism and harassment in the U.S. This, the ADL stated, was a 12% increase from similar violent incidents in 2019. These numbers are among the highest on record since the organization

Its plans call for construction of 142 single-family homes, 190 townhomes and 360 apartments. A 143,000-square-foot area for retail development is planned along the site's southwest and west sides at the corner of Brown Bridge and Crowell roads.

About 60% of the site would be left both as open space and part of a planned nine-hole, par-3 golf course because of the existence of a 108-acre floodplain on its east side nearest Brown Bridge Road and the Yellow River, developers have said.

Porterdale Mills first developed the site in the 1930s as a golf course for its employees. Later owners continued to operate it as golf courses under the names Porterdale Golf Club, Pinewoods Golf Club, Silo Cay Country Club and Fox Run Golf Club.

However, subsequent owners did not operate a golf course on the site for many years before an investment group that included Richard Schulz redeveloped it in 1989 and later added new and upgraded clubhouse and restaurant facilities.

Schulz, who is a general partner, and wife Nancy have operated the course since then.

Schulz said the owners will be auctioning equipment from the restaurant, pro shop and other parts of the facility Dec. 4.

He said The Oaks is closed to the public and he and some employees — including one who has worked there

after the meeting on Facebook Live she voted to hire Turner to be an interim manager because she wanted to be proactive about filling a top county government position that could be left vacant after Jan. 1.

She also said the county charter does not address how an interim county manager should be appointed.

"I did not want to leave the county wide open," Sanders said.

Turner was hired in November 2018 to lead the former Newton County Recreation Commission, which was a semi-autonomous board that operated the Parks and Recreation Department.

The Georgia General Assembly dissolved it in June 2020 at the request of the Board of Commissioners after the county deemed as illegal bonuses totaling \$28,000 the Recreation commission approved for some employees in December 2019.

Turner remained as recreation director under Kerr's supervision after the commission was dissolved but resigned in August 2020.

Commissioners must appoint someone to fill the county manager position by Jan. 1 when Kerr's contract ends.

However, the time required to find qualified candidates, interview them and choose a finalist could stretch into months, during which the government would be without someone running the day-to-day operations as required in the charter.

Banes, in a memo to board members, said he had discussed the position with Association County Commissioners of Georgia officials and "been advised that the pool of qualified candidates ... is very small.'

He said he recommended a transition plan be put in place that includes extending Kerr's contract for one year and either hiring someone for a new deputy manager position to replace Kerr in January 2023, or opening the search for Kerr's replacement no later than Jan. 15, 2022.

Banes said the county manager has myriad upcoming responsibilities including beginning

work in February to formulate a 2023 budget and continuing negotiations with the five cities over division of Local Option Sales Tax proceeds — among other duties.

"Based upon our form of government, without a county manager in place, the county's operations will not have any supervision," Banes wrote. "To expect to have a qualified candidate for the county manager position or an interim county manager in place by Jan. 2, 2022, ready to continue the daily duties of Kerr is not realistic."

The board on Nov. 2 voted 3-2 not to renew Kerr's contract. Banes said he planned to veto the action but Jaugstetter said the veto would not overrule state law requiring a governing body's majority vote to renew a

Kerr has served as county manager since 2016 and his contract renewed once in 2019.

Jaugstetter has declined public comment on his interpretation of the state law's effect on Kerr's contract.

News and affirmed nothing was being hidden.

"I did not know the city council was not aware that we were involved in this project," Tucker said. "I feel very confident in saying that if they looked at any other responses to

RFPs then they'll see other people forming an LLC as the front of the project. And we were not hiding anything. It's in there.

"There are no secrets," she continued. "Why [developers] didn't put [in the cover letter], 'We're doing this on behalf of the Covington Housing Authority,' is because people have all these wild misconceptions [about the housing authority]. I've heard all of these crazy rumors in the last week, including that we were going to build this \$14 million building and fill it with

homeless people.

"I run a housing authority," Tucker said. "Yes, I am a public servant, but I'm a business person. And I like my job — I think I'd lose it if I did that."

On Tuesday, Nov. 23, City Attorney Frank Turner Jr. confirmed to The News that he had completed an investigation into the matter, at the request of the mayor and city manager, and reported his findings to the city council.

"It was determined that there had been no ulterior scheme on the part of the CHA

to conceal its involvement with the proposed development of the Conyers Street gym and Baker Field," Keck said in a Tuesday statement. "I regret having made a statement to that effect. The CHA, it is clear, had no part in hiding

their involvement. "Frankly, I have learned a lot from this experience," Keck added. "Going forward, I will dutifully review the financial documents of every project that involves city of Covington property. There is truth behind the old saying, 'Follow the money."

Officers other than Teasley include Clack as vice president; Sullivan as secretary; and Bradley as the historian for the Ambassadors.

Through a process involving application, letters of recommendation, and interviews, college administrators choose students whom they believe to be motivated and who show leadership potential to serve as Ambassadors.

To continue in the organization, students must maintain at least a 2.5 cumulative grade point average on a 4.0 scale and commit at least 35 hours per semester to their service as Ambassadors.

Newton County Board of Commissioners

Newton board approves Social Circle tax sharing pact for new business park

COVINGTON, Ga. Newton commissioners have approved a sharing agreement to give Social Circle a portion of the property tax proceeds from a new business park under development partially in the city and two counties.

Newton County **Board of Commission**ers recently voted to approve an amendment to a revenue sharing agreement to give the city — which straddles the line between Newton and Walton counties — a share of payments in lieu of taxes (PILOT)

proceeds from the new Stanton Springs North business park. **Stanton Springs**

North includes 665 acres within Walton and Morgan counties and the Social Circle city limits at the northeast corner of I-20 and U.S. Hwy. 278.

The Joint Development Authority (JDA) of Jasper, Morgan, Newton and Walton Counties bought the land for \$23.9 million earlier this year for the new park.

The sale was completed around the same time the Authority sold the last available land it owned within the adjacent, 1,500-acre Stanton Springs business park to a company only identified publicly as "Baymare" for \$38

Before the agreement, Newton County was to receive 37.5% of any tax proceeds from both parks. The Board of Commissioners' approval Nov. 2 allows the city to receive 5% of tax proceeds from Stanton Springs North only and cuts Newton County share of tax proceeds from the new park to 35.625%.

In other action at its most recent meeting Nov. 2, the Newton County Board of Commissioners approved additional funding for construction and interior work at Washington Street Community Center.

The Board approved a change order totaling \$458,000. Funding is coming from Special

Purpose Local Option Sales Tax.

The action is part of Sunbelt Builders' work to complete highest priority renovations at the Washington Street center, including a new roof, mechanical system, LED lighting, inside painting and plumbing upgrades.

The project also includes some interior work at the Cousins center.

Jeff Prine of Ascension Project Management, which is managing the project for the county, said center officials also wanted renovation of the kitchen facilities but it would exceed the budget.

He said officials planned to develop a plan for funding the

renovations for the nonprofit, which offers a variety of programming for youth and seniors and receives partial funding from the

county. The Board at its most recent meeting Nov. 2 also:

- Approved Public Works department's request for construction agreement with Peach State Construction Company for storm sewer replacement on Ratcliff Trace for \$136,850 with funding from 2017 SPLOST.
- Approved Newton County District Attorney's Office's request for the acceptance of Victim of Crimes Act grants totaling \$119,474.

In doubles play, the Eagles only secured one victory on court three with McCain and classmate Allie Lucky defeating Mohawk Valley's Julia Cucci and Elina Brutsky 6-1, 6-0.

"It feels great to have the chance to compete for a national title again this year after not having a season last year,"

head coach Pernilla Hardin said, who was officially inducted into the NJCAA Hall of Fame on Oct. 30 during a ceremony held at nationals. "Our girls worked hard from the moment they stepped on campus in August and they got better every week. I am very proud of them for how well they competed [from Oct. 30-31]."

Rivalry renewed

Possible history book revisions Saturday in 'Clean, Old-Fashioned Hate'

ATLANTA — Rivalry week is here for college football. On Saturday, Nov. 27, the Georgia Bulldogs and Georgia Tech Yellow Lackets will meet on

books in more ways than one.
In the 114 contests, with the first back on

with the first back on Nov. 4, 1893, the Bulldogs lead the overall series 68-41-5. Georgia opens as a

35-point favorite over Georgia Tech. The last time these teams faced each other, which was in 2019, the Bulldogs topped the Yellow Jackets 52-7 in Atlanta. Georgia Tech's last win in the rivalry came in 2016 in Athens winning

28-27.
Both teams didn't face each other in 2020 due to the SEC adopting a conference-only schedule for COVID-19 precautions. That was the first time since 1924 that these in-state rivals didn't play one another.

Now, heading into 2021's matchup, Georgia and Georgia

Tech are on two totally different trajectories.

The Bulldogs (11-0; 8-0) sit atop the College Football Playoff Standings coming off a 56-7 thrashing of FCS opponent Charleston Southern. Meanwhile, the Yellow Jackets (3-8; 2-6) are riding a 5-game losing streak with the latest fall coming at Notre Dame a week ago 55-0.

Depending upon this year's result, the history books could be updated.

MARGIN OF VICTORY

First, the record for the largest margin of victory could be changed.

Right now, the record is held by Georgia Tech. It defeated the Bulldogs 48-0 in 1943. The closest any team has come to topping was in 2019 with Georgia's 45-point victory.

Georgia's defense has only given up 73 total points all season. (6.6 points given up on average.) Its offense scores an average of 31 points, too.

Though Georgia Tech comes in five games under .500, it has been in some near losses that may keep things close enough to not lose by more than the record

margin.

The Yellow Jackets offense averages 26 points per game while their defense surrenders 32 points per game. That's less than

Quick Facts

Georgia leads the series 68-41-5 but the Bulldogs don't count two Georgia Tech wins during WWII (1943-44) when the Yellow Jackets utilized players from a naval officer's training program hosted on campus. The Georgia-Georgia Tech series is one of the nation's oldest. There are only 13 other FBS rivalries played more. Georgia aims to go 12-0 for the first time since Vince Dooley's 1980 national championship team.

a touchdown loss on average.

Even so, the Yellow Jackets will be trying to bounce back from their worst loss of the season.

PLAYING IN ATLANTA AGAIN?

Since last year's game was cancelled due to the pandemic, the rivalry will return to the capital city of Georgia for a second straight time.

It has a resemblance to early in the rivalry.

The Yellow Jackets and Bulldogs played in 1915 that ended in a tie in Athens. It wasn't until 1925 when the rivalry was once again renewed.

When the matchup resumed, the two teams met on the gridiron in Atlanta for the next four seasons.

After that, the series alternated between the two cities for the most part.

The last time backto-back matches were played in the same place was in 1932-33, when Georgia Tech hosted both of them.

Georgia last hosted back-to-back matches in Athens when it welcomed Georgia Tech for the series' first four matchups from 1893, 1897-99. Be that as it may, Georgia has enjoyed a lot of success at Georgia Tech's place winning nine straight at Bobby Dodd Stadium.

CONTINUE WINNING STREAK

Back when Bobby Dodd was at the helm of the Georgia Tech football program, the Yellow Jackets put together an 8-game winning streak over the Bulldogs.

Their streak is the longest in the series history.

But it doesn't mean the Bulldogs haven't gotten close to tying the record themselves before.

From 2001-2007, Georgia won seven straight over Georgia Tech. In the 2008 game, the Bulldogs held a 28-12 lead against first-year head coach Paul Johnson's Yellow Jackets.

Then, the triple option came to life in the third quarter to lead Georgia Tech's 45-42 comeback win.

Georgia was that close to tying the record in 2008.

Should it win this year, Georgia will extend its winning streak to four straight.
