# 17-year-old charged with murder

# Covington teen connected to recent shooting death of man found near Fairview Elementary School

COVINGTON, Ga. A 17-year-old is facing murder and weapons charges connected to the recent death of a man found shot and killed at a residence near Fairview Elementary School.

Jayden Elijah Cuvilje, 17, of Fieldview Lane, was charged in connection to a shooting at 90 Arlington Drive in Covington.

The shooting left Deartavius Tarrico Rogers, 25, of Convers, dead Sept. 14 just before 11 p.m., according

to a warrant and incident report.

A Newton County sheriff's deputy reported responding to a "penetrating trauma" in the area of Arlington Drive Sept. 14 at 10:55 p.m.

The deputy arrived at the scene and reportedly detained three subjects

who were not identified.

He also observed "a male laying on his back with blood coming from his head in the driveway."

"There was no signs of life for the male laying in the driveway so medical treatment was not rendered," the deputy reported.

Crime scene technicians were called and detectives were notified to investigate the incident, the report stated.


Cuvilje was later charged with using a handgun to shoot and

# K-9 officer's death still under investigation

COVINGTON, Ga. — Newton County Sheriff's Office this week was still awaiting the results of a death investigation to determine how a K-9 officer died after it was found in one of the agency's fleet vehicles in late August.

A recent statement from the sheriff's office said it will release information to the public "once the investigation is completed" about the death of K-9 officer Tom-Tom, a German shorthaired pointer.

University of Georgia experts are conducting the death investigation called a necropsy — an autopsy done on an animal.

A community activist recently claimed on his website that sources within the sheriff's office alleged the K-9 officer died from heat exhaustion both from neglect by its handler and because of engine trouble which led to an aging vehicle's air conditioner shutting off with the dog

However, the sheriff's office on Sept. 1 stated the vehicle in which the K-9 officer was left "was running, and the air conditioner appeared to be properly functioning." "The death of K-9 Tom-Tom was

# **Council OKs permit for 227 townhomes**

Councilwoman's push for more green space at quarry project fails; unhappy with city's code requirements

COVINGTON, Ga. — Despite a little pushback from one council member, a special use permit to construct more than 200 townhomes as part of a large-scale, mixed-use development off Covington Bypass Road was approved Monday.

Covington City Council members voted 4-1 to approve the permit for Taylor Weaver, who is planning to build 227 townhomes as part of a previously reported 200-acre mixeduse development project called The Quarry at Neely Farms. In addition to the townhomes, developers plan for 330 houses located within two single-family detached neighborhoods, 39 upscale estate homes, several condos and apartments, a variety of retailers and restaurants and an amphitheater, all surrounding

a quaint quarry.

As first reported in May, local attorney Phil Johnson, who represents Neely Farms Family Limited Partnership LLLP, said the development could generate a more than \$350

million impact in Newton County. Site plans for the project have drawn

comparisons to Avalon in Alpharetta. Councilwoman Susie Keck cast the only dissenting vote for the townhomes proposal. Her reason was largely due to the lack of green

"I'm all in favor of townhouses," Keck said. "I was glad to be part of agreeing and bringing them to Covington. I'm not happy with the 'row' look. To me, with six units to a building — I know that you can have up to 10 units per acre, per code — but it would be so much better to have more grass, which would

# 'Go in the right direction'

Organizer hopes anti-meth event will show the perils of beginning use of illegal drug

PORTERDALE,

Ga. — Destiny Gee is hoping the inaugural Freedom Fest she has organized this weekend will make a strong case

against using a highly addictive and illegal drug that could end up consuming the user's life.

Gee, a Covington resident, operates a nonprofit called March Against Meth that will host the inaugural Freedom Fest Saturday, Sept. 25, from 2 to 4 p.m. at Porter Memorial Gym at 2201 Main St. in Porterdale.

The event is scheduled to feature three guest speakers as well as live musical performances by Primo and East Rich; and testimonies by others.

One of the scheduled speakers, Veronica Reid, said she plans to tell attendees about her experience with the drug — including turning her life around in 2019 after 18 years as a meth addict.

"If I could reach one family and give them hope it will be worth it," she said.

Gee, 27, is a single mom and office worker. She is an active member of Living Way World Church in Covington.

She also openly admits to overcoming meth and pill addictions in her late teens in 2013.

All who are scheduled to speak or perform have either overcome addictions or are working to gain "freedom" from them, Gee said.

"Each person comes from a different perspective on it," Gee said. "I want to inspire (attendees) to keep going and go in the right direction."

Reid began using meth at age 17 while living in Newton County because many of her friends were doing it and it was readily available, she said.

She has not used methamphetamine for more than three years and now works for a local packaging com-

"We are breaking free one at a time so the next generation won't have to go through what we did," Reid said.

The Georgia Meth Project reports the U.S. Drug Enforcement Administration lists Atlanta as a strategic hub for methamphetamine and other drug trafficking by Mexican drug cartels.

It states that methamphetamine abuse costs Georgia an estimated \$1.3 billion annually, including expenses related to law enforcement, family and social services, treatment, and

lost productivity[.

Many Georgia counties report that 50% to 60% of children in foster care in those counties are there because of meth addiction by one or both parents.

Meanwhile, many national news outlets reported results of a recent study showing meth use increased 43% between 2015 and 2019, and deaths linked to methamphetamine overdoses nearly tripled the same time period in the U.S.

The results reported Wednesday in the publication JAMA Psychiatry found the number of overdose deaths involving psychostimulant drugs — mostly meth increased 180% from 5,526 in 2015 to 15,489 in 2019.

However, meth use only increased by 43% in that same time period, suggesting that high risk behaviors such as mixing substances may be contributing to the increase in deaths, the study found.

# Kemp calls early **November special** legislative session for redistricting

The General Assembly will meet Nov. 3 to begin a special session to redraw Georgia's congressional and legislative districts.

Gov. Brian Kemp announced the date for the session in a proclamation late Thursday.

Under Georgia law, the legislature must adopt new district boundaries every 10 years to account for population shifts reflected in the U.S.

Two legislative committees, one from the Georgia House of Representatives and one from the state Senate, held hearings across the state during the summer to gather public feedback ahead of drawing the new maps.

Lawmakers heard an earful from representatives of civil rights and voting rights groups calling for new district lines that accurately reflect population gains by minority groups during the last decade.

But if the past is any indication, the party in control of the General Assembly – in this case, the Republicans – will draw maps aimed at regaining losses during the last two election cycles in both the legislature and the state's congressional delegation.

With dramatic growth having occurred in metro Atlanta and some parts of North Georgia since 2010, the maps also are expected to shift more legislative districts north of Interstate 20. Rural counties in the southern half of the Peach State likely will see a reduction in the number of districts reflecting losses in population sustained by those areas.

Among other things, lawmakers during the special session also will be asked to ratify executive orders Kemp issued in May to suspend the collection of state gasoline and diesel fuel taxes. The governor acted after the shutdown of the Colonial Pipeline disrupted fuel supplies.

However, the special

session will not include legislative proposals to address the crime wave that has hit Georgia during the past 18 months. Kemp had indicated in July that he planned to put crime on the agenda for the special session.

Also absent will be discussion of whether the state should expand its Medicaid program to cover more uninsured Georgians. Democrats have been calling for adding Medicaid to the special session agenda, but the governor has consistently opposed the idea due to the costs.

The special session likely will run at least into the week of Thanksgiving. The last redistricting special session, which took place in 2010, lasted for two and a half weeks.

# Violence against healthcare workers increasing, state lawmakers told

A veteran nurse who was allegedly attacked by a violent patient was one of several speakers Thursday before a state Senate study committee formed to look into violence against health-

care workers. "I was attacked by a patient who had already attacked one of our technicians," a nurse who identified herself only as Destiny, said. "While I was trying to de-escalate the situation, the patient lunged at me, grabbed my hair and twisted it in her hands. I was punched and kicked several times; I was bit; and she tried to drag me

into the bathroom." Destiny, who works at Northeast Georgia Health System's Braselton location, said it took five nurses and three security guards to restrain the patient. She said she suffered a back injury, multiple scratches and bruises, and weeks of headaches and anxiety as a court

date nears. "I've been asked multiple times, am I sure I want to press charges," she said. "The patient and her family have requested my home address, and now they

know where I am. I work 12- and 14-hour shifts, and I have a son and daughter who are sometimes home alone.

"We are here to take care of patients," she said. "We are not here to be harmed."

According to a study from the Occupational Safety and Health Administration, healthcare workers account for approximately 50% of all victims of workplace violence.

But Deborah Bailey, executive director of government affairs at Northeast Georgia Medical Center, told the committee 75% of all workplace assaults in the U.S. involve health-care workers.

"Only 30% of nurses and 26% of physicians actually report those incidents," Bailey said. "Violent altercations are so common now that most employees consider them just part of the daily job."

Workers in healthcare settings are four times more likely to be assaulted than workers in private industry, according to the Joint Commission on Accreditation of Healthcare Organizations.

"Alarmingly, the actual number of violent incidents involving health care workers is likely much higher because reporting is voluntary," the commission stated.

Kevin August, a veteran former police officer and FBI official and now director of security at Grady Memorial Hospital, said any legislation addressing attacks on health-care workers must come with enforcement powers.

"Training and more staffing are imperative, but if police aren't enforcing the laws and judges aren't punishing it, this problem will never be solved," he said.

Lindsey Caulfield, chief marketing and experience officer at Grady, said health care is the fastest-growing industry in the nation, and health-care and social service workers are five times more likely to suffer violent workplace injuries than other workers.

"Eighty percent of patients are responsible for those incidents," Caulfield said.

Anna Adams of the Georgia Hospital Association (GHA), said rising cases of violence are occurring throughout the state, not just metro Atlanta.

"The pandemic has highlighted our major workforce shortage," she said. "These types of attacks are often covered under worker's comp, and figures show 22% of these claims are filed due to injuries inflicted by a patient, a member of a patient's family, or a co-worker."

Dr. Kathleen Toomey, commissioner of the Georgia Department of Public Health, said stresses brought on by the pandemic, coupled with easy access to social media, are also

Adams said a GHA survey shows most Georgia hospitals see violence against healthcare workers from mentally ill patients or patients suffering from behavioral health issues.

State lawmakers passed a resolution creating the study committee earlier this year. Its mission is to look into the problem of violence against health workers in the state.

# Legislators examine raising Georgia's mandatory school age to 17

Legislators studying the issue of raising Georgia's mandatory age for school attendance from 16 to 17 were met with tough, complex questions from some metro Atlanta school officials on Wednesday.

"The first question for us is, what is the reason for raising the age for compulsory attendance?" asked Gretchen Walton, compliance and legislative affairs officer for the Cobb County School District. "Our research shows raising the age for compulsory attendance doesn't increase high school graduation rates. So what are some of the other reasons for doing so?"

"What can you do at age 16?" asked Nicole Holmes, chief academic officer for Cherokee County schools. "What else is out there except fast-food and retail jobs? You can't join the military. Our own research shows that raising the mandatory

attendance age has to be coupled with other programs that support the student. So what is the impact you are hoping for by raising the age?"

The meeting was the fourth of five by a Senate study committee formed earlier this year after state Sen. Lester Jackson, D-Savannah, introduced a bill to raise the school attendance age.

"This is an idea for which we've seen support in every meeting so far," Sen. Chuck Payne, R-Dalton, the committee's chairman, told Capitol Beat before the meeting.

Payne said the committee plans to file its recommendations for consideration in January, when the legislature reconvenes. "We can already spot

kids who are heading down the wrong path by middle school," he said. "The question is, what more can we do to get them back on the right

Jackson said Georgia's current school attendance law is antiquated, dating back to the 1940s.

# It's no secret Cognia is disregarding **Open Records Law**

Thether you are a Democrat or a Republican, liberal or

vative, there is one thing that should unite

one and all – how government spends your tax dollars. In Georgia, the best way to know that is through the state's Open Records Law.

In short form, gov-

ernment entities, agencies and individuals using our tax dollars must — with very limited exceptions make all documents available to us upon request. Unfortunately, nothing in the law says it must be done willingly or cooperatively.

One of the most egregious examples of a "public be damned" response to Open Records is occurring in Cobb County. Cognia, the principal

school accreditation agency in Georgia, is currently conducting a "special review" of the Cobb County School District at the behest of three Black Democrats on one of the world's most dysfunctional school boards because they either can't get along with the four white Republicans or don't want to.

The Democrats asked Cognia for its "professional expertise in ensuring that the Cobb Board of Education is upholding its duties as a governing body." That is in lieu of looking in the mirror and discovering where the problem really lies.

Cognia agreed to the review saying it had received 50 community and staff complaints. Complaints? From whom? About what? Are they legitimate complaints or did some friends of the Democrats do their pals a favor and make up stuff? No one knows because Cognia isn't saying. The Marietta Daily Journal has asked to see the complaints to no avail. Cognia says they are not subject to Open Records. Even the school district has not been allowed to see them.

Georgia Press Association attorney David Hudson says flatly, "Cognia is paid with taxpayer money for the services it provides to the Cobb School District. Therefore, the organization's documents are subject to Open Records requests." Still Cognia

refuses to budge. OK, time to call in the big guns – Georgia's Attorney General Chris Carr. His office is charged with ensuring compliance with the Open Records Law.

Or, so I thought.

"We will be unable to mediate your complaint," Jennifer Colangelo, an assistant attorney general in Carr's office, informed the Marietta Daily Journal, saying in part, "Based on the facts and email correspondence presented here, it is unclear whether the records you requested from Cognia are public records and it is therefore unclear whether Cognia is violating the Open Records Act."

Colangelo finishes the kiss-off with this head-scratcher, "The thoughts I have expressed in this email are not the official opinion of our office." Say what? I have seen better punts in a Pee Wee football game.

I would remind Colangelo that her boss is running for reelection against a tough opponent and telling the media that Cognia's arrogant attitude is their problem, not the AG's, is not the best way to win friends and influence voters. Don't think the newspapers in Georgia — including this one — haven't noticed.

Jim Zachary is editor of the Valdosta Times and President Emeritus of Georgia's First Amendment Foundation. I asked him about the Attorney General's response. "I do not see the ambiguity the AG's office is referring to," Zachary says. "In my view, this is not a matter of just who holds the record but what is in the record and it seems obvious the contents of the documents in question are the people's business and if it is the people's business, it should be public."

Zachary goes on to say, "People with nothing to hide, simply don't hide. So, the greater question here is not only what is Cognia trying to hide but what are the three members of the board hiding from the very public they were elected to serve?" An

excellent question. Cognia's leadership is not elected and it has a near monopoly in the business. But their day of reckoning may be

coming. They are likely to find themselves in the legislative crosshairs in the next session of the General Assembly. State Sen. Lindsey Tippins, R-Cobb, a former chair of the Cobb School Board, says he has concerns over the motivations behind the review since the district had received renewed accreditation just two years earlier



hat's it like for you when you have to do hard things? We've

been talking with our 8-yearold a lot lately about this very subject.



The students I work with at Oxford College are in full swing now and many are starting to settle into a routine. As we made it to the choir loft and he stood waiting for the final hymn to finish, I noticed him edging closer

not knowing when the hymn was going to end and whether he should be sitting on the organ bench yet. I was behind him, steadying my hand and ready to hit the bright red record He slid next to his

teacher and a minute later the hymn ended. It was time. She counted off for him, and they began playing the majestic tune as people exited the church. A few people stayed and then others came back from outside once they realized what was happening.

In only the way time slips through our firm grip, the moment was gone. I had successfully recorded it, which in and of itself was a miracle.

# Reader petitions BOC to abandon quest to remove monument

# Covington police charge 2 teens after 50 vehicle burglaries reported in September

COVINGTON, Ga. — Police say they believe two Covington teens were among a group that entered and stole from more than 50 vehicles countywide

Tremayne Hill, 18, and Mekhi Nickols, 18, both of Nixon Circle in Covington, were being

earlier this month.



held in the Newton County Detention Center Thursday on charges related to a rash of thefts from vehicles inside the city.

Nickols is charged with 19 counts of entering vehicles with intent to commit theft, and one count of stealing a vehicle. He was being held without bond. Hill is charged with two counts of entering vehicles with intent to commit theft.

More charges are possible for allegedly doing the same crimes, said spokesman Capt. Ken Malcom.

Malcom said Covington Police Officer Wesley Couch observed two individuals at the intersection of Floyd and Mill streets wearing all black clothing Sunday, Sept. 19, at about 3 a.m. Couch conducted field interviews with

the two individuals and one, Hill, was arrested on a charge of giving a false name,.

"The second subject was positively identified by officers as Mekhi Nickols," Malcom said. "These two individuals matched the description of the individuals who entered approximately 35 vehicles in the city limits and [several other] vehicles outside the city limits in recent days."

Covington Detectives Sgt. Slade McCullough, Julie English and Mark Joyner continued the investigation and determined that Hill and Nickols were among a group involved in a recent rash of thefts that included a Ford Edge earlier this month.

Hill and Nickols were being held in the Newton County Detention Center on the charges.

"This is an ongoing investigation and additional charges are expected," Malcom said.

He said other agencies were investigating the additional Entering Auto cases outside the

city limits.

Nickols and Hill are accused of being connected with a series of vehicle thefts and burglaries in and near one Covington neighborhood during the three-day Labor Day weekend.

Four vehicles were stolen and 12 vehicles entered during the weekend earlier this month, Malcom said.

He said police recovered two of the four stolen vehicles, including a Chevrolet Silverado stolen from Ashley Drive and the Ford Edge stolen from Dearing Street, in the **Covington Housing** Authority apartment complex on Alcovy Street.

At least three offenders walked through Covington Place and nearby neighborhoods where they entered several unlocked vehicles and took a variety of items of value. All appeared to be young males and "possibly teenagers," Malcom

require less density."

A partner developer of Taylor Weaver briefly addressed Keck's comments, saying the townhomes were designed specific to the city's codes and requirements, which ultimately led to a lack of coveted green space.

Keck then asked if the city's code could be amended to accommodate for more green

"I want it to look like a community," Keck said. "I don't want it to look like army barracks, and that's how I feel it looks.

"I know that we put in new zoning for townhomes," she added. "We didn't really discuss what the zoning was. This was our first townhome community to come before us, and I see what we're requiring and I don't like it. If this is what we're requiring, I don't like it. Covington is a quaint, Southern town, and -Ineed grass there. I need breaks. I don't need

roads."

Eventually, Keck put forward a motion to approve the special-use permit with the added condition that there only be eight townhomes per acre, rather than the planned 10 per acre, which would have totaled 181 townhomes

— 46 less than the original proposal. However, her motion later died for a lack of a second. Council members

Don Floyd, Anthony Henderson, Kenneth Morgan and Hawnethia Williams each understood Keck's reasoning, and some of them even agreed that more green space was preferable. But because every code and zoning requirement had been met, and proposed conditions were also being addressed, the four believed "moving the goal post" now wouldn't be the right thing to do. Councilwoman Fleeta Baggett was not present for the meeting, as Mayor Steve Horton said she was recovering from a recent surgery.

The council then moved to approve the original proposal and OK the special use permit with the following conditions from city staff and the Planning Commission:

During the time for a public hearing, Johnson provided an update on the intersection approval from GDOT. He said after the developers' traffic engineer further reviewed initial plans for a roundabout, it was determined traffic flow wouldn't be helped much due to sizable neighboring developments underway. Johnson said the engineer was currently drawing plans to make it a "signalized intersection" and include left-hand turn lanes.

"It's not what we had originally wanted to do ... but the traffic engineer and DOT thought that this [signalized intersection] was a better solution," Johnson said.

On the issue of increased traffic and growth, Horton said he and other city staff members recently met with Newton County Schools Superintendent Samantha Fuhrey to

seek input on how the district may be affected by the increasing number of developments happening within the city.

"The city engineer provided the school system a detailed list of what we believe that are developments that will occur within our city, some along this corridor," Horton said. "In talking with the superintendent ... though she didn't really voice any concerns to begin with about capacity, as we continued to talk she did voice some concerns for development within what she called the east side, east-Newton school areas, and I think she specifically mentioned the bypass

Horton said in that same conversation, Fuhrey shared that capacity at the elementary schools and middle schools were manageable, but high schools had the fastest growing numbers, and one had already reached its capacity.

"In spite of the concerns, I don't think they were willing to say stop or restrict development from their standpoint because, as she said, you just didn't know how people were coming or not coming with a development," Horton said.

# Public input will play major role in county parks master plan

COVINGTON, Ga. Public input will play a major part in compiling a plan for future operation of the county government's parks and recreation facilities, a design specialist says.

Aaron St. Pierre of Lawrenceville-based Lose Design told Newton County commissioners during a Tuesday, Sept. 21, work session the study of the county government's parks and recreation facilities and operations also would include suggestions on how to fund new facilities.

County Manager Lloyd Kerr said the plan is costing \$93,000 but will "take us into the future."

"This is something that we have never done in this county," Kerr said.

St. Pierre said a series of open meetings were planned where residents could participate in activities and give comments informally to those conducting the study — rather than a more formal meeting featuring a speaker.

# UGA Extension agent: Leyland cypress trees often planted incorrectly

Leyland cypress are one of the most commonly planted landscape trees, but poor site selection and disease pressure may soon send them the way of red tips and Bradford

Popular as a hedge and in new development, the trees must be planted at least 10 to 15 feet apart, as the trees' rapid growth will require thinning out the trees after a few years to prevent them from growing into one another and reducing the air circulation needed in the canopy to prevent

# Inexpensive, fast-growing and tall

"Leyland cypress trees are one of the most commonly planted trees in the landscape," said Tim Daly, a University of Georgia Cooperative Extension agent in Gwinnett County. "They are popular because of their fast growth and their ability to provide a screen against traffic areas or neighbors."


Leyland cypress (X Cupressocyparis leylandii) is a hybrid species that resulted from a cross between the Nootka false cypress (Chamaecyparis nootkantensis) and the Monterey cypress, (Cupressocyparis macrocarpa). It was discovered on a British estate in the late 1800s,

Daly said.

Poor site selection can create problems with Leyland cypress trees. "They grow into large trees, and in some parts of the world they can reach 100 feet tall and nearly 50 feet wide," Daly said. "Think of the damage a tree that size could do to your house, fence or driveway only a few feet away."

# Four feet taller each year

It may be hard to imagine a small Leyland cypress growing into a 100-foot tall tree, but with proper care, it can and will happen, he said. Leyland cypresses grow about 4 feet per year in height and 2 to



They require full, all-day sun. "Shade will reduce their vigor, causing them to thin out and become more susceptible to diseases," Daly said. "They also need plenty of air circulation inside the canopy to dry out the branches and leaves."

Planting too close to a fence, building or each other will prevent the interiors of the trees from drying out, he said, and could lead to fungal diseases.

# Well-drained soil a must

Disease pressure, improper planting and overuse may send Leyland cypress the way of plants like the red tip photinia and Bradford pears, according to Daly.

The tree is best suited for fertile, well-drained soils. "The amount of soil water is one of the most critical factors in the growth of Leyland cypress," Daly said. "Excess water will increase root-rotting fungal diseases, and too little water leads to

stem and leaf diseases." To monitor the soil moisture, use a shovel to open a 4-inch-deep gap in the soil near the base of the trees. Feel the soil and test it for moisture. If it feels dry,

stress and ultimately

avoid watering. Diseases can take their toll on Leyland

water. If it feels wet,

cypress trees. "Using chemical control is not feasible because application is ineffective and will not have effect on control," he said. "Severely infected trees may have to be removed.'

# Waning popularity

Disease pressure, improper planting and overuse may send Leyland cypress the way of plants like the red tip photinia and Bradford pears, he said.

Red tip photinias are small trees that were used extensively in the 1980s as a hedge. Most of the plants succumbed to Entomosporium fungal leaf spot

Bradford pears, although not afflicted with any serious diseases, have quick-growing soft wood and crotches at an angle. This causes the branches to split off easily.

# Alternatives to Leyland cypress

Several substitutes for Leyland cypress are available. Here are Daly's recommendations:

Hollies like "Nellie R. Stevens" and "Emily Bruner" varieties. These are best for borders in full sun.

Arbovitaes (Thuja occidentalis), particularly the "Green Giant" cultivar, which was selected as a 2007 Georgia Gold Medal Plant.

Wax myrtles (Myrica cerifera) grow rapidly

in full sun.

Tea olive (Osmanthus fragrantisima) or lusterleaf holly (Ilex latifolia) are good choices for shaded hedgerows.

"In general, these plants don't suffer from

the problems afflicting Leyland cypress as much," Daly said. "But they still need to be given proper cultural conditions such as applying the correct amount of water."



Honored at our Employee Appreciation lunch in June for 25 years of service, Dexter would often be driving the street sweeper while most of us were still enjoying the comfort of bed. After any special event on the Square, he would make sure the streets looked better than before the event had started. "For those of us who knew

him around the halls and dock of City Hall, his jovial laugh was infectious; his spiritual encouragement uplifting; and stories of his beloved Barbara and children Dexter Jr. and Imani were filled with pride and unconditional love. Also in a social media post, Councilwoman Fleeta Baggett touted the work of Scott.

Today [Sept. 14] YOUR city sweeper, Dexter Scott died of COVID. He did a job with pride that not many even noticed. He was a classmate of my brothers and my friend. He will be missed. My heart is broken."

A funeral service for Scott was held Saturday, Sept. 18, at Flat Rock Baptist Church with the assistance of Young-Levett Funeral Home in Covington.



# Dirty Birds making most out of lopsided Bucs loss

ATLANTA(AP) - Aweek after looking downright pathetic in a season-opening loss to Philadelphia, the Atlanta Falcons were at least competent in a 48-25 defeat at Tampa Bay.

The score was not entirely indicative of the game's flow, and first-year coach Arthur Smith was hardly despondent.

"I'm proud to coach this group," he said. "We are building something in there. These guys fight. So, you go on the road like this against a really good, veteran team, our guys kept swinging. It's unfortunate what happened at the end."

The end included two tipped passes from Matt Ryan that were intercepted and returned for touchdowns, putting the game out of reach. But there were some encouraging moments for the Falcons.

Cordarrelle Patterson got loose for a 23-yard catch on a screen that was nearly a touchdown. Calvin Ridley caught a short TD pass on fourth-and-goal. Dante Fowler Jr. strip-sacked Tom Brady. Patterson took a toss sweep 10 yards for a score.

Atlanta was trailing by only three points early in the fourth quarter, so it was in the game late. That will give Smith an opening for positive messaging this week as the team tries to avoid a 0-3 start for the second straight year.

"They got two Pick-6s off tipped balls? That's 14 points right there," Smith said. "It looks ugly in the box score, on the surface looking at it. Understanding the context of

Ryan's connection with Patterson and rookie tight end Kyle Pitts, who combined for 10 catches for 131 yards and one touchdown. Patterson, Pitts and receiver Calvin Ridley are the team's best playmakers, and Ridley led the team with seven catches for 63 yards. There's ample opportunity for more. Ryan

did a good job of looking at every option as 10 different receivers caught a pass.

# WHAT NEEDS HELP

The running game averaged 2.8 yards on 20 attempts. Atlanta was trailing throughout, so Smith, who calls the plays, essentially had to abandon the run to play catch-up, but the Falcons still need to get a better push up front early on.

Ryan also had eight pass deflections, mostly because the Bucs' front seven kept pressuring the line and pushing him off his spot.

"Yeah, that's part of the game," Ryan said. "It's tough. You've got to give them

credit. They did a good job the entire night of continuing to pressure, getting their hands up. It's tough to go against, but you've got to learn from it. You better. Hopefully, we can do that across the board as we move forward.

A week after catching four passes for 31 yards in a 32-6 blowout loss to the Eagles, Pitts had five for 73. That's not much of an increase, but the fourth overall draft pick flashed his athleticism on a pass over the middle that was thrown behind him. Pitts readjusted to make the catch for a decent gain. He said Monday that he did a better job of reading coverages, proof that he's shortening his learning curve.

Cameron Nizialek shanked two punts that gave the Bucs good field position, the worst coming early in the fourth quarter after a three-and-out. Tampa Bay took over at the Atlanta 43. Three plays later, the Bucs scored to make it 35-25.

Beamer was astonished at Georgia coach Kirby Smart's long list of top-rated players, including the massive duo of Jordan Davis (6'6", 340 pounds) and Devonte Wyatt (6'3", 315 pounds) on the defensive line.

Sometimes the depth may make it difficult for a backup to earn significant practice time behind the starters. Smart says that may

mean those backups volunteer to work on the scout team defense against Georgia's top offensive linemen.

"And when you've got players in your program texting you, 'Coach can I get some good work against Warren McClendon or Jamaree Salyer?' that's when you know you got a good culture," Smart said Monday.

"They're trying to get reps against better people rather than staying down with the defense... For me, that is everything we're about, that's what our culture is built on. 

# Breakthroughs in imaging technologies can help fight cancer

Doctors and patients have many different tools available in the war against cancer. Imaging is one of the essential resources used in such battles. Imaging helps screen and diagnose cancer and can be used to guide treatments and determine the efficacy of various therapies. Therefore, advancements in imaging can have profound effects on the ability to manage — and hopefully in the future — prevent or cure the disease.

The goal of cancer imaging is to detect the smallest possible number of tumor cells at the earliest possible time. Traditionally, X-ray, ultrasound, magnetic resonance imaging, single-photon emission computed tomography, and positron emission tomography have been utilized as key cancer imaging techniques. These technologies are being studied and advancing.

Imaging probes are one area of imaging worthy of attention. The Center for Probe Development and Commercialization, a supplier of radiopharmaceuticals, is developing the next generation of molecular imaging probes. They are designed to detect responses to chemo-

therapy in breast cancer patients. CPDC also has started to manufacture another probe designed to identify hypoxic tumors. These probes work on a molecular level, according to data published in 2013 in the International Journal of Biomedical Imaging. Molecular imaging has the potential to greatly enhance understanding of various cancers.

Another cancer imaging and evaluation tool that is being produced and tested is called the MasSpec Pen, which enables a controlled

and automated delivery of a water droplet to a tissue surface during tumor surgery or diagnostic exploration to extract biomolecules. The sample taken can immediately tell if cancer cells are present and distinguish tumors from healthy tissue.

Imaging has merged nanotechnology and conventional imaging tools with new developments. These technologies are still in the testing phase. Novel diagnostic probes with nanoparticles can improve imaging

results. A 2018 review paper published in the Journal of Controlled Release looked at how nanotechnology could improve the imaging and treatment of lung cancer. For example, gold nanoparticles work better than iodine-based agents for CT imaging. Similarly, superparamagnetic iron-oxide nanoparticles can be utilized with MRI for the ultra-sensitive reactions they produce.

Other imaging technologies in the works involve combining and improving the

workflow of various methodologies. Philips Medical Systems' Ingenia MR-RT Oncology Configuration is a comprehensive solution that allows radiation oncology departments to integrate MRI into their computed tomography-based radiation treatment planning.

In addition to the imaging evolution itself, researchers have realized the limitations of the human eye to discern abnormalities or small changes from images collected. Therefore, techno-

logical advancements are enabling artificial intelligence to look for key signs in images and correlate changes to the aggressiveness of the disease. This can improve treatment success rates and reduce the chances for human oversight.

Imaging plays a key role in cancer diagnoses and therapies. Improving cancer imaging can improve treatment plans now and in the future.

Because there are more than 100 different types of arthritis, men and women diagnosed with the condition can benefit greatly from individualized care. 

The American Academy of Periodontology notes there's a connection between periodontitis and several other diseases. While bacteria was long suspected to be the link between periodontitis and other diseases in the body, the AAP notes that recent research points to inflammation as the culprit that connects periodontitis with diseases such as diabetes and heart

The AAP notes that people with diabetes are at increased risk

for periodontal disease, speculating that diabetes patients' risk is higher because people with diabetes are more vulnerable to infections than those without diabetes. While that suggests periodontal disease is a byproduct of diabetes, the AAP notes that research points to the relationship being a two-way street. Periodontal disease may make it more difficult

for people with diabetes to control their blood sugar, making dental hygiene an especially vital component of routine healthcare for people with diabetes.

### **Heart disease**

The AAP notes that research indicates periodontal disease increases a person's risk for heart disease, with the inflammation caused by the former leading to

the latter. People with existing heart conditions also may find that periodontal disease exacerbates those conditions. The Mayo Clinic notes that the link between heart disease and periodontal disease is not fully understood, but enough studies have been conducted for scientists to support the notion that the two are connected.

# Can periodontal disease be prevented?

Periodontal disease is preventable. A daily dental hygiene regimen that includes brushing after meals, flossing at least once per day and swishing with mouthwash are some simple, healthy habits that can prevent periodontal disease. In addition, the AAP recommends that people at increased risk

for periodontal disease,

including the elderly and smokers, should discuss their risk with their dental profession-

als.

Dental hygiene can do more for individuals than produce a mouthful of pearly white teeth. In fact, people who prioritize dental hygiene may lower their risks for various diseases.

# Cataracts: what are they and can we avoid them?

When a brand new car is driven off a dealership lot, its plastic headlight lenses are clear and pristine. Over time, due to contaminants in the environment and oxidation from ultraviolet rays, those same lenses can become cloudy, yellow and opaque. Cloudy headlights can decrease visibility and potentially put drivers at risk.

Similar scenarios sometimes unfold involving the human eye. Starting around age 40, proteins in the eye may begin to break down and cause lenses to become cloudy. UV rays can be damaging to the eyes and contribute to this natural protein degradation. While pronounced vision problems may not occur immediately, the American Academy of Ophthalmology says vision can be impaired later in life. The organization All About Vision states cataracts are the most common cause of vision loss in people over age 40 and also are the principal cause of blindness in the world.

Unprotected exposure to the sun is just one contributor to cataracts. Certain medical problems, such as diabetes, also can cause cataracts. An eye injury, eye surgery or

radiation treatments on the upper body also can cause cataracts, as can corticosteroids, advises the AAO. Congenital cataracts, which occur when infants are born with cataracts, may be caused by infection, injury or poor development in the womb; otherwise, they can form in childhood.

Cataracts form in var-

ious regions depending on the cause, according to AAV.

• Subcapsular cataract: A subcapsular cataract occurs at the back of the lens. People

with diabetes or those who take high doses of steroid medications have a greater risk of developing this type of cataract.

Nuclear cataract:

This cataract forms in the central zone of the lens and is often associated with aging.

• Cortical cataract: This cataract is characterized by opacities that are white and wedge-like, which form on the periphery of the lens. Eventually they work to the center in a spoke-like fashion. Cortical cataracts can result from aging.

Symptoms of cataracts often can be slow to form, so people may not even notice they have cataracts until they start to block light, while others may learn of their presence during vision exams. Cataracts may cause vision that is filmy, blurry or foggy, indicates Web-MD. In older adults, nearsightedness may be attributed to cataracts. Glare, both during the day and at night, also may affect vision due to cataracts. Double vision or changes in the way one sees color can be symptoms of cataracts as well.

Eye professionals can diagnose cataracts and make recommendations on the course of treatment. Cataract removal surgery is highly effective. More than 95 percent of people who have undergone the surgery experience improvements. Such surgeries are often performed on an outpatient basis.

foods like French fries will not lead to a bout of acne. Various factors directly contribute to acne, offers Harvard Medical School, and such factors include:

• Bacteria: Bacteria contribute to inflammatory lesions in acne. At various times, including during puberty, bacteria on the surface of the skin can increase. Antimicrobials can suppress certain bacteria in patients with acne.

• Hormones: Fluctuating hormones, including fluctuations that occur during pregnancy and menopause, can

lead to acne. Stopping or starting birth control also can lead to acne. Hormones that increase in boys and girls during puberty can cause sebaceous glands to enlarge and make more sebum as well, says the Mayo Clinic.

• Excess oil produc-

tion: Some people may produce more sebum than others. When coupled with skin care products and makeup that can clog pores, this may lead to acne.

- Inflammation: Inflammation caused by diet can lead to inflammation throughout the body, and that may result in acne.
- Underlying medical condition: Certain conditions, such as polycystic ovarian syndrome in women,

are often accompanied by chronic or difficult-to-control acne.

• Medications: Medications people take for various conditions may actually cause acne as a side effect. This includes drugs that contain testosterone, lithium or corticosteroids. Changing medications may reduce breakouts.

It's important to note that acne is not caused by dirty skin. Scrubbing skin too harshly with chemicals or soaps may actually make acne worse by irritating the skin. Though makeup will not contribute to acne, opt for oil-free, noncomedogenic products and remove makeup each night before going to bed.

Acne is often tied to adolescence, but it also can persist into or even first appear during adulthood. Learning the causes of acne can help people of all ages successfully confront it.

# 3 things to know about Irritable Bowel Syndrome

COVINGTON, Ga. — The most common condition that gastroenterologists, or physicians who specialize in digestive health issues, diagnose and treat is irritable bowel syndrome (IBS). Even though 10% to 15% of adults in the United States have it, only about half of those will be diagnosed.

If you are suffering from chronic abdominal pain or experiencing changes to your bowel movements, like diarrhea, constipation, or both, you may need to see a gastroenterologist to discuss the possibility of IBS.

Women are twice as likely as men to develop the disorder.

Michael Cheng, M.D., and Gregory Gibson, M.D., formed a new gastroenterology practice at Piedmont Newton Hospital in August. They want people to better understand this under-diagnosed problem.

"There is no single test to confirm IBS and no cure," Cheng said. "But it can be managed."

• Diagnosis does not necessarily require invasive tests.
Often, a conversation and abdominal exam are enough.
A physician concerned about IBS will ask about a patient's

bowel movements: the frequency, appearance and any pain or strain associated with them.

• It is a common misconception that stress causes IBS. The American College of Gastroenterology (ACG) reports that "changes in the nerves and muscles that control sensation and motil-

ity of the bowel" cause IBS. But because of the connection between the brain and the gut, cognitive-behavioral therapy can be adapted to address the core symptoms of IBS, according to the clinical guidelines on IBS issued by the ACG for the first time this year.

• Temporary dietary changes can help. The ACG recommends a limited trial of a diet low in gas-producing foods, a group known as FODMAPs, to identify an individual's triggers for IBS symptoms. For three months or so, avoid foods with fructose (fruit sugar) or lactose (milk sugar) as well

as beans, onions, broccoli, and cabbage.

"What works for one person, may make things worse for another with IBS, so it is really important to talk to your doctor about your situation," Gibson said.

"But these symptoms are real and you do not have to 'just deal with' them."

# Understanding fibromyalgia and how disabling pain is treated

Pain is a fact of everyday life for millions of people across the globe. According to the National Fibromyalgia & Chronic Pain Association, one in nine adults in the United States suffers with severe, disabling pain. The NFMCPA reports that roughly 10 million Americans have fibromyalgia and that the overwhelming majority of those cases are women. Canada's Arthritis Society notes that fibromyalgia affects roughly 2% of Canadians, meaning it's as significant an issue in Canada as it is in the United States.

The American College of Rheumatology notes that people with fibromyalgia often suffer from fatigue and sleep problems.

# What do medical professionals know about fibromyalgia?

Much is known about fibromyalgia, but unfortunately there is no cure for it. The

causes of fibromyalgia are unknown, but the ACR reports that the latest research suggests the central nervous system is involved in the development of the disorder. The ACR also emphasizes that fibromyalgia is not a byproduct of an autoimmune, inflammation, joint, or muscle disorder. In addition, the ACR indicates that, while fibromyalgia may run in families, genetics alone do not cause it. However, certain genes may make certain people more likely to get fibromyalgia.

Emotional stress may contribute to fibromyalgia. For example, the Arthritis Society notes that the onset of some instances of fibromyalgia have been linked to traumatic incidents or emotional experiences, such as car accidents or the death of a loved one.

# Can fibromyalgia be treated?

Treatment can help people live with fibromyalgia, but a treatment that works for one person will not necessarily be effective for another. The ACR notes that both nondrug and medication-based treatments are available to patients diagnosed with fibromyalgia. People can discuss the pros and cons of the various fibromyalgia treatment options with their physicians to find the best solution for them.

# Noise-induced hearing loss can impact people of all ages

Aging has long been associated with hearing loss, and that association is not unwarranted. The National Institute on Deafness and Other Communication Disorders notes that age-related hearing loss can arise from changes in the inner ear as the body ages. However, hearing loss can affect people of all ages, including the very young.

Noise-induced hearing loss, or NIHL, can affect people of all ages. In fact, a 2011-12 study from the Centers for Disease Control and Prevention found that as many as 40 million adults in the United States have some degree of hearing loss related to exposure to loud noise. Another study published in 2011 in the journal Pediatrics found that as many as 17% of adolescents between the ages of 12 and 19 had features of their hearing suggestive of NIHL.

No single activity can explain the prevalence of NIHL among adolescents and adults under 70. However, there are steps everyone can take to protect their hearing and reduce their risk for NIHL.

• Switch from earbuds to over-the-ear headphones. The Cleveland Clinic notes that over-the-ear headphones encase the

ear and are often more effective at canceling outside noise. Why is that important? If outside noise is effectively canceled out, wearers won't have to turn up the volume on their headphones in order to hear their music. Listening at lower volumes is a great way to protect your hearing and pre-

vent NIHL.

• Recognize that others shouldn't hear what's coming through your headphones. Audiologist Sharon A. Sandridge, Ph.D. of the Head and Neck Institute at the Cleveland Clinic notes that if people standing at arm's length can hear the music coming from

an individual's headphones or earbud, then the volume levels on that person's devices are too loud.

• Purchase activity-specific headphones, earplugs or earmuffs. Hardware stores and sporting goods stores sell activity-specific headphones, earplugs and earmuffs that can

be utilized when engaging in activities like yard work or hunting. Such products are often designed to block out noises from backpack leaf blowers and hunting rifles, and could therefore prove more protective of users' hearing than over-the-ear headphones designed for listening to

music.

# Many factors could increase risk for preterm births

Expecting mothers often go to great lengths to protect their developing babies as they aspire to achieve a healthy, full-term pregnancy. That's a notable and worthy goal, as the Association of Women's Health, Obstetric and Neonatal Nurses notes that babies need a full 40 weeks to grow and develop.

Despite the best efforts and intentions of expecting parents and their medical teams, preterm births remain a significant issue across the globe. According to the World Health Organization, about 11% of the world's live births are preterm births. March of Dimes reports that the rate of preterm births in the United States is 9.8%, while the Canadian Institute for Health Information notes that Canada's preterm birth rate is roughly 8 percent.

If those figures are alarming, it's worth noting that many of the risk factors for preterm births are defined as "modifiable" by the Eunice Kennedy Shriver National Institute of Child Health and Human Development. Modifiable risk factors can be changed to help women reduce their risk of giving birth before their pregnancies reach full-term.

### Preterm births remain a significant issue across the globe.

One study sponsored by March of Dimes and published in the Maternal and Child Health Journal concluded that as many as one-quarter of all preterm births might be attributed to modifiable risk factors. These factors included:

- Abnormalities in the interval between pregnancies
- A woman's body mass index before pregnancy
- The amount of weight gained during pregnancy

The Centers for Disease Control and Prevention notes that certain behavioral factors also can increase a woman's risk for premature birth. Such behaviors, including tobacco usage and alcohol consumption, are modifiable risk factors that women can control.

Though modifiable risk factors are within women's control, they are not the only variables that can increase a woman's risk for

preterm births. The NICHHD notes that additional factors women cannot control or influence put them at high risk for preterm birth. These factors include:

- A history of delivering prematurely
- Being pregnant with twins, triplets or more or the use of assisted reproductive technology to become pregnant. In fact, the American College of Obstetricians and Gynecologists notes that preterm birth is the most com-

mon complication of multiple pregnancy.

 Abnormalities of the reproductive organs, including a short cervix or a shortening of the cervix during the second trimester instead of the third trimester.

March of Dimes notes that prematurity can cause problems, including developmental issues, for babies throughout their lives. However, the WHO has developed new guidelines for improving the outcomes of preterm

births, and these interventions can improve the chances of survival and health outcomes for preterm infants.

Pregnant women and women hoping to become pregnant can speak with their physicians about what they can do to increase the chances their pregnancies reach full-term. More information about preterm births is available at marchofdimes. org.
